An Act establishing an industrial communities action program for making grants to industrial communities to complement private investment at industrial sites; and prescribing requirements of and conditions for grants.

On that question, the gentleman from Washington County, Representative Trich, is recognized on final passage.

Mr. TRICH. Mr. Speaker, I merely rise to support this companion bill of HB 1700.

HB 1701 merely serves as an additional one-two punch to aggressively deal with some of the areas that have lagged behind economically in the Commonwealth. Although there are similar funding tools certainly, HB 1701 is flexible enough to deal with the matters at hand and to hopefully find solutions in a quicker manner.

For that reason and to generate what I hope will be new economic activity in areas around the Commonwealth that need that, I would ask that the House lend its support to this bill.

(e) Preservation of assets subject to restitution.—Upon application of the Commonwealth, the court may enter a restraining order or injunction, require the execution of a satisfactory performance bond or take any other action to preserve the availability of property which may be necessary to satisfy an anticipated restitution order under this section:

(1) upon the filing of a criminal complaint, information, or indictment charging a criminal violation for which restitution may be ordered and alleging that the property with respect to which the order is sought appears to be necessary to satisfy such restitution order and judgment; and

(2) if, after notice to persons appearing to have an interest in the property and an opportunity for a hearing, the court determines that:

(i) there is a substantial probability that:

(A) the Commonwealth will prevail on the underlying criminal charges;

(B) restitution will be ordered exceeding \$10,000 in value;

(C) the property appears to be necessary to satisfy such restitution order; and

(D) failure to enter the order will result in the property being destroyed, removed from the jurisdiction of the court or otherwise made unavailable for payment of the anticipated restitution order; and

(ii) the need to preserve the availability of the property through the entry of the requested order outweighs the hardship on any party against whom the order is to be entered.

(f) Temporary restraining order.—A temporary restraining order under subsection (e) may be entered upon application of the Commonwealth without notice or opportunity for a hearing, whether or not a complaint, information or indictment has been filed with respect to the property, if the Commonwealth demonstrates that there is probable cause to believe that the property with respect to which the order is sought appears to be necessary to satisfy an anticipated restitution order under this section and that provision of notice will jeopardize the availability of the property to satisfy such restitution order and judgment. Such a temporary order shall expire not more than ten days after the date on which it is entered, unless extended for good cause shown or unless the party against whom it is entered consents to an extension for a longer period. A hearing requested concerning an order entered under this subsection shall be held at the earliest possible time and prior to the expiration of the temporary order.

Mr. PIEVSKY. Mr. Speaker, the amendment is agreed to, and I would urge an affirmative vote.

The Chair recognizes Representative Belfanti from Northumberland County.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, I cosponsored the Piccola amendment. It models a bill which I have introduced the past two legislative sessions which would allow the courts to impose a freeze on the assets of a convicted criminal.

In an instance in Northumberland County, an individual murdered a police officer and was subsequently convicted and sentenced to life imprisonment. Over the course of his confinement in Northumberland County Prison, he filed a litigation against the county commissioners and the warden for mistreatment. Rather than fight the case in court, the insurance company for the county awarded him \$5,000. He promptly mailed that check to his sister. In addition, he was the owner of some property, including a tractor-trailer, and signed all of those assets over to his sister. There was nothing that any of the courts could do to prevent him from doing this. At the same time, the court had awarded damages to the slain police officer's widow and court costs were imposed, and not a dime of it has been collected.

Mr. Speaker, this amendment is necessary to prevent this type of situation from occurring in the future. I would hope that if a felon has been convicted and a defendant is on trial, or has been on trial and found guilty, that sufficient assets be encumbered by the courts to pay restitution and court costs.

I would appreciate a "yes" vote on the Piccola-Belfanti amendment. Thank you.

Mr. DALEY. Thank you, Mr. Speaker.

A great enemy to the cause for human rights and an ally of tyranny has been perpetrated against all people today. Three young freedom fighters were executed for antirevolutionary activities. Eight more stand in the shadow of the firing squad. Hundreds and maybe thousands of young Chinese thirsting for freedom were murdered in the streets of that Communist country.

The question is, why should we care about what happened in China and what can we do? Should we let this act of violence go unquestioned? I think if we did, we would be guilty of passive toleration. It would be similar to witnessing a crime and not trying to help that innocent victim.

Two hundred and thirteen years ago the Declaration of Independence put it very succinctly in those timeless words that make as much sense today, and if we look at the picture on the wall, and we call ourselves the cradle of liberty, what you see is the picture of someone reading something like this, saying that we hold those truths to be self-evident; that all men—all men—are created equal, and they are endowed by their Creator with certain inalienable rights; that among those are life, liberty, and the pursuit of happiness, and to secure those rights, governments are instituted among men, governments are instituted among men, driving their just powers from the consent of the governed; and whenever that government or any government becomes destructive of those ends, it is the right of the people to alter or abolish that government. It is the right of the people to alter or abolish that government, and that is what was happening in China and that is what is happening in China today.

The dread disease of freedom is growing. The voices of change are being heard, and the roar of tanks cannot silence those deafening cries for democracy. Social and political justice cannot be thwarted by any army; not only any army, not even the Red army. The new patriots for democracy in the world today are not Nathanael Greene and they do not have

names like Ethan Allen or Mad Anthony Wayne, but they are the new patriots of freedom, and they have displayed the ultimate measure of commitment. God bless that cause and God bless their courage.

Freedom's fires are being fanned by winds of change throughout the world, and as the sons and daughters of the Fathers of Independence, it is not only our right but our obligation to acknowledge, support, and encourage liberty, justice, and freedom, not only for our people but for all people for all time.

I ask for unanimous support for this resolution, Mr. Speaker.
