BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 246**, **PN 2688**, entitled:

An Act amending Title 15 (Corporations and Unincorporated Associations) of the Pennsylvania Consolidated Statutes, requiring nonprofit corporations to supply information as to affiliation, activities and tax status to the Commonwealth; providing for powers and duties of the Department of State and the Department of Revenue; and providing for penalties.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On final passage of the bill, the gentleman from Erie County, Mr. Cappabianca, is recognized.

Mr. CAPPABIANCA. Thank you, Mr. Speaker.

It goes without saying that I would appreciate overwhelming support for HB 246. But, very briefly, this is the result of some 3 years of public hearings that a select committee had on the issue of nonprofits, unfair competition, and how it affects the for-profit community within the Commonwealth of Pennsylvania. In my opinion, all this bill does is add a little parity to the situation. All for-profit businesses in Pennsylvania file with the Pennsylvania Department of Revenue, just as they do with the Internal Revenue Service of the Federal Government. What this piece of legislation, if it should ever be enacted, would do is simply say that nonprofits for the first time in Pennsylvania will file annual reports with our Department of Revenue, and that is all it does. It is not a taxing mechanism, Mr. Speaker. It is a mechanism to acquire data, data which the future General Assemblies may use to make determinations, if in fact there may be some undue competition between the nonprofit world and the for-profit world.

So on that basis alone, Mr. Speaker, in the interest of fairness, the interest of parity, I would ask for overwhelming support of this piece of legislation.

Mr. Speaker, it has been brought to my attention just now that the explanation, which says "This bill would require all non-profit organizations to submit a report to the IRS," is wrong. It means that you will submit reports to the Pennsylvania Department of Revenue, because it goes without saying that nonprofits are already reporting to the IRS with what are known as their 990 forms. They would basically be sending those 990 forms to the Pennsylvania Department of Revenue also. Thank you.

The SPEAKER. The gentleman, Mr. Ryan, the minority leader, is recognized on final passage of HB 246.

Mr. RYAN. Mr. Speaker, I would not want my remarks misinterpreted, but the gentleman, Mr. Cappabianca, has for these 3 or more years had something "in for" the nonprofits. We have watched legislation introduced by the gentleman, amendments introduced by the gentleman, all out to further regulate the nonprofits. This is, if I may, the latest attempt to further annoy and regulate nonprofit corporations.

Mr. Speaker, what the gentleman is attempting to do is further regulate with a paper trail the nonprofits of this State that are engaged in any profit-making sidelines, I suppose you could call it. This that I have in my hand is the Federal return that must be filed which this gentleman would have filed now at the Department of Revenue.

I am told—and I would be pleased to hear from the gentleman on this—I am told that the Department of Revenue wants nothing to do with this particular piece of legislation; that they do not care to be the repository or depository, as the case may be, of further paperwork that really is of no moment to them. They are not collecting taxes. It is something for future generations of revenuers and legislators to lift up, file, and throw away as useless or worthless data.

The gentleman has had 3 years of investigations into the nonprofits, has disturbed them time and time again with the threatened legislation that has been brought to this floor. I suspect if you or any of you care to know whether this is a good bill in the minds of your constituent, your nonprofit constituent, you will find that they would ask you to vote a hearty "no" as I am also asking you to do to this proposed legislation. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes on final passage the gentleman from Schuylkill County, Representative Lucyk.

Mr. LUCYK. Mr. Speaker, a question for the prime sponsor, please.

Mr. Speaker, does this include volunteer organizations - firemen, ambulance squads, et cetera? I looked through the definitions in the bill, and this was not really spelled out.

Mr. CAPPABIANCA. It would include, Mr. Speaker, anyone who is incorporated in Pennsylvania as a nonprofit organization.

Mr. LUCYK. All right. Then your answer to me is it includes your senior citizen groups, your fire companies, your rescue squads. Organizations which are incorporated would have to file this report.

Mr. CAPPABIANCA. No. Mr. Speaker, in essence you are correct. However, since we are piggybacking on IRS those nonprofits which have gross revenues of less than \$25,000 and therefore do not report to the IRS, they therefore would not have to report to the Pennsylvania Department of Revenue. They would be exempt.

But your initial question was, whom does it pertain to? It pertains to all nonprofits in Pennsylvania that are incorporated with our Department of State.

Mr. LUCYK. Thank you, Mr. Speaker. 1 have no further questions.

The SPEAKER. The Chair recognizes, from Bucks County, Representative Wright on final passage of the bill.

Mr. J. L. WRIGHT. Thank you, Mr. Speaker.

I hope that each one of us in the chamber today is paying close attention to this piece of legislation. I strongly suspect that many of us here sit on a board of directors of a non-profit. If we do not, somebody in our family or somebody close to us in the neighborhood does.

You do know that we are fighting a budgetary crisis each year in the nonprofits regarding the percentage of the money that we raise, the percentage of money that we spend for administrative costs, for accounting, for auditing, and it bothers us because it is that kind of money that we cannot spend in providing a service on the charitable level or to the needy.

I strongly suggest that you consider, when voting on this bill, that it is going to affect an organization you belong to or an organization you are representing here in the House. Thank you.

The SPEAKER. On final passage of the bill, from Mercer County, Representative Fargo is recognized.

Mr. FARGO. Thank you, Mr. Speaker.

Could I ask a couple questions of the maker of the bill?

The SPEAKER. The gentleman indicates he will stand for interrogation. You may proceed.

Mr. FARGO. There is a requirement in this bill that 1 percent of the annual filings under this bill be audited by the Department of Revenue. Has there been a fiscal note on this particular requirement?

Mr. CAPPABIANCA. I did not hear the question.

Mr. FARGO. Has there been a fiscal note prepared on this particular requirement that we audit 1 percent of all the non-profit corporations that file?

Mr. CAPPABIANCA. There is a fiscal note attached. Now, specifically for that provision, I am assuming that the fiscal note does cover that provision also. The breakdown on our analysis, if you want me to read it to you—

Mr. FARGO. I would appreciate that.

Mr. CAPPABIANCA. —the breakdown, the estimated administrative cost for the Department of State to keep the records is \$283,000. That is the first time. Then an annual cost from the second year to the fifth year—by the way, there is a 5-year sunset provision in this particular piece of legislation, sunset review—there will be an estimated \$2,000 per year to maintain and notify the nonprofits as well as any new nonprofit that comes on board. Then with our Department of Revenue, the first-year cost for the Department of Revenue is estimated to be \$790,000 for 6 months. The second-year costs are estimated at \$1 1/2 million. The reason for this, I understand this would include 25 new positions to handle 100,000 new returns, and it would also include five auditors to audit the required—the question you asked—five auditors, five new auditors to audit the required 1 percent of the returns.

Mr. FARGO. Apparently, from that figure they are estimating that they are going to receive 100,000 reports under this nonprofit requirement.

Mr. CAPPABIANCA. My understanding is that is just to handle 100,000 new returns, which would be the nonprofits.

Mr. FARGO. That means then if 1 percent of those have to be audited, we are going to be maintaining 10,000 additional audits for Pennsylvania under the Department of Revenue.

Mr. CAPPABIANCA. Possibly.

You must understand, Mr. Speaker-

Mr. FARGO. One thousand? Thank you.

I am told that that is 1,000 rather than 10,000 at 1 percent.

So we are asking the Department of Revenue to audit 1,000 nonprofit organizations under this legislation.

It is my recollection when we used to prepare returns on the 990's, that a Kiwanis organization, a Rotary organization, and so forth, if they received in excess of \$25,000, had to file an individual return although they were members of the International Kiwanis or whatever it may be. Do you know if this will cover those people or those organizations now?

Mr. CAPPABIANCA. It is my understanding that any national organization that files a report with the IRS, it would only require the national organization to file, not the auxiliary organizations.

Mr. FARGO. But under present regulations, if any individual Kiwanis Club, for instance, receives in excess of \$25,000, then they are required to file a 990 even though they are a member of the total organization.

Mr. CAPPABIANCA. That is my understanding with the IRS. Yes.

Mr. FARGO. This requires that if a parent company is audited, then all the individual organizations under that

parent company will also be audited in that particular year. Is that a fair reading of the law?

Mr. CAPPABIANCA. Mr. Speaker, it is my understanding again that the legislation proposed here would only require organizations that are nationally affiliated and that are reporting only to have the national affiliation report.

Mr. FARGO. Well, thank you, Mr. Speaker.

Could I make a statement?

The SPEAKER. The gentleman is in order with a statement on final passage.

Mr. FARGO. Thank you, Mr. Speaker.

The answer that I got, as far as national organizations are concerned, would make me believe that we are even asking that Kiwanis International would have to be audited, and I am not even sure that that would be a possibility. I do not know whether we and the Department of Revenue could go and audit Kiwanis International because we happen to have some Kiwanises in Pennsylvania that file these returns.

But be that as it may, I want everyone here to understand that we are going to now be having the Department of Revenue auditing at least 1,000 nonprofit organizations in Pennsylvania. We are asking them to—Regardless, these nonprofit organizations, the vast majority of them, are not the kinds of organizations that Mr. Cappabianca is concerned about. They are not the hospitals. They are not the people who have a lot of other businesses within their organizations. But still on a random selection we are going to be auditing those people, and I just cannot imagine from my experience with this kind of an organization that this is a fair procedure and certainly not one that your neighbors—and remember, you are going to be members of these organizations also, if you look into the organizations that you do participate in—the problems that we are going to be causing these organizations.

I think we have to look at this bill very carefully as to what it is going to do to the nonprofits in Pennsylvania. In my estimation, this is overkill, and we had better be careful with what we are doing and how it is going to affect us in the future.

I would suggest that we either table this bill or that we look at it very carefully, and I would propose a negative vote. Thank you.

The SPEAKER. The question is on final passage. The gentleman from Erie, Mr. Cappabianca, is recognized on final passage.

Mr. CAPPABIANCA. Thank you.

I would remind the House that this legislation is a compromise that was worked out by the select committee, all parties concerned. I will point out to you also that the Department of Revenue presently has the authority and the power to audit 260-odd thousand for-profit businesses in Pennsylvania if they wanted to.

All we are trying to look for here is some parity. If we are going to have a deterrent of any kind, if we are going to have to wait until we have a national scandal before we audit non-profits, then you could probably say you are going to vote

against this type of legislation. But if we want to keep everything on the up-and-up, then we ought to tell nonprofits that are legitimately operating the way they should be that they have nothing to fear. Basically, all they have to do is send a copy of their 990 that they are presently sending to the IRS, send those same forms and applications to our Department of Revenue. All this other smoke screen as to what it is going to cost us to perform this operation, that is nothing but a smoke screen. If you want parity, if you want fairness in Pennsylvania, then we can be the first State to put nonprofits on the same level with for-profits.

The SPEAKER. Will the members suspend in their debate for just a few moments. We have some distinguished guests with us today who have other appointments.

WELCOME

The SPEAKER. The Speaker is happy to welcome to the hall of the House this morning Ms. Dorothy Hileman, who is Ms. Senior Pennsylvania. She is accompanied by the 1987 Ms. Senior America, Mabel Hoffman. They are each to the left of the Speaker. They are the guests of Representative Chris McNally.

CONSIDERATION OF HB 246 CONTINUED

The SPEAKER. On final passage of the bill, Representative Ryan is recognized.

Mr. RYAN. Thank you, Mr. Speaker.

Mr. Speaker, we have here a bill that is going to cost the people of the Commonwealth, according to the fiscal note, about \$2 million to enforce, give or take a couple hundred thousand. What we did not look into as we went through this debate is the cost to these various organizations, the cost of filing the returns, and then going through an audit, the cost to them of an audit. If it is going to cost the Department of Revenue \$1 1/2 million to conduct audits, those thousand charitable organizations are going to have at least that much money to spend in connection with the same audits.

I think there are any number of consuming reasons why we should kill this bill, and I would urge that we do just that.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

WELCOME

The SPEAKER. The Speaker is happy on behalf of the House to welcome to the hall of the House several visitors who are the guests of Representative Jean Wilson. The Chair welcomes Mr. and Mrs. James Hanak and Mr. and Mrs. Curyto from Bucks County. They are here today to the left of the Speaker.

ASTRONAUT JAMES IRWIN PRESENTED

The SPEAKER. These individuals are accompanying a special guest of the House today. As an exception to the Monday-only rule, we have with us today the eighth astronaut on the moon, Col. James Irwin, Apollo 15 astronaut. He is here as a special guest of Representative Ron Gamble and Representative Dennis Leh, and Representative Dennis Leh I invite to the podium to introduce astronaut Col. James Irwin.

Mr. LEH. Thank you, Mr. Speaker.

There is no sense in my saying anything. I give you Jim Irwin, eighth man to walk on the moon.

COLONEL IRWIN. Thank you, Mr. Speaker.

What an honor it is for me to stand here in the Pennsylvania House of Representatives and to be so honored. I thank all of you for giving me this opportunity.

I thank you that I was able to be in your city for the Prayer Breakfast this morning. In preparation for that, I was reviewing my life and reminded that life began for me in Pittsburgh, Pennsylvania, in the Magee Hospital. I was also reminded that my first ride in an airplane was at Allegheny County Airport, and when I came back from that flight, I knew that I wanted to be a pilot. Then just yesterday I was speaking at the Naval Air Development Center in Warminster and reminded that there I also had a lot of training that would prepare me for a higher flight.

This morning at the Prayer Breakfast I was able to show the flag of Pennsylvania that we carried, flew to the moon on the flight of Apollo 15, and I am looking forward to presenting it to Governor Casey at 1:30 this afternoon. I am sorry it has taken so long to perform this presentation, but I have been looking for the right occasion, and fortunately, the Prayer Breakfast this morning, the visit back to my home State, and the visit here to the Capitol provided that opportunity.

You see the patch or insignia for the flight of Apollo 15. My colleagues on the flight were Al Worden and Dave Scott. Then the photograph I think all of you would recognize. It is regarded as the best picture ever taken on the moon, and I am glad that I happened to be in it. Dave Scott was my photographer, and I am glad that I took him along as my photographer. But it was a proud moment in my life to be able to place our flag on the moon and salute it. I felt so proud I thought that I should sing the "The Star-Spangled Banner," but my singing voice is not that good, so I did not try that. But I was also reminded that I had come a long way from the Allegheny Mountains of Pennsylvania to the Apennine Mountains of the moon.

You see our little home on the moon. We called it the Falcon, because we were the first all-Air Force crew to fly together in space, and part of the Falcon is still there. The gold part is there; the silver part has gone because that was our transportation back into space.

There is the little automobile that we took, man's first car on the moon, and we just barely broke it in, just put about 20 miles on it and left it up there on the used-car lot, the highest used-car lot in the world. And I recommend it for your use. I hope you will not tax it. But it sits there and it is ready for any of you, and if you do not go, perhaps your children or your grandchildren will be able to go to the moon someday and you can tell them that Jim Irwin and Dave Scott left a little car there. So it sits there. It is ready for you.

You can see our boot prints in the dust of the moon. Scientists say they will be there for a million years. So it makes you feel very special to leave your boot print on another world.

In the background is a mountain 13,000 feet high, and on the slope of that mountain is where we found a strange white rock that the press labeled the "genesis" rock, because they thought it would be the oldest rock that we would find. But just after we found the white rock, I looked over my shoulder and there sat a beautiful green rock. We brought that back, too. It turns out the green rock is older than the white rock. In fact, is that not significant that an Irishman born on St. Patrick's Day in Magee Hospital would find a green rock on the moon?

But I will be presenting this to Governor Casey this afternoon. I did bring a copy of that photograph, that same photograph, to present to the Speaker for the House of Representatives in my home State of Pennsylvania. Thank you for this honor.

The SPEAKER. It is a beautiful memento that I accept on behalf of the House and will find an appropriate place, probably in our new Visitors Center, to display the same.

Mr. COWELL. Thank you, Mr. Speaker.

Mr. Speaker, this is amendment 3311. The amendment and a fiscal note have been circulated.

The legislation that we are dealing with pertains to PHEAA (Pennsylvania Higher Education Assistance Agency), as does the amendment. The amendment in particular deals with work study programs which are administered by PHEAA. It would do two things. One, it would authorize PHEAA to receive funds from foundations and other nongovernment agencies to help support work study programs for students. Right now the programs are funded with State, Federal, or institutional dollars. This is intended to create another potential source of money and allow work study programs for college students to be expanded.

Secondly, the current law requires PHEAA to send work study checks to institutions, which in turn will pass them along to employers who are employing the work study students. This amendment would allow PHEAA to send checks directly to employers rather than having to route them through the institutions.

Mr. Speaker, I would urge support for the amendment.

However, the legislature, when it approved the 1989-90 budget, did provide funds sufficient to allow PHEAA to award grants not in excess of \$2,100, and a number of those grants have tentatively been awarded.

With the passage of this legislation, we will allow PHEAA to honor those tentative commitments of \$2,100 grants to students and give them authority to consider, if we provide the dollars, grants up to \$2,500 per year in future years. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The SPEAKER. The Chair recognizes the minority leader, Representative Ryan.

Mr. RYAN. Mr. Speaker, this amendment has been reviewed by the gentleman, Mr. McHale, the prime sponsor, and it is intended, in the nature of a technical amendment, to make it clear that if a referendum fails, the county cannot go ahead with the "911" plan.

The SPEAKER. The question is, will the House agree to the amendment? On that question, Representative McHale from Lehigh County is recognized.

Mr. McHALE. Thank you again, Mr. Speaker.

The gentleman, Mr. Ryan, is correct. This is an agreed-to amendment. I urge an affirmative vote.

The SPEAKER. From Somerset County, Representative Lloyd is recognized.

Mr. LLOYD. Mr. Speaker, would Mr. Ryan stand for interrogation?

The SPEAKER. The gentleman indicates he will. You may proceed.

Mr. LLOYD. Mr. Speaker, the Somerset County commissioners have contacted me with regard to their particular predicament, and I just want to find out what your intention is with your amendment.

They are in the process of obtaining the equipment necessary to put in a "911" system. They are going to pay for that by utilizing community development block grant money from the county and from a number of the entitlement municipalities. At the time that this legislation becomes law, they will probably already have bid those particular purchases. We are going to have to have some language, probably in the conference committee, to try to work this out, but is your amendment intended to say that under that set of circumstances, if the people in Somerset County say we do not want to fund the operating expenses through a surcharge, is it your intention that the Somerset County commissioners would then basically have bought a white elephant and not be allowed to put on any kind of other levy or take it out of general funds in order to operate the system?

Mr. RYAN. I do not believe this amendment affects that set of facts as you have given it to me but rather is restricted to the referendum question and the effect of it.

Mr. LLOYD. Well, but the problem is that the referendum question, the way it is now worded in the bill, is a two-pronged question: Do you want a system, and do you want a surcharge? All I would like to know is, if we can revise this language in conference, do you have any intention to try to stop Somerset County or anybody else in like circumstances from proceeding?

Mr. RYAN. No. I have no intention with this amendment other than to clear up what I believe to be an inconsistency in the language, and if there is a separate problem that is not addressed by this and the bill in fact goes into a conference committee, I have no thoughts, really, with respect to it and would be glad to cooperate.

Mr. LLOYD. Okay. Thank you, Mr. Speaker.
