1989 SURPLUS PROPERTY DISPOSITION PLAN

The SPEAKER pro tempore. The Chair wishes to acknowledge receipt from the Governor of the Surplus Property Disposition Plan No. 1 of 1989, which will then be placed on the legislative calendar.

Commonwealth of Pennsylvania Governor's Office Harrisburg

To the General Assembly of the Commonwealth of Pennsylvania

By the authority vested in me by Article XXIV-A of the act of April 9, 1929, (P.L. 177, No. 175), known as "The Administrative Code of 1929," added by Section 5 of the Act of July 1, 1981 (P.L. 143, No. 48) and entitled "Disposition of Commonwealth Surplus Land," I transmit herewith the 1989 Surplus Property Disposition Plan.

The annual Surplus Property Disposition Plan, required by Article XXIV-A, provides for the systematic management of Commonwealth-owned real estate assets and the efficient disposition of surplus holdings. The Plan also ensures that all conveyances are made for fair consideration predicated upon fair market value.

Contained in the Plan for 1989 are three (3) properties whose usefulness to State Government has ceased. However, they are useful and valuable for other purposes. Any special considerations, such as zoning restrictions, retention of mineral rights, and easements or leases presently in effect, have been identified.

Pursuant to Article XXIV-A, the Plan was transmitted to the Chairman and the Minority Chairman of the House and the Senate State Government Committees. The House and Senate Committees conducted a joint public hearing on September 26, 1989, as part of their review of the Plan and advised the Department of General Services of their findings.

The Department of General Services also invited public comment on the Plan through publication in the Pennsylvania

Bulletin, Vol. 19, No. 34, August 26, 1989. In addition, pursuant to Article XXIV-A, the Department requested and received approval of the Plan by the Attorney General as to form and legality.

Legislative consideration of the sale of the property contained in the Plan will result in substantial benefits to the Commonwealth, including the return of idle real estate to the local tax rolls, the reduction of State exposure to liability and other insurance risks, and the elimination of excessive security and maintenance costs.

I, therefore, transmit to you and urge your approval of the 1989 Surplus Property Disposition Plan.

Before I just give a brief explanation of this amendment, I would like to inform the Chair that I am withdrawing amendment A3417, and I will only be offering the one that I am currently going to explain.

Mr. BIRMELIN. Thank you, Mr. Speaker.

It is a quirk in the current law that if you will read the amendment, you will see that currently dog wardens are allowed to enter onto the premises of a property without a search warrant. That is clearly unconstitutional. The amendment that I am introducing here clarifies the fact that a dog warden could not enter into a person's home unless they were given permission or had a duly authorized search warrant, therefore clarifying this language, and I think this will be of benefit to the citizens of Pennsylvania to know that their constitutional rights are being protected in this manner.

Also, I would like to let you know that the Department of Agriculture is in favor of this and feels it would help their law enforcement as well.

I would ask for your support.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Wyoming, Mr. Lee.

Mr. LEE. Mr. Speaker, section 505-A of HB 820 criminalizes certain behavior concerning the keeping of dangerous dogs and other dogs. Specifically, section 505-A(b) makes it a second-degree misdemeanor if a dangerous dog attacks a person or another domestic animal. The dog's owner will be guilty of a misdemeanor of the second degree. In section 505-A(c), the owner of any dog that aggressively attacks and causes severe injury or death of any human shall be guilty of a misdemeanor of the first degree.

Mr. Speaker, this section contains no standard of culpability which a court shall use to determine whether an individual is actually guilty of this crime. What my amendment would do is basically establish a negligence standard for these crimes. Specifically, if anyone intentionally or recklessly or negligently takes care of his or her dog, then they shall be guilty of a crime, instead of setting up a strict liability standard which the bill seems to imply.

This amendment has been agreed to by the prime sponsor of the bill, Representative Brandt, and I urge its adoption.

STATEMENT BY MR. COWELL

The SPEAKER pro tempore. The Chair now recognizes the gentleman from Allegheny, Mr. Cowell.

Mr. COWELL. Thank you, Mr. Speaker.

Mr. Speaker, I know members are anxious to return to their offices and to other business, but I wanted to take a couple of minutes to share some information about special education regulations and standards that might be of interest to members, particularly since members may be receiving comment from constituents about this issue during the next couple of weeks when you are back in your districts.

You might recall that when we passed the budget at the end of June, we also passed Act 43, and in Act 43 the legislature directed the State Board of Education to promulgate new regulations and standards no later than March 1 of 1990 - regulations and standards for special education. The State Board of Education is well along in that process, and last Thursday, on November 9, the board adopted a motion of intent to adopt regulations and standards. Those regulations and standards, which were the subject of that action by the State Board last week, are now subject to review by the House and Senate Education Committees, and Act 43 gave us 30 days during which time we could develop comments and deliver comments to the State Board pertaining to the special education regulations and standards.

As part of that process of doing some homework, the House Education Committee next Monday at 1 o'clock is going to conduct a meeting where we will receive a briefing by the department and by the State Board of Education on the regulations and standards. I would encourage any members or their staff who might have an interest in learning more about what is in the special education proposals to sit through that briefing. I would expect it is going to be very helpful.

Additionally, we will be delivering to everybody's mailbox later today a copy of the proposed regulations and standards so that you will have the benefit of the material that was considered by the State Board last week.

The deadline that our committee is working with is Monday, December 11. By that time, we are going to have to deliver to the State Board whatever formal comments or reaction we want to offer pertaining to the regulations and standards which have been proposed, and I would hope that we would have the benefit of comments and suggestions from all the members of the House. If you are going to offer us comments and suggestions, I would encourage you to deliver those to my office or to Ed Burns' office as soon as possible so that we can make sure those opinions are reflected in the comment that we deliver to the State Board.

Mr. Speaker, if there are any questions about this issue, I am going to be in my office for the remainder of the day. I would be glad to try to respond to any requests for additional information. Thank you very much.
