I have the honor to inform you that I have this day approved and signed House Bill 521, Printer's No. 1291, entitled "AN ACT amending the act of June 26, 1931 (P.L. 1379, No. 348), entitled, as amended, 'An act creating in counties of the second A and third class a board for the assessment and revision of taxes; providing for the appointment of the members of such board by the county commissioners; providing for their salaries, payable by the county; abolishing existing boards; defining the powers and duties of such board; regulating the assessment of persons, property, and occupations for county, borough, town, township, school, and poor purposes; authorizing the appointment of subordinate assessors, a solicitor, engineers, and clerks; providing for their compensation, payable by such counties; abolishing the office of ward, borough, and township assessors, so far as the making of assessments and valuations for taxation is concerned; and providing for the acceptance of this act by cities,' PROHIB-ITING SPOT REASSESSMENT; **PROVIDING** CHANGES IN VALUATION IN CERTAIN CASES; AND further providing for appeals by persons who have suffered catastrophic losses to their property.

#### House Resolution No. 169

#### A RESOLUTION

Memorializing the Congress of the United States to investigate the live sightings of POW's and MIA's and to investigate our national policy in this area.

RESOLVED, That the House of Representatives of the Commonwealth of Pennsylvania memorialize the Congress of the United States to investigate the live sightings of POW's and MIA's in Southeast Asia and to investigate the current policy of the United States regarding the sightings of POW's and MIA's; and be it further

RESOLVED, That copies of this resolution be transmitted to the presiding officers of each house of Congress and to each member of Congress from Pennsylvania.

The SPEAKER. The gentleman, Mr. Kasunic, is recognized.

Mr. KASUNIC. Mr. Speaker, I rise to ask your support of this resolution.

I am sure by now each and every one of you has seen this picture in your local newspapers and on the TV screens throughout this Nation. What it is is a photograph of three American servicemen reportedly still being held captive some 16 years after the last shot was fired in the Vietnam War conflict.

In view of these recent reported sightings and the photograph of American prisoners of war and those believed to be missing in action, my resolution asks Congress to thoroughly investigate these sightings. This resolution also asks Congress to look more deeply into the policies and operations of the agency that heads these investigations.

Within the past year, and I do not recall the gentleman's name right now, but the gentleman who was heading these investigations in the agency concerning these sightings resigned his post because of his belief that there are Americans being held captive in Indochina and that our government was stalling or not doing enough to help those some 2,200 service personnel who are still listed as being "missing in action" in Indochina.

As recent as this past week, the Secretary of Veterans Affairs, Secretary Edward Derwinski, stated publicly that he believes that it is possible that Americans could still be being held captive in Indochina.

It seems to me that something has seriously gone wrong with our POW/MIA investigations. We have reports of live sightings of American military and then the newspaper runs a photograph of men who, if they are still alive, have been held captive for years and years while their families and friends were led to believe all hope was gone.

We, as Americans, owe those 2,200, in excess of 2,200 American personnel that debt of gratitude to thoroughly investigate these reported sightings. We owe it to their families. These were men and women who left this country, who left the shelter of their homeland, to fight a war on foreign soil, and perhaps they are still fighting that war for those of us here in America.

As Americans, we cannot let members of our Armed Forces or their families be led astray, and we cannot allow them to give up hope. Maybe these sightings are false, and maybe the picture is a fraud, but "maybes" are not good enough, not good enough for family and friends that hoped and prayed for years for the safe return of the ones they loved so dearly, and we as fellow Americans cannot let them down.

This resolution only asks that the American Government do the job they are expected to do in these situations. Resolve these cases once and for all. Let the families and friends of approximately 2,200 POW's and MIA's move on with their lives. Let us allow them to grieve or allow them to be joyous, but let us allow them to go on.

After all the turmoil, particularly from the Vietnam conflict, we owe this much to the brave people who fought and who may still be in captivity in Indochina.

I will be the first to admit that I had my doubts that there were such things going on. I had my doubts that 16 years after a conflict, people could still endure and could still be alive. But after the evidence that has been presented to us, the evidence that has recently been reported, I now doubt that we have been told the truth over the years.

As I said, I cannot imagine that people could endure that kind of torture or suffering that these people may have endured over that number of years. But then again, they are Americans and they are proud, so I really cannot doubt their endurance.

By the same token, I cannot imagine that people of any country would hold others in captivity for so many years, but we see it every day in other parts of the world. Maybe, just maybe someday we will see a world where human lives are not the sacrifice that must be paid for peace.

I ask for your support in passing this resolution. Thank you very much.

And in closing, I would also ask, Mr. Speaker, that upon the passage of this resolution, that the resolution be left at the desk for anybody who would care to join me in the cosponsorship of this resolution. Thank you very much.

#### House Resolution No. 171

#### A RESOLUTION

Congratulating PONY Baseball on the occasion of its 40th Anniversary and designating August 1991 as "PONY Baseball Month" in Pennsylvania.

WHEREAS, PONY Baseball, which began in 1951 with only six Pony League teams, currently has a membership of over 24,000 teams in the United States and 12 foreign countries and more than 300,000 players, making it the second largest international amateur youth baseball program in the world; and

WHEREAS, PONY Baseball originally stood for Protect Our Neighborhood Youth, but because of growing interest in the program throughout the country, Neighborhood was changed to Nation's in 1952; and

WHEREAS, PONY Baseball was founded in Washington, Pennsylvania, where it still maintains its international headquarters; and

WHEREAS, Pony League was founded in order to provide a transition for players from the Little League diamond to the regulation size baseball field; and

WHEREAS, Pony League was also designed to give the 13and 14-year-olds the opportunity to continue their youth baseball career; and

WHEREAS, Pony League is played on a field with bases set at 80 feet and a pitching distance of 54 feet. It is a transition diamond enabling the 13- and 14-year-olds to play a complete game of baseball before moving to the regulation 90 foot diamond; and

WHEREAS, Currently there are over 300 Major League Baseball players who are graduates of PONY Baseball. Tony Gwynn of the San Diego Padres, Roger Clemens of the Boston Red Sox, Wally Joyner of the California Angels, Brett Saberhagen of the Kansas City Royals and Ryne Sandberg of the Chicago Cubs are just a few of the many Major League Baseball players that played PONY Baseball; and

WHEREAS, Joe E. Brown, a comedian, acrobat and actor whose career spanned the entertainment world from vaudeville and silent movies through circus, fairs and carnivals to the Broadway stage, radio and television, became the first president of Pony League when the organization was incorporated in 1953. He held the post until late 1964 when he retired; and

WHEREAS, Lewis W. Hays succeeded Joe E. Brown as PONY Baseball President; and after his retirement, Roy R. Gillespie became President, the office in which he currently serves; and

WHEREAS, Present House member Leo Trich, Jr. served with the PONY Baseball program for 15 years and served as its National Commissioner from 1980 through 1986; and

WHEREAS, PONY Baseball is celebrating its 40th Anniversary; and

WHEREAS, The Pony League World Series for 13- and 14-year-olds will be held in Washington, Pennsylvania, starting August 17, 1991; therefore be it

RESOLVED, That the House of Representatives hereby congratulate PONY Baseball on the occasion of its 40th Anniversary and for its outstanding contributions to our nation's youth; and be it further

RESOLVED, That August 1991 is hereby designated as "PONY Baseball Month" in Pennsylvania.
