This amendment 2238 under present statute of the motor vehicles for personal plates limits it to 9,000 pounds, and this would include motor homes that are so prevalent around the State of Pennsylvania and Penn State and other areas. I have had several requests for this. It would only apply to motor homes, and it is my understanding that it is an agreed-to amendment. Thank you.

The SPEAKER. The Chair recognizes Mr. Jarolin.

Mr. JAROLIN. Thank you, Mr. Speaker.

Would the maker of the amendment please stand for a brief interrogation?

The SPEAKER. The gentleman indicates that he will.

Mr. JAROLIN. As it stands right now, mobile homes do have a mobile home license plate. When you put on a vanity plate, which is an extra cost, anything exceeding 9,000 pounds is going to have to be paying an extra rate. At some point, and I will not really go out and oppose the amendment, but I just would like a little bit of a clarification. What may happen to the license plate is the State Police could possibly stop you just to check you for that additional sticker as a vanity plate. So it would read "mobile home" or "Penn State." But the Penn State license or any other vanity license could not go in excess of 9,000 pounds, so the Department of Transportation would possibly have to issue a personal little sticker for that particular mobile home. So we do not create a serious problem with his constituents or my constituents, I would ask Mr. Carlson if he could give me a brief explanation as to that.
