Mr. Speaker, HB 1136 is the bill that will establish the Keystone Quality Leadership Awards Council, Keystone Quality Leadership Foundation, which they in turn will establish the Keystone Quality Award. The award is based and modeled after the Malcolm Baldrige Quality Award, which is under the auspices of the Federal Government, as well as it is modeled after several local quality awards that towns such as Erie, Pennsylvania, and Butler, Pennsylvania, have established already. This award will encourage the competition for quality among the private sector, and the one difference that our bill has as opposed to the Federal bill is that it will also include the public sector and public sector organizations can compete for the quality award.

I urge all the members to vote in the affirmative. Thank you, Mr. Speaker.

SENATE MESSAGE

AMENDED HOUSE BILL RETURNED FOR CONCURRENCE AND REFERRED TO COMMITTEE ON RULES

The clerk of the Senate, being introduced, returned HB 2529, PN 3480, with information that the Senate has passed the same with amendment in which the concurrence of the House of Representatives is requested.

The SPEAKER. The Chair is about to recognize the majority leader for remarks. Members should be advised that there will be apparently one more and possibly more than one vote after the conclusion of the gentleman's remarks.

STATEMENT BY MAJORITY LEADER

The SPEAKER. The Chair recognizes the majority leader. Mr. DeWEESE. Mr. Speaker, I would like to have the attention of the House and ask that my colleagues pay special attention to the very brief remarks I will be sharing today.

Mr. Speaker, the signal feature of the balanced budget proposal that the House Democrats are introducing today is in fact that it is today, May 6, that we are introducing it. This is 55 days earlier than the deadline, and I do not believe that anything can be stated more unequivocally about our collective intentions on this side of the aisle to realize a timely, balanced, and effective budget process than the fact that we are introducing it on May 6. It is 28 days earlier than we did it last year, and I think this is an auspicious commencement. It is even 15 days earlier than the deadline that we all voted on. All of us voted 196 to nothing to impose upon ourselves a deadline when we passed HB 2383 3 months ago. As we did last year, the House Democratic Caucus is doing our utmost to insure a timely passage of a balanced proposal.

We on our side take substantial satisfaction, Mr. Speaker, budgets. This fulfilling the first part, the first part, of our obligation. Yet

in fulfilling the first part, the first part, of our obligation. Yet obviously, we feel compelled by painful recollections of last year to remind the people of Pennsylvania that this is not just the job of the Democratic House of Representatives. This is a collective responsibility that must be shouldered not only by House Democrats but by House Republicans. It must be shouldered by Senate Democrats and Senate Republicans. All of us, all of us, will get the chance to put our cards on the table.

Last year the House Democrats passed a spending plan on June 6, 24 days ahead of time. Before that point the Senate Republicans had flatly refused to have any discussions whatsoever about the budget. We were the pitchers, they were the catchers, and they refused to throw the ball back. I really think that metaphor is simple, but I think it is accurate.

After that point the Senate Republicans took every opportunity to delay the timely passage of our budget, and they succeeded in that delay, Mr. Speaker, for 34 days past the deadline. Retrospectively, as I look back upon that distant horizon, I am still convinced that if 20 or 30 Republican members had come up with a package that Fred Anton and Cliff Jones had devised, it would probably have percolated inexorably to passage, because the general political will that common sense and political longevity would combine to dictate would have probably allowed for 70 or so votes early in the process - May 15, June 15 of last year - to come together with a package that would have been more amenable to the Republican side. But the intransigence and the recalcitrance of the minority party last year obviously debilitated the process and we had to endure a very, very long summer.

I hope that we will not repeat that kind of destructive behavior this year. If our chamber does, I am hopeful and confident that by the introduction today of a balanced proposal on May 6, the people of our Commonwealth will realize the differentiation between these two teams, and they will realize that the House Democrats did in fact in early May, almost 2 months before the bell rings at midnight on June 30, propose a balanced document not increasing taxes and balancing our budget.

Next week, Mr. Speaker, we will begin to debate this proposal that we are submitting today, and that debate will be what you have all been asking for and what I personally respond affirmatively toward: it will be a freewheeling, aggressive, sometimes rancorous debate. I am sure that even, even moments will come when heat will be turned up high, but nevertheless, the press, the public will get a chance to see the internal aspects of our process and the inside pages, page 219, line item 47.

All of the budget efforts that have been requested in the past, because of our early start and because of the fact that additional revenues will not be requested, should be giving us a chance to have this lively and productive debate. I think it will be the most open debate in memory. And although Mr. Ryan's experience goes back to when Christ was a corporal to use a boot-camp reference—my only experience is 16 budgets. This will be the 17th budget for me, but I do not recall any of them being as open as Chairman Evans and his Appropriations Committee staff and his Appropriations Committee members, both sides, are anxious to make this budget.

The Eagleton Institute at Rutgers University has said over and over and over, and I have made this comment from this microphone in the past, that we are the most partisan of the 50 States, our legislative apparatus, and I realize the necessity for hard-hitting partisan efforts during the late weeks of the autumn. That is natural. That is the way it should be. But I would like to think that in the summer of 1992, with no tax increase on the horizon, with substantial cuts made in line item after line item after line item, that we could come together and work together with Chairman Evans and Chairman Pitts, the Republican leadership team, the Democratic leadership team, and urge all of our members to come back next week to the Capitol, to our chamber, and give it our best. I do not think we have done that in the past, but the past is behind us and the future is this summer, and we can make a mark this summer by passing a budget way before June 30 midnight. We have not had this kind of chance in quite a while, and I would certainly solicit the collective involvement of House and Senate Democrats and Republicans as we strive toward what should be a mutual goal for the men and women and children whom we represent.

Mr. Speaker, I will relinquish the microphone to the gentleman from Philadelphia, the chairman of the committee.

STATEMENT BY MR. EVANS

The SPEAKER. The Chair recognizes Mr. Evans.

Mr. EVANS. Thank you, Mr. Speaker.

Mr. Speaker, I would like to announce to members of the House that this morning we have introduced the budget, and the bill number is HB 2696.

Mr. Speaker, as we promised in February when the House approved a package of budget reform legislation, House Democrats would follow the deadlines set in that package, regardless of whether the Senate took the action. Today House Democrats introduce a General Fund spending plan.

From the beginning of this budget season we have asked ourselves, how can we best appropriate the available and the anticipated dollars so that we can take care of Pennsylvania's most immediate and critical needs and at the same time insist that the cost-containment proposals be implemented? This budget proposal reflects House Democrats' efforts to contain costs; to make government operations more efficient and effective, and insure the money we spend now will help reduce further expenditures; provide for the economic development and the infrastructure needs of the Commonwealth; insure that fiscal prudence be matched with compassion for those most vulnerable in Pennsylvania's communities, along with an investment in Pennsylvania's future, its families and children. As I said we would, where we found the Governor's proposal took an appropriate course of action, we would support it. Where we felt his proposal did not go far enough, we will work to do better. While we have not closed off consideration of responsible, well-thought proposals, we believe today's proposal achieves our goals.

The \$14.19-billion General Fund proposed plan is a 1.3percent increase over 1991-1992. Let me repeat that: The \$14.19-billion General Fund proposed spending plan is a 1.3percent increase over 1991-1992, about \$17.1 million less than the Governor's proposal in February. There are no tax increases. Let me repeat that: There are no tax increases. There are no false promises, there is no gimmickry; just basic, fundamental budgeting.

The House Democratic proposal includes \$637 million in increased funding for some State programs and \$449 million in cuts to other State programs. The increases occur where they are most critical. The decreases do not impair the operation of the necessary programs or governmental services.

Education remains the largest piece of the budget, 46.4 percent, followed by health and welfare at a 36.9-percent increase. Many cost-containment proposals for welfare and health programs hold increased costs in those areas to a minimum - the expansion of several proactive cost-saving measures in the Department of Public Welfare, the reinstatement of a community work program, and changes in the medical assistance benefits package offered general assistance clients.

The highlight of the cost-saving effort is the proposal to require language in all State contracts that a good-faith effort be made to hire welfare clients for new jobs created as the result of State funds. No existing employees or employees receiving unemployment compensation are to be displaced by this effort.

Another 7.9 percent is allocated for protection of persons and property.

I anticipate this year's budget debate will be lively, but I expect we will approve a final spending plan in the time frame we have set for ourselves. Thank you, Mr. Speaker.

The SPEAKER. Is there any further business to be brought before the House?

Mr. RYAN. Yes. I would like to have some---

STATEMENT BY MINORITY LEADER

The SPEAKER. The Chair recognizes Mr. Ryan.

Mr. RYAN. I guess, Mr. Speaker, it is a redundancy to say that these remarks sound a little bit like the beating of a hollow drum, in that by definition I suppose a drum is hollow, but that is how this struck me.

The gentleman, Mr. DeWeese, started off with a chip on his shoulder, I thought today, frankly, and he was thumping on his chest a little bit about having introduced a bill early. Well, you know, just to take some of the thump out of it, Mr. Speaker, 10 years ago when we were in the majority, we had one signed at this time of the year, and as I recall, we did it on our own. Maybe we had one of you with us.

I think if you are looking for cooperation, you are going about it the wrong way when you are critical of some of what took place last year. If you want to start being critical of what took place last year, maybe you should look in the mirror, look in the respective mirrors of the Democrat caucuses at the proposed almost \$2 billion in savings that we proposed that was turned down without consideration, except one bill that would have represented a savings to this Commonwealth or an income producer to this Commonwealth became law, and then it was-as agreed to by all of the negotiators-and then our good Governor, he vetoed it as soon as he got his hands on it. So we are leaving last year's budget as we finish up this year. And as I told Chairman Evans the other day in a private telephone conversation, we are, frankly, leaving this year's budget and going into next year's budget with a sour taste in our mouth, because the Governor no sooner got the budget that we had negotiated to a great extent last summer, then he started vetoing and line-item vetoing and reserving and then lapsing things that had been part of that budget that had been agreed to, and that is not the way you do business here or any other place, as I see it.

So I really believe when you talk about your metaphor being rather simplistic of throwing a ball to the Senate and waiting for them to throw it back, I think the thing that is so simplistic about it is the person who is pitching the ball, and we had better take a look at that one. He will laugh. He did.

Now, here comes the challenge. I am not going to try and pull rank on you, because I was a corporal way back in them there days, Mr. Speaker, but I put in quotes your words, "This is going to be the most open budget. It is intended to be the most open budget that we have had," and I forget what the quote was; in a long period of time in any event. I am curious if by "most open budget" you mean that it is going to be in print for a change and we are going to be able to actually read it before it comes out of committee, or if "most open budget" means we may actually have an opportunity to amend it and put amendments in, which would be a welcome change of openness.

I wonder if the gentleman from Philadelphia, when he refers to the budget as HB 2696, has forgotten or just neglected to mention that we also have a string of bills that are normally part of the budget that are nonpreferred bills, or are they going to be held in hostage as hostages for the passage of HB 2696? That is something I guess we will find out when we get a look at what has been introduced, whether we have one bill introduced or are we going to take care of any of the colleges and the charitable institutions of Pennsylvania which historically we have taken care of lo these many years.

The last remarks, I really did not understand exactly what that one provision was that Mr. Evans made reference to, that there is going to be a— His idea, I suspect, of welfare reform is that anytime—and I gathered this just from that short statement—is anytime there is a State job or money that the State is putting into a project anywhere in Pennsylvania, you must first hire someone who is on welfare. That is what I gathered. Now, I have to think that if that is the idea, that qualification must come into it somewhere, and I will be interested in seeing that. It sounds to me, however, it smacks to me of something that is going to require a good bit of looking at. That is not exactly what we had in mind when we thought of welfare reform, but what we have in mind— But it might be worthwhile, and I am not dismissing that, but I will be curious to see it.

I am told by a staff person that nonpreferreds were introduced, so that answers that one question which I had.

On this good-faith openness, I think it is also interesting to note that you guys introduced all these bills. We never saw them, and we, of course, were never asked for any input; we were not asked to cosponsor them. And that is your right; you are in the majority. But do not preach good-faith openness as you slip these things into a committee where we have absolutely no leverage and nothing to say. But that is neither here nor there. We will have something to say on the floor, unless there is once again a destruction of the democratic system by a failure to allow us to introduce amendments to any of these bills that are introduced.

So we all understand where we are coming from, I believe that what has been introduced— And I have not seen it. I have had casual conversations. I think I have a feel for what is happening, although I do not know what is happening at the moment. I do not know what is contained in the bill. I rather suspect that our promise, your promise, my promise to the school people, the school children of Pennsylvania that this year we would give them \$125 million into the ESBE (equalized subsidy for basic education) formula, I rather think that what you have cosigned, if in fact you cosigned this HB 2696, probably contains a breach of that agreement and that that \$125 million that all of us have promised the people of Pennsylvania last year in law probably is not to be found there. Well, we are interested in that. We want to live up to that commitment that we made.

Last year you took away from all of the counties, after we passed it and we negotiated it, you took away from all of the counties the moneys that they earned over a long period of time for their district justices, money to help their courthouses, little odds and ends like this. I do not know whether they are restored or whether they are further depleted by the Governor.

I am curious as to whether—and I do not know the answer to this—whether the \$75-plus million in new taxes requested by the Governor in the budget address, which he started out by saying, there will be no new taxes, except look at footnote 4(d) on page 3, which says assumes the passage of \$75 or \$77 million in taxes— I do not know whether that is part of your program or not, the passage of that tax. If so, I am sure you have got 102 heroes over there who are ready to give you that one. None of my troops are going to do it.

The other thing that I wonder about, the Governor— And I really did not understand this until recently when some of my retired teachers came to me, and I do not know whether any of your retired teachers have been to see you yet, and even

after four or five of them had been to see me. I still did not know what they were talking about because I am so thick. But apparently somehow or another the Governor has proposed in his budget that about \$75 million or \$77 or \$74 millionforgive me-\$74 million of State money not be given to the retired teachers of Pennsylvania, as represented by their pension fund, and that we play a numbers game with the pension fund, as we did once before, and that way we save \$75 million, our local school districts save \$75 million, for which I guess at this point Mr. Evans says, see, look, I gave \$75 million to the local school districts because they do not have to contribute that because we are stretching out payments on an actuarial basis to 35 years instead of the 15 or 20 that would normally happen. I do not know that. I cannot imagine that your leaders would be such flimflam artists that they would follow the lead of someone else who was playing games with the numbers and with the lives of the retired teachers of Pennsylvania. At least that is the way I look at it at this time. It may very well be that there is good reason to do this. I do not know. They do not seem to think so, and I am not sure, but it will be interesting to see what you have on it.

The higher education. Now, as many years as we have been here and even your leader at 17 years, in 17 years, the past 17 years, we have all gone home and we have told our people that we are going to take care of the higher educational needs of the people of this Commonwealth, and we have never shirked our duty. Now, we did not always give them everything they needed, but we sure tried our best to do what we could do. I think we were all disappointed when the Governor's budget came out with a cut, and I think we were disappointed last year when a cut was made by the Governor, and we all did our best. We put it back to where it had been the year before, and I suspect that Chairman Evans, when he put his bill in and put it together, he probably ignored-I am guessing-he ignored the Governor's budget in this area of the moneys to be spent by Pennsylvania. I cannot believe that Chairman Evans and Majority Leader DeWeese would ignore the needs of the higher educational community of Pennsylvania and not restore, not restore, that spending to the higher education community. But, of course, we will have to take a look at that and see just what has happened to it.

In brief, I have mentioned spending, and we are those tightfisted, rightwing conservatives. We do not really agree with a lot of that stuff, huh? Well, we can meet those needs given the opportunity. We can meet those needs that we have all been talking about or I have been talking about, and it can be done by—according to my staff people—it can be done by the Dick Willeys of the world and Michael and the people from the Senate getting together, the staff people at the staff level, and doing some of the things, I suspect, that Chairman Evans made reference to; that is, cutting line after line one painful place after another. You pull the money out; you look it over, and you give some of it back, and you take some of it, and you put it away. But that is not going to do the whole trick, obviously. There has got to be a real hit. Where do we save a good deal of money?

I am going to recommend to you, any of you who are interested, give my office a call. I think I sent out to you here a couple of months ago our welfare reform proposals. It looked like this, and I will be glad to send this over to you now, because I think you should read it. I think you should have an opportunity to take a look at it, because you are going to vote on it. I believe you are going to vote on it. I believe that someway, somehow, I am going to find a way to give you the opportunity to vote on it, and I do not want it to hit you by surprise. I want you to have the opportunity to study it so that when it does come up, either as an amendment to something or as a discharge resolution, you are going to know what you are voting for or against, and what you are voting for or against is going to be used to fund higher education; it is going to be used-that is assuming that these things are not taken care of in Chairman Evans' bill-it is going to be used to take care of this \$125 million or so much of it that is not taken care of in the bill for basic education; it is going to be used to take care of all these other areas that maybe had to be cut that maybe are sensitive to us. They may not be sensitive to the staff on the majority Appropriations Committee, but maybe they are sensitive to the members and we decide some of that should be put back in.

Eventually you are going to come down to the question, do we adopt some welfare reform and come into compliance and look like other States in the United States or do we deprive the school districts of Pennsylvania of moneys that we promised them last year? Do we deprive higher education of the source of funds that we have always given them? And that, I think, is the question that is going to come up unfortunately in this election year. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Mr. DeWeese.

Mr. DeWEESE. Quickly, Mr. Speaker, and in a spirit of amicability and bipartisanship.

Retrospectively, Mr. Speaker, the brigadier from Delaware County should have probably asked us - Mr. Evans, myself, the men and women whom I work with daily - you should have asked us for input in that document that you held high. You should have asked us to be partners as you developed it just as maybe we should have asked you to be more involved in our process of developing a budget.

However, however, Mr. Speaker, it should be noted that when HB 2383 passed unanimously by our collective efforts, we were anticipating that we would introduce a budget, that you would introduce a budget, that our two sides of the aisle in the Senate chamber would also introduce budgets, and by the utter fecundity of our collective intellectual abilities, we would have four ideas that we could mesh and that we could bounce off each other. And due to the Dick Willeys and the Mike Rosensteins, the Joe Pittses, due to the fact that all of us are legislators, we are sent here to legislate, and in the new Democratic House leadership team, we are asking our legislators to be legislating. We are asking McNally to work on export proposals, we are invigorating our chairmanships, and we were thinking when we introduced the bill—and you voted for it; we all passed HB 2383—we will have a budget to start out with, you will have a budget. We will look at your welfare proposals. I am sure, I am sure—and I am glad you are sitting down, Mr. Speaker—that there is some efficacy in some paragraph that you people have produced.

But anyway, you did not ask us to help you develop that and we did not ask you to help develop the proposal that we are introducing today. But notwithstanding the initial pride of authorship and the initial zeal that went into these proposals, I believe there is a lot in each of them that can be meshed, can be adopted, can be accommodated, and that is essentially our assignment here. And we have not performed our assignment as well as we should have in the past, and I am certain that I will see those remarks come back, but that is candid and that is reflective and that is the way it is.

So I would challenge the ladies and gentlemen, leaders and rank and file, on the Republican side to come up with a budget; come up with a budget. You talk about the \$125 million, and that is a valid subject for dialogue, but if you are going to produce that \$125 million, obviously you will have to cut in other areas, and I assume that the document that you held up will be part of the roadmap toward those cuts, but I cannot help but think — And by the way, Mr. Speaker, the Republican leader said that he was a tightfisted, rightwing conservative. I do not believe that for a moment. I have always thought that the distinguished pasha from the southeast was more of the Rockefeller wing of the party. Now, I am not saying, as I gaze across my many friends, my many friends, that there are not a few tightfisted, rightwing Republicans out there, but I always held you to be of the Rockefeller wing, the moderate wing of the party, so I think you were overly self-deprecatory in that observation.

I wish, in closing—and this is a non sequitur; I am sure many of you think that everything I have said has been a non sequitur—but I wish, I wish as I watch—Mr. Speaker, thank you for your indulgence—I wish that as I watch C-SPAN once in the proverbial blue moon and I see British Parliamentarians lacerating each other and making aspersions and strictures at each other, I wish that somehow we could loosen up in here a little bit more. Maybe that day will come; maybe it will not. But nevertheless, as we loosen up, there should be a spirit of fraternity and good feeling, and I just have more than a modicum of confidence that notwithstanding some of today's observations from both sides, we are going to get the job done this year on time and effectively, and naturally it can be done a lot easier if we do it together. Thank you, Mr. Speaker.

A RESOLUTION

Memorializing Congress to consider the impact of the Rodney King verdict.

WHEREAS, The Rodney King verdict in the city of Los Angeles and the resultant violence in that city and around the nation has gripped the attention of the citizens of Pennsylvania and the United States; and

WHEREAS, The Commonwealth of Pennsylvania recognizes that we are dealing with humanitarian issues and that to promote respect and cooperation among diverse cultural groups, we must initiate methods to better explain and allow people to understand that unprovoked violence perpetrated against another human is wrong; and

WHEREAS, This Commonwealth should promote peace, harmony and good will among all men and women irrespective of ethnic origin, socioeconomic standing or religious affiliation; and

WHEREAS, We encourage all branches of government to consider that excessive, needless violence, whether it be perpetrated by a citizen or sanctioned by an agent of a Federal, State or local authority, is wrong and that we as a governmental entity be cognizant of promoting methods to reduce the frequency of such violence; and

WHEREAS, We encourage the highest levels of government to provide direction and leadership by actively participating in whatever measures they have available to help restore the dignity and pride which we all share in our nation's creed of promising fairness and justice to each citizen; and

WHEREAS, We, the members of the Pennsylvania House of Representatives, believe that these measures will assist in restoring confidence, pride and hope for the future to all citizens of this Commonwealth and this nation who view our commitment to the preservation of justice as apocryphal and dishonest; therefore be it

RESOLVED, That the House of Representatives of the Commonwealth of Pennsylvania memorialize the Congress of the United States to immediately consider the impact of the violence which is occurring in the city of Los Angeles and other cities across the United States which was initiated by the Rodney King verdict; and be it further

RESOLVED, That copies of this resolution be transmitted to the presiding officers of each house of Congress and to each member of Congress from Pennsylvania.

The people who were ripped from those trucks and the violence which was perpetuated upon them was as wrong as the violence which was perpetuated upon the other person, Rodney King, in the videotape, and it is from that standpoint that I would hope that our government would stand solidly behind reducing the tensions that are coming across this country as well as this State, and I would thank all members for support of this resolution. Thank you very much.
