Section 1. Sections 211(d) and 404 of the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, reenacted and amended June 29, 1987 (P.L.32, No.14), are amended to read:

Section 211. Enforcement.-* * *

(d) The Office of Chief Counsel for the Pennsylvania State Police shall represent the enforcement bureau in all enforcement proceedings brought before the Office of Administrative Law Judge or any other adjudicatory body. The enforcement bureau is bound by legal opinions issued by the board or its counsel.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Mihalich.

Mr. MIHALICH. Thank you, Mr. Speaker.

Mr. Speaker, this amendment was approved here in the House of Representatives last year and it died in the Senate attached to another bill which was not taken out of committee there.

Mr. Speaker, let me briefly review the reasons why this House of Representatives approved this amendment last year in 1992.

There are more than 20,000 licensees of all kinds regulated by the Pennsylvania Liquor Control Board in Pennsylvania. These 20,000-plus licensees service millions of Pennsylvania and out-of-State customers. These licensees and patrons are by and large honest, good businessmen, good customers who want to live and operate by the laws of this Commonwealth.

We make the laws here. The Pennsylvania Liquor Control Board writes the regulations, and we should expect that they who write the regulations, their legal department, would be the ones to interpret those regulations. I think it is just common sense to say that the agency that writes the regulations and has the responsibility of enforcing the laws should be the ones to interpret the meaning of those laws and regulations.

For that reason, Mr. Speaker, I ask for a positive vote on this amendment.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Oliver.

Mr. OLIVER. Mr. Speaker, I rise also in support of the Mihalich amendment. This amendment was approved last year. It is a good amendment, and I ask for the support from both sides of the aisle.

The SPEAKER pro tempore. The Chair thanks the gentleman.

An Act amending the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, providing automatic suspension of practitioners' licenses for conviction of drug offenses.

On the question,

Will the House agree to the bill on third consideration? Mr. FAJT offered the following amendments No. A0693:

Amend Title, page 1, line 10, by inserting after "act," "
further providing for prescriptions; and

Amend Bill, page 1, lines 15 through 17, by striking out all of said lines and inserting

Section 1. Section 11(f) of the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, is amended to read:

Section 11. Professional Prescription, Administration, and Dispensing.-**

(f) Any drug or device dispensed by a pharmacist pursuant to a prescription order shall bear a label showing (i) the name and address of the pharmacy and any registration number obtained pursuant to any applicable Federal laws, (ii) the name of the patient, or, if the patient is an animal, the name of the owner of the animal and the species of the animal, (iii) the name [and any registration number required to be obtained pursuant to any applicable Federal laws,] of the practitioner by whom the prescription order was written, and (iv) the serial number and date of filing of the prescription order. In addition, the following statement shall be required on the label of a controlled substance: "Transfer of this drug to anyone other than the patient for whom it was prescribed is illegal."

Section 2. Section 23 of the act is amended by adding a subsection to read:

Amend Sec. 2, page 2, line 22, by striking out "2" and inserting

Mr. FAJT. Thank you, Mr. Speaker.

Mr. Speaker, this amendment simply provides for the deletion on controlled substances of the doctor's FDA (Food and Drug Administration) number. Right now Pennsylvania is one of the few States that requires the doctor's FDA number to be shown on a prescription bottle, and when people are counterfeiting these prescriptions, they not only have the doctor's name and can get the address out of the phone book, but they also can now get the FDA number right off the prescription vial.

So this is a technical amendment, and I would like to ask the members' support for this in an attempt to cut down on counterfeiting of illegal drugs, Mr. Speaker. Thank you.

Mr. ITKIN. Mr. Speaker, I move that the House insist upon its amendments nonconcurred in by the Senate to SB 1 and that a committee of conference on the part of the House be appointed.

Mr. Speaker, I rise to oppose Representative Itkin's motion. In my estimation, this body should recede from House amendments.

This legislation, in my judgment, does nothing to make Pennsylvania competitive with other Northeastern States. It does nothing to reduce the cost of workers' compensation insurance but rather, in my estimation, increases those costs to Pennsylvania's employers. This would be catastrophic, in my view, to Pennsylvania's ability to attract new business and industry and to retain existing businesses.

Incidentally, for the information of the House, the Senate in their vote the other day had the lowest number of Senators supporting this legislation in all the time that we have considered workers' compensation. The number was 15. There were 32 Senators that voted against the legislation as we have now.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Somerset County, Mr. Lloyd. Mr. LLOYD. Mr. Speaker, I rise to support the majority leader's motion.

Members should be aware of the effect of receding from the House amendments. Receding from the House amendments would be to go back to the version of the bill exactly as it came from the Senate. If members recall the discussion we had on the Ryan motion to revert, there is language in the Senate bill which attempts to roll back rates to reflect the savings. That language makes reference to an incorrect citation of the opinion from last fall, and if that legislation were sent to the Governor, the effect would be that there would be no requirement for a rollback in rates.

Mr. Speaker, the way to solve this problem is to put it into a conference committee, in which we can fashion a compromise between the two versions. We have moved much, much closer over the last year. There is momentum to get this done. The only way to get that done is to go to a conference committee, and the only way to go to a conference committee is to support the majority leader's motion.

Mr. Speaker, I would ask for a "yes" vote.
