### **BILL ON THIRD CONSIDERATION**

The House proceeded to third consideration of **HB 919**, **PN 996**, entitled:

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, further providing for revocation and suspension of licenses.

On the question,

Will the House agree to the bill on third consideration?

Mr. CORRIGAN offered the following amendments No. A1442:

Amend Title, page 1, line 16, by inserting after "laws,"" reducing the amount of gross sales of food for Sunday sales permit; and

Amend Bill, page 1, lines 20 through 22, by striking out all of said lines and inserting

Section 1. Section 406(a)(3) of the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, reenacted and amended June 29, 1987 (P.L.32, No.14), is amended to read:

Section 406. Sales by Liquor Licensees; Restrictions.-(a)

(3) Hotel and restaurant liquor licensees, airport restaurant liquor licensees, municipal golf course restaurant liquor licensees and privately-owned public golf course restaurant licensees whose sales of food and nonalcoholic beverages are equal to [forty] twenty per centum or more of the combined gross sales of both food and alcoholic beverages may sell liquor and malt or brewed beverages on Sunday between the hours of eleven o'clock antemeridian and two o'clock antemeridian Monday upon purchase of a special annual permit from the board at a fee [of two hundred dollars (\$200.00)] per year as prescribed by law, which shall be in addition to any other license fees.

\* \* \*

Section 2. Section 471(a) of the act is amended to read: Amend Bill, page 2, line 18, by striking out all of said line and inserting

Section 3. This act shall take effect as follows:

- (1) The amendment of section 406(a)(3) of the act shall take effect immediately.
- (2) The remainder of this act shall take effect in 60 days.

On the question,

Will the House agree to the amendments?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Corrigan.

Mr. CORRIGAN. Thank you, Mr. Speaker.

Mr. Speaker, the amendment that I offer to HB 919 is an amendment that affects 18,000 small business people in Pennsylvania. This amendment is not intended to sell more liquor. This amendment intends to bring our small business people into compliance with the law.

In the past 20 years, the price of alcohol has risen approximately 50 percent, whereas the price of food has risen about 20 percent, thereby creating a difference for our small businessmen in their retail sales.

I want to make sure that the members of the House understand this amendment is not designed to sell more booze. This amendment is an amendment that benefits small business people in the Commonwealth of Pennsylvania, and I would certainly appreciate the support of the House. Thank you.

The SPEAKER. The Chair thanks the gentleman.

Does the gentleman, Mr. Carn, wish to be recognized? The gentleman, Mr. Carn, is recognized.

Mr. CARN. Thank you, Mr. Speaker.

I rise to oppose this amendment.

One of the things that we have to realize when we consider this amendment is that we are saying that we want more liquor establishments open on Sundays. I know in the city of Philadelphia, we have more problems with liquor licenses now and we do not need more open on Sundays, because that is what this amendment effectively does. It allows more liquor-license establishments to be open on Sundays because we are reducing the requirement of their food sales. We are actually saying that they can sell more alcohol through more establishments.

So I just want to take note of this; I want the House to take note of this and give it some serious consideration. I just ask for a negative vote on this amendment.

The SPEAKER. The Chair thanks the gentleman.

Mr. Clymer is recognized for debate on the Corrigan amendment.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, I support the comments of my colleague who just mentioned that indeed this amendment would allow more establishments to be open and to sell alcohol.

Now, we recognize that alcohol is the number one drug substance abuse in Pennsylvania, so it just does not make sense what we are doing here today with this amendment. It seems to me that we should be moving in the other direction.

Mr. Speaker, we have passed on different occasions legislation here in the General Assembly to cite those who drink while driving, and we have also had tough legislation for young people as well dealing with the issue of alcoholism, and so this amendment seems counterproductive to what historically this General Assembly has done to try to save lives on the highway, to help society with the problem of alcoholism.

So I, too, rise in opposition to this amendment. Thank you. The SPEAKER. The gentleman, Mr. Preston, is recognized. Mr. PRESTON. Thank you, Mr. Speaker.

I rise in opposition to this particular amendment. I do this also on behalf of the nuisance bar task force for the city of Pittsburgh in relationship to the police, the many different neighborhood groups – for us to be able to give somebody for \$100 or \$300 an extra day of operation; to be able to increase the consumption of alcohol; to be able to give them the extra right to be able to open up on a Sunday.

I can remember too long ago when we gave certain other individuals the opportunity to be able to open up on Sunday, and that is where we mistakenly opened up the law for a short time for gambling. I am just very concerned that we are going to continuously give the establishments— Let us let people respect the family; let us let churches operate on a Sunday; let us let people be openly working with the community; and let us oppose this particular amendment.

It is unfortunate we are trying to do this. This is not a revenue enhancer. All it is going to do is, it is going to cost the taxpayers in the Commonwealth in the long run. It is going to increase, if you look in my city, in the city of Pittsburgh, the respective number of police calls from our local police agencies. We also in Allegheny County have respective communities that do not even have a police force, that are literally depending on the State Police and other private

contractors. There are some communities that have nuisance bars that have had numerous problems, and the police there are even being paid minimum wage. There are an awful lot of distressed communities themselves that do not want to see bars open up on Sunday. It is too much of a burden on the community.

I would respectfully request that we oppose this amendment, and let us be able to do the responsible thing and give families 1 day off.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Bucks County, Mr. Matthew Wright.

Mr. M. N. WRIGHT. Mr. Speaker, I rise in support of the amendment.

I heard comments earlier about expanding the availability of alcohol would increase the drinking. I disagree with that. I believe right now in most of our communities, if somebody wants to have a drink on a Sunday, they will find a bar. There are many bars that are open on Sundays.

I disagree that by giving the opportunity for some of the borderline taverns that might try to cook their books a little bit to stay open, and there was also a comment about not a revenue enhancement. Some of these operations are cooking their books in such a way to make it look like they are selling more food, which we are not collecting the tax on. Some of these operations now legitimately might be able to stay open longer and be open on Sundays, and therefore, we will be able to capitalize on some of that revenue.

I rise in support of this amendment. I think it is a good amendment. I think a lot of these bars that are open that should not be and under the current law that are operating properly would give them the lawful right to be open, and I support this amendment.

The SPEAKER. The gentleman from Philadelphia, Mr. Acosta, is recognized.

Mr. ACOSTA. Thank you, Mr. Speaker.

The previous speaker just had a trip to Philadelphia this past week. I should have shown you some of the bars that we have in my district. If you would have seen some of those bars, you would agree with me that we have to vote against this amendment. If anything, we have more crime and more problems from those bars, I am sure throughout the State, but in my district in particular, we have a lot of problems that we would like to take care of.

I would ask my colleagues to vote against this amendment. We have a lot of problems, and I do not think that keeping the bars open is going to solve them. Thank you.

The SPEAKER. The gentleman from Luzerne County, Mr. Jarolin, is recognized.

Mr. JAROLIN. Thank you, Mr. Speaker.

Mr. Speaker, I have heard some of the statements here against this amendment, and I really think that they are not addressing the situation in the right way.

Whether this amendment passes or not, there is still going to be the same amount of bars that are open. We are not going to decrease the bars. However, the tavern owners that are in the business right now are finding extreme difficulties with the requirement of the 40 percent of food. I have seen a variation in food purchases between 20 and 40 percent and costing the guy a license and causing the people that own the bars quite a bit of problems.

What I would like to see is this amendment decreasing it to 20 percent per annum, and I certainly hope my associates on this floor vote for it. Thank you.

The SPEAKER. The gentleman, Mr. Corrigan, from Bucks County for the second time on the Corrigan amendment.

Mr. CORRIGAN. Thank you, Mr. Speaker.

Mr. Speaker, I am of the opinion that an awful lot of people sitting here today do not understand exactly what we are talking about. I think some of the speakers that we have heard, I know that they are all well meaning, but I think they have some bad information.

If we go on the premise today that all tavern owners own nuisance bars, then I would withdraw this amendment. The fact of the matter is that tavern owners for the most part—and there are 18,000 of them in Pennsylvania—are good, hard-working, honest, small business people. They employ an average of four to six to seven people in their establishment, and they are credible people that are a credit to their community.

I want to talk just for a minute, Mr. Speaker, about the history of this bill. This bill has been introduced in two consecutive sessions. When I originally introduced this bill, I excluded, and I want everybody to hear this—

The SPEAKER. The gentleman is correct. This is a sensitive subject to many of our members, and the House should respond by giving its attention to the speaker.

The gentleman may proceed.

Mr. CORRIGAN. The thing that I would like to make most clear is when this bill was originally introduced by me, it excluded cities of the first class and cities of the second class. This bill went to the Liquor Committee 2 years ago. Those Representatives from the city of the first class insisted that cities of the first class go back into the bill; those people from cities of the second class insisted that cities of the second class go back into the bill, and that is the way the bill is at this moment. So I would also say that most of the members here have voted for this bill.

What we are laying on the small business people in this category is that they all run nuisance bars. I very seriously doubt that the taverns that we are talking about that my good friend, Representative Acosta, speaks of, I seriously doubt whether they sell any food there, and most of these nuisance bars do not sell food. We are talking about people who have a menu, have a restaurant, have employees, and they sell food, and they are now in a situation where they are in noncompliance with the law because the price of alcohol has far outstripped the price of food. That is the kind of a situation we are talking about.

If I thought we were going to sell more booze, I would withdraw this amendment. If I thought that this was going to cause more people to open on Sunday, I would withdraw this amendment. The fact of the matter is, some of the people that

are open on Sunday do not have any license at all. Some of them are under suspension.

I want to call to the members' attention, if I could, a letter that I received just recently from the Liquor Control Board. It is dated May 14, and what this letter said is, in effect—and I will not read it to you; I assume everybody has it—if you have a nuisance bar in your district, the Liquor Control Board has solicited your support. The Liquor Control Board sent you a letter and said if you have a nuisance bar, tell us where they are and we will not renew their license. So the system is working. The board is not renewing licenses.

This is a good amendment. It is an amendment designed to help small business people. It just happens that these small business people are in the business of selling food and liquor, and they deserve the same consideration as any other business in Pennsylvania.

Mr. Speaker, I ask for a "yes" vote on this amendment. Thank you.

The SPEAKER. The gentleman, Mr. Acosta, for the second time.

Mr. ACOSTA. Mr. Speaker, if I could ask some questions to the previous speaker.

The SPEAKER. The gentleman indicates he will stand for interrogation. Mr. Acosta, you may proceed.

Mr. ACOSTA. Mr. Speaker, this amendment is only for second-class cities. Does that include first-class cities?

Mr. CORRIGAN. The amendment as drafted is the same as the bill that was drafted last session. That includes cities of the first class and second class at the insistence of the members of this body who represent first- and second-class cities.

Mr. ACOSTA. My problem is in first-class cities. I do not think that your amendment is going to help any, specifically areas like mine in my district, where the Liquor Control Enforcement at public hearings several times have said that they do not have enough manpower to control the problems that we have in our cities, in the first-class cities, Philadelphia for one. So if you say that this bill is okay because in Bristol, PA, or some other parts of the State you do not have the kind of problems that we have in our districts, then this bill has got to be redrafted and make it only for second-class cities.

Mr. CORRIGAN. Thank you.

The bill has been redrafted at the insistence of the people that I described.

What I think we are not considering here is that the small business people we are talking about do not own nuisance bars. They are small business people. The people I think that you are talking about own nuisance bars, and I am very sensitive to that problem. I sat on the committee for 3 years now.

I originally drafted the bill to exclude Philadelphia. The members from Philadelphia said, put Philadelphia back in. I do not know how we do that.

Mr. ACOSTA. I happen to be a member of Liquor Control, and I was never asked and never told that you changed over the bill to include first-class cities. You know, I have been having a fight here for the last 9 years against nuisance bars, and every one that I have within my district is a nuisance bar.

Mr. CORRIGAN. Let me just respond this way, Mr. Speaker: This bill in the last session was amended in the Liquor Committee by members from the first-class city. I voted "no." I wanted to exclude Philadelphia, I wanted to exclude Pittsburgh, because I am sensitive to the problems that they have.

The bill is the way it is now because— I already described why it is the way it is now.

Mr. ACOSTA. Mr. Speaker, if possible, I would like to get this bill postponed until I get members of the Liquor Control Committee to come down into my city, my district, and take a look, take a firsthand look, as to what I am trying to describe here. I believe it is unfair for the residents and the people in my district and people of many other districts to have this amendment passed when we have a tremendous amount of problems with the bars in the city of Philadelphia. Probably not the whole city of Philadelphia but some of the members from different districts, we have a lot of problems that are not controlled, and the Liquor Control Enforcement is saying to us, we do not have the manpower to fight the problem.

Mr. CORRIGAN. Thank you.

Mr. Speaker, the establishments that I am talking about for the most part, and I would say overwhelmingly, do not need liquor enforcement agents. They do not need those people in their place. They do not have complaints. They do not need people to come in there and arrest anybody. They are trying to sell food and make a living.

Mr. ACOSTA. So we are saying that then the amendment should go only for second-class cities.

Mr. CORRIGAN. I think maybe at a later date if you want to do something like that-

Mr. ACOSTA. I am sorry; I said it wrong.

The amendment should go only for second-class cities.

Mr. CORRIGAN. I tried it that way. It did not work. I told you that.

# BILL PLACED ON THIRD CONSIDERATION POSTPONED CALENDAR

Mr. ACOSTA. Mr. Speaker, I want to make a motion to postpone this amendment. I think we should have a second look in the districts that we are talking about in Philadelphia – my district, Andrew Carn's district, Curtis Thomas' district, and a whole group of us. Marie Lederer's district is just as bad. So we have five or six districts here that are having similar problems.

The SPEAKER. Since it is not in order to postpone only the amendment, the gentleman must make a motion that the bill be put on the third consideration postponed calendar.

Mr. ACOSTA. Mr. Speaker, I make a motion to postpone the bill.

The SPEAKER. The Chair thanks the gentleman.

The membership should be aware that a motion has been made to put the bill on the third consideration postponed calendar.

On the question,

Will the House agree to the motion?

The SPEAKER. There are opportunities for debate.

The gentleman, Mr. Corrigan, is recognized on the motion to postpone the bill.

Mr. CORRIGAN. Thank you, Mr. Speaker.

Mr. Speaker, I have to ask for a "no" vote on the motion to postpone. This bill has been around for— This is the second session, as I said before. Let us address the issue. I think now everybody understands what we are dealing with and why we are dealing with it.

The motion to postpone has to do with the first- and second-class cities. If in the future they would like to offer a bill or an amendment to a bill to do what they would like to do, I will support that amendment. I have already done it when I originally drafted this bill.

The people that I am trying to represent here today need this amendment. They need this kind of legislation so that they are no longer in noncompliance with the liquor laws.

I ask for a "no" vote on the motion to postpone. Thank you.

The SPEAKER. The gentleman, Mr. Snyder, is recognized. Mr. SNYDER. Thank you, Mr. Speaker.

Mr. Speaker, I speak in favor of postponement of HB 919. The Corrigan amendment is scheduled for consideration as a bill. Mr. Corrigan's bill is scheduled for consideration by the Liquor Control Committee at a meeting tomorrow morning.

As the members of the floor know, if there are to be amendments to this issue, it is very difficult to amend an amendment, particularly under the current House rules, and there are members of both caucuses who have some concern about this issue that would like to have the opportunity to review it in committee tomorrow morning, for which this bill

We ask, Mr. Speaker, for support of postponement. If the committee action is such that the bill would be reported out intact, we can certainly move HB 919 tomorrow with the amendment or we can take other action depending on how the committee's recommendation results.

will be considered.

Therefore, Mr. Speaker, we are not asking for undue delay for HB 919. We are just asking that it be postponed for a day so that we can have an opportunity to discuss this issue not in the heat of floor debate but through consideration by the committee and working with the sponsor of the amendment. Thank you, Mr. Speaker.

The SPEAKER. The gentleman from Allegheny County, Mr. Preston, is recognized.

Mr. PRESTON. Thank you, Mr. Speaker.

I also rise that we vote "yes" on the postponement.

#### POINT OF ORDER

Mr. CORRIGAN. Could I have a point of order, Mr. Speaker?

The SPEAKER. The gentleman, Mr. Corrigan, asks for a point of order. The gentleman may state his point.

Mr. CORRIGAN. Mr. Speaker, the last speaker talked about recommittal. We are talking about postponement to no future date. We are not talking about recommittal. We are talking about the motion to postpone.

The SPEAKER. The gentleman's point is well taken.

Mr. PRESTON. I would ask for us to postpone this.

It is obvious that because of the knowledge of some members who felt that we had to change our process, those of us who are being caught up with this particular amendment do not have time under our current rules to be able to prepare the appropriate amendments to try to reverse this action should it pass.

If we do not do this, then basically what we will be doing is encouraging the sale of alcohol on Sunday. I am concerned that people need to have a chance to be able to think this very rationally and very effectively. This should be handled within the committee process, and being that we have a chance to be able to do this tomorrow, I would ask for us to vote in the affirmative to postpone this.

The SPEAKER. The gentleman, Mr. Kenney, is recognized. Mr. KENNEY. Thank you, Mr. Speaker.

Mr. Speaker, can I ask Representative Corrigan a question? He made a comment that I did not hear prior to Mr. Preston speaking, and I was wondering if he is for postponement or against postponement at this time.

The SPEAKER. The gentleman, Mr. Corrigan, is against postponement.

Mr. CORRIGAN. That is correct.

Mr. KENNEY. Mr. Speaker, if I may make a comment.

The SPEAKER. The gentleman is recognized and may proceed.

Mr. KENNEY. Mr. Speaker, I rise to support Mr. Corrigan in asking for a "no" vote in postponing his amendment and this legislation.

As a Philadelphia legislator, I am well aware of the arguments made by Mr. Acosta and Mr. Carn and a number of members from Philadelphia about nuisance bars. I also have nuisance bars in my district of Philadelphia, but they are in the minority and they should not drive the legislation today that says because 3 out of 30 are bad, we should penalize the other 27 bars. That is what we are saying today. We are saying to the legitimate bar owners that, no, we are going to penalize you and hold you back because of the bad guys.

I agree that nuisance bars must be shut down. The Liquor Code enforcement agents must do their job, and we need more of them to do their job. But that should not say today that because we have a few from Philadelphia rising to say they have nuisance bars, which I also have, but the majority of my bar owners are hard-working, honest, small business people, and they should be included in this legislation.

I rise against postponement and in support of the Corrigan amendment. Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Roebuck, from Philadelphia is recognized.

Mr. ROEBUCK. Thank you, Mr. Speaker.

I rise in support of postponing this legislation.

For the very reasons in part that Mr. Corrigan and others have stated, the reality is that there is nothing in this amendment or in the bill that attacks the basic problem that many of us face in our district, and that is that you have bars, albeit a minority, that are problems. There is nothing in this bill that attacks that, and there is nothing that deals with the specific issue. There is a lack of clarity in the basic legislation. That needs to be clarified. There is nothing wrong with seeking to clarify the impact on first-class cities, second-class cities. That can be done by holding this bill over and discussing it at some greater length.

There is no rush here; there is no urgency about having to do this today. It is clear we are going to take it up in the Liquor Control Committee tomorrow. We can come back on Wednesday with a bill that makes sense. This clearly does not make sense. It does not make sense because it does not attack the basic problems; it does not deal with the kinds of flaws inherent in the law as it presently exists; it does not address the problems of how you respond to those problems. I fail to understand why this absolutely is something that cannot be discussed at greater length in committee and with the assurance that it comes back to us in a form that is acceptable, that is reasonable, and that works. Thank you, Mr. Speaker.

The SPEAKER. Does the gentleman, Mr. Gigliotti, seek recognition?

Mr. GIGLIOTTI. Thank you, Mr. Speaker. Yes, I do.

Mr. Speaker, I rise to support the postponement of this bill because we are going to work this problem out in tomorrow's Liquor Control Board meeting. This is something that all parties have an interest in I am asking everybody to vote to postpone.

The SPEAKER. The Chair thanks the gentleman.
