The SPEAKER. Does the gentleman request recognition at this point? The Chair recognizes Mr. Pitts.

Mr. PIITS. Mr. Speaker, I am trying to ask the Speaker, since this was not on our calendar, what the issue is. Was that my amendment that we just voted to reconsider?

The SPEAKER. The Chair would request that the gentleman either have a sidebar with the majority leader or interrogate the majority leader.

PARLIAMENTARY INQUIRY

The SPEAKER. For what reason does the gentleman, Mr. Nailor, from Cumberland County rise?

Mr. NAILOR. A parliamentary inquiry, Mr. Speaker.

The SPEAKER. The gentleman is in order and may proceed.

Mr. NAILOR. Mr. Speaker, when we recently voted to reconsider HB 294, was that the first time the General Assembly, the House of Representatives, voted to reconsider that bill, or did we vote to reconsider that on June 23?

The SPEAKER. Yes.

Mr. NAILOR. That was the first time?

The SPEAKER. Yes.

Mr. NAILOR. And just for my understanding, Mr. Speaker, the reason it was not passed on to the Senate is because someone filed a motion to reconsider, but we did not see that motion to reconsider and did not reconsider. Is that correct?

The SPEAKER. That is correct, but under normal circumstances, the motions to reconsider are not distributed to the entire membership as an administrative matter.

Mr. NAILOR. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

BILL PLACED ON THIRD CONSIDERATION POSTPONED CALENDAR

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Mr. Itkin.

Mr. ITKIN. Mr. Speaker, I move that HB 294 be placed upon the postponed calendar.

On the question,

Will the House agree to the motion?

Motion was agreed to.

PARLIAMENTARY INQUIRY

The SPEAKER. Does the gentleman, Mr. Fairchild, seek recognition?

Mr. FAIRCHILD. Thank you, Mr. Speaker.

A point of parliamentary inquiry.

The SPEAKER. The gentleman may state his point.

Mr. FAIRCHILD. For the benefit of the membership, are there any other bills that were passed by this House that have not been sent over to the Senate?

The SPEAKER. No.

Mr. FAIRCHILD. Thank you.

The SPEAKER. The gentleman is welcome.

Mr. Saurman from Montgomery County is recognized.

Mr. SAURMAN. Thank you, Mr. Speaker.

Just a point of clarification. The motion was just made to put HB 294 back on the postponed calendar. Did that include the amendment that was also under reconsideration?

The SPEAKER. If the gentleman, Mr. Pitts, seeks to offer the amendment, the amendment will be available for him to offer

Mr. SAURMAN. At that time?

The SPEAKER. That is correct.

Mr. SAURMAN. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

GUESTS INTRODUCED

The SPEAKER. The Chair would like to welcome to the hall of the House guests of Representative Gaynor Cawley and guests of Representative Fred Belardi – to our left the city controller of the city of Scranton, the Honorable Roseann Novembrino, and Rose Marie Pizano. Would they please rise and be recognized.

MOTION TO SUSPEND RULES

The SPEAKER. For what purpose does the gentleman, Mr. Strittmatter, rise?

Mr. STRITIMATTER. Thank you, Mr. Speaker.

I rise, as requested by you yesterday when I asked the question-

The SPEAKER. Will the gentleman yield momentarily.

The gentleman, Mr. Strittmatter, is going to share with the membership an issue that should be monitored by each member.

The gentleman, Mr. Strittmatter, may proceed.

Mr. STRITTMATTER. Thank you, Mr. Speaker.

When I asked the Speaker yesterday, it was suggested that I prepare a resolution to address the issue I had raised that when the Senate meets this week, should renovations of the Senate chamber prevent the use of the Senate chamber, I asked that the Senate be allowed to use the House chamber to conduct business when we are in recess, caucus, or have adjourned for the day.

I have, with the help of our legal staff and with the help of the Reference Bureau, drafted such a resolution: Directing the Speaker of the House...to make the Chamber...available to the Senate.

WHEREAS, The Chamber of the Senate is undergoing major renovation and is not in suitable condition for the conduct of legislative business for the immediately foreseeable future; and

WHEREAS, It is in the vital interests of the people of this Commonwealth that the General Assembly be in a position to act on such pressing issues as health care reform, welfare reform and job creation at this time; therefore be it

RESOLVED, That the House...direct the Speaker...to make the Chamber...available to the Senate for the conduct of its legislative business upon a written request signed by a majority of the members elected to the Senate when such use does not conflict with the schedule of the House of Representatives.

I had this resolution prepared for the House to consider today and hopefully to adopt. I believe that our chamber has been made available to such worthy causes as model legislatures, as the Electoral College, as well as other joint sessions.

So I would move at this time, Mr. Speaker, that the rules of the House be suspended so that we can consider this resolution immediately and make the Senate know that our House chambers are available to them. So I would move to suspend the rules. Thank you.

On the question,

Will the House agree to the motion?

The SPEAKER. This item is not debatable unless the majority leader or his designee is anxious to debate the suspension of the rules.

The Chair recognizes the gentleman, Mr. Itkin.

Mr. ITKIN. Mr. Speaker, it is my feeling that while Representative Strittmatter's resolution deserves consideration, it ought not be in extraordinary form to be considered at this time. All resolutions, normally as a course, according to our rules, are referred to the Rules Committee for subsequent review and action by that committee. I see nothing at this time that compels the House to act expeditiously on this issue. It would seem to me that we could accomplish the same aim by having the resolution go through the normal course, to the Rules Committee, and the Rules Committee will ultimately decide whether this resolution should be reported to the floor for final action by the House.

Consequently, I would ask that my members of the House support the traditional rules, the rules upon which we have agreed to adhere to in this session, and reject the Strittmatter request.

The SPEAKER. The Republican leader, Mr. Ryan, is recognized.

Mr. RYAN. Mr. Speaker, when the gentleman, Mr. Itkin, began his debate, the first 6, 8, 10 sentences of that debate I was nodding yes; I was agreeing with him. I wondered why we needed such a resolution as this myself, and if he had quit

about 10 sentences into his remarks, I think I was prepared to get up and go against this resolution on its merits. However, Mr. Itkin continued and said that this is the type resolution that should go to Rules. Well, that is ridiculous, and everyone on the floor of this House knows it is ridiculous.

I just asked the Chief Reporter to make sure that I get a copy of his remarks today so that this afternoon or an hour from now when some half a dozen of us go to Mr. Itkin or come to me and say, I have a resolution; I have to get it passed; it is for Milkmaid Day, and I want to suspend the rules to have today declared Milkmaid Day; will you agree to it, and I agree to it and he agrees to it, and we declare a Milkmaid Day or we make some other resolution important enough to suspend the rules, I can read back these remarks that this important thing should go through the Rules Committee.

Now, the reason I was going to agree with his earlier remarks is this: I believe-and I am going to end this up, Mr. Speaker; I would like you to pay attention to me or at least have the Parliamentarian pay attention if you do not care to-I do not think this resolution is necessary. My recollection and the recollection of at least one former Speaker is that we did this and we do this on our own as Speaker of the House; that you, Mr. Speaker, have the right and have exercised that right, I am guessing, without the need for a resolution, is what I am talking about, as a matter of courtesy to say to a group of citizens, do you want to use; we are not going to be in session on Friday. A school group wants to use our chambers for whatever reason, a civic reason of some sort. I would be amazed if Representative Bill DeWeese, Speaker of the Pennsylvania House, said, ah, I would love to do it, but I need a resolution of the House to do it. You would not do that, and I know you would not do that. You would say, do it, particularly if you are from my county, and I would be disappointed if you did otherwise. I did it. Mr. O'Donnell did it. Speakers of the House for 100 years have done it.

Now, the Parliamentarian is going to show where we were out of order. I can tell by the look on his face. But the fact remains, we have always done it. We have done it with the Pennsylvania Junior Chamber. We have done it with other youth groups.

PARLIAMENTARY INQUIRY

Mr. RYAN. Now as a question of parliamentary inquiry, Mr. Speaker, I ask you, am I right, or has the Parliamentarian found that I have been preaching against our own rules?

The SPEAKER. The major differential that the Parliamentarian did not point out but that comes to my own mind is that the State JC's and other young Pennsylvanians that have requested the use of the hall of the House and have been granted the hall of the House have simply asked the Speaker for permission to come to the chamber. The State Senate has not asked us to come here, so at this point the question is moot.

Mr. RYAN. Mr. Speaker, may I ask the question? The SPEAKER. The gentleman is recognized.

LEGISLATIVE JOURNAL — HOUSE

Mr. RYAN. If a majority of the State Senate asked for the use of these chambers, what would the Speaker say, for the benefit of the press and the traveling public?

The SPEAKER. The Speaker's interpretation would be that the request should come from the President of the Senate, not a rump group of the Senate.

Mr. RYAN. I think we better vote the resolution,

The SPEAKER. On the motion to suspend, the motion is not debatable except by the floor leaders. The members will proceed to vote.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Mr. Olasz.

Mr. OLASZ. Mr. Speaker, I have remarks prepared for HB 1898, which I will submit to the clerk for the record. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The gentleman will please refer his remarks immediately to the clerk.

Mr. OLASZ submitted the following remarks for the Legislative Journal:

HB 1898 would renew the Abandoned Mine Assistance Act through October 31, 1998.

Five years ago I sponsored this legislation to create a loan and grant program for people whose homes have been destroyed by mine subsidence for which they had no insurance coverage.

In addition, this program paid for legal notices which are published in area newspapers informing residents of nearby subsidence incidents and encouraging them to buy mine subsidence insurance.

The mine subsidence insurance program is one of the best deals State government offers. For \$88.50 a year, a homeowner can get \$100,000 in coverage, coverage that private insurance companies will not provide.

The problem is, not enough people have purchased the insurance. This program helps publicize the insurance program and is the only fund authorized to do so. If this act is not renewed, DER will not have the ability to publish subsidence notices in newspapers, and homeowners will not be made aware of the importance of purchasing the insurance.

A total of 633 subsidence incident reports have been published in the last 5 years, an indication of just how widespread this problem is.

Over a 5-year period, three low-interest loans have been approved and five more are pending. Three grants totaling \$9,907 have also been awarded. The grants only cover relocation costs for people who must move when their homes become uninhabitable due to subsidence.

Of the original \$500,000 earmarked for this program, over \$92,000 remains. HB 1898 does not contain an additional appropriation for this program, but rather would use the unexpended funds available.

I request your support for this bill that has been a godsend for those people whose homes have been destroyed in a matter of minutes due to the collapse of an abandoned underground coal mine.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair recognizes Mr. Staback. Mr. STABACK. Mr. Speaker, I have remarks to be submitted for the record.

Mr. STABACK submitted the following remarks for the Legislative Journal:

I rise to support this measure because of the assistance it has provided homeowners in our State's anthracite coal region.

Without this program, my constituents who do not have mine subsidence insurance would be left high and dry if their homes were destroyed by the collapse of an underground abandoned coal mine

While we can all agree that homeowners should protect their properties by buying mine subsidence insurance, the fact of the matter is not all homeowners at risk are aware of the problem.

Fortunately, in the anthracite region, homeowners are better covered by the insurance because many lending institutions require it for a mortgage. But in the bituminous region, lending institutions generally do not require the insurance and too many people are not aware of the potential problem they face.

Because more homeowners are covered in the northeastern part of our State, only one of the loans and one of the grants were awarded in that region. Of the 633 subsidence incidents which have been published in Pennsylvania, 192 were in the anthracite region in the last 5 years.

This is a worthy program – a program that has helped people who were otherwise unaware that a potential problem existed from a coal mine that was abandoned 100 years ago. The \$92,534 that remains in the fund should continue to be used for these purposes, and I encourage you to vote for this important bill that would continue the program another 5 years.
