HARRISBURG POLICE OFFICERS PRESENTED

The SPEAKER. From time to time we have all had the opportunity to be involved with members of our police forces in our local constituencies. The Chair takes high esteem in presenting one of our colleagues, Ron Buxton, to present a citation to police officers whose behavior went far beyond the call of duty.

The Chair recognizes the gentleman from Dauphin County. Mr. BUXTON. Thank you, Mr. Speaker.

Mr. Speaker, pursuant to the adoption of HR 157 back in October, it is my honor today to introduce two members to the House of Representatives of the Harrisburg Police Bureau, who were wounded in the line of duty, Investigator Linda Lewis and Investigator Richard Curtis.

They are joined today by members of their family. I would like to point out in the visitors' gallery Carolyn Curtis, Richard's mother; his wife, Tama Curtis; and their son, Dax. Would you please rise. Joining Officer Lewis is her sister, Jonnie Dean.

With me to my left is the chief of police of the Harrisburg Police Bureau, Richard Shaffer; and to my right the commanding officer in the unit to which Officers Lewis and Curtis are attached, Capt. Greg King.

Mr. Speaker, on March 5, 1993, Investigator Lewis and her partner, Investigator Curtis, were critically wounded while

investigating the disappearance of a Harrisburg woman. Upon discovery of the victim's body in the suspect's home, the suspect shot Investigator Lewis and Investigator Curtis.

These two individuals, along with every law enforcement officer, place their lives on the line for us daily for the citizens of our community, and too often they do not receive the recognition deserving of their duty, sacrifice, and courage.

Please join me in paying special tribute to Officers Linda Lewis and Richard Curtis in presenting each with a House citation recognizing their valiant actions and commitment to serve, protect, and preserve the health and safety and wellbeing of their fellow man. Thank you.

Picture a beautifully decorated mall with every store advertising its finest gifts. Crowds of people are in search of that one special gift for a loved one. In the midst of the hustle and bustle is a petite girl cheerfully playing a keyboard. Beside her sits a pail with a sign in front of it that says, "I'm not the best player but I'm playing from my heart. Won't you give to the Children's Home of York and do your part?"

From the mall let us go to the Children's Home of York. This facility offers children from a seven-county region a haven, a place to get off the streets. The home is a shelter for teenagers with no place to turn because they come from broken families or homes in turmoil.

The House proceeded to third consideration of **HB 1244**, **PN 1361**, entitled:

An Act amending the act of May 9, 1949 (P.L.908, No.250), entitled "An act relating to public records of political subdivisions other than cities and counties of the first class; authorizing the recording and copying of documents, plats, papers and instruments of writing by photostatic, photographic, microfilm or other mechanical process, and the admissibility thereof and enlargements thereof in evidence; providing for the storage of duplicates and sale of microfilm copies of official records and for the destruction of other records deemed valueless; and providing for the services of the Department of Property and Supplies to political subdivisions," further providing for additional methods for the copying of certain records.

On the question,

Will the House agree to the bill on third consideration?

Mr. MERRY offered the following amendments No. A4280:

Amend Title, page 1, line 12, by striking out "additional" Amend Title, page 1, line 13, by removing the period after "records" and inserting

, for identification of records, for duplicates of records, for the

sale of certain records, for the destruction or disposal of certain records, for records requiring special care and for Commonwealth services to political subdivisions.

Amend Sec. 1, page 1, line 16, by striking out "Section 1" where it appears the second time and inserting

Sections 1 and 3

Amend Sec. 1, page 2, line 4, by striking out "is" and inserting

Amend Bill, page 3, by inserting between lines 5 and 6 Section 3. [Each roll of microfilm bearing official copies of records shall begin with a separate photographic image showing on a title target the name and location of the office holding the records copied, the name and title of the officer having custody of the records at the date of copying, a brief, but clear, title for the particular series of records copied, and such volume, numbers, inclusive dates and serial numbers as shall make identification of the records filmed clear and positive. Each roll shall end with a separate photographic image repeating in substance the information given on the title target, together with the signature of the camera operator appended to a certificate which shall state the day, month and year on which the records were copied and affirm that the copying was performed in accordance with procedures prescribed by the custodian.] Roll and unitized microfilms and imaged records shall be adequately identified in conformance with standards, policies and procedures approved by the County and Local Government Records Committees. It shall be the responsibility of the custodian of the records copied to regulate and supervise the copying process and to inspect the resulting microcopies and imaged records so as to satisfy [himself] the custodian that all copies are complete, accurate and clearly legible. When any enlarged reproduction of a negative or positive film is to be used as evidence, the reproduction shall contain, or have attached thereto, the signed and sealed attestation of the officer having the official custody of the negative or positive film that the same is a true and correct copy thereof.

Section 2. Sections 4 and 5 of the act are repealed.

Section 3. Section 6 of the act is amended to read:

Section 6. Records which have been reproduced or copied in accordance with section one of this act or other records which are deemed valueless may be destroyed or otherwise disposed of[, subject to the approval of the court of common pleas of the proper county. The records of the register of wills and of the clerk of the orphans' court which have been so reproduced or which are deemed valueless may be destroyed or disposed of, subject to the approval of the orphans' court of the proper county in accordance with applicable legislation and regulations or schedules and procedures relating to the destruction of public records approved by the County and Local Government Records Committees.

Section 4. Sections 6.1, 6.2 and 7 of the act are repealed. Section 5. Section 8 of the act is amended to read:

Section 8. The [Secretary of Property and Supplies] executive director of the Pennsylvania Historical and Museum Commission may, at [his] the executive director's discretion, make available the services of the [Department of Property and Supplies] Pennsylvania Historical and Museum Commission to political subdivisions of the Commonwealth for the purpose of photographing or imaging public records upon such terms and conditions as [he] the executive director may prescribe, which terms shall provide for the payment to, and reimbursement of, the Commonwealth for the reasonable cost of such services. [Any money payable to the Department of Property and Supplies by way of reimbursement shall be paid into the General Fund in the State Treasury through the Department of Revenue and credited to the appropriation from which the expense incurred by the Department of Property and Supplies was met.]

Amend Sec. 2, page 3, line 6, by striking out "2" and inserting

And carry on she has. With her charm, her energy, and her genuine love for her city and its people, Sophie put a human face on one town's struggle to gain a firm foothold in the shifting sands of today's economy. Just like the city of Pittsburgh, she is unique, and her time as mayor will be fondly remembered for many years to come.

Today I have the honor, the privilege, of presenting Mayor Masloff with a citation recognizing her contributions to the city of Pittsburgh and the Commonwealth of Pennsylvania. Frankly, I think the House of Representatives got a real bargain out of this deal. In exchange for this citation, we got 5 1/2 years of dedicated service and loyal friendship from someone who shared our goal of revitalizing Pittsburgh and all of southwestern Pennsylvania.

To all of you, I say thank you, thank you from the bottom of my heart, and I will always be there to help wherever I can. Ivan, I thank you.

The SPEAKER. Fifty years, fifty years of public service. Other than Matt Ryan, none of us will probably ever experience 50 years in public life.

Mr. CESSAR. Mr. Speaker?

The SPEAKER. For what purpose does the gentleman rise?

Mr. CESSAR. Personal privilege.

The SPEAKER. You are granted that privilege. You may proceed, sir.

Mr. CESSAR. I have not been around as long as Sophie, my dear friend, but I am fast approaching it.

But to each and every one of you here gathered today, it is an honor for me to join with Ivan Itkin in praising Sophie as a leader in our beloved city of Pittsburgh.

Even though I live in the suburbs, Sophie, you have always been a star, you have been a person I could talk to, and you have always been willing to help us in the suburbs. Unfortunately, we have not always reciprocated, as you well know. But again to you, Sophie, the best of everything. You have been a charm, a delight, and an honorable politician, and that is really what you were.

God bless you, and may you have a wonderful retirement. Thank you.

The SPEAKER. The Chair would like to inform the House that one night at a Pittsburgh Penquins game, I was booed, Sophie was booed, and every other politician was booed, so I am glad that on one of her last days in office she can get a standing ovation from politicians, from men and women who serve in the public weal just like you do.

An Act amending the act of November 26, 1978 (P.L.1309, No.317), referred to as the Public Works Contract Regulation Law, further providing for prompt payment schedules.

On the question,

Will the House agree to the bill on third consideration?

Mr. S. H. SMITH offered the following amendments No.

A4789:

Amend Title, page 1, line 6, by removing the period after "schedules" and inserting

and for bidder lists.

Amend Bill, page 2, by inserting after line 30 Section 2. Section 2 of the act is amended to read: Section 2. Time for awarding contracts; list of bidders.

(a) Every public contract shall be awarded by the contracting body to the lowest responsible bidder within 60 days of the date of bid opening or all bids shall be rejected except as otherwise provided in this section.

If the award is delayed by a required approval of another government agency, the sale of bonds, the award of a grant or grants, the contracting body shall reject all bids or award the contract to the lowest responsible bidder within 120 days of the date of bid opening.

Thirty-day extensions of the date for the award may be made by the mutual written consent of the contracting body and the lowest responsible bidder.

(b) All contracting bodies of the Commonwealth or any State-aided institution shall be required to provide a list of the bidders and their bid amount on each public contract within ten working days of the bid opening to interested parties for a fee to be determined by the contracting body to cover the cost of developing such list. This requirement shall not apply to the contracting bodies of any political subdivision or local authority which has the authority to enter into a public contract.

Amend Sec. 2, page 3, line 1, by striking out "2" and inserting

Amend Sec. 3, page 9, line 5, by striking out "3" and inserting

On the question,

Will the House agree to the amendments?

The SPEAKER. On the amendment, the gentleman, Mr. Smith.

Mr. S. H. SMITH. Thank you, Mr. Speaker.

This amendment is relatively simple, and it does not cost anybody any money. Basically what it would do would require primarily the Department of General Services to provide a copy of the various bidders to all of the bidders if they want it. In other words, if I bid on a project to supply some service or materials to the State, currently I either have to come and show up at the bid opening or I have to wait awhile to get ahold of those.

Most of the other government entities, the Federal Government included, will send out an immediate copy of all the bidders with the acknowledgment that this does not mean that you were awarded the bid but just lets you know where you stood, and they basically charge a fee for it. Most of the people that do the bidding are glad to get ahold of that information in a matter of a couple of days. It is a simple process.

This amendment would allow the Department of General Services to charge a fee that they feel is commensurate with the service being provided, and I hope that the members will agree with the intent of the amendment. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman, and the gentleman from Washington County, for what purpose does the gentleman rise?

Mr. LESCOVITZ. Thank you, Mr. Speaker.

I rise to support this amendment.

I think it is good to publicize the bidding lists, and I hope everybody supports the amendment.

The SPEAKER. The Chair thanks the gentleman.

Mr. KENNEY offered the following amendment No. A4790:

Amend Sec. 2 (Sec. 6.8), page 8, lines 11 through 17, by striking out all of said lines

On the question,

Will the House agree to the amendment?

The SPEAKER. On the amendment, Mr. Kenney.

Mr. KENNEY. Thank you, Mr. Speaker.

Mr. Speaker, this amendment would require that the city of Philadelphia follow the same guidelines as other government agencies in prompt payment of public contracts. For some reason, Mr. Speaker, the city just does not want to play by the same rules as every other government agency in this city, but it always asks its taxpayers in Philadelphia to play by the same rules, meaning, pay your taxes on time. But when it comes to the city administration paying its bills, they want to be exempt, and this amendment would require that they not be exempt, that they follow the same guidelines as any other government agency.

Mr. Speaker, what the lack of prompt payment has done in the city of Philadelphia has raised the cost of contracts for Philadelphians. We pay higher prices because the city administration just does not want to pay promptly. In the PICA report, the Pennsylvania Intergovernmental Cooperation Authority, they continue to say to the city administration, your delays in payments to vendors continue to cost the city of Philadelphia money. It is not that they do not have the money, Mr. Speaker; they just do not want to pay it to contractors. That also hurts our business community by delaying payments to them, and it hurts economic growth and prosperity.

Mr. Speaker, but I guess the final blow, when it comes to responsibility, was echoed by the Department of Revenue in today's Inquirer, where they talk about "Philadelphia...on the Rebound," and the Revenue Commissioner, Al Outlaw, took an ad in today's Inquirer to talk about how some people just do not want to assume responsibility by paying their taxes, and is it not funny that they criticize and they list 14 delinquent taxpayers, but when you say to the city of Philadelphia, well, why do you not pay on time, they want to be exempt.

I just want to read what the Revenue Commissioner, Al Outlaw, says in his ad to us, we the taxpayers, the people footing the bill for city government. It says, "Unfortunately, not everyone is interested in sharing in the new 'Spirit of Philadelphia'. Some taxpayers are living in the past. They continue to believe that making Philadelphia work is someone else's responsibility."

Well, that is funny, Mr. Speaker. I am introducing this amendment, and the one group opposed to it is the city administration, because they do not want to take responsibility in paying their vendors and our contractors.

I would ask this House to support this amendment. Thank you, Mr. Speaker.

The SPEAKER. The gentleman from Washington County, Mr. Lescovitz, is recognized.

Mr. LESCOVITZ. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose this amendment basically for one reason.

Right now in the Commonwealth, underneath this act, we exclude those municipalities and school districts which are distressed. Currently under the law, Philadelphia cannot become a distressed municipality or a distressed school district because of the PICA Act that now currently exists. Once they would pay off their bonds, because of the debt that they have now incurred, they would be excluded underneath this legislation.

Mr. Speaker, I believe that Philadelphia should not be included in this legislation, basically because they are considered a distressed municipality underneath the PICA Act. About 5 months ago, we did also exclude them under the provisions of the small business legislation that we passed, just like we excluded those municipalities and school districts that are distressed, and I think we should give them the same consideration in this legislation.

The SPEAKER. The gentleman, Mr. Cohen, is recognized on the amendment.

Mr. COHEN. Thank you, Mr. Speaker.

Mr. Speaker, the city of Philadelphia is, as Representative Kenney has indicated, doing a good job bailing out from a lot of debt. However, this amendment will be a step back for the city. It would create problems that now do not exist. I think it is in everybody's interest that the city of Philadelphia be able to solve its own problems.

It is Mayor Rendell's strong and repeatedly stated goal that he wants to solve the problems of Philadelphia without aid from the State legislature. On the other hand, I think he also would like the State legislature not to provide roadblocks for him, and this amendment will be a roadblock. It is something that Philadelphia really does not need as it struggles to repay debt; it is something that creates a burden on the city of Philadelphia; and it is something that may lead to the city of Philadelphia making demands upon this General Assembly, since this General Assembly would be creating the problem, not the city of Philadelphia.

I think Mayor Rendell is right in trying to take responsibility for Philadelphia's improvement. He has done an excellent job in building up a sense of hope and confidence that the Philadelphia problems can be turned around. I think the Rendell administration deserves the confidence of this body.

I would urge the defeat of this amendment.

The SPEAKER. The gentleman, Mr. Kenney, for the second time on the amendment. Does the gentleman wish to be recognized?

Mr. KENNEY. Yes. Thank you, Mr. Speaker.

Mr. Speaker, I am asking this House today to go on record in supporting the taxpayers of Philadelphia.

You know, what you have heard from the gentleman, the chairman of the Business and Economic Development Committee, was about distressed municipalities. That is a term the city of Philadelphia fought with for years and refused to be deemed a distressed municipality. That is why we have the PICA Act. We had to come up with something different, because they said we are not a distressed municipality and we should not come under that terminology.

Mr. Speaker, you know, the question, PICA, this board we put in place in 1991 to oversee the flow of government and responsibility in bringing the city of Philadelphia back to prosperity, lists—and I will read them—their primary areas of concern, and this is December of 1993: "Inability to expend appropriated funds on a timely basis." What they are saying is, they give the city the money to pay their contractors, and they still do not pay. "Inability to monitor and track fund balances throughout the fiscal year," meaning they do not know what they have sitting in the accounts to pay them to begin with. And "Delays in payments to vendors" have caused taxpayers in Philadelphia extra dollars.

Every year the city of Philadelphia comes to this chamber to say, give us extra dollars. Well, I would say, without this legislation you are going to continue to pay extra dollars to Philadelphia, because they do not believe in prompt pay and paying in a timely fashion.

Again, Mr. Speaker, if you support taxpayers, vote for my amendment; if you support the city administration, then vote against my amendment. That is the issue, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Hasay, is recognized.

Mr. HASAY. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the Kenney amendment.

We have contractors from all over Pennsylvania that do business in Philadelphia, and if the rest of Pennsylvania has to pay their bills on time, so should the city of Philadelphia. So please support this amendment, Mr. Speaker. Thank you.

The SPEAKER. The gentleman from Washington County, Mr. Lescovitz, for the second time.

Mr. LESCOVITZ. Thank you, Mr. Speaker.

Again I am going to rise to oppose the amendment, basically because it will treat Philadelphia, which is a distressed municipality, differently than we do to other distressed municipalities across the Commonwealth.

Secondly, this legislation which we have had meetings and hearings on, the contractors had no complaints whatsoever about excluding those cities which are underneath the PICA Act or are distressed municipalities.

Thirdly, if the George Kenney amendment does go in, under a fiscal note prepared by the Appropriations chairman, it would cost the city of Philadelphia this year some \$4.5 million. Mr. Cohen already communicated to us about the situation in Philadelphia where the mayor is working to resolve the budget problems in that city. I think this will only cause greater havoc to the city of Philadelphia if the Kenney amendment goes in, and I therefore would oppose the amendment.

For such actions a majority of the remaining members of the board shall constitute a quorum.

(b) No office shall be declared vacant for failure to attend meetings of the board until the holder of the office shall have been given an opportunity for a hearing before the remaining members of the board, at which time he shall show cause why he shall not be removed. He shall be given at least ten days' written notice of the time and place of the hearing.

Section 2. The introductory paragraph and clause (2) of subsection (d) of section 1802 of the act, amended July 10, 1990 (P.L.389, No.92), are amended to read:

Amend Sec. 2, page 2, line 9, by striking out "2" and inserting

It provides the opportunity for the person whose seat is to be declared vacant to provide justification for their absence and also provides means for review by the court.
