Section 1. The definition of "longtime owner-occupant" in section 3 of the act of December 13, 1988 (P.L.1190, No.146), known as the First and Second Class County Property Tax Relief Act, is amended to read;

Section 3. Definitions.

The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Longtime owner-occupant." [Any] For counties of the first class, any person who for at least ten continuous years has owned and has occupied the same dwelling place as a principal residence and domicile, or any person who for at least five years has owned and occupied the same dwelling as a principal residence and domicile if that person received assistance in the acquisition of the property as part of a government or nonprofit housing program. For counties of the second class, any person who for at least three continuous years has owned and has occupied the same dwelling place as a principal residence and domicile.

Section 2. Sections 4 and 5 of the act are amended to read: Amend Sec. 1 (Sec. 4), page 1, line 13, by inserting brackets before and after "Deferral or exemption" and inserting immediately thereafter
