House Resolution No. 275

A RESOLUTION

Recognizing the storm active duty assignments of the Pennsylvania National Guard.

WHEREAS, The Pennsylvania National Guard was called to State active duty for three separate periods, a total of 20 days. The soldiers and airmen performed 61 missions, a total of more than 3,000 man-days; and

WHEREAS, The first period was January 6 through 14, created by a major snowstorm in Allegheny, Westmoreland, Washington, Green and Fayette Counties. The Pennsylvania National Guard emergency duty, however, drew in soldiers from other sections of this Commonwealth; and

WHEREAS, In that first period, the Pennsylvania National Guard helped rescue stranded motorists, transported emergency medical personnel and people in need of medical treatment and helped with snow removal; and

WHEREAS, Two guardsmen from Company B, 876th Engineers, Punxsutawney, rescued an elderly couple in Jefferson County who had been snowbound in their rural farm home for more than a week; and

WHEREAS, The second period of active duty began as the first one was ending, lasting January 14 through 19. The emergency was created by record-breaking cold temperatures combining with a major snowstorm. The duty was concentrated in the lower Susquehanna Valley and in Philadelphia; and

WHEREAS, Guard fuel trucks transported more than 386,000 gallons of fuel to Philadelphia Electric plants in southeastern Pennsylvania; and

WHEREAS, In central Pennsylvania, Pennsylvania National Guard activity was centered around the southern section of Interstate 81 where stalled trucks forced Pennsylvania State Police to close the highway. Pennsylvania National Guard members helped remove the trucks and also helped direct traffic through neighboring communities, including Carlisle, until the highway could be reopened; and

WHEREAS, The Pennsylvania National Guard also helped remove snow from the roofs of temporary public buildings in Cumberland County; and WHEREAS, The third period was January 27 through 31 when the Pennsylvania National Guard was asked to haul highway salt from a mine in New York State to PennDOT maintenance centers in five locations from eastern to western Pennsylvania; and

WHEREAS, The Pennsylvania National Guard used army and Air Guard and Army reserve trucks, 81 in all, to haul 3,500 tons of salt. They traveled 76,000 accident-free miles; and

WHEREAS, The peak period of active duty came with the salt convoys. On the busiest day, 472 guardsmen were involved in the hauling and unloading; and

WHEREAS, In early February, the Pennsylvania National Guard sent a helicopter to Pike County to help a rescue team that had bogged down trying to retrieve the bodies of two elderly Canadian skiers; therefore be it

RESOLVED, That the House of Representatives recognize the tireless efforts of the Pennsylvania National Guard.

Mrs. LAUGHLIN. Thank you, Mr. Speaker.

As many of you may know, scleroderma is not exactly a household word. By introducing this resolution today, I hope to change that.

Scleroderma, also known as systemic sclerosis, is a chronic connective-tissue disease which affects over 300,000 people in the United States alone.

Scleroderma is an incurable disease which causes hardening of the joints, muscles, blood vessels, and internal organs. It most often strikes people between the ages of 20 and 60.

Two forms of the disease have been diagnosed. Limited scleroderma affects less of the skin and fewer internal organs and progresses at a slower pace. Diffuse scleroderma is widespread and affects the lungs, esophagus, and intestines to a greater degree. This is a very painful and sometimes fatal disease which should be more widely recognized. The Scleroderma Agency of Western Pennsylvania has grown rapidly and has worked hard to promote public awareness of this very painful disease.

On behalf of those afflicted with this life-threatening sickness as well as those involved in support organizations, I thank you who cosponsored my resolution recognizing March 20 through 26, 1994, as "Scleroderma Week," and I ask each and every one of you to vote affirmatively on this resolution. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the Representative from Beaver County and recognizes Representative Masland on the resolution.

Mr. MASLAND. Thank you, Mr. Speaker.

I want to commend, first of all, Representative Laughlin for doing her best to bring an awareness of this dreaded disease to at least the 200 of us here on the floor of the House.

I would like to briefly put a more human face on this disease. A lifelong friend of mine who is 34 years old is

afflicted with scleroderma. He has had it for about the last 3 years.

You can talk about something being a connective-tissue disease, but what does that really mean? What it means is that his skin is as hard as rock, and very slowly and inexorably, his organs are turning to stone. He has lost 60 percent of the use of his lungs, and they will continue to deteriorate until he is killed because of this disease. His hands are like little rocks. His fingers do not look like normal fingers. He is becoming disfigured every day, and here is somebody with a 6-year-old child.

This is a very dreaded disease, and I hope that this resolution will help us come to a little bit better understanding of what it really means in human terms. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes Representative Hershey on the resolution.

Mr. HERSHEY. Thank you, Mr. Speaker.

I appreciate Representative Laughlin sponsoring this resolution. Not many people know much about this disease, but my mother contracted this 23 years ago, and in 3 years she passed away, and there were only five known cases then in Lancaster County.

So I thank her for sponsoring this, and it is a very, very dreaded, slow, slow way to go. Thank you very much.

The SPEAKER. On the amendment, the gentleman from Lehigh.

Mr. SNYDER. Mr. Speaker, this amendment adds an additional provision and new element to the loan program.

While the legislation is intended to provide additional terms for major loans, currently the program includes in those time periods loans for buildings and major upgrades or modernization for facilities. The volunteer loan program has asked us to introduce this amendment to provide up to 20 years for loans that establish or modernize facilities when the loan is in excess of \$100,000. This is more in line with what a traditional mortgage would be for these fire companies and would allow them to amortize loans for facilities over a 20-year period.

Again, we ask for your support.

The SPEAKER. Mr. Mihalich, again, from Westmoreland County on the amendment.

Mr. MIHALICH. Mr. Speaker, this is an agreed-to amendment.

The SPEAKER. The Chair thanks the gentleman.

On the amendment, Mr. Gordner.

Mr. GORDNER. Thank you, Mr. Speaker.

I do not believe that we have this amendment. Has it been distributed yet?

The SPEAKER. It is making its way up to Berwick.

The Chair will yield momentarily until the gentleman, Mr. Gordner, has a chance to peruse the amendment.

Does the gentleman, Mr. Fargo, seek recognition?

Mr. FARGO. Yes. I would like to ask a question of the maker of the amendment.

The SPEAKER. The gentleman is in order. Mr. Snyder will please respond. The gentleman indicates that he will.

Mr. FARGO. Thank you, Mr. Speaker.

I have had expressed the concern that by extending the number of years in a situation like this, that what it will do is to make the number of loans less available because of the fact that the money is not being repaid as quickly as it is under the present system. Has this been discussed at all as far as the committee, or do you have a way to respond to that concern?

Mr. SNYDER. Mr. Speaker, certainly the concern you raise was an issue that was discussed when the loan program was amended a few years ago to raise the amount of money that could be included in the loans. When the maximum used to be around \$50,000, \$75,000, and then we increased that to \$100,000, \$150,000, that was one of the issues this General Assembly considered when we approved that language that is in the existing law. However, Mr. Speaker, when we raised those limits to the higher levels, then it made it very difficult for many fire companies to qualify for those loans because of the monthly payments in the shorter time periods, which is what Representative Mihalich is trying to address with his legislation.

Mr. Speaker, however, this amendment is very limited to only buildings and facilities. It does not impact on the equipment loan program, and as a result, we feel that the impact that it would have on the applications that are pending would be rather minimal.

Mr. FARGO. Thank you.

It is my understanding that the department is in favor of this particular amendment, but have you had any concerted effort, by the fire companies out in the district, have you heard of any concerted effort in opposition to this arrangement?

Mr. SNYDER. Mr. Speaker, there has been no opposition to this particular amendment. In fact, this amendment has been introduced at the request of both the fire association and the loan program.

Mr. FARGO. Thank you, Mr. Speaker.

On the question recurring, Will the House agree to the amendment?

On the question recurring,

Will the House agree to the bill on third consideration as amended?

Bill as amended was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On the bill, the gentleman, Mr. Mihalich, is recognized. Mr. MIHALICH. You have answered my question, Mr. Speaker. Thank you.

The SPEAKER. The gentleman is welcome.

For what purpose does the gentleman, Mr. Maitland, rise?

Mr. MAITLAND. On the bill, Mr. Speaker.

The SPEAKER. The gentleman is recognized.

Mr. MAITLAND. Mr. Speaker, I rise to urge a "no" vote for this bill.

This is a bill that I took interest in when Mr. Mihalich circulated his memo. So I wrote to the fire companies in Adams County, had a meeting with them, and discussed this legislation with them, and they felt very strongly against lengthening any of the terms of repayment for the 2-percent loans. They would like to see that money turned over as frequently as possible, and basically their feeling was, if it's not broke, don't fix it.

So for that purpose, I am voting "no" on the bill and I urge my colleagues to vote "no" likewise. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman, Mr. Maitland, from Adams County, and Mr. Civera is recognized.

Mr. CIVERA. Thank you, Mr. Speaker.

I rise to support HB 2340.

Now, there are different fire companies throughout the State that have taken a position that they would not be in favor of the legislation for the reason of extending the loans. However, it was explained to them that there are fire companies in Pennsylvania that, if this legislation does not pass, will go bankrupt and go out of service.

When Representative Snyder said it altogether just a couple of minutes ago, when he had said that when we extended the loan program from \$50,000 to \$100,000 is when we made the major step, and we did that 3 or 4 years ago, we are at the point right now where if this legislation does not go through, and I repeat again, there will be fire companies in the State of Pennsylvania that will literally go out of business. This is not the solution to all the problems, but it is something that we need to do at this moment.

Now, I have been on top of this loan program since last year when we had the battle with the interest money. I spoke to many fire services throughout the Commonwealth of Pennsylvania, and I know their sensitivity to whenever you bring up this loan account money and how they feel about it. However, this is a situation where we must respond to keep some of these fire services in business.

So I urge you to vote for HB 2340. Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Mihalich, is recognized.

Mr. MIHALICH. Mr. Speaker, the ranks of the volunteer firemen in Pennsylvania have dwindled in the last decade from almost 110,000 down to a little over, or maybe a little under, 90,000 at this juncture.

Many of our volunteer firemen are becoming discouraged. Some of the young people do not want to get involved because there is a lot of hard work involved, not only in fighting fires, but these volunteer fire companies expend tremendous amounts of energy—and their families—to go out and raise money to buy apparatus, to fund programs that are in the interests of all Pennsylvanians, to provide fire protection at a bargain-basement cost.

The thrust of this legislation is to make it easier for these people who are so hard pressed to go out and raise money, who are so hard pressed to go out and provide these services, it makes it easier for them. And one little illustration I would like to use: If a volunteer fire company would borrow \$99,999, their payback per month under the program without this new bill, without this amendment, their payback would be approximately \$960 a month. With this amendment here, their payback could be reduced almost \$340.

Three hundred and forty dollars a month may not seem like a big amount to us sitting here today, but if you belong to some small rural fire company who is selling hoagies, maybe running a bingo game, raising money from their friends and neighbors, \$350 a month is a make-or-break proposition for literally hundreds of fire companies across this State, I would estimate, based on the fact that I have three in my district who are on that line of either make or break, and they can continue going if they can get some equipment and not have to pay almost \$1,000 a month but pay only 500-and-some dollars a month.

Mr. Speaker, in the interests of all those volunteer firemen out there who are providing this service for us, for all of our citizens, I ask you to make their lives easier to provide those services for us by adopting this bill. Thank you.

The SPEAKER. The gentleman, Mr. Sturla, from Lancaster is recognized on final passage.

Mr. STURLA. Mr. Speaker, I rise in support of HB 2340, because I believe it is important that the State be involved in the firefighting efforts throughout the State. However, I would be remiss if I did not point out that this volunteer fire department loan program, which has been established in the State of Pennsylvania for many years now, does not include those municipalities which have paid fire departments. So as a result of that, those areas that have paid fire departments, those constituents in those areas help support volunteer fire departments through State tax dollars which help support these loans. Conversely, those areas that have those paid fire departments, where the local governments make the effort to pay for fire equipment, often go out and do bond issues at 5 or 6 or 7 or 8 percent, and we do not get money at 2 percent.

I would hope that someday soon we could extend this type of program, and I do not want to combine it with the volunteer

program, but I would hope that someday we could extend this same type of program to those municipalities that pay their fire departments, because we have the same needs for equipment as do volunteer fire companies that are not supported by their local governments. Thank you.

The SPEAKER. The gentleman from Franklin County, Mr. Coy, on final passage.

Mr. COY. Thank you, Mr. Speaker.

I rise in support of the legislation.

Very frankly, at times when the economy is such that it is hard for volunteer fire companies to raise money, when it is hard for volunteers, whether they do it through carnivals or bingo or other volunteer activities, when the economy gets tough and ends are hard to meet and put together, that is the time that you need to give a little more flexibility to volunteer departments, and that is exactly what this legislation does. It allows them to stretch out the repayment terms of loans from the volunteer firemen's loan fund.

The legislation provides the flexibility that is needed, and I commend Representative Mihalich and the other sponsors of the legislation for responding to a need which occurs right now. Maybe there are individual legislative districts whose departments are fluid enough and affluent enough not to need this, but for those departments in the State where the economy has touched them a little harder than others and where they might not have the volunteer resources, the resources from those carnivals and bingos and other activities that they do, this provides a little relief, a little well-needed relief.

I commend the sponsors, and I, too, along with Representative Sturla, would like to see the day when the program could be extended further. But for now, for now, this is a positive step, it is a flexibility step, and I ask for a positive vote on the legislation. Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Waugh, is recognized on final passage.

Mr. WAUGH. Thank you, Mr. Speaker.

Could I question the maker of the bill, please?

The SPEAKER. Will the prime sponsor yield to interrogation? The gentleman indicates he will, and Mr. Waugh may proceed.

Mr. WAUGH. Thank you, Mr. Speaker.

Mr. Speaker, do you have a reaction from the Fire Commissioner's office and the loan office on this? Are they in support?

Mr. MIHALICH. I assume they are in support since they sent over suggested amendments to this, two of which were adopted today - the two amendments offered by Mr. Snyder.

They are in support; yes.

Mr. WAUGH. Okay.

Secondly, did they provide us with an analysis of how the extended payback would affect the long term; in the long run, would affect the loan balance available for other departments?

In other words, I think one of the concerns that is being voiced here, and I have to admit, I guess I sort of have the same concern. From time to time there is a question on how reliable the loan balance is and the money that is available in

the Fire Commissioner's office, and I think the concern is that if we stretch to 20 years the payback, we are not going to have enough money coming back into the office to fund new applications for loans. So my question is, did they provide us with an analysis of how the loan balance is going to be affected over the long run?

Mr. MIHALICH. The answer to your question is no.

This was brought to their attention September of 1993. I do not know if they could prepare one if we wanted one. There is no way to determine which fire departments would want longer, how many would want shorter terms. I think it would be almost an impossible task to do, to make that determination. But the answer to your question is no.

Mr. WAUGH. Okay. Thank you, Mr. Speaker.

The SPEAKER. The gentleman has concluded his interrogation.

On final passage, the gentleman, Mr. Fargo, is recognized. Mr. FARGO. Thank you, Mr. Speaker.

I still express a concern about this particular piece of legislation. It seems to me that it kind of has an incentive for making larger loans and making those larger loans over a longer period of time.

We have had very recently a major problem in this loan system in that there was not sufficient money in the fund balance, and we had to replenish that and have done so a couple of different times. The other concern was the amount of time that was necessary to take care of these loans and get them out to the various fire companies. But I think we have to take into consideration that we are probably better off helping a lot of people, a lot of the companies out there in the field, as compared to helping a few with a smaller amount of money, and it is really paramount that money be replaced in this fund as quickly as possible so that it can be loaned out to other fire companies who want to buy equipment.

I frankly, in my area, have not had a loan requested of the size that we are talking about in these major additions that we are making in this loan and in the amendments that we have had to the bill. So I have a feeling that we are not helping the majority of the fire companies; instead we are looking at trying to help a very few, and I personally am going to vote against the bill as it stands at the present time.

The SPEAKER. The gentleman from Bucks, Mr. Corrigan, is recognized on final passage.

Mr. CORRIGAN. Thank you, Mr. Speaker.

Mr. Speaker, in listening to the debate on HB 2340, I am a little bit perplexed, and for the life of me, when this bill was on the calendar today, I was hard pressed to find a downside. I cannot imagine anyone voting "no" on this bill. This bill will benefit each and every volunteer fire department in the Commonwealth of Pennsylvania.

There is not a downside. It is a good bill. I would urge everybody to vote "yes." Thank you.

The SPEAKER. Does the gentleman, Mr. Snyder, seek recognition on final passage? The gentleman is so recognized. Mr. SNYDER. Thank you, Mr. Speaker.

Mr. Speaker, there has been some concern on the floor about the impact on this program, but let me reemphasize a few points for the members.

First of all, this program has been a model program for other States. It has been very successful in allowing our volunteer fire companies to have the resources necessary for the equipment and the technology that is required to provide adequate emergency service protection in our communities.

Mr. Speaker, this program has been put to the voters several times for bonds to finance this program, and those bond programs have been approved by the voters overwhelmingly each time.

There are adequate resources available in the program right now, Mr. Speaker. Only half of the bond money that was recently authorized has been utilized so far.

Also, Mr. Speaker, one Representative was concerned about the increased size of the loans, that the money is cheaper, but there is a limit in the legislation right now that the fire company may not exceed 50 percent of the cost of that equipment. They are not going to go out and spend hundreds of thousands of more dollars on equipment just because they can get it for another 4 or 5 years for payback. Most of our volunteer fire companies are very conscientious in meeting their obligations. In fact, we have a very, very low default rate in this program.

Mr. Speaker, even in the worst-case scenario, if it costs us a little bit more in the long run, it is a very small price to pay to enable our communities to have protection from volunteers. Look at what the alternative is: paid fire departments. I do not think any of us want to be able to start footing the bill for that in every single community in the Commonwealth of Pennsylvania.

Mr. Speaker, it is a good program. This bill makes the program more meaningful and relatively more accessible to many more companies, and I ask for support of this legislation. Thank you.

The SPEAKER. The gentleman, Mr. Mihalich, is recognized on final passage.

Mr. MIHALICH. Mr. Speaker, I would advise the members here not to misinterpret some things that were said here.

Number one, this bill in no way allows increased or bigger loans than are currently allowed under the program as it exists now. This does not provide for bigger loans; only on payback. And it would not have a negative impact on the program; it would have a modest beneficial impact on the program, because the longer you take to pay back, the more interest you pay back.

So I do not see any problem with that, but this bill does not in any way increase the amount of a loan that can be made. Thank you.

The SPEAKER. The gentleman, Mr. Fargo, on final passage.

Mr. FARGO. Thank you, Mr. Speaker.

I just want to make it clear that I, too, feel that this program is an extremely fine and a very important program, and my opposition to this particular bill has nothing to do with

that. For a fact, it is the exact opposite. I want to make sure that that system, that that program, is available to everyone in as wide a range as possible. Although I am told here by the previous speaker that there is sufficient money in the fund, that has not been true over the past, and I believe that this fund very much depends upon the repayment of the money that comes from all the various volunteer fire companies.

Certainly, I have no opposition. For a fact, I am highly, extremely in favor of this particular program, and that is the reason I would say that it should be protected. Too often we set up a good program and then we tend to ruin it by making it more generous and more easily used, and I would be a little careful here in this program to make sure that we are not doing that here.

I am expressing the concerns that are apparent as far as some of the companies out there in the field who have applied for and have used this loan. They want to make sure that those loans are available when they need them. Thank you, Mr. Speaker.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

(3) increase sales for American-made weatherization products; and

WHEREAS, LIHEAP funding alone cannot resolve the underlying cause of cold, unsafe houses, and improved weatherization and heating conservation measures are needed as well; therefore be it

RESOLVED, That the House of Representatives of the Commonwealth of Pennsylvania memorialize the President of the United States and Congress to fund the Low-Income Home Energy

Assistance Program at a level equal to or greater than the funding level for the 1992-1993 program year; and be it further

RESOLVED, That the House of Representatives memorialize the President and Congress to support the increased funding proposed for weatherization programs, which help to conserve energy and decrease energy bills of low-income customers; and be it further

homes that are not energy efficient, we are going to continue to have to pay those LIHEAP bills for people year after year after year.

I think that we should be looking to try to prevent future LIHEAP bills rather than simply trying to retain that program. That is what I hope that the House will agree to do in our message to Congress.

Mr. Speaker, I would like to thank my colleagues for their support of HB 1701, and I would like to submit my remarks for the record.

The SPEAKER. The Chair thanks the gentleman from Lackawanna.

Mr. BELARDI submitted the following remarks for the Legislative Journal:

The Independent Living Services Act (HB 1701) establishes in State law policies and practices to assure that people with disabilities have input and control over the government systems designed to serve them.

Until recently, our society and our Commonwealth have viewed individuals with disabilities as the unfortunate victims of their conditions. As a result, we have tended to create public policies that abridge the self-reliance and self-determination of these people, and inadvertently have limited their social and economic independence.

We have, in Pennsylvania, a network of fifteen (15) centers for independent living serving people with disabilities in all regions of the Commonwealth, both urban and rural. These centers are directed and staffed by people with disabilities who assist their peers in overcoming the barriers to social and economic self-sufficiency. Roughly half of these organizations receive Federal funds under the Rehabilitation Act and are subject to strict criteria that assures people with disabilities continued control of these centers and the services they provide. The remaining centers are supported through State appropriation without any legislative guarantee that they will operate in accordance with our intent.

Pennsylvania also currently has an Independent Living Council, comprised of a majority of people with disabilities as appointed by the Governor, which plans for the appropriate development of federally financed independent living programs and services. This council is not currently empowered to plan and oversee State-funded independent living programs.

The Independent Living Services Act will, at no additional cost:

- Allow people with disabilities the opportunity to exercise some control over the systems, programs and services that they receive.
- Assure that all of Pennsylvania's centers for independent living remain in the control of people with disabilities, as intended.
- * Guarantee that the full range of independent living services for people with disabilities are made available in all regions of the State.
- Begin to correct, through direct empowerment of people with disabilities, the public policies that have inadvertently created barriers to self-determination and self-reliance.
- Advance the Commonwealth's commitment to placing control over disability-related programs directly in the hands of service recipients, as occurs in our nationally recognized attendant care program.
- * Create consistency with Federal law.
- * Through an ever stronger network of centers for independent living, afford people with disabilities the opportunity to develop local, community-based responses to the barriers that inhibit their full and equal participation in all aspects of community life.
