The House proceeded to third consideration of HB 2630, PN 3585, entitled:

An Act providing for signage near licensed limited farm wineries.

On the question,

Will the House agree to the bill on third consideration? Mr. FAJT offered the following amendment No. A1935:

Amend Sec. 3, page 4, lines 14 and 15, by striking out  $\sim$ "INTERSTATE HIGHWAYS AND"

Amend Sec. 3, page 4, line 15, by striking out "ROADS" and inserting highways

On the question,

Will the House agree to the amendment?

The SPEAKER. On the amendment, the gentleman, Mr. Fait, is recognized.

Mr. FAJT. Thank you, Mr. Speaker.

This amendment simply clarifies the types of highways in the Commonwealth that may be approved for the installation of directional signage for wineries.

Right now the way the bill is written, we can have directional signage on our interstate highways, and I am very concerned about the proliferation of alcohol. I do not think we need people pulling off the interstate highways so they can find a winery.

There are roads that will have signage for the wineries, but they will not be the interstates. There are two other States in the United States - New York and Virginia - that have a policy that is consistent with my amendment. The only State that has a policy that is inconsistent with my amendment is the State of Florida, and we have been in contact with them and found out that they are quite concerned about the proliferation of signs dealing with their wineries.

So this amendment, the whole intent of this is to say you cannot have directional signage on an interstate highway for a winery. Again, I am concerned about the proliferation of alcohol. I do not think we need to have people pulling off our interstates to go to a winery and then back on.

Thank you, Mr. Speaker. I would like to ask everybody for their support for this amendment.

The SPEAKER. The Chair thanks the gentleman from Allegheny County and recognizes his colleague, chairman of the Tourism Committee, Mr. Gamble.

Mr. GAMBLE. Mr. Speaker, I rise to oppose this amendment. The reason for the amendment, there is a threat from the Federal Government in Florida that they may have to remove those signs along their interstate highways.

What we are doing here is trying to promote tourism, and we have people go straight through our State, straight through our State on the interstates, and we think it would be a good thing for tourism if those few wineries in Pennsylvania could put ample advertising along the highway. We do not see a roliferation of signs along the highway. There are not going to be signs for flea markets and this and that and the other thing. This is an industry. This is a tourist attraction.

I would respectfully ask that you reject this amendment and pass the bill in its present form. Thank you.

The SPEAKER. The Chair thanks the gentleman.

For the second time, the gentleman, Mr. Fait.

Mr. FAJT. Thank you, Mr. Speaker.

Just quickly, this amendment is supported by PennDOT, for the information of the members. Thank you,

The SPEAKER. Mr. Gamble is recognized also for the second time.

Mr. GAMBLE. My bill is supported by the tourism industry, and I would hope that you would vote "no" on the amendment.

The SPEAKER. On the Fajt amendment, the gentleman from Lackawanna, Mr. Serafini, is recognized.

Mr. SERAFINI. Mr. Speaker, as the minority chairman of the Tourism Committee, I must agree with the chairman of the Tourism Committee that this amendment will not help tourism in Pennsylvania and it is not needed in this bill. This industry is trying to keep its head above water in a tough economic market, and we are just trying to give them the benefit that other States have given this industry.

I appreciate your rejection of the amendment.

The following resolution was read:

#### House Resolution No. 323

#### A RESOLUTION

Recognizing the week of May 22 through 28, 1994, as "Senseless Acts of Random Kindness Week" in Pennsylvania.

WHEREAS, Children see thousands of random acts of senseless violence yearly on television entertainment programs and in movie theaters and learn from television and radio news programs and newspapers of such incidents in their neighborhoods and across the country; and

WHEREAS, Acts of violence in entertainment and news programs, movies and throughout the media or in communities may desensitize people, particularly children, to the pain, suffering and consequences that ripple through society from violence and may wrongly teach people, particularly children, that violence is a means to settle conflict; and

WHEREAS, Drive-by shootings, random street murders, domestic abuse and violent crime in this Commonwealth and across the nation have made many people afraid to go out of their homes at night, get to know their neighbors or get involved in community problems; and

WHEREAS, Incidents are on the increase in this Commonwealth in which students carry a gun to school for protection from conflict; and

WHEREAS, Many people throughout this Commonwealth and nation promote kindness through volunteer work in their communities, schools and churches by helping men and women in need, thus making the world a better place to live, work and raise a family; and

WHEREAS, Promoting kindness, compassion, mutual respect, understanding, diversity, negotiation, conflict resolution and good will can help stop violence; and

WHEREAS, This Commonwealth and the United States were founded, in part, on the principles of mutual kindness, decency and respect for others; and

WHEREAS, A national trend to promote senseless acts of random kindness, good will, mutual respect and dignity has grown from a class assignment that a professor at Bakersfield College in California gave to his students; and

WHEREAS, The assignment to commit one senseless act of random kindness, such as giving up a parking space in a busy mall, volunteering at a church or helping the Salvation Army taught the students that being kind to one's fellow men and women in turn promotes kindness, decency, good will and a true sense of satisfaction; and

WHEREAS, The lessons that the students learned quickly reached millions of people around the world, thanks to stories about their experiences that appeared in newspapers and magazines and on television programs like the Oprah Winfrey Show, The Crusaders and Primetime Live, prompting other groups to copy the idea; and

WHEREAS, The professor, Dr. Charles Wall, has worked to persuade Congress, State legislatures and local governments to designate "Senseless Acts of Random Kindness Week" to promote the idea of mutual respect and dignity in order to get adults, teenagers and children to discuss the values of respect and to learn how to solve their differences peacefully; and

WHEREAS, Schools as well as various groups and individuals in this Commonwealth can easily organize senseless acts of random kindness programs in their communities to encourage residents to take the time to get to know each other, organize and work together to take back their neighborhoods and change the emphasis in society from violence to kindness; and

WHEREAS, Similar campaigns such as "Just Say No" focused attention on the problems of drug use among teenagers and children in society and promoted similar efforts at drug abuse prevention; and

WHEREAS, Focusing attention on such efforts can promote kindness, understanding and mutual respect throughout this Commonwealth and defeat the fear that stops people from getting involved; and
