Just as an aside, I understand, in talking with Representatives Benninghoff and Clark, that maybe a little championship scrimmage is in the offing between the AAA and the AAAA teams here.

## MANSFIELD UNIVERSITY BASKETBALL TEAM PRESENTED

The SPEAKER. The gentleman, Mr. Baker, come to the rostrum.

The Chair recognizes the gentleman, Mr. Baker.

Mr. BAKER. Thank you, Mr. Speaker.

It is indeed an honor and a pleasure to be here today to celebrate the State championship team from Mansfield University. The 1996-97 Mansfield University basketball team will go down in the annals of Pennsylvania collegiate sports history.

The Mountaineers not only won their first Pennsylvania State Athletic Conference championship since 1984 but also set school records for wins during the regular season -23 – while tying the school mark for overall wins in a season with 26.

Mansfield University's 26-and-4 record was the best winning percentage posted by any school in the Commonwealth of Pennsylvania. The Mountaineers improved their win total by 16 games over the previous season, the best turnaround in the NCAA.

Head Coach Tom Ackerman was named the Pennsylvania State Athletic Conference Eastern Division Coach of the Year, while senior Louis Judson – incidentally, from Troy, Pennsylvania – was selected the PSAC East Player of the Year. Unfortunately, Louis could not be with us today. Seniors Lawrence Culver and Kenny Woseley, along with Judson, were named to All-PSAC East first team honors, while Culver and Judson also earned All-East selection.

No collegiate team in the State averaged more points per game than the school record 96.6 points, third highest in the NCAA Division II this year.

The Mountaineers finished the regular season ranked 10th in the Nation in NCAA Division II, while Judson ranked among the country's elite in scoring, shooting percentage, and 3-point shooting. Culver set new school records in rebounding, while ranking third in the Nation in that category. Woseley was among the national leaders in steals.

As a team, Mansfield ranked 4th in the NCAA Division II in winning percentage, 7th in 3-point field goal percentage, 8th in scoring margin, 13th in field goal percentage, and 17th in 3-point field goals per game.

Not only did Mansfield University basketball prove itself on the basketball court, they were also winners in the community. The Mountaineer basketball team provided a free weekly junior basketball league that enrolled more than 100 area youngsters in the preseason. In addition, the team sponsored "Shootout for Special Olympics" that has raised more than \$800 for the Tioga County Special Olympics.

At this time I would ask that the remaining team located in the rear of the House please stand and that you join me in recognizing and honoring Mansfield University's State champions.

Section 1. The act of July 28, 1953 (P.L.723, No.230), known as the Second Class County Code, is amended by adding a section to read:

Section 1970.3. Joint Tax Collector - Notwithstanding the provisions of section 10(b) of the act of December 31, 1965 (P.J. 1257, No.511), known as "The Local Tax Enabling Act," if a municipality having a population of at least 50,000 and less than 100,000 located in a second class county has adopted a home rule charter under 53 Pa.C.S. Pt. III Subpt, E (relating to home rule and optional plan government), the governing body of the municipality and board of school directors for the school district in which the municipality is located shall annually agree on and jointly appoint a collector or collectors of taxes for taxes levied under "The Local Tax Enabling Act." In the event the governing hody of the municipality and the board of school directors for the school district in which the municipality is located cannot agree on the appointment of a collector or collectors of taxes levied under this act within ninety days of the commencement of each ensuing municipal fiscal year, then three arbitrators shall be appointed who by majority vote shall choose a tax collector to collect taxes levied under this act; one person shall be appointed by the governing body of the municipality who is a resident of the municipality and who is not a member of the governing body, one person shall be appointed by the board of school directors who is a resident of the school district and who is not a school director, and one resident shall be appointed by the elected controller of the municipality.

Section 2. Sections 2565 and 2566 of the act, amended June 19, 1961 (P.L.463, No.232), are amended to read:

Amend Bill, page 4, by inserting between lines 6 and 7

Section 3. This act shall be implemented no later than July 1 of the first year following the effective date of this act.

Amend Sec. 2, page 4, line 7, by striking out "2" and inserting

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, this amendment addresses a problem that I have in a municipality in my district, in Allegheny County. It affects one municipality, and what it tries to do is it tries to be accountable for a tax collection system that the municipality has created, where we have a dual tax collection system that is creating a burden for the taxpayers and creating a burden for the business community.

The taxpayers and the business community are in favor of this amendment. This amendment passed two sessions ago. It got tied down in the Senate. Hopefully this session we will be able to move it so that the people in Penn Hills can have some relief on their tax collection system.

Amend Title, page 1, line 4, by inserting after "thereto," "
providing for retirement eligibility; and

Amend Bill, page 1, lines 9 and 10, by striking out all of said lines and inserting

Section 1. Section 1710(a) and (b) of the act of July 28, 1953 (P.L.723, No.230), known as the Second Class County Code, amended February 9, 1984 (P.L.12, No.6), May 9, 1984 (P.L.261, No.61) and December 4, 1992 (P.L.776, No.121), are amended to read:

Section 1710. Employes Eligible for Retirement Allowances.-(a) Every county employe [who was initially hired on or prior to the effective date of this amendatory act,] who has reached the age of sixty years or upwards and who has to his or her credit a period of service of eight years, but less than twenty years, [or every county employe who was hired after the effective date of this amendatory act, who has reached the age of sixty-five years or upwards and who has to his or her credit a period of service of ten years, but less than twenty years] shall, upon application to the board, be eligible for retirement from service, and shall thereafter receive, during life, except as hereinafter provided, a retirement allowance computed on a service period of twenty (20) years which shall equal one twentieth (1/20) of such amount as he or she may be eligible to receive in accordance with the provisions of subsection (a) of section 1712, for each year's service which such county employe may have to his or her credit during the aforesaid period of time. The time spent in the employ of the county or county institution district need not necessarily have been continuous. The aforesaid retirement allowance shall be subject to a suspension thereof in accordance with the provisions of subsection (h) of this section 1710 and subsection (c) of section 1712.

(b) Every county employe, other than a member of the police force or the fire department or a fire inspector or a sheriff or deputy sheriff, [who was initially hired on or prior to the effective date of this amendatory act,] who has reached the age of sixty years or upwards and who has to his or her credit a period of service of eight years, but less than twenty years, [or every county employe, other than a member of the police or the fire department or a fire inspector, who was hired after the effective date of this amendatory act, who has reached the age of sixty-five years or upwards, and who has to his or her credit a period of service of ten years, but less than twenty years,] and every county employe who is a member of the police force or the fire department or a fire inspector, and who shall have been a county employe during a period of twenty or more years and has reached the age of fifty years or upwards shall, upon application to the board, be eligible for retirement from service, and shall thereafter receive,

during life, except as hereinafter provided, a retirement allowance plus a service increment if any, in accordance with the provisions of section 1712. Every county officer or employe who is a sheriff, deputy sheriff or prison guard who shall have been a county officer or employe during a period of twenty or more years and has reached the age of fifty-five years or upward, shall, upon application to the board, be eligible for retirement from service and shall thereafter receive, during life, except as hereafter provided, a retirement allowance in accordance with section 1712. The time spent in the employ of the county or county institution district need not necessarily have been continuous: Provided, That when any county employe has twenty or more years service, not necessarily continuous, and has reached the age of fifty years or upwards, and shall be separated from the service of the county or county institution district by reason of no cause or act of his or her own, upon application to the board he or she shall thereafter receive, during life, except as hereinafter provided, a retirement allowance plus a service increment if any, in accordance with the provisions of section 1712. The aforesaid retirement allowance plus a service increment if any, shall be subject to a suspension thereof in accordance with the provisions of subsection (h) of this section 1710 and subsection (c) of section 1712.

Section 2. Sections 2565 and 2566 of the act, Amend Sec. 2, page 4, line 7, by striking out "2" and inserting

On the question,

The SPEAKER. The Chair recognizes the gentleman, Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

This is another amendment. It just affects the county of Allegheny County, and what we are trying to do here is to seek to correct inequity in a situation for some of the nonuniformed employees in Allegheny County.

Presently some of these employees are forced to work till 65 with 10 years of vesting. They presently have a two-tier retirement plan, and we are just trying to bring them down to where the second tier was before, being able to retire at 60 with no penalty. Some of the uniformed employees who are in this pension plan presently retire at 55.

So this is just a bill to put some equity in for nonuniformed employees in Allegheny County. The county commissioners, from what I understand, are in favor of this; so are the employees.

I would seek an affirmative vote on this, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman, Mr. Fargo.

Mr. FARGO. Thank you, Mr. Speaker.

Would the maker of this amendment stand for interrogation? The SPEAKER. The gentleman, Mr. DeLuca, indicates he will stand for interrogation. You may begin.

Mr. FARGO. Thank you.

If I understand this bill correctly, it not only reduces from 65 to 60 the age at which you can qualify for this but also reduces the number of years on the low side as to how many years you actually have to be an employee from 10 to—

The SPEAKER. Will the gentleman, Mr. Fargo, yield.

Mr. FARGO. Yes.

The SPEAKER. The conferences on the floor should cease. Members, please be seated. If it is necessary to confer, go to the conference rooms in the rear of the House.

Mr. Fargo.

Adolph

Mr. FARGO. Thank you, Mr. Speaker.

I feel that this amendment not only reduces from 65 to 60 years of age the age at which they can qualify, but you have also reduced from 10 years to 8 years the number of years that is necessary on the low side to qualify. Is that correct?

Mr. DeLUCA. That is correct, Mr. Speaker.

Mr. FARGO. Has there been an actuarial study prepared for this particular amendment? Have we received a notice from the retirement board – that is, their report – as to what this will cost as far as the individual counties are concerned?

Mr. DeLUCA. No; I have not received a report. I talked to the retirement board. They feel there would be no impact, since they do have a surplus in their retirement fund.

Mr. FARGO. No impact, but there will be a cost, an additional cost?

Mr. DeLUCA. There will be a slight additional cost, Mr. Speaker.

Mr. FARGO. Thank you. Thank you, Mr. Speaker.

Mr. DeLUCA. Can I answer this?

Let me also say, Allegheny County is presently facing a crisis, a deficit in their county budget. This will enable some of their employees to take an early pension and put some of the other employees who are being hired— It is the same way that we do with the schoolteachers. We get rid of the ones who have more seniority, and we bring the other ones back up at lesser pay. This is the same thing that we are doing with this county. It has a two-tier system. In 1984 they permitted them to retire at 60 with 8 years. I mean, this will save the county in the long run a lot of money, the same as we save some of our school districts money when we give them the early-and-out, which we intend to do once again.

Mr. FARGO. Thank you.

Could I make a statement, Mr. Speaker?

The SPEAKER. The gentleman, Mr. Fargo.

Mr. FARGO. Thank you.

Actually, the speaker before me indicated that in the long run this would save money. I am sure that this is not correct. As we look at any of the retirement actuary studies, we find that the actuarial cost to the pension plan and, of course, to the people who have to put the money into the pension plan has always increased. So I cannot believe that in the long run this would be of any savings. Possibly on the short run, I would agree with him.

But this is an additional cost to the counties. Once more, this is another one of those mandates that gets sneaked into our legislation, which I feel we are wrong in so doing, and it is my suggestion that we vote against this amendment.

## POINT OF ORDER

Mr. FARGO. I would also, I guess, raise the suggestion that we have to have an actuarial study under rule 19(a), subparagraph (7). I would like to raise the question.

The SPEAKER. The gentleman, Mr. Fargo, are you raising a point of order with respect to the actuarial note?

Mr. FARGO. Yes, I am, Mr. Speaker.

The SPEAKER. It is a well-taken point of order.

This amendment requires an actuarial note. Mr. DeLuca, this amendment, this amendment, in the judgment of the Chair, requires an actuarial note.

#### AMENDMENT WITHDRAWN

Mr. DeLUCA. Mr. Speaker, the gentleman makes a very good point. Let me withdraw this amendment and get an actuarial study on this. Okay?

The DRBC's proposed amendments would establish numerical groundwater withdrawal limits for watersheds in the protected area. The amendments will also, for the first time, establish procedures for revising withdrawal limits to correspond with integrated water resource plans adopted by municipalities.

Several municipalities in northern Chester County are grappling with a proposal to pump nearly 100,000 gallons of water a day in the groundwater protected area. Adoption of the proposed amendments by the DRBC would provide a method by which residents, through their local elected officials, could safeguard their water supply for future generations.

I believe this is a positive step by the DRBC and I believe this House should go on record in support of this initiative. I urge your support for the resolution.

#### STATEMENT BY DEMOCRATIC LEADER

The SPEAKER. The Chair recognizes the gentleman, Mr. DeWeese.

Will the gentleman yield.

Will the Sergeant at Arms clear the area behind the rail.

The Chair recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

I will be brief. I just wanted to put a few remarks on the record. After the gasoline tax increase of last week, with registrations going up and the price of gasoline going up, I wanted to at least put on the record again a couple of observations.

One of those observations is that the length of single trucks will be increased from 48 feet to 53 feet. The length of tandem trucks will be increased from 60 feet to infinity. Triple trailers, theoretically quadruple trailers, could be coming to highways near us. The width of trucks increased from 8 feet to 8½ feet plus 1 foot for mirrors, safety inspections on our big trailers from twice a year to once a year. I think it is important that this litany be recounted today.

Tandem trailers can travel rural roads virtually at will unless there is a sign prohibiting them from a particular road. Mr. Speaker, that prohibition, however, is virtually toothless since this Republican law cuts the fines for trucks that travel these prohibited roads from \$300 to \$50. That means in rural Greene County, if you are going from Aleppo to Ned or from Nineveh to Spraggs and you are traversing a highway that has been signed as prohibitive, your fine will only be \$50. If you are a big logger or you have another commercial enterprise where your cash flow is substantial, \$50 is comparatively inconsequential. Your rural folks down in York County will pay \$300 fines for littering and only \$50 when these rolling behemoths traverse backroads that they do not have any business being on. Highway registration fees apply to family cars this year, right away, but the gasoline tax that you invoked upon our Commonwealth does not take effect upon trucks until next January.

Mr. Speaker, I appreciate the opportunity to share these observations for the record. The trucking industry in this Commonwealth was treated especially well by this proposal, but

in general, I think that the citizenry of Pennsylvania has not been treated well, and again and again and again, Mr. Speaker, we will be inculcating to this Assembly and to our body politic the results of what was done when Governor Ridge and the Republican majority increased gasoline taxes, registration fees in the State of Pennsylvania. Thank you very much, Mr. Speaker.
