MARIA JAMES PRESENTED

Mr. JAMES. Thank you, Mr. Speaker.

As part of the Commonwealth's recognition of the month of February as designated "Black History Month," I would like to introduce to my esteemed colleagues a young lady that has begun to make an outstanding name for herself throughout this area, using her oratorical talents and skills.

Ms. Maria James – and I have not determined whether we are related yet; I have to talk to her father and grandfather, but at this

time we are no relation – has received her undergraduate degree from Shippensburg University and is presently working towards her master's in communications at Shippensburg. She has a published anthology and is a member of the Writers Workshop here in Harrisburg.

Her proud parents are also visiting with us today, and that is Mr. and Mrs. Richard James, if you would please stand.

Maria's talents have made her a local celebrity. She recently performed this monologue for the Auditor General's Office Black History Month program, where she received a standing ovation, and on Wednesday will be performing at the East Shore Library in Lower Paxton Township.

It is my honor and privilege to introduce Ms. Maria James, performing a monologue entitled "The Road to the Promised Land."

The SPEAKER. Will the lady yield for a moment.

The House will come to attention, please.

Ms. James.

Ms. JAMES. Thank you.

"The Road to the Promised Land."

Why am I crying? You see what they are doing out there. Could hell be worse? My people burning down their own communities, and for what? Because I died? Do they not remember what I lived for? Did my words have any significant meaning? I had a dream that one day we would live in a world where man would not be judged by the color of his skin but by the content of his character. I still believe that.

Look how far we have come. Twenty years ago a Negro could be arrested for eating a hotdog in Woolworth's. Today Negroes attend integrated schools, sit where they choose to on buses, and do a host of other things our fathers never dreamed that they could do. We did not gain these achievements by killing each other. We fought our oppressors with Christian love. That is what I stand for. That is how I want to be remembered.

Angel, let me talk to them; please, let me tell them just one last time, tell them that the Reverend Dr. Martin Luther King, Jr., just tried to love somebody.

Well, do they not think that I ever got angry? I mean, when they bombed my house, almost killing my wife and child, do they not think I was angry?

I remember times when we marched and the crowds called us everything but children of God, but we remained strong. We kept our heads up high. We remained nonviolent.

I do not know; maybe my young brothers today think I am crazy. Maybe the road that I chose was not the easiest or the fastest, but I believe that it was the best choice for our people at the time. The road to the promised land is through nonviolent resistance.

Please, just one more moment, Angel; just one to say goodbye. Look; there is Coretta.

Do not worry, Sugar. I said I might not get there with you, but I have been to the mountaintop and I have seen the promised land. Please, do not let my dreams die here with me.

Yes, Angel, I see the light. It is more beautiful than I ever imagined. But there is so much left for me to do.

Yes, I know. My time has come.

Well, goodbye, sweet Coretta. I will see you again in the promised land.

Thank you.

STATEMENT BY MR. JAMES

The SPEAKER. The Chair apologizes. Did the gentleman, Mr. James, wish to be recognized on the last resolution?

The gentleman, Mr. James.

Mr. JAMES. Thank you, Mr. Speaker.

I just have some remarks as it relates to the resolution, and they are about 2 minutes.

Good morning, Mr. Speaker, again. I stand before you this morning and thank the members for supporting HR 335, and I offered this resolution to honor and celebrate February as Black History Month.

I have always believed that the study and celebration of black history actually deserved more than 1 month. How can we possibly honor the many contributions that so many African-Americans have made to this Commonwealth and to this nation in merely 1 month? The truth is, we cannot. There are not enough days in February – which just happens to be the shortest month of the year, coincidentally – to do justice to the history of the American people of African ancestry.

Recognizing the worthy contributions of great African-Americans throughout our history is important not only during this month but in every month throughout the year. So many have given so much toward improving the lives of our people in this Commonwealth and nation. Individuals such as Sojourner Truth, Ida B. Wells, W.E.B. DuBois, Booker T. Washington, Frederick Douglass, Malcolm X, Martin Luther King, Jr., Al Deal, David P. Richardson, and Roxanne Jones, and many more, all contributed nobly to the wonderful history of not only black America but all of America. They struggled, suffered, and sacrificed for the betterment of not only their race but for the human race as a whole.

They believed that the causes of justice, equality, and most important, respect were worth fighting for and even dying for. We honor all of those brothers and sisters who came before us in teaching us all that, as Frederick Douglass once said, "The struggle may be a moral one, or it may be a physical one, or it may be both moral and physical, but it must be a struggle. Power concedes nothing without a demand; it never has and it never will."

The occasion of the celebration of Black History Month is an appropriate time to note that Pennsylvania, like many other States all across the country, has a problem with hate crimes. Dr. King once said, "When evil men plot, good men must plan. When evil men shout ugly words of hatred, good men must commit themselves to the glories of love." This quote is especially noteworthy during a time in which our Commonwealth and our entire nation have witnessed an upswing in the number of hate groups and crime activity. Sadly, as you may know, our State leads the nation in the number of active hate groups.

We as policymakers must work diligently to see that racial violence and hate crimes do not go unnoticed and, instead, are

exposed as the cowardly acts they are. And on this note, you should know that I have requested that the House Judiciary Committee take a closer look at this matter by reconvening hearings on the issue of racial violence and intolerance, and I hope soon we will hold these hearings and develop solutions to combat what remains to be one of the greatest problems that this Commonwealth and nation have today, and that is racism.

Those who, like Dr. King, long for a time when racial hatred and violence are relics in America need to be united and encouraged to raise their voices against such heinous acts, and it will take a concentrated effort by all fair-minded individuals to correct the racial division in America that has plagued this country for far too long, especially as it relates to racial hatred and violence.

So today we celebrate Black History Month. However, we should all focus as well on the future of blacks in our Commonwealth and our entire nation. It is up to us to ensure that the history of blacks in this country will pale in comparison to the greatness of contributions that they will make in the years to come. Our forefathers and our foremothers had dreams of a better nation. It remains up to us to make those dreams a reality. We should remember that black history is not just a history for African-Americans but a history for all Americans.

The SPEAKER. The gentleman, Mr. George, desires recognition?

Mr. GEORGE. Yes, Mr. Speaker, I do.

The SPEAKER. The gentleman will state the reason for desiring recognition, please.

Mr. GEORGE. Mr. Speaker, I noticed with extreme concern that again we have gone over an education bill, and when the Speaker feels that he can allow me to address that, I would hope that, in all fairness, since we had a forum today and had scores of people that are concerned about what had taken place in Pennsylvania and the fact, Mr. Speaker, that this involves my colleagues on the other side of the hall in regard to their districts, I would like to address the fact that, very carefully, without being partisan, that I think this is wrong, and I would like to be able to present that.

I think, Mr. Speaker, you would be, and I would not want you—

The SPEAKER. Will the gentleman yield.

The members will please come to order. The House will come to order.

The gentleman, Mr. George.

Mr. GEORGE. Mr. Speaker, thank you.

Mr. Speaker, I am not going to stand here today and order a special order of business or get cute in that I am no match for you in parliamentarian business, but what I can say to you and I am sure you will respect, that today we had a news conference. We had dozens of people there; we had people representing almost every entity concerned with education, and the fact remains that there are 71 school districts, Mr. Speaker, that do not know what they are going to do when July 1, 1998, comes about. I am simply saying that we have a problem.

We attend to emergencies and catastrophes, Mr. Speaker, and this happens to meet that qualification of a catastrophe or an emergency, and we are going to continue. It is not fair to the Democrat legislators; it is not fair to the Republican legislators; Mr. Speaker, it is not fair to you; it is not fair to me. We have got to address this matter. If they have the votes to knock it down, so be it. Let them go back into their districts, Mr. Speaker, and tell them they turned down the call for help.

All I am saying is, Mr. Speaker, that I am going to ask you for permission to address this every time they go over an educational bill, because, Mr. Speaker, if I was not right, I would not be standing here questioning this.

Mr. GEORGE. Mr. Speaker, it will not take an hour to explain this. We should be rational, intelligent people.

All this amendment insists, that where some realtor or some landlord has abused badly a situation and where they have made it very difficult for an individual to live and where they are collecting rent, if that abuse comes about and the individual involved is a senior citizen, then all it does is take a fine that is now in the law at \$1,000 and raise it to no more than \$1,500.

Mr. Speaker, again, I implore these colleagues of ours, there are Republican areas that have as many senior citizens living in rented housing as Bud George does, and I ask simply that we allow this amendment to take effect and raise that fine \$500 more where we are abusing our senior citizens.

I ask for their support.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to HB 14, PN 2851, entitled:

An Act regulating the check-cashing industry; providing for the licensing of check cashers, for additional duties of the Department of Banking and for certain terms and conditions of the business of check cashing; and providing penalties for money-laundering activities and violations of the act.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. On that question, the Chair recognizes the gentleman from Philadelphia County, Mr. Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I first would like to extend my personal thanks and appreciation to leadership and members of my caucus. Also, I would like to extend thanks and appreciation to you and to the majority leader and members of the other caucus that have spent a lot of time in developing HB 14.

HB 14, with the Senate amendments, is a compromise bill which provides consumers throughout Pennsylvania with protection while at the same time balancing the interests of the myriad of check-cashing businesses throughout Pennsylvania.

The amendments are supported by leadership from all four caucuses, and I strongly urge concurrence on the Senate amendments in HB 14.

The SPEAKER. The Chair thanks the gentleman.

Has the gentleman concluded his remarks?

Mr. THOMAS. Yes, Mr. Speaker. I am open for any questions. But as I mentioned, this is a consensus on the amendments in HB 14. HB 14 will provide the kind of protections that were intended by this body when we sent HB 14 to the Senate, and the bill will provide and bring Pennsylvania in line with the rest of the northeastern corridor in providing a regulatory scheme for these business activities in the Commonwealth of Pennsylvania.

The SPEAKER. The Chair thanks the gentleman.

Mr. Hasay.

Mr. HASAY. Thank you, Mr. Speaker.

Mr. Speaker, HB 14 has been worked on for a number of years. It has been now 7 to 8 years since Mr. Thomas has been working on this important piece of legislation. Mr. Thomas has not given up. When Mr. Thomas came to me as chairman of the House Commerce Committee, he asked me to look at the bill because of what is happening to his people in his district with those check-cashing people and the rates that they were charging. So we passed the bill in committee and we passed the bill here on the floor and it got sent to the Senate; that was approximately 7 years ago, and over in the Senate, it died and it was buried and nothing happened. Mr. Thomas came back to me, drafted it again, went through the process again, and the same thing happened.

Now, because of what is more knowledgeable about check-cashing people and the rates that they have charged these poor people, there need to be limits put on the fees they charge. Mr. Thomas has worked that way. It came back from the Senate. This is the best that we can get from the Senate.

And the other problem is, if we do not concur in the bill today, it may go back to the Senate and not come back to help the people that Mr. Thomas is trying to help.

So I ask the House, concur in the Senate amendments to HB 14. Thank you, Mr. Speaker.

The SPEAKER. On the question of concurrence, Mr. Thomas, do you seek recognition again?

Mr. THOMAS. Yes, Mr. Speaker, only to add to what Chairman Hasay has mentioned.

This bill is not only designed to protect people in my legislative district but in legislative districts throughout Pennsylvania, and I will cite one example. Throughout this process, I received a letter from a member from Montgomery County. Some years ago no one would have thought that Montgomery County was a place where you would have check cashers overcharging people, but I received a letter from this member talking about a disabled vet in her district who had gone to cash his check and was charged 11 percent, almost 11 percent, to cash a check that totaled about \$600 or \$700. So the problem is not just limited to Philadelphia County; it is in Montgomery County; it is in Allegheny County; it is in Berks County; it is in Erie County.

Whether it be a stationary facility or whether it be a mobile unit, the problem is the same. Without a regulatory scheme, check cashers are free to charge whatever they want, under whatever circumstances they want.

So I urge each and every member from both sides of the aisle to concur on HB 14.

The SPEAKER. The Chair thanks the gentleman.

An Act amending Title 24 (Education) of the Pennsylvania Consolidated Statutes, further providing for creditable nonschool service.

On the question,

The SPEAKER. For the benefit of the members, the amendment that the gentleman, Mr. George, desires to offer requires an actuarial note; all parties agree that it requires an actuarial note.

HB 908 is called up at this time. The Chair was about to recognize the gentleman, Mr. George, but had a conference with the gentleman and at that conference pointed out to him that his amendment required an actuarial note. The actuarial note is something that is required by statutory provision; it is not something that can be waived by suspension of the rules.

The gentleman, Mr. George, requested an opportunity to address the issue, and the Chair at this time recognizes the gentleman for that purpose.

Mr. GEORGE. Thank you, Mr. Speaker.

I address you for this purpose and this purpose alone in that I have asked the Speaker and he has ruled, and I think fairly, in that I attempt to remediate or amend the bill, HB 908, by offering an amendment that will take care of about 4,000 school retirees that are not eligible for health insurance premium assistance because they do not have a carrier approved by the Public School Employees' Retirement Fund. I would listen if I were you because you are going to get a lot of calls on this.

The assistance amount of \$55 also has not been augmented to meet the health insurance premium increases since 1992. What this amendment would do, it would increase the amount of health insurance premium assistance from \$55 to \$162 per month or the

actual monthly premium, whichever is less. It would also add subsection 8509(d), which would disallow the Public School Employees' Retirement Board from restricting annuitants from their choice of who their insurance carrier should be. This is important.

I asked the Speaker what could be done, and he assures me that it takes an actuarial study from the Retirement Board. Even though the Appropriations Committee did attempt to get it, my argument to the Speaker is, how could I possibly get this if the bill just came out of the Appropriations Committee yesterday?

I have asked the sponsor if he would hold up on the bill, and I respectfully understand that he refuses to do so. I ask that when I bring this amendment forward, by that time you will all agree we have got to do something about this problem and hopefully we will be able to do it.

I thank the Appropriations chairman. I thank the Speaker for your flexibility.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

- (ii) Service for the period of time spent on a maternity leave of absence required by the employer, which creditable service shall not exceed two years per leave and shall be applicable only to a maternity leave that was mandatory and began after May 16, 1975, and prior to November 1, 1978. The purchase of this service shall begin within one year of the employee's eligibility to purchase the creditable service under this subparagraph.

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the gentleman, Mr. Lloyd.

Mr. LLOYD. Thank you, Mr. Speaker.

Mr. Speaker, the House passed this amendment before, and what it is designed to do is to close a loophole that was created when we enacted this statute a number of years ago to give retirement credit to teachers or other school employees who had been forced to take a leave of absence because of maternity. Back in 1975 the State Human Relations Commission issued an order indicating that that could no longer be done, that that was illegal. There were about 52 school employees around the State who worked for school districts which, for whatever reason, did not follow that order. Whether it was because they did not know about it or because they discounted it, they did not follow it. Subsequently, in November of 1978 there was a Federal law enacted.

The purpose of this amendment is to allow those 50-some employees, who should have been covered when the law originally passed but who were not, to take advantage of the opportunity to buy their time and get retirement credit for the time that they were forced to take maternity leave.

Mr. Speaker, as I indicated, this amendment passed last year overwhelmingly, and I would ask for an affirmative vote.
