Today we have some special guests. First, Mrs. Louise Chase, department commander of the Pennsylvania Department of the American Legion. Mrs. Chase is a World War II Navy veteran and was elected as the department commander at the conclusion of the 79th Convention on July 20 of 1997. It should also be noted that Mrs. Chase is the first female department commander of the Pennsylvania Department of the American Legion. She is with us over here at your left, Mr. Speaker.

With her today is Mr. Anthony G. Jordan, who is the current national commander of the American Legion. Anthony Jordan of Augusta, Maine, was elected national commander of the American Legion on September 4, 1997, at the close of the organization's 79th National Convention in Orlando, Florida. Mr. Jordan served in the U.S. Army from 1963 to 1965 and joined the nation's largest veterans organization in 1966. Mr. Jordan has served as chairman of the National Security Commission, chairman of the National Membership and Post Activities Committee, chairman of the Foreign Relations Council, member of the National Subcommittee on Committees, and liaison to the National Finance Commission. Mr. Jordan is a member of the Bradford-Sortwell-Wright American Legion Post No. 54 in Wiscasset, Maine, where he served 2 years as post commander. He served as a commander at the county and district levels and as commander of the American Legion Department of Maine, 1979 to 1980. Mr. Jordan was Maine's alternate member of the American Legion National Executive Committee, the Legion's board of directors, from 1980 to 1982. He served as a national executive committeeman from 1982 to 1990. Mr. Jordan recently retired from the Maine Yankee Atomic Power Company after 26 years, and he and his wife, Claudette, have six grown children. Mr. Jordan is currently on a 50-State tour of all the American Legion State department headquarters as well as various American Legion posts across our nation.

Mr. Jordan, I would like to officially welcome you to Pennsylvania and to thank you for all that you and your organization do for our Commonwealth veterans. Thank you for being here.

Mr. Speaker, we have several other guests with us, who are in the back of the floor of the House, who are accompanying Commander Jordan and Commander Chase today. We have

Section 5. Powers and duties of board.

The board has the following powers and duties:

(6) Prepare and submit by May 1 each year an annual report [for] to the Governor and the General Assembly, including recommendations for legislative action and regulatory change when needed and appropriate.

Amend Sec. 3, page 2, line 10, by striking out "3" and inserting

In recent years, this report has not been submitted in a timely fashion, and this amendment would require the department to meet its statutory requirement.

I would urge that we would adopt this amendment.

#### **RESOLUTIONS PASSED OVER**

The SPEAKER. Page 7. HR 320 and HR 330 are over.

Mr. PERZEL called up HR 357, PN 3023, entitled:

A Resolution adopting a temporary rule of the House relating solely to amendments to and debate on the General Appropriation Bill and all nonpreferred appropriation bills, for the fiscal year 1998-1999, including amendments or supplementals to appropriations of prior fiscal years.

On the question,
Will the House adopt the resolution?

The SPEAKER. Mr. Itkin, do you desire recognition on this resolution? Mr. Itkin, you are recognized.

Mr. ITKIN. Mr. Speaker, as I understand, HR 357 is a resolution to adopt a special rule dealing with the budget. Let me say, Mr. Speaker, that I was only one of two members in the Rules Committee that voted not to move this special rule to the House floor. I come from that perspective—

The SPEAKER. Will the gentleman yield.

Conferences on the floor will please break up. Members of staff who are not involved in the debate of this resolution will please be seated or leave the floor.

Mr. Itkin.

Mr. ITKIN. Mr. Speaker, has the resolution been distributed? One of my colleagues on the House floor has asked that I make that observation.

The SPEAKER. It is my understanding that it has been. If there is anyone who does not have it—

I am told it is in the books.

Does anyone specifically need a copy? Ms. Mundy.

Mr. Itkin.

Mr. ITKIN. Thank you very much, Mr. Speaker.

As I was mentioning, I was one of only two members of the House Rules Committee that opposed moving this resolution to the floor for your consideration today. My principal opposition to the resolution is because it stifles the General Assembly, us as members of the House of Representatives, from fully using the revenues that will be collected by the State in order to fashion a State budget.

We know, you know and I know, that because of the strong national economy, this Commonwealth is rolling in dough.

The SPEAKER. Will the gentleman yield.

The conferences in the vicinity of the gentleman, Mr. Itkin, will please cease. The members will please take their seats in the area of the speaker. It is distracting to the speaker – not this Speaker, to the member speaker, and this Speaker.

Mr. Itkin, I apologize,

Mr. ITKIN. Well, thank you, Mr. Speaker. I appreciate the attention of the House today.

Anyone who is of knowledge who says that the State is not rolling in dough, does not have excessive revenues, is lying. We know that. We know that. We look at those revenue predictions and the revenue collections month to month and we know that large surpluses are accruing, yet this resolution does not address the total amount of revenue coming into Pennsylvania.

So where is this money that we know is accruing into the State Treasury and yet this resolution talks about balancing a budget and appropriating in one fashion or another all of the State revenue?

Mr. Speaker, this hidden money, this hidden money that we are not addressing today, does not belong to us. It belongs to the people we represent; it belongs to the people of Pennsylvania, and if we are not going to use it, if we are not going to use it, we ought not to hoard it; we should give it back, and that is my strongest contention in opposition to this resolution. We must consider what the total revenues are going to be, accurately, responsibly, and then decide to give what we cannot use and do not need to use, give it back.

This resolution, in essence, denies the existence of hundreds of millions of dollars in surplus money. That is real money that is coming in today and tomorrow, and we are really just the keepers of those funds. It does not belong to us, because we are not able to appropriate it.

Year after year there is a general pattern emerging with the Ridge administration. The Governor lowballs the State's estimates, and then at the end, after we pass the State budget early this year, lo and behold, uncovered hundreds of millions of dollars in politically convenient surplus. What a wonderful thing that we found as we adopt the budget in April, and then come June 30 we have all of this additional money that just fell into our pockets.

Now, if you compare what we do in Pennsylvania with what other States do, they return those surpluses in the form of tax cuts and highway repairs as one instance of how to spend additional excess revenue. Not Pennsylvania, however. Pennsylvania hoards its surplus, and we have now, as you know, building up this huge amount of money in this Rainy Day Fund, this huge amount of money in the tax reconciliation accounts that we do not need to.

The last time I checked, it was told that diverting public money for anything other than its intended purpose was called embezzling. Obviously, I do not believe that any one of us are embezzlers, but this resolution puts us uncomfortably close to that definition.

So let us conveniently do the math — a potential half-a-billion-dollar surplus, \$50 million in the Rainy Day Fund, and the suggestion that all we have is a \$132-million overage that is to be appropriated by this resolution, and what that does is to leave, if my math is correct, \$318 million in taxpayer dollars that is not returned to the taxpayers; \$318 million that is hidden from public view, unaccounted for in this resolution.

Pennsylvania's middle class, the vast majority of the 12 million people that we 203 represent, deserves a rebate. They do not get a Pennsylvania income tax cut this year; they do not get a business tax cut this year, and interestingly, they do not even get a refund on their overpaid taxes, and we could do it easily with property tax cuts. And who is looking out for the interests of Pennsylvania's

working families? Not this administration. And if we pass this resolution—

The SPEAKER. Will the members take their seats; will the members please take their seats. The conferences in the corner of the hall, please break up.

Mr. Itkin.

Mr. ITKIN. Thank you.

Apparently, if we pass this resolution, then it gives the appearance that this House is not interested in Pennsylvania's working families. This resolution does not move us toward property tax cuts, which is on the minds of most of the members of this General Assembly, and it perpetuates an unconscionable surplus, which has been taken, unreasonably taken, from our taxpayers.

I believe that we should do a meaningful budget process, considering all of the revenues that are projected to this State's Treasury, to return those moneys that we do not need in developing an adequate State budget. I would personally – and I hope you do – want to return those moneys to their rightful owners, the people of Pennsylvania, and we can only start that process if we are willing to accept that there is a huge surplus, and so we can make the right determination with respect to any type of tax relief, perhaps it should be, in my judgment, property tax relief.

So, Mr. Speaker, I am going to urge that we not support this resolution and change the dollar amount so that we can take advantage of giving the people of Pennsylvania some consideration to their tax overburden.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

Does the gentleman, Mr. Cowell, desire recognition? The gentleman is recognized.

Mr. COWELL. Thank you, Mr. Speaker.

Mr. Speaker, Representative Itkin is correct. This resolution, this proposed rule, this year is a bad deal for the taxpayers of Pennsylvania. This is a year when we ought to be trying to solve some problems. The State has an enormous surplus that is growing every week, and we ought to take advantage of that surplus, of this opportunity to solve some problems of Pennsylvania, particularly problems affecting local taxpayers throughout the Commonwealth.

We are into this hurry-up mode, this hurry-up schedule to pass a budget, in part because we want to look good. We want to look like we can move the process along expeditiously, but part of the agenda is we do not want the taxpayers of the State and even some members of the General Assembly to understand truly how large the surplus will be this year. And if we do all of this now rather than waiting a few weeks, we can embrace a far too conservative figure.

This proposed rule artificially assumes that we have \$260 million to neatly divide between the two caucuses. The way this rule is constructed, as a practical matter, there can be no consideration of any substantial amendment that would significantly reduce property taxes all over this State, school property taxes in particular. As sure as we are sitting here today, 2 or 3 weeks from now we will hear the Speaker rule amendments out of order, amendments that would reduce property taxes, amendments that would have the State pay a more fair share of school bills so that local school taxes could be reduced, the Speaker will rule those amendments out of order because of this proposed rule that we would adopt today.

Mr. Speaker, usually, or let me say often at least, this kind of rule makes sense when we have a long list of new, big, costly spending proposals, but this year the real debate is about how we can return some of this big surplus to local taxpayers. The real debate on the minds of many Republican and Democratic members and taxpayers all over the State is how the State is going to end this practice of accumulating these large surpluses that make us look good while we are causing local property taxes to go up in school districts all over the State. This is the year when we ought to have the State pay a more fair share of the cost of special education in particular and basic education generally, and we can do that by returning more of the surplus to school districts and to local school district taxpayers throughout the Commonwealth, but we will not have the opportunity to do that; we will not have the opportunity to consider those amendments if we pass this change in the rules today.

Those who support this today will be voting to close the door on any opportunity to substantially reduce school property taxes across the State. We ought not to do that; we ought not to close the door. We ought to at least fashion a rule that will allow those kinds of amendments to use the big surplus, to use all of it or most of it to reduce school property taxes throughout this State, and we can fashion a rule that would permit that. This rule does not do it; this proposed change does not do it. This proposed change in the rule, a temporary change, which admittedly is like some that we have employed in past years, this year will have the effect of making sure that the State surplus grows while we fail to have the State pay a fair share of the cost of public education in this State. The State surplus will grow while local property taxes continue to grow.

Mr. Speaker, I urge that we take advantage of the opportunity this year to solve a problem, to solve a problem of high school property taxes, a problem that exists because for the last several years the State has been accumulating a surplus while not sending a fair share of dollars back to our school districts. We look good in Harrisburg we think, while we are socking it to our local school districts and our local school district taxpayers. Let us begin to solve that problem. Let us not close the door on an opportunity to solve that problem.

Let us defeat this proposed rules change.

The SPEAKER. The gentleman, Mr. George. Did you desire recognition on this point?

Mr. GEORGE. Thank you, Mr. Speaker.

I will not be long.

Mr. Speaker, I noticed that when the gentleman, Mr. Itkin, first started his presentation, he made us aware that there were two individuals that had voted "no" in the Rules Committee. He insisted that he was one, and I am most certain that I was the second.

Now, when I went over to the majority leader and asked him how the vote had gone, he said, and if I can quote him, "Well, I voted 'yes' and you voted 'no.' "And I guess he is very happy that he voted "yes," and honestly, I concern myself that there were only two noes in that, as a minority party, we should be more inclined and more reserved in attempting to do what is right. And, Mr. Speaker, you more than I know that the majority will have their way, but as the minority, we ought to have our say.

Now, I do not know how much money, Mr. Speaker, is in the budget. I do not know how much of a surplus there is. I do not even know if the Governor knows because constantly they deny the amount that is listed in the papers. All I can say is, Mr. Speaker, none of us come down here and bring it all back home, but the important thing, Mr. Speaker, is that we speak to each other in the manner in which those back home would appreciate and expect us to.

Mr. Speaker, you know already that I am not going to vote for this even though I was honorable enough to vote for the suspension, but the truth of the matter is, only when there is an alternative is there a fairness in what we do and what we deliberate.

Again, we will go through a year when we are expected in our guises whether it be to find moneys for 54 schools that will be destitute in a couple of months or whether we want programs that we know are worthwhile. The only way we will get them after the amendments are used up and called for by the Speaker, those of us that are left in the rear will have to offset, and so what we will do, Mr. Speaker, is we will be asked, in order for us to provide the proper amendment for those things that we know are needed in your district and mine, is that we have to offset something you or your district want or something that I or my district wants. I think it is wrong. Hopefully, things this bad will not last forever. Thank you very much.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. Sturla? The gentleman is recognized.

Mr. STURLA. Thank you, Mr. Speaker.

Mr. Speaker, yesterday in the morning I had a meeting with my local school officials and there were other school officials from the entire intermediate unit, and my school officials were asking me whether in fact in this year's budget, given the surplus that we had, whether we were going to solve the problems of special education among the other myriad of problems that the school districts face right now. And I said, well, I am not sure; my sense is that they will be squirreling money away in the Rainy Day Fund instead, and the school official looked at me and he said, tell them it is raining in Lancaster.

My Republican school officials in Lancaster need help. My Republican mayor has put on hold a police station because we do not have the local dollars to do it, and we are sitting on hundreds of millions of dollars in the State. We are not building police stations; we are not funding special education; we are not doing the business of the people of Pennsylvania when we hoard these dollars.

I would urge a "no" vote on this resolution and allow us to free up some of the funds that we are currently hoarding. Thank you.

The SPEAKER. Mr. Olasz, you desire recognition?

Mr. OLASZ. Thank you very much, Mr. Speaker.

I hope you would rest your jaws for a moment and give some serious consideration to what I am going to say and then think about it, think about it very thoroughly.

This is no joke; this is for real. I come from a town – and I am repeating myself for many, many times in this chamber – my hometown was once the home of the largest steel mill in the country, in the world. There was not a warship afloat up until the Vietnam War where the armor plate did not come out of U.S. Steel Homestead Works. Their position today is felt by six other school districts in western Pennsylvania. They are distressed because the

industries are gone. There are no buildings out there anymore, and I challenge the Governor to come out there and show me where these 250,000 jobs are because we do not even have buildings in western Pennsylvania to put people to work anymore.

There is a huge surplus out there. We talk about, let us not waste the mind; it is a valuable thing. Well, if you do not permit us to put money into those distressed school districts – they have met with the Secretary of Education; they have pleaded for help out there – and if we do not give them help, then do you know where they are going? They are going to declare bankruptcy, and it is a shame and a disgrace that a Commonwealth, with its cash drawers bulging and the dollars overflowing, that we cannot aid these distressed school districts.

You take a look at those children. Is building jails the answer? Maybe that is what you want, is build jails. My thought is, build an education; give them the necessary money to get out of the desperate straits they are in.

You think about it and vote properly, and vote your conscience. Thank you.

The SPEAKER. Mr. Colafella.

Mr. COLAFELLA. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose HR 357.

What this resolution simply means is that the surplus that we have, over \$700 million, will not be used to solve problems and to help people in Pennsylvania. Quite frankly, I thought that is why we were sent here, to represent the people and do the best we can so that we can help them live a good life.

This resolution is a signal to us and it should be a signal to all the people in Pennsylvania that we do not want to do anything about special education. Just let the schools keep eating these costs and let property taxes just keep increasing and we do not really care. We just do not want to spend the surplus, and that is the tax money that they have sent to us.

We do not want to do anything about higher education tuition. We do not want to give any more moneys to our colleges and universities because we want to hoard our money, and why, I do not know, and we do not want to do anything about reducing the personal income tax in this State.

I think if you vote for this resolution today, I think you are saying to the people of Pennsylvania you do not want to do anything about solving any of these problems; you just want to save this money and save this money and just let people fend for themselves.

Mr. Speaker, I urge everyone to vote against this resolution.

The SPEAKER. Does the gentleman, Mr. Jarolin, desire recognition?

Mr. JAROLIN. Thank you, Mr. Speaker.

Mr. Speaker, on this particular resolution, it is going to keep us from trying to put any amendments into that piece of legislation.

Nanticoke City, my hometown, had a population of 25,000 people. Today it is down to 11,500. The school district is almost \$2 million in the hole. The millage for the Greater Nanticoke Area School District, I believe, is 212 mills. The city of Nanticoke is \$1½ million in the hole. They just bargained with a big loan to pay that back, and that is the third loan they have got coming.

Our base in Nanticoke is a senior citizen population, which turns around, I would say, in the vicinity of about a 30-percent problem. Those people have got to be taken care of. We have got three senior citizen highrises, not telling you how many more people are out in their own private homes that are over the age of 65, which is extremely difficult for those people that pay their taxes

Mr. Speaker, I beg the legislators to vote against this resolution. Thank you.

The SPEAKER. On the question, the gentleman, Mr. Trello.

Mr. TRELLO. Mr. Speaker, about a month ago a number of Representatives, five or six of us from western Pennsylvania, met with eight superintendents of the school districts back in western Pennsylvania, and the topic was the Midland School District. I do not know if you are familiar with the Midland School District, but the entire school district is being transported to East Liverpool, Ohio, under a voucher program to go to school because they have no money to keep their school open. On several occasions they tried to merge with rather affluent school districts but were turned down; they did not want them.

Now, I think that is a travesty that Pennsylvania kids have to be transported to Ohio to get their basic education. There were 12 superintendents there, and each and every one of them are having difficulty. Some of them are having difficulty adding additions to their school; they are using a trailer for a classroom because they do not have the money to expand their school district. These are all school districts that have lost their tax base over the years – the devastation of the steel industry – and I do not really think it is fair that we have a surplus and our amendments have to be revenue-neutral. That simply means you are going to have to take away from somebody else to give to someone, and I do not really think that is fair.

I think we should take a long, hard look at what we are trying to do here today and consider the problems that we are having in our school districts. The most serious problem we are having is the fact that the lack of funding for these school districts is causing an increase in local real estate taxes. My district is about 54 percent 65 years and older living on a fixed income, and that is a terrible travesty for those senior citizens to pay increased taxes.

Since we have this surplus, why do we not take a long, hard look at everything and see if we can solve just some of the problems without having our amendment be revenue-neutral, and I would urge this body to do just exactly that.

I am going to have to vote "no" on this because of the problems I have, not only in my district but my adjoining districts. Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Evans.

Mr. EVANS. Mr. Speaker, I have been listening to some of my colleagues, and I have been here 18 years, and we have complained about not being involved in the process on both sides of the aisle, and we have complained, when we do not open up the process, we are doing it in some backroom, that there is some group of legislators, which are the ones that you elect, sitting in some backroom making the decisions.

For the last couple years that I have been chairman, since 1990, and even when the time that I was chairman, I have tried to encourage an openness of the process, and that is not to say that all of you or any of you individually will agree with that opening of the process. This is just the beginning of the process. This is just a rule that will set up a guideline; no more different than what we did last year. We set up a guideline, we set up a framework, and the members had the opportunity to offer amendments within a parameter of the dollars that were available.

Now, I understand that some members are subjective about the dollars that are available, and that is understandable, but we need to begin this process, and it begins with the acceptance of this particular rule. Once this rule is accepted, Mr. Speaker, then it goes from this rule to the Appropriations Committee; they will vote it out of committee. Members have an opportunity, on both sides of the aisle, to offer their amendments. If they want to change something that they offer, then they try to do a suspension of the rules. They then try to convince a certain amount of the members to agree with the suspension of the rules.

Now, this is a part of the process. Most of us, all of us, have been around here, except for a few of the members who have been elected, long enough to know that, yes, it is nice to play the little games, but the fact of the matter is that this is the beginning of the process; it is not the end.

Some members have asked, well, Dwight, do you have some kind of guarantee from my colleagues on the other side of the aisle? No, I do not have any type of guarantee from the members on that side of the aisle. The only thing I have asked, as the Democratic chairman on this side of the aisle, that the members on that side of the aisle, who are in the majority, that they be fair to our members. Now, it is all subjective in terms of what people mean by fairness, but the fact of the matter is, we need to begin this process and we need to begin this process now by accepting this rule.

So, Mr. Speaker, I stand to say that I am supporting this resolution. I supported it last year; I am supporting it this year. I hope, Mr. Speaker, that this can be something that is bipartisan; it is not something that it is the Republicans or the Democrats, but that we move in this process, move this process along, accept this rule, accept this rule, and then begin the debate about the budget in terms of the direction of Pennsylvania. There is no question that I have some differences with this budget. I do not agree with everything that is in this budget. I do not agree with every recommendation that this Governor has made, but I do, Mr. Speaker, agree that we should set up some guidelines, and this rule is no more than a guideline so we can begin that process.

I would ask all members to consider voting "yes" on this resolution. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question, the gentleman, Mr. Maher.

Mr. MAHER. Mr. Speaker, I have been listening intently to all of the discussion about the supposed surplus, and I am concerned. I am very concerned that my colleagues across the aisle are confusing the public, as unlikely as that might be and as unintended as it might be.

The fact of the matter is that the surplus that is being discussed for last year amounted to less than 3 percent of the entire budget. For this year it amounts to less than 1 percent of the entire budget. In both cases, I think what we have is a demonstration that this administration and this legislature has done an awfully good job of being financial stewards. Being 1 percent in the black, being 3 percent in the black, is hardly hoarding surpluses, but more importantly, Mr. Speaker, if we can continue this stewardship, we may have an opportunity to start retiring Pennsylvania's debt.

With all this discussion of surpluses, there has been very little attention to the \$10 billion, roughly, which Pennsylvania has accumulated in debt over the years, and with good luck and good stewardship and 20 years of these surpluses, we might be able to

in fact retire that debt, and I think that is an important consideration as we look forward.

So a resolution which inspires us making choices, just as the families in our districts have to make choices to live within their means, is certainly one which I will support. Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Walko.

Mr. WALKO. Thank you, Mr. Speaker.

I would just like to clarify, Mr. Speaker, for the people of Pennsylvania. Yes, these percentages might be small; 4 percent is a small percentage number. But last year, Mr. Speaker, we had a \$700-million budget surplus. Now, that is a big number. That can do a lot of good for a lot of people in Pennsylvania. How many property-tax payers do you know in your district who cannot afford to keep their homes? A lot of people are stressed in Pennsylvania, and if \$700 million is only 3 percent, I do not care; \$700 million is a lot of money, and this year we are looking at perhaps \$400 million. I do not care if that is .00001 percent; \$400 million is a lot of dollars. It could do a lot of good.

I do not think we should rush into this. There are a lot of needs out there in Pennsylvania. There are a lot of burdens that should be relieved. What is the rush? Let us wait, determine what the surplus is, and then use it for the benefit of the people of Pennsylvania. Thank you, Mr. Speaker.

The SPEAKER. On the question, the gentleman, Mr. Perzel. Mr. PERZEL. Thank you, Mr. Speaker.

I would like to thank both the Appropriations chairmen, Representative Evans and Representative Barley, for the last 2 weeks of budget negotiations and hearings that have been going on, and it has been a very, very good process, Mr. Speaker.

This is not a hurry-up. The Governor gave us his budget a month ago. It is the Governor's budget as he gave it to the General Assembly that has been put in.

We will be— One of the things we were trying to do is make sure that once we pass the resolution today, every member has 3 days to draft up the amendments to the budget document itself. If you want to cut taxes, you can cut taxes; if you want to cut spending, you can cut spending; if you want to put more money into the schools, you can put more money into the schools. This is, as Representative Evans said, only the beginning of the appropriations process.

We are only asking the members to vote "yes" on this resolution so that we can have some parameters, Mr. Speaker. I would urge a "yes" vote by the membership.

#### STATEMENT BY MR. GEORGE

The SPEAKER. The gentleman, Mr. George, seeks unanimous consent to address the House. The Chair hears no objections.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, I believe what I am about to say needs to be said, and I thank you for the opportunity for unanimous consent.

Honestly, Mr. Speaker, my original intent was to have a House resolution, a condolence resolution drafted, but I felt that a few remarks on the House floor may be more effective.

I would like to be the first to pass my condolence to the Governor, Tom Ridge, on the recently published statistics that show Pennsylvania has achieved a dubious new distinction. For the first time in the history of the Commonwealth of Pennsylvania, Pennsylvania has accepted more out-of-State waste into our landfills—

Mr. PERZEL. Mr. Speaker, I object.

The SPEAKER. Will the gentleman come to the rostrum; both gentlemen come to the rostrum.

Mr. GEORGE. Mr. Speaker, before I come to your rostrum, because I respect you like no other man in this House, I am going to say to you that you have watched me for 24 years and you have seen me every day. I have only missed 1 day in 24 years, and I have been honorable. I have not been partisan, because I get elected back home by Republicans. Well, Mr. Speaker, Mr. Speaker, tell those Republicans that I get more Republican votes sometimes than they do.

Now, let us do this right, Mr. Speaker. I do not want to fight with you. I have got too much respect for you.

The SPEAKER. Mr. George, come up and visit with me.

(Conference held at Speaker's podium.)

The SPEAKER. Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker, and I also thank the majority leader for his indulgence. Even at times he can be wrong, Mr. Speaker; not often, but when he is, he is darn wrong.

The SPEAKER. You are getting close to making that same mistake. Why do you not make your speech.

Mr. GEORGE. Thank you.

Mr. Speaker, before I was interrupted by the gentleman, I was simply trying to make a point. I do not know who you would blame it on when trash is coming into the State as it is. You could not blame it on us, especially those of us that have tried to stop it. I do not want to criticize the Governor per se, but he is the chief administrator.

Mr. Speaker, for the first time in history, as I said, the Commonwealth has accepted more out-of-State waste into our landfills than what we have produced inside of our own borders. The responsible citizens of this Commonwealth have recycled 26 percent of the waste we generated in 1996. As a result, we sent only 6.7 million tons to landfills across the State. In contrast, we opened our doors and imported 7 million tons of trash from our neighbors. Our DEP (Department of Environmental Protection) has allowed, projected that number will grow to 8.5 million tons when the 1997 data is tabulated.

I feel it is important to note that after all of the bells and whistles and proclamations and executive orders from the Ridge administration on this issue, one fact has remained abundantly clear: Sadly and tragically, Pennsylvania is still the nation's dumping ground.

And, Mr. Speaker, in conclusion, you will never see the day that I will walk out while one of them is talking, and I would say to you, if that is the way you do business, then somebody is not being represented properly.

Mr. Speaker, I thank you from the bottom of my heart.

Mr. COY. Mr. Speaker, I want to thank, candidly, the Chair and whoever else sought to make an accommodation to allow Representative George to speak. I think it was the right decision.

I for some time have advocated a change in the rules of the House to provide for a time for, as our brethren in the Congress of the United States have, petitions or remonstrances. I know that at times when I listen to that time when the Congress spends, there are often things said that I do not agree with, that I would rather not hear, but candidly, there needs to be a time when members have the opportunity, whether they are in the majority or the minority, to address the House and the people of Pennsylvania on matters that they feel to be important.

Whatever the issue, I think that every elected member of this House of Representatives needs to have that opportunity, and when they do not, the 55,000 or 60,000 people that they represent are disenfranchised and this body is cheapened by it.

So I thank the Chair for helping with the accommodation, and I look forward to the opportunity when members can continue to address matters that they believe to be important either for their district or for statewide policy. Thank you, Mr. Speaker.
