Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, I want to say a few words about this resolution, because I think it is important that we all realize what was accomplished with the Civilian Conservation Corps.

On April 23, 1933, the first CCC camp in Pennsylvania was established near Marienville. From that time until its last year of operation in 1941, the Civilian Conservation Corps compiled an impressive list of achievements which are still evident today. From hundreds of miles of stream improvement work, fire suppression projects and wildlife conservation to flood relief, recreation site work, and varied efforts to help stabilize our forest system, the Civilian Conservation Corps was responsible for these projects.

It is impossible to place a dollar figure on the corps' accomplishments in Pennsylvania, but every Pennsylvanian, whether directly or indirectly, has benefited from its works. For that, the Civilian Conservation Corps deserves recognition on its 65th anniversary, and I would encourage every member to take a copy of that resolution back to your district, because there are a lot of people who work in the Civilian Conservation Corps projects that are throughout the State. As a matter of fact, they have an annual meeting once a year, and I would encourage you to bring that resolution back to your district, because there are probably a lot of members that live in your district who have worked on these projects.

REMARKS SUBMITTED FOR THE RECORD

Mr. DeLUCA submitted the following remarks for the Legislative Journal:

- First camp in Pennsylvania and the second CCC camp in the nation established at Duhring, Pennsylvania, 10 miles northeast of Marienville, Pennsylvania, April 23, 1933.
- Helped "grow" the Pennsylvania State Park System and stabilized the Pennsylvania State Forest System. (According to Maurice Goddard.)
- Stopped the scourge of forest fires that regularly plagued the Pennsylvania forests prior to the advent of the CCC.
- 4) Constructed numerous preventative fire suppression measures such as building of fire lookout towers and stringing of hundreds of miles of telephone lines.
- Planted over 50,000 acres of trees on State and national land in Pennsylvania.
- 6) Constructed 2,000 miles of truck trails used for fire suppression.
- 7) Built numerous recreation sites on county, State, and national land within Pennsylvania.
- 8) Accomplished hundreds of miles of stream improvement work.
- 9) Conducted statewide antierosion projects.

- 10) Accomplished thousands of acres of timber survey projects.
- Did massive flood relief work throughout the State in 1936. (Saved millions of dollars of civilian-owned property as well as saving many lives.)
- 12) Conducted the largest night school program for enrollees in the State's history.
- Helped save the white pine population by eradicating the blister-rust threat.
- 14) Helped conserve and foster wildlife growth in the State. (Accomplished through food and cover projects, clearing of ponds and streams, and erecting small bridges and dams.)
- 15) Worked on restoration projects at Gettysburg and Fort Necessity.
- 16) Thousands of young men became proficient in work that offered a means of making a living in the future.

By June 1933, there were 40 camps in the State. That figure doubled by January 1933. The total increased to 90 in 1936. The last year of its full operation (1941), there were 52 operating CCC camps. Each camp had a complement of 200 enrollees and an operating staff of about 20 men. (This included army and civilian personnel who ran the camp and conducted the work projects outside the camp.)

The CCC was a total relief program: It provided work for the hopelessly unemployed young men who were paid \$5 a month; each enrollee's family received an additional \$25 a month while he remained in the CCC; army and civilian personnel gained employment from the CCC; and local communities received an economic infusion from the nearby CCC camps.

The CCC was an expensive program. It cost about \$1,000 per year per enrollee. But the worth of its accomplishments surpassed its costs exponentially. It would be impossible to place a dollar figure on the accomplishments of the CCC in Pennsylvania. Almost every person in Pennsylvania has benefited, directly or indirectly, by the works of the CCC.

That is why the CCC should be recognized on its 65th anniversary on March 31, 1998.
