## PENN STATE UNIVERSITY FENCING TEAM PRESENTED

Mr. HERMAN. Thank you very much, Mr. Speaker.

And for all you Penn State fans and Nittany Lion alums, I would like you to listen up for a little bit. Many of you have been asking me about the annual Blue-White Game at Penn State that was played Saturday, looking forward to the gridiron coming up this fall.

Well, Penn State has more than just football at the university; they have a lot of champions, and we are here today to honor three championship teams from Penn State. I have asked Representative Kerry Benninghoff to join me on the dais today to honor them in this regard.

Two of these teams are from the Penn State fencing team and also the Penn State ice hockey team. #### BILLS PASSED OVER

The SPEAKER. The balance of the bills on page 2 are over. Page 3 of today's calendar. All the bills on page 3 are over. Page 4 of today's calendar. SB 888 is over.

The House proceeded to third consideration of HB 591, PN 2587, entitled:

\* \* \*

An Act amending the act of July 31, 1968 (P.L.805, No.247), known as the Pennsylvania Municipalities Planning Code, further providing for the procedure for joint municipal curative amendments.

On the question,

Will the House agree to the bill on third consideration?

Mr. GEORGE offered the following amendment No. A0036:

Amend Title, page 1, line 20, by inserting after "acts," "

providing for regulation of sewage sludge; and Amend Bill, page 1, lines 24 through 27, by striking out all of said lines and inserting

Section 1. The act of July 31, 1968 (P.L.805, No.247), known as the Pennsylvania Municipalities Planning Code, reenacted and amended December 21, 1988 (P.L.1329, No.170), is amended by adding a section to read:

Section 106.1. Regulation of Sewage Sludge-Notwithstanding any other provision of law to the contrary, the governing body of every

They should have this right. We are asking you to concur with this amendment, if you will.

The SPEAKER. On the question, the gentleman, Mr. Saylor.

Mr. SAYLOR. Mr. Speaker, I would rise to oppose this amendment.

First of all, as we across the Commonwealth continue to talk about planning, we talk about county planning. We talk about tying our communities together and working cooperatively. If we start breaking down how we deal with the problem of sludge by municipality, we will never resolve that issue.

If this issue is to be looked at, it should be looked at on a countywide basis and dealt with from that point of view. What the Representative's amendment does is, again, goes back and does not allow for governmental cooperation, in my opinion, and again, it defocuses what we can do by working together.

I ask for a "no" vote on Representative George's amendment. The SPEAKER. The Chair recognizes the gentleman from Bucks, Mr. Steil.

Mr. STEIL. Thank you, Mr. Speaker.

I am also asking for a "no" vote on this amendment. There are a number of very good reasons why we should vote "no." The first reason is, contrary to the indication that has previously been given, I know of no municipal association that is asking for this authority, not one, and I do not think any member has any letters from any of our township associations asking for this authority.

As a matter of fact, giving them this authority gives them a liability which municipalities do not want. If we give them the right to regulate the deposition of biosolids or sewage sludge, we are giving them a liability even if they choose not to regulate such activities, because if they do not regulate and there is an incident, they will be held accountable. That is the reason why most municipalities do not want this authority, and their professional associations have specifically not supported this legislation.

Next, we should determine that this is already a regulated activity. The Department of Environmental Protection already has the responsibility to regulate. Placing another level of bureaucracy on top of the existing regulations is not going to change the problem if there is a problem. If this body believes that we need to have tighter controls and tighter regulation for the depositing of biosolids, then we ought to determine that the Department of Environmental Protection is responsible for enhancing their own regulations of this activity, not create another level of bureaucracy.

Lastly, we go back to the item that we are simply adding for another layer of bureaucracy, and if no municipality is asking for this, I am asking for a "no" vote, because it accomplishes and is another regulation that has no need. Thank you very much.

The SPEAKER. The gentieman, Mr. Surra.

Mr. SURRA. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the George amendment.

Under current law, Mr. Speaker, the State Department of Environmental Protection is the one that is authorized to determine where and when and how much sewage sludge or biosolids, as it is called, can be spread on our farm fields and strip jobs in the various land applications throughout Pennsylvania.

Mr. Speaker, this is not an amendment that requires local municipalities to have some oversight. It is a "may" provision. If you look at the amendment, Mr. Speaker, it says that municipalities "may" set the guidelines for the disposal of sewage sludge or biosolids.

Under current law, Mr. Speaker, some land applications of sewage sludge in Pennsylvania only have to be tested one time per year. The sludge has to be tested one time per year under some applications. And currently in Pennsylvania, Pennsylvania law allows 30 times more heavy-metal content in the sewage sludge that is applied in Pennsylvania than New York does under their law.

When the companies come to your municipalities and the public opposition occurs because they want to spread sewage sludge in your area, and your local government, the people go to your local townships and local borough officials and want some assistance in this, I hope you can tell them that you voted for the George amendment to allow them some oversight, because under current law, they have no oversight.

So I would ask that my colleagues support the George amendment.

The SPEAKER. The Chair thanks the gentleman.

On the question of the adoption of the George amendment, the gentleman, Mr. Jarolin.

Mr. JAROLIN. Thank you, Mr. Speaker.

Up in my particular area we have got all kinds of problems, whether they are dumps, sewage sludge, ash sludge, and it has been going on quite often.

I have to be in favor of the George amendment, and I certainly hope the rest of the legislators will vote with him on this particular piece of legislation. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question of the adoption of the George amendment, the Chair recognizes the lady, Mrs. Rubley.

Mrs. RUBLEY. Thank you, Mr. Speaker.

I also rise to urge that we vote against this amendment.

Currently there are extensive requirements that must be followed before biosolids can be applied to agricultural land.

Extensive testing must be submitted to the DEP. This takes qualified personnel who have to evaluate these tests.

Furthermore, I know from personal experience that in the past, DEP personnel would also go out to the farm sites, walk those farm sites to ensure that the soils were suitable for these biosolids. If this amendment were passed, municipalities would have to take upon themselves very extensive testing and analytical procedures that many of them really are not in the position to do.

Therefore, I urge that we do not support this amendment.

The SPEAKER. The Chair thanks the lady.

The gentleman, Mr. George, for the second time on his amendment.

Mr. GEORGE. Mr. Speaker, if any of us have an opportunity to admit their naivete, I guess this should be the time for me in that I never realized, Mr. Speaker, it was so hard to do the right thing, not only for Democrat legislators but also for Republican legislators.

Out in the foyer at this time there are lobbyists insisting that it will put sludge up \$15 a ton. That is what they are saying. But you know, Mr. Speaker, a lot of people do not know that if you put sludge application on lands that have been mined, you cannot even stop that application, because DEP controls that and they are not stopping it.

Mr. Speaker, let me at least apprise my good colleagues, and there are Republican colleagues that their constituents have called me for whatever reason, I guess because they understand I believe in this type of protection. This does not stop anybody from putting it on their land; it just gives a little bit more control to those areas that want someone to understand that there is a concern. They cannot stop it or block it.

DEP will say, well, we do not encourage it, but, Mr. Speaker, I want them to listen to this. Even though DEP says they do not encourage it, they give them their bond forfeiture money back I year earlier when they agree to put sludge in. So for those that are receiving the sludge and those that are making the money to send it in, if that is what we are all about, there is not much I can do to stop it. But then, Mr. Speaker, I would be remiss if I did not stick up for what I believe in my heart is right.

I am not personal on this. There are as many Republican legislators in the rural area that have these mining operations as I do. This is not for me; it is for everyone who has a concern, and all I can say is, if you want to do the right thing, then you will vote for it. If you do not want to do the right thing, you will listen to the lobbyists, you will listen to those that are making the money, and we will go about this continually trying to do the right thing, because that is what it is all about. Thank you.

The SPEAKER. The Chair recognizes the gentleman, Mr. Hershey.

Mr. HERSHEY. Thank you, Mr. Speaker.

I wish to speak on the amendment.

The SPEAKER. The gentleman is in order.

Mr. HERSHEY. Thank you.

I urge the body to vote against this amendment. I have some experience in this area. We applied to do this one time on our one farm, and I can say that the Department of Environmental Protection and the soil conservation district of our county spent a year and a half getting tests, citing where we could spread, where we could not spread. The soil conservation district has a long history of soil stewardship. They are very well highly regarded,

Mr. PISTELLA. Mr. Speaker, at the appropriate time, I would wish to be recognized for the purpose of correcting the record.

The SPEAKER pro tempore. We will do it now. Go ahead.

Mr. PISTELLA. Thank you, Mr. Speaker.

Mr. Speaker, I have not been recorded on final passage for HB 48. I wish to be recorded in the affirmative, please.

The SPEAKER pro tempore. The gentleman's remarks will be spread upon the record.

#### **OUESTION OF PERSONAL PRIVILEGE**

#### VOTE CORRECTION

The SPEAKER pro tempore. Mr. Lucyk, for what purpose do you rise?

Mr. LUCYK. Mr. Speaker, at the appropriate time, I would like to be recognized for a point of personal privilege concerning a vote taken yesterday.

The SPEAKER pro tempore. Under unanimous consent, the gentleman is recognized. Go ahead.

Mr. LUCYK. Thank you, Mr. Speaker.

Yesterday the House considered SB 981, and it was Mr. Roberts' amendment, I believe it was 0382, and at the time there was a lot of confusion on the floor concerning this amendment, and what the amendment did is it dealt with the admittance of the spouses of veterans to our State veterans' homes. As I said, there was a lot of confusion on the floor on the part of everyone involved, in the explanation by the prime sponsor of the amendment and both chairmen of the House Veterans Affairs Committee. I at the time misunderstood the explanation given by the people on the floor, and I urged our members to vote in favor of that amendment.

What I would like to say now is that under current law, the spouse of a veteran who derives eligibility for entrance must have been married to a veteran for 2 years. What the amendment would have done is increased this time period to 10 years or when the spouse was married to the veteran while the veteran was on active duty.

I clearly misled our members, the members on this side of the aisle, on this in urging for that vote. I voted for it. I would like to have my vote changed to be voted in the negative on that amendment.

Again I apologize, number one, to our members for misleading them and to the veterans and the members of the veterans communities in misleading our members in voting for that.

I thank you for your courtesy, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman, and the gentleman's remarks will be spread upon the record.

#### **VOTE CORRECTION**

The SPEAKER pro tempore. We will take one more before we get back to the voting calendar.

Representative Steelman.

Ms. STEELMAN. Thank you, Mr. Speaker.

During the voting on the nonpreferred appropriations bills, my vote was not recorded on SB 1341. I would like that to be recorded in the affirmative, please.

#### RESOLUTION

#### Mr. READSHAW called up HR 437, PN 3430, entitled:

A Resolution memorializing the Pennsylvania Historical and Museum Commission to establish an advisory committee to provide advice and guidance in the effort to restore Pennsylvania monuments at the Gettysburg National Military Park.

On the question,

Will the House adopt the resolution?

The SPEAKER pro tempore. On that question, the Chair recognizes Mr. Readshaw.

Mr. READSHAW. Thank you, Mr. Speaker.

Mr. Speaker, this resolution, HR 437, is the culmination of HB 1863 that called for a commission to develop and implement a strategy to use private donations to repair and preserve the 111 Pennsylvania monuments at the Gettysburg battlefield. We must not forget and we must protect the legacy to our Commonwealth and to our nation that is represented by every Pennsylvania monument that stands on those hallowed grounds.

This resolution, unlike some others, will not be forgotten when we leave this chamber today, simply because I will not and many, many other people will not let it be forgotten. The contents of this resolution and those that have agreed to it – the administration, the Historical and Museum Commission, and others – will have many

people dedicated to the cause of keeping a watchful eye at the task at hand.

I would like to thank those interested people that signed and circulated over 22,000 petitions for this project.

May I have some order, Mr. Speaker, please?

The SPEAKER pro tempore. The House will come to order.

Members will please take their conversations outside the hall of the House.

Will the Sergeants at Arms assist in breaking up conversations in this aisle over here.

Mr. Readshaw, go ahead.

Mr. READSHAW. Thank you, Mr. Speaker.

I would be remiss if I did not thank the chairman of the State Government Committee, Mr. Paul Clymer of Bucks County, for his assistance and support; the 138 sponsors of this resolution; Civil War reenactors; and the many dedicated men and women who indeed love the Pennsylvania monuments and the history of our Commonwealth at Gettysburg.

Mr. Speaker, I would like to share with the members a brief poem by James Brady, who is a Gettysburg poet, that depicts the spirit of the task before us as contained in this resolution. It is entitled "Echos at the Angle."

Can you hear them? Can you feel them? As you stand there in the cold. Can you tell that soldiers fought here, Brave men of armies old.

The ghostly armies of the past. Still occupy this place. At times you feel they still are here, But you'll never see a face.

You may never hear the sound, Of bugle, drum or gun, But you still may feel the tension, As when they fought here in the sun.

The emotions in a soldier's heart, On the battle's eve, Strong thoughts of wounding, death, and home, The echos never leave.

Valor, courage, and soldier's pride, With fear and terror blend. Of the men who fought this fight, Their emotions never end.

So as you stand and gaze across, This field of battle then, Reach out and touch the feelings, That were left here by those men.

Mr. Speaker, the Pennsylvania monuments at Gettysburg, icons of freedom, implore us to remember them, and remember them we will. Poor is a nation that has no heroes; shameful is the one that having them forgets.

Mr. Speaker, the restoration of the 111 Pennsylvania monuments is near and dear to my heart. Therefore, I personally pledge \$1,000 towards this endeavor.

As President Lincoln once said, I will prepare and someday my chance will come. We have prepared, and the contents of this resolution is our chance. I ask the members for an affirmative vote, and I thank you very much.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Adams County, Mr. Maitland, on the resolution. Mr. MAITLAND. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of HR 437, which memorializes the Pennsylvania Historical and Museum Commission to establish an advisory committee to provide advice and guidance in the effort to restore monuments to Pennsylvania soldiers at the Gettysburg National Military Park, which is located in my legislative district.

This bipartisan measure has been the focus of discussion by a number of interested parties, including the gentleman, Mr. Readshaw, who brought this issue to the fore; Chairman Clymer of the State Government Committee; the PHMC commissioners and staff; the Governor's Office; veterans groups and reenactors groups from around the State and country; and me in my dual role as local legislator and PHMC commissioner.

I invite any interested member, staff person, or citizen to join in our effort. Please remember Pennsylvania's Civil War heroes with your affirmative vote on this resolution today. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Franklin County, Mr. Coy.

Mr. COY. Thank you, Mr. Speaker.

Mr. Speaker, I want to congratulate everyone involved in this effort, because as a member of the commission that honored the Battle of Gettysburg's 125th anniversary in 1988, a lot of work went into that anniversary and into that celebration, and I commend Representative Readshaw for taking the bull by the horns in this regard, but also Representative Maitland, because the battlefield is in the district that he represents.

But truly, the battlefield is a statewide treasure. It is a treasure that General Assemblies of Pennsylvania in years past recognized. Many years ago, on the 50th anniversary of the battle, the General Assembly authorized the building of the Pennsylvania Monument. That was appropriate then. It is even more appropriate now that we look to the restoration, the long historic activities which have taken place there, not just for the sake of what it means to us today but because, candidly, it is our duty. I commend all who have been involved in this effort - so many people, volunteers; as Representative Maitland said, the people, the reenactors, who constantly have this as part of the thing that they do to commemorate history. So I think the least the General Assembly can do is provide this active direction to the project, support funding in as many ways as we can, but more than that, to simply recognize that it is our duty and our sacred honor to protect these monuments and to make them continue to be a lasting edifice toward the history of that important event in our nation. Thank you, Mr. Speaker.

Mr. TRICH. Mr. Speaker, I would just like to make a comment concerning the announcement that was made by Representative Cohen just a second ago, if I may, if I am in order.

Mr. DeWEESE. Mr. Speaker, may we have some order, please, on the floor?

The SPEAKER pro tempore. Will the members please take their seats. This involves the schedule for the rest of the day.

Mr. Trich.

Mr. TRICH. Thank you, Mr. Speaker.

Mr. Speaker, the comment that I wish to make goes along with the schedule, a tentative schedule, I realize very tentative schedule, that Representative Cohen just made reference to, and it concerns the issue of tax reform. Please understand, on both sides of the aisle, there is no one who is more impassioned about tax reform than I happen to be from Washington County and knowing the need for tax reform.

My comment to the House floor today, though, and my concern, I guess, to the leadership of the House floor would be

along these lines: Yesterday we were informed that there was really no true movement, no true consensus; that the Republican side did not know any more than the Democratic side relative to this very critical, very important issue. Yet today we find out that there is consensus being worked on on one side of the aisle. I think it is unfortunate, with the committee system that we have that should be functioning, that we find ourselves on this side of the aisle, in the minority, sitting and waiting to see if a consensus can be reached on the majority side. Whatever happened to the committee system where that was supposed to have been worked out together ? I think that is unfortunate.

Again, I do not want to be an obstructionist, and if in fact we can get to tax reform today, then that is fine, but I truly believe that the system is not quite working when many of us, 99 of us, are sitting on one side of the aisle with absolutely no input into this project, and I think that is unfortunate.

Mr. Speaker, thank you for the courtesy of the time to make that comment.
