111th SECURITY POLICE SQUADRON PENNSYLVANIA AIR NATIONAL GUARD PRESENTED

The SPEAKER. The Chair recognizes the gentleman from Philadelphia County, Mr. John Taylor.

Mr. TAYLOR. Thank you, Mr. Speaker.

Thanks for the House indulging us this afternoon.

We are honored to have with us some brave Pennsylvanians from the 111th Security Police Squadron of the Pennsylvania Air National Guard.

While many of us were enjoying the Olympic Games in 1996 and we also heard of the tragedy of the bombing in Centennial Park, little did we know that we had seven Pennsylvanians from the Pennsylvania Air National Guard helping the victims of that tragedy. They are here with us today, and I would like to present to them a citation from the House.

> WHEREAS, The 111th Security Police Squadron, Pennsylvania Air National Guard, is being recognized for its heroic participation in Atlanta, Georgia, on July 25, 1996, when a bomb exploded in Centennial Park during the Olympic Games; and

> WHEREAS, The 111th Security Police Squadron assisted Atlanta police officers with the evacuation of the park area and during the evacuation ensured that the emergency roads were opened for ambulances, fire trucks, police vehicles and other emergency vehicles and kept curious citizens out of the park area. The squadron also cleared the inbound and outbound roads of Atlanta to enable emergency vehicles to enter and exit the city rapidly and transport those injured in the explosion to nearby hospitals for medical attention; and

> WHEREAS, These proud Pennsylvania citizens risked their lives to preserve and protect the health, safety and welfare of the people attending the Olympic Games and the citizens of Atlanta, Georgia, thereby earning the respect and gratitude of all those who have received the benefit of their tireless devotion to duty.

> NOW THEREFORE, The House of Representatives of the Commonwealth of Pennsylvania pays tribute to the 111th Security Police Squadron, Pennsylvania Air National Guard, for its commitment and dedication to the welfare of its fellowman; offers best wishes for a continued tradition of excellence in the years to come....

Amend Sec. 2, page 2, line 10, by striking out "is" and inserting are

Amend Sec. 2 (Sec. 14.1), page 10, by inserting between lines 14 and 15

(e) Easement purchase.-

(1) The State board may reject the recommendation made by a county for purchase of an agricultural conservation easement whenever:

(i) The recommendation does not comply with a county program certified and approved by the State board for purchasing agricultural conservation easements.

(ii) Clear title cannot be conveyed.

(iii) The farmland which would be subject to the agricultural conservation easement is not located within a duly established agricultural security area of 500 or more acres established or recognized under this act.

(iv) The allocation of a county established pursuant to subsection (h) is exhausted or is insufficient to pay the purchase price.

(v) Compensation is not provided to owners of surface-mineable coal disturbed or affected by the creation of such easement.

(1.1) The State board shall reject the recommendation made by a county for purchase of an agricultural conservation easement whenever sewage sludge has been applied to the land within the last two years.

(2) The State board shall act to approve, disapprove or table the recommendation by a county for purchase of an agricultural conservation easement within 60 days of its receipt unless the following conditions delay such action:

(i) The occurrence of a catastrophic event which precludes the convening of the State board. Any natural disaster, including, but not limited to, fire, flood, excessive wind, snow or earthquake shall constitute a catastrophic event.

(ii) The issue of a subdivision causes further questions by the State board.

(iii) Legal actions or court decisions are pending which would affect the recommendation in question.

(iv) The State board passes a resolution directing that an independent hearing examiner conduct an administrative hearing

on any issue relating to the recommendation submitted by the county. In such an occurrence, the 60-day period shall be extended to 120 days.

The 60-day period shall be extended until all issues set forth in this paragraph are resolved to the satisfaction of the State board, whereby the State board shall act at the next scheduled meeting on the recommendation of the county board. Decisions delayed due to catastrophic events shall be determined in as reasonable an amount of time as possible.

(3) If the State board disapproves the recommendation by a county for purchase of an agricultural conservation easement, the county shall be given written notice of the disapproval within ten days of the decision of the State board. The written notice shall state the reason for the State board's disapproval of the recommendation.

(4) A decision of the State board issued under the authority of this subsection shall be an adjudication subject to the provisions of 2 Pa.C.S. (relating to administrative law and procedure).

(5) Failure of the State board to act on a recommendation by a county for purchase of an agricultural conservation easement within 60 days of its receipt shall be deemed to constitute approval by the State board unless one or more of the conditions under paragraph (1.1)or (2) exist. * * *

For what purpose does the gentleman, Mr. Smith, rise?

Mr. B. SMITH. Thank you, Mr. Speaker.

I would like to make a motion to revert to the prior printer's number.

AMENDMENT WITHDRAWN TEMPORARILY

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Wilt, to determine if he is willing to withdraw his amendment temporarily and yield to the gentleman, Mr. Smith, for a motion to revert to the prior printer's number.

Mr. WILT. That is correct, Mr. Speaker. Thank you. The SPEAKER pro tempore. Thank you.

BILL REVERTED TO PRIOR PRINTER'S NUMBER

The SPEAKER pro tempore. Then the Chair recognizes the gentleman, Mr. Smith.

Mr. B. SMITH. Thank you, Mr. Speaker.

I rise to move to the prior printer's number, Mr. Speaker, and the prior printer's number that I want is prior PN 55.

LEAVE OF ABSENCE

The SPEAKER pro tempore. The Chair recognizes the majority whip, who requests that the gentleman, Mr. ALLEN, be placed on leave. The gentleman's name will be added to the leave list.

CONSIDERATION OF SB 56 CONTINUED

On the question, Will the House agree to the motion?

The SPEAKER pro tempore. The Chair now recognizes the gentleman, Mr. Smith, on the motion to revert to PN 55.

Mr. B. SMITH. Thank you, Mr. Speaker.

SB 56 relates to Act 74 of 1988, and Act 74 was designed to protect existing sportsmen's clubs and shooting ranges from being shut down due to harassment from local municipalities using impossible standards to comply with noise ordinances. Act 74 states that a club only has to comply with those local noise ordinances which were in existence at the time the club was constructed. The intent of the legislature was to grandfather existing shooting ranges and allow that before new ranges could be constructed, that they be in compliance with noise control laws in existence at the time the ranges were constructed. This includes those clubs that were under construction and not completed.

A recent court case, specifically Gray v. Barnhart, a shooting club attempted to defend itself by citing Act 74 of 1988. The court ruled that since there were no noise control laws in existence at the time the range was being constructed, the municipality could enact one and the club would be required to comply. This was not the intent of the legislation. SB 56 was introduced in response to this court decision in order to restore the original legislative intent of the General Assembly.

Now, the amendment problem specifically is, the Senate amended SB 56 on page 2 beginning at line 15, and if the members check on page 2 beginning at line 15, as they well know – this is in capital letters – the intent of this amendment is to ensure that SB 56 could not be construed to dissolve any agreement between a shooting range and a municipality. However, after further review, it is clear that this language would have no impact on such court-ordered agreements. However, this language could lead to court misinterpretation of the statute. Amendatory language does not refer to court-ordered agreement. Therefore, a court could interpret this language that one would be required if a municipality demands such an agreement.

Now, most importantly, Mr. Speaker, the Senate has agreed with the motion to revert to the prior printer's number. This would avoid any controversy or problems with the intent of this legislation. So I respectfully ask for members' support in reverting to the prior printer's number.

The SPEAKER pro tempore. It is appropriate that we have a little less noise when we are discussing noise in this particular piece of legislation. Would the House please come to order.

On the motion to revert to the prior printer's number, the Chair recognizes the gentleman from Lackawanna, Mr. Staback.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, I concur fully with all that the previous speaker had to say and also ask for an affirmative vote on reverting to PN 55 and would further ask for an affirmative vote on SB 56, PN 55. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Mercer, Mr. Wilt.

Mr. WILT. Thank you, Mr. Speaker.

I would like to also ask that we support this motion to revert to the prior printer's number.

My amendment, which I had offered to the new printer's number, would basically say that the enactment of this piece of legislation would not require that shooting clubs enter into an agreement with their local municipalities. That language is included in the prior printer's number and would make my amendment obsolete, and therefore, I fully support this motion and would ask the support of all the members on the floor. Thank you very much.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Northumberland, Mr. Phillips. Mr. PHILLIPS. Thank you, Mr. Speaker.

I agree with the motion to revert to the prior printer's number. Due to the court case that was spoken about, the amendment that was placed in the bill in the Senate would cause some problems and maybe not fulfill the full intent of SB 56.

And I agree with the former speaker that the Senate has agreed. The prime sponsor of the bill and the maker of the amendment have agreed for us to withdraw that amendment and go back to PN 55 as was proposed by Representative Smith. Thank you very much.

The SPEAKER pro tempore. The Chair thanks the gentleman.

CONSIDERATION OF SB 56 CONTINUED

The SPEAKER pro tempore. The Chair recognizes the gentleman from Allegheny, Mr. Michlovic.

Mr. MICHLOVIC. Thank you, Mr. Speaker.

Since we do not have the bill, perhaps the member that made the motion could once again explain the difference between the current version and what SB 56 was. What is the difference between the two?

The SPEAKER pro tempore. The gentleman, Mr. Smith, cannot hear the gentleman, Mr. Michlovic.

It is going to be a long night. Let us get it over with. The gentleman may proceed.

Mr. MICHLOVIC. Thank you, Mr. Speaker.

Mr. Speaker, since we do not have that version of the bill readily available in front of us, perhaps the gentleman could explain the difference between the version of SB 56 we just had and the current bill now before us.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Smith.

Mr. B. SMITH. Thank you, Mr. Speaker.

Basically, the section that was eliminated was added by the Senate to further define and explain its intent. However, upon closer examination, they feared that it would endanger the bill through future court interpretations, and therefore, the Senate and we in the House just now have agreed to revert to the prior printer's number.

What we basically are trying to do - and we have done this before a number of times in the House - is to grandfather shooting ranges that are already in existence so that local governments cannot come in later and take a shooting range out of existence with the noise ordinance.

Basically, we are just doing this one more time to clarify that it is our intent to grandfather in shooting ranges that are already in existence. That is the intent of SB 56, and it is our intent now that we reverted to the prior printer's number.

Mr. MICHLOVIC. And the reversion to the prior printer's number is simply a matter of a technical problem with the other printer's number, that it would not do the job. Is that correct?

Mr. B. SMITH. There is the fear that the addition would endanger future court decisions, and by reverting to the prior printer's number, the court would definitely understand the intent of our legislation, which was the intent the last time we passed this legislation.

Mr. MICHLOVIC. Okay. Thank you, Mr. Speaker. I thank the gentleman.

The SPEAKER pro tempore. For purposes of clarification, if the members have in front of them SB 56, PN 1483, if they will look on the second page of the bill, lines 15 through 21, that language was added in the Senate. That language would be removed if the House votes to revert to PN 55.

The Chair recognizes the gentleman from Northumberland, Mr. Belfanti.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, this legislation was originally prime-sponsored by myself a number of sessions ago and did pass the House by a wide margin. It has since been reintroduced in the Senate by my colleague, Senator Helfrick, and I believe that the legislation has been well thought out.

The reversion to the prior printer's number simply puts back into perspective a situation where shooting ranges that have been in existence many years cannot be put out of business simply because the owner of the shooting range and a township supervisor do not happen to like each other or a member of a zoning board.

So, Mr. Speaker, in my part of the State, there are many such ranges that are enjoyed by widespread - men and women, young and old -- individuals, and I would hope that members here would show us your consideration and vote "yes" on this bill.

The SPEAKER pro tempore. The Chair thanks the gentleman.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of SB 1292, PN 1672, entitled:

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for certain expenses and fees relating to the minor judiciary.

On the question,

Will the House agree to the bill on third consideration?

Mr. GEORGE offered the following amendment No. A3097:

Amend Title, page 1, line 3, by removing the period after "judiciary" and inserting

; and providing for immunity from suit in connection with certain actions related to environmental law or regulation.

Amend Bill, page 2, by inserting between lines 7 and 8

Section 2. Title 42 is amended by adding a section to read: § 8340.1. Environmental law or regulation.

(a) General rule.—A person who acts in furtherance of the person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in connection with an issue related to enforcement or implementation of environmental law or regulation shall be immune from civil liability in any action regardless of intent or purpose except where the communication to the government agency is not genuinely aimed at procuring a favorable governmental action, result or outcome. A communication is not genuinely aimed at procuring a favorable governmental action, result or relevant to the enforcement or implementation of environmental law or regulation.

(b) Motion to strike .--

(1) A cause of action against a person arising from any act of that person in furtherance of the person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in connection with a public issue shall be subject to a special motion to strike unless the court determines that the plaintiff has established that there is a substantial likelihood that the plaintiff will prevail on the claim. In making its determination, the court shall consider the pleadings and supporting and opposing affidavits stating the facts upon which the liability or defense is based. The court shall advance any motion to strike so that it may be heard and determined with as little delay as possible.

(2) The court shall stay all discovery proceedings in the action upon the filing of a motion to strike, provided, however, that the court, on motion and after a hearing and for good cause shown, may order that specified discovery be conducted. The stay of discovery shall remain in effect until notice of the entry of the order ruling on the motion to strike.

(3) If the court determines that the plaintiff has established that there is a substantial likelihood that he will prevail on the claim, neither that determination nor the fact of that determination shall be admissible in evidence at any later stage of the case, and no burden of proof or degree of proof otherwise applicable shall be affected by that determination.

(4) The special motion may be filed within 60 days of the service of the complaint or, in the court's discretion, at any later time upon terms it deems proper.

(c) Attorney fees.—If a person successfully defends against an action under this section, that person shall be awarded reasonable attorney fees and the costs of litigation. If the person prevails in part, the court may award reasonable attorney fees and costs of litigation or an appropriate portion thereof. A person successfully defends against an action if the person prevails on a motion to strike a cause of action under subsection (b) or later prevails on the merits in the action.

(d) Intervention of government agency.—The government agency involved in the furtherance of a person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in connection with a public issue shall have the right to intervene or otherwise participate as an amicus curiae in the action involving public petition and participation.

(e) Construction.-Nothing in this section shall be construed to limit any constitutional, statutory or common-law protections of defendants to actions involving public petition and participation.

(f) Definitions.-As used in this section, the following words and phrases shall have the meanings given to them in this subsection:

"Act in furtherance of a person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in connection with a public issue." Any written or oral statement or writing made before a legislative, executive or judicial proceeding, or any other official proceeding authorized by law; any written or oral statement or writing made in connection with an issue under consideration or review by a legislative, executive or judicial body, or any other official proceeding authorized by law; any written or oral statement or writing made in a place open to the public or a public forum in connection with an issue of public interest; or any written or oral statement or writing made to a government agency in connection with the implementation and enforcement of environmental law and regulations.

"Enforcement of environmental law and regulations." Any activity related to the identification and elimination of violations of environmental laws and regulations, including investigations of alleged violations, inspections of activities subject to regulation under environmental law and regulations and responses taken to produce correction of the violations.

"Government agency." The Federal Government, the Commonwealth and all of its departments, commissions, boards, agencies and authorities, and all political subdivisions and their authorities.

"Implementation of environmental law and regulations." Any activity related to the development and administration of environmental programs developed under environmental law and regulations.

Amend Sec. 2, page 2, line 8, by striking out "2" and inserting

On the question,

The SPEAKER pro tempore. On that question, the Chair recognizes Mr. George.

Mr. GEORGE. Madam Speaker, I am attempting to insert amendment A3097. Now, what we are really doing here is what we have tried to do on several occasions. There have been many arguments for it and some against it. Whether they are against it or not, the truth of the matter is, it is much needed. In this amendment we attempt to put the language commonly known as the SLAPP (strategic lawsuits against public participation) language and insert it so those individuals who have often spoken out because of a concern, an environmental concern, would not be sued and intimidated to keep them quiet on the matter.

So, Madam Speaker, there is nothing wrong with the amendment. The responsibility of protecting these people is ours. Many types of SLAPP suits can be placed against individuals, whether they are landfills or mining or industrial, anything at all where people want to challenge because they feel in their heart that they must speak out to protect themselves or their properties.

The minute an individual files a suit, this matter becomes too expensive for the individual to be able to fight it off in the courts, and we are attempting to give individuals who wish to speak out, who wish to take and show concern over some permits or some action that is being taken, to give them the right to do this without being basically hit over the head because of the fear of expensive lawsuits.

I ask that we accept this amendment. We have on every occasion. I think we ought to tell the Senate that, look, here it comes again: now quit ignoring it; let us do what is right for the people. Even though we are in the waning days, there are some that will say we should be passing our debt ceiling; we should be passing a school choice; we should be passing these very important programs. There is not any program that is any more important than this one here. It takes care of people.

I ask that we vote affirmatively on this amendment.

(ii) Any of the following prohibited conduct where the child was 15 years of age or older at the time of the alleged conduct and a deadly weapon as defined in 18 Pa.C.S. § 2301 (relating to definitions) was used during the commission of the offense which, if committed by an adult, would be classified as:

(A) Rape as defined in 18 Pa.C.S. § 3121 (relating to rape).

(B) Involuntary deviate sexual intercourse as defined in 18 Pa.C.S. § 3123 (relating to involuntary deviate sexual intercourse).

(C) Aggravated assault as defined in 18 Pa.C.S.§ 2702(a)(1) or (2) (relating to aggravated assault).

(D) Robbery as defined in 18 Pa.C.S. § 3701(a)(1)(i),(ii) or (iii) (relating to robbery).

(E) Robbery of motor vehicle as defined in 18 Pa.C.S. § 3702 (relating to robbery of motor vehicle).

 (F) Aggravated indecent assault as defined in 18 Pa.C.S. § 3125 (relating to aggravated indecent assault).
(G) Kidnamping as defined in 18 Pa.C.S. § 2001

(G) Kidnapping as defined in 18 Pa.C.S. § 2901 (relating to kidnapping).

(H) Voluntary manslaughter.

(I) An attempt, conspiracy or solicitation to commit murder or any of these crimes as provided in 18 Pa.C.S. §§ 901 (relating to criminal attempt), 902 (relating to criminal solicitation) and 903 (relating to criminal conspiracy).

(iii) Any of the following prohibited conduct where the child was 15 years of age or older at the time of the alleged conduct and has been previously adjudicated delinquent of any of the following prohibited conduct which, if committed by an adult, would be classified as:

(A) Rape as defined in 18 Pa.C.S. § 3121.

(B) Involuntary deviate sexual intercourse as defined in 18 Pa.C.S. § 3123.

(C) Robbery as defined in 18 Pa.C.S. § 3701(a)(1)(i),(ii) or (iii).

(D) Robbery of motor vehicle as defined in 18 Pa.C.S. § 3702.

(E) Aggravated indecent assault as defined in 18 Pa.C.S. § 3125.

(F) Kidnapping as defined in 18 Pa.C.S. § 2901.

(G) Voluntary manslaughter.

(H) Possession of a weapon on school property as defined in 18 Pa.C.S. § 912 (relating to possession of weapon on school property) while in possession of a firearm as defined in section 6102 (relating to definitions).

[(H)] (I) An attempt, conspiracy or solicitation to commit murder or any of these crimes as provided in 18 Pa.C.S. §§ 901, 902 and 903.

(iv) Summary offenses, unless the child fails to comply with a lawful sentence imposed thereunder, in which event notice of such fact shall be certified to the court.

(v) A crime committed by a child who has been found guilty in a criminal proceeding for other than a summary offense. 1998

Section 3. Sections 6352 and 8103 of Title 42 are amended to read: § 6352. Disposition of delinquent child.

(a) General rule.—If the child is found to be a delinquent child the court may make any of the following orders of disposition determined to be consistent with the protection of the public interest and best suited to the child's treatment, supervision, rehabilitation and welfare, which disposition shall, as appropriate to the individual circumstances of the child's case, provide balanced attention to the protection of the community, the imposition of accountability for offenses committed and the development of competencies to enable the child to become a responsible and productive member of the community:

(1) Any order authorized by section 6351 (relating to disposition of dependent child).

(2) Placing the child on probation under supervision of the probation officer of the court or the court of another state as provided in section 6363 (relating to ordering foreign supervision), under conditions and limitations the court prescribes.

(3) Committing the child to an institution, youth development center, camp, or other facility for delinquent children operated under the direction or supervision of the court or other public authority and approved by the Department of Public Welfare.

(4) If the child is 12 years of age or older, committing the child to an institution operated by the Department of Public Welfare.

(5) Ordering payment by the child of reasonable amounts of money as fines, costs or restitution as deemed appropriate as part of the plan of rehabilitation considering the nature of the acts committed and the earning capacity of the child. For an order made under this subsection, the court shall retain jurisdiction until there has been full compliance with the order or until the delinquent child attains 21 years of age. Any restitution order which remains unpaid at the time the child attains 21 years of age shall continue to be collectible under section 9728 (relating to collection of restitution, reparation, fees, costs, fines and penalties).

(6) An order of the terms of probation may include an appropriate fine considering the nature of the act committed or restitution not in excess of actual damages caused by the child which shall be paid from the earnings of the child received through participation in a constructive program of service or education acceptable to the victim and the court whereby, during the course of such service, the child shall be paid not less than the minimum wage of this Commonwealth. In ordering such service, the court shall take into consideration the age, physical and mental capacity of the child and the service shall be designed to impress upon the child a sense of responsibility for the injuries caused to the person or property of another. The order of the court shall be limited in duration consistent with the limitations in section 6353 (relating to limitation on and change in place of commitment) and in the act of May 13, 1915 (P.L.286, No.177), known as the Child Labor Law. The court order shall specify the nature of the work, the number of hours to be spent performing the assigned tasks, and shall further specify that as part of a plan of treatment and rehabilitation that up to 75% of the earnings of the child be used for restitution in order to provide positive reinforcement for the work performed.

In selecting from the alternatives set forth in this section, the court shall follow the general principle that the disposition imposed should provide the means through which the provisions of this chapter are executed and enforced consistent with section 6301(b) (relating to purposes) and when confinement is necessary, the court shall impose the minimum amount of confinement that is consistent with the protection of the public and the rehabilitation needs of the child.

(b) Limitation on place of commitment.—A child shall not be committed or transferred to a penal institution or other facility used primarily for the execution of sentences of adults convicted of a crime.

(c) Possession of firearm or explosive device on school property.—
(1) Where a child has been adjudicated delinquent for the offense

of possession of a firearm or explosive device on school property

under 18 Pa.C.S. § 912 (relating to possession of weapon on school property), the court shall make an order of disposition committing the child pursuant to subsection (a)(2). (3) or (4) for at least one year, notwithstanding any other provision of this title or other statute to the contrary.

(2) There shall be no authority for a court to impose on a child to which this subsection is applicable a lesser order of disposition than provided for in paragraph (1) or to suspend the order of disposition. Nothing in this section shall prevent the court from making an order or disposition greater than that provided in paragraph (1).

(3) If a court refuses to apply paragraph (1) where applicable, the Commonwealth shall have the right to appellate review of the action of the court. The appellate court shall vacate the disposition and remand to the court for imposition of a disposition in accordance with this section if it finds that the disposition was imposed in violation of paragraph (1).

Mr. HENNESSEY called up HR 555, PN 4110, entitled:

A Resolution calling on the President of the United States and the Federal Government to take all necessary and appropriate action to respond to the surge of steel imports resulting from the financial crises in Asia, Russia and other regions.

and the motion was agreed to.

The SPEAKER pro tempore. The Chair recognizes Mr. Hennessey.

Mr. HENNESSEY. Thank you, Madam Speaker.

Madam Speaker, with the recent economic collapse in the Far East, steel companies from Japan and Russia and elsewhere have been dumping steel in the U.S. marketplace at prices well below their cost, and they can do this because they are subsidized in many cases by their government, and the paper losses really do not add up to real losses for those companies because they are

cushioned by the subsidies they receive from their governments. The American steel industry does not have the benefit of that, and this puts them at a decided disadvantage in today's marketplace.

The American steel industry as a group has filed claims with the fair trade commission in Washington seeking to enforce existing fair trade laws. The substance of HR 555 is to seek a prompt disposition of those claims by the fair trade council and also an energetic defense of those claims by the American government.

It is important to note that the American steel industry is not seeking to change existing law. What it is seeking to do is to have enforcement of existing law, and I would ask your support of HR 555. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman, and the Chair recognizes the gentleman from Allegheny County, Mr. Olasz.

Mr. OLASZ. Thank you very much, Madam Speaker.

I hope some of my friends will be quiet for a minute, because I will give them something to think about.

This is a very noble effort, but I think we should send 535 Big Ben alarm clocks to Washington along with this resolution, along with a gong for the President of the United States.

Just this week in my hometown, the last rolling mill of U.S. Steel is cutting back on production. The last hot-metal facility in Allegheny County in Representative Michlovic's district is cutting back on production. This was once the area that was the largest steel mill in the world. Now, you tell me who in Washington has the brains to give \$15 billion again to Russia, and we know what went on with Russia with the prior \$18 billion, and this is your tax money going over there, and they continue to dump steel. One country not mentioned here that was just the recipient of \$30 billion in the last few days is Brazil. Brazil is the notorious steel dumper in this country. Now, someone down there better wake up as to what is happening, and it is not only the steel industry; it is being done to the farmers. We just gave Russia millions and millions of dollars of wheat free, and they are in turn selling it. I mean, what is going on in Washington?

So, Madam Speaker, I think this is a very noble effort on Mr. Hennessey's part, but somebody better wake up the IMF (International Monetary Fund) bank down there in Washington, D.C., and what they are doing with your tax money, and perhaps the Governor, instead of floating money for that stadium in the North Side, should start floating money up in the Steel Valley to build a steel mill so that we can subsidize our own people. Think about it.

The SPEAKER pro tempore. The Chair thanks the gentleman, Mr. Olasz.

The Chair recognizes, from Bucks County, the gentleman, Mr. Corrigan.

Mr. CORRIGAN. Thank you, Madam Speaker.

Madam Speaker, I want to thank the gentleman, Mr. Hennessey, for putting together this comprehensive resolution. This is one that I would ask the members of the House to take a look at and think about it, as the gentleman, Mr. Olasz, just said. Mr. Hennessey put it very well; Mr. Olasz put it very well.

Closer to home, in my district, we have a steel mill that is called Fairless Works that not too long ago employed over 10,000 people. We now have about 900. We are facing massive layoffs by the end of this year as a result of the dumping of foreign steel in lower Bucks County.

The ironic part of this situation is that the taxpaying steelworkers in lower Bucks County send their dollars to Washington; the people in Washington send those dollars to the foreign countries - Russia, Brazil, and others - who make steel, who subsidize the making of their steel with the dollars that we send them. We also send dollars to those foreign countries to feed the people that work in those steel mills. They make the steel, they send it to this country, and they sell it cheaper here than they can make it. This is the problem. This is something that we all ought to be aware of.

I know one thing that we are aware of, and that is that the people in Washington very, very seldom pay any attention to resolutions that we send them. I have been here for 12 years. I have seen many, many resolutions. I have cosponsored some, and I have sponsored some. I have never gotten a response on any resolution that we have sent to Washington, D.C.

Mr. Olasz put it very well. The people in Washington ought to wake up; they ought to take those dollars that the steelworkers in Pennsylvania send to Washington and put them to better use. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Washington County, Mr. Daley,

Mr. DALEY. Thank you, Madam Speaker.

I rise in support of this resolution. You know, I do this kind of hesitantly, simply because we have done this so often, but I think it is a message that needs to be said over and over again by all of us that someone somewhere in Congress needs to rise up, stand up, and fight for the steelworkers of Pennsylvania.

In the Mon Valley we have seen the steel mills dissipate - in Homestead, in Clairton, McKeesport, South Side, Hazleton, Aliquippa, Monessen. Donora had 15,000 employees in 1962, and now Donora has none.

We need to stand up and fight for the working men and women of Pennsylvania, especially the steelworkers. This will happen to Bethlehem: it will happen to Allentown: it will happen right down here, to Steelton, because the steel industry is moving because of technology. We cannot afford to lose any more high-tech jobs in the steel industry, those jobs that create thousands of dollars and support families.

I ask for an affirmative vote. Thank you, Madam Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman. The Chair recognizes, from Montgomery County, the lady, Mrs. Cohen.

Mrs. COHEN. Thank you, Madam Speaker.

Madam Speaker, times change, and right now we are living in a global economy and participating in a global economy, and I believe that we have to recognize that we now have to compete not just in this nation but in the world and the world economy. However, the situation that we face now is not fair competition, fair global competition; this is steel dumping, and I believe that that changes the complexion of our competition entirely.

I wholeheartedly support this resolution, because this is, as I said, dumping; this is not fair competition, and we must stand up against such things and encourage all nations to compete on a fair global basis, without jeopardizing our workers, our jobs, here in the Commonwealth. By supporting this resolution, we are supporting our economy in the Commonwealth, we are supporting jobs, and we are supporting our workers.

I urge my fellow members to please support and vote "yes" on this resolution. Thank you, Madam Speaker.

FAREWELL ADDRESS BY MS. BOSCOLA

The SPEAKER. The Chair thanks the lady, Ms. Boscola, for temporarily presiding and requests that she make a few remarks to the members.

Ms. BOSCOLA. Thank you, Mr. Speaker.

Mr. Speaker, this is truly a day of mixed emotions for me. I remember, about 4 years ago, the very first time I stood on this House floor and how honored I was to be one of the 203 members here today. And I remember -a lot of you in this room know this name - former State Representative and former Congressman Paul McHale, and Paul McHale, when I was elected, said to me, "Lisa, when you get to this House," he goes, "legislators take one of two paths. I came here to represent the people of the 135th Legislative District, and represent them I did, to the best of my ability.

In my 4 years in this chamber, I learned that the House is made up of more than just Democrats and Republicans; this House is made up of dedicated men and women who take their office very seriously and who try each and every day to do the best for the people that they represent. I will never forget those times when we were able to put partisan politics aside and join together to do what was best for the people of Pennsylvania. And probably my proudest moment in those 4 years was when Gov. Tom Ridge came to Bethlehem to sign my boot camp bill into law. This goes to show you what happens when people work together and put the people's interests above the parties' interests.

I want to thank each and every one of you in this room today for all that you have done for me, all that you have taught me, and all that you have meant to me both as colleagues and as friends. As a member of the Senate, I look forward to continuing to work with you on those issues that are truly important to the people we represent.

And on a real personal note, I cannot leave this chamber without expressing to Speaker Ryan – a fellow Villanova graduate – my gratitude and my admiration. You taught me, Mr. Speaker, that your word is truly your bond and that personal respect for every member and for the dignity of this body is far more important than any political or personal consideration. For that I thank you, and for that I will never forget you.

I am honored to have served in this chamber, and I am blessed that I can call you colleagues. Thank you.

BILLS SIGNED BY SPEAKER

SB 263, PN 313

An Act amending the act of January 18, 1952 (1951 P.L.2128, No.605), entitled Private Driver Education or Training School Act, further regulating mileage and age of driver training vehicles.

SB 1051, PN 1806

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, providing for standby guardians for minors.

SB 1372, PN 2019

An Act relating to the unlawful disposition of motor vehicles; and providing penalties.

The SPEAKER. The gentleman, Mr. Civera.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The gentleman, Mr. Armstrong.

Mr. ARMSTRONG. Mr. Speaker, I have some remarks to submit for the record.

The SPEAKER. The gentleman will submit his remarks.

Mr. ARMSTRONG submitted the following remarks for the Legislative Journal:

SB 211 would amend the Borough Code to provide for the imposition of a so-called land value tax. Under this system of taxation, borough officials may impose a higher rate of taxation on land vs. buildings. The purpose is to encourage property owners to develop their land or sell the property to someone who will. Approximately 18 taxing districts, mostly third-class cities, currently impose this tax.

However, SB 211 is different from previous unsuccessful amendments to the Borough Code on this subject. This bill provides that only nonfarmland shall be subject to the higher tax rate and farmland shall be subject to the lower tax rate applied to structures. This difference is necessary and appropriate because of the often rural nature of the 950 boroughs in the Commonwealth. The Subcommittee on Boroughs of the House Local Government Committee held a public hearing on this bill and numerous discussions with representatives of farm groups, especially the Pennsylvania Farm Bureau and the Pennsylvania Grange. These groups support SB 211 in its current form.

The SPEAKER. Members of the Professional Licensure Committee will take note that a meeting has been called for 9:30 tomorrow morning.

An Act repealing the act of December 29, 1972 (Sp.Sess., P.L.2024, No.5), entitled "An act authorizing abatement of real estate taxes because of destruction or damage of property by flood, or the refund of the amount of such taxes by certain political subdivisions; authorizing assessment of properties retroactive to January 1, of the year of flood damage and authorizing reimbursement to certain political subdivisions for real estate taxes lost due to the flood of September 1971 and the Great June Flood of 1972."
