# REMARKS BY DEMOCRATIC LEADER

The SPEAKER. The Chair recognizes the Democratic leader, Mr. DeWeese.

Mr. DeWEESE. Mr. Speaker, Judge Doyle, Senator Williams, and colleagues, I am glad that I got to meet Ron and spend some time with him recently with the high bailiff of Philadelphia, commonly known as Ed Rendell, and also as we broke bread more recently last week. There is no doubt he has an infectious enthusiasm for the process. It is no doubt that his bosom friend, the Honorable Senator Williams, has at least initially guided him on a path to victory, and obviously there are many more paths and, hopefully, there will be some more guides. But notwithstanding that, it is going to be, as the honorable gentleman, Mr. Perzel, said, a career studded with public remarks, some that you will share and some that you will receive.

At least you will be around the flagpole, because you and Tony and your friends — Jeff Thomas with the sartorial manifestation of the bow tie, and all of your other friends here today — are, as John said, a solid phalanx on your behalf.

Shakespeare completed "The Merry Wives of Windsor" in 14 days. You are probably not going to complete much in 14 days; not many of us have.

Leonidas, the Spartan warrior who fell at Thermopylae with a couple hundred troops arrayed against 10,000 Persians or more, was told by scouts that there were enough Persians in the fields approaching his fortified position that their arrows would cloud out the sun, that they would be so thick in the heavens that there would be no light, and Leonidas said, good, then we will fight in the shade. The Spartans fell, of course, at Thermopylae, but their valor is that stuff of legends.

We in the minority – the Honorable Perzel at this juncture has the majority – we have our work cut out for us. Many times there are a lot of arrows clouding out the light, but with your help, our ranks swell to 100. And as you and I talked last week in Philadelphia, that is a fun, memorable, solid number – 100 – and with you with us, hopefully we will advance that number and some of our mutual causes.

In closing, Mr. Speaker, I am reminded of a moment early in the American Civil War, when George Pickett, that perfumed dandy of the old South, was writing to his wife before a battle. General McClellan, his classmate at West Point, was on the other side of the field, and as he scribed that epistle late in the tent that night, he said, "My dearest darling, you will never understand the entente cordiale between me and General McClellan." The "entente cordiale"—the good will, the warm feelings.

This is a fraternity, notwithstanding the masculine gender associated with the metaphor. All the men and women in this room have a fraternal bond, some quite strong. We welcome you to our fraternal bond.

The SPEAKER. The Chair thanks the gentleman.

The Chair at this time would like to thank Judge Doyle for performing his duties so well, and we invite him back at any time, and I will take the liberty of giving him a ceremonial gavel.

We have to keep reminding the court that we pass the laws, and we are trying to establish a good relationship with the judges so that they remember that. Judge Doyle is not one of them though; he has been through this.

On February 20, 1999, Officer Steven Jerman of the Kane Police was shot and mortally wounded during a traffic stop. Officer Jerman served his community and his State with distinction, pride, and honor. He was an excellent public servant, a model police officer, and a fine individual. He set an example of hard work, dedication, and commitment to his community, his family, and his State that we should all try to emulate in our daily lives.

He will certainly be missed by his family, friends, fellow officers, and everybody in Kane Borough and McKean County. We, the people he swore an oath to protect and defend, are eternally grateful for his service and deeply saddened by this tragic loss.

I would like to point out that nearly 1,000 police officers attended Officer Jerman's funeral, which was held at the auditorium of Kane Area High School and broadcast live over radio. The funeral procession included 400 police cars and was 4 miles long. Clearly, many people knew Officer Jerman and had the privilege of calling him a friend, myself included.

## REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Mr. Godshall. For what purpose does the gentleman rise?

Mr. GODSHALL. Mr. Speaker, I would like to submit comments for the record pertaining to HB 81.

The SPEAKER. The gentleman will send the statement to the Chair.

Mr. GODSHALL submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

I rise to urge my colleagues to support HB 81, legislation to provide a tax credit for businesses that grant a paid leave of absence to employees for the purpose of bone marrow or living organ donation.

Mr. Speaker, since the passage of Act 102 of 1994, Pennsylvania has been a national and international leader in organ donation for lifesaving transplants. In fact, organ donations within the Commonwealth have increased by over 40 percent in less than 4 years.

As a result, our law has become the standard to which many other Sates – and even the U.S. Health Department – aspire in establishing similar donor programs. Additionally, the Canadian Parliament is considering passage of a bill modeled on Pennsylvania's law.

But, Mr. Speaker, we must not rest on our laurels. With passage of HB 81, Pennsylvania will retain its place in the forefront on organ donation and transplantation.

In 1998, over 1,500 organ transplants were performed in the State. Of that number, approximately 250 - or 1 in 6 - involved a living organ donor. Obviously, living donors play a crucial, lifesaving part in the donor pool, as a vast majority - about 80 percent - of living donors give a kidney for transplantation.

In some cases, a section of a lung or liver can be resected and transplanted. Such procedures are often performed between a parent or other close relative and a young child.

Additionally, bone marrow donation can greatly help patients suffering from life-threatening blood diseases.

Nationally, the organ transplant waiting list contains about 65,000 patients, approximately 10 of whom die every day because of the lack of donated organs. In Pennsylvania, we have a waiting list of about 3,500 people. Many of these sufferers would benefit from a donation of a living organ.

Mr. Speaker, most living donors are back to work within 4 to 6 weeks. Additionally, new surgical techniques used in kidney donation can cut that time in half.

Among reasons cited as a deterrent for becoming a living donor is the fear of loss of income or loss of a job because the donor must miss 4 to 6 weeks of work.

My legislation as amended, Mr. Speaker, removes this deterrent for those who would donate bone marrow, a kidney, or a portion of a lung or liver or other organ. HB 81 simply provides a tax credit for businesses that grant a paid leave of absence to employees for the purpose of bone marrow or organ donation. The credit would cover up to 40 work hours and would be equal to (1) the amount of the employee's salary during the leave of absence (2) the cost of any temporary replacement help; and (3) miscellaneous expenses in connection with the leave of absence.

The credit would be applied to the corporate net income tax, the capital stock and franchise tax, the bank shares tax, the title insurance tax, the insurance premium tax, and the mutual thrift institution tax.

Mr. Speaker, HB 81 can reap considerable health-care cost savings – including Medicare and Medicaid – since it would remove many patients from costly kidney dialysis after receiving a donated kidney.

Additionally, the legislation would encourage more employers to offer time off for bone marrow or organ donation. It would encourage bone marrow donors, thus aiding in the creation of a larger nationwide registry. This would provide a greater probability in finding matches for the 16,000 Americans every year that contract fatal blood diseases.

And, Mr. Speaker, most importantly, HB 81 can save lives! Thank you, Mr. Speaker.

- (b) Composition.—The council shall consist of 21 voting members, composed of and appointed in accordance with the following:
  - (1) The Secretary of Health.
  - (1.1) The Physician General
  - (2) The Secretary of Public Welfare.
  - (3) The Insurance Commissioner.
  - (4) [Six] Four representatives of the business community, at least one of whom represents small business, who are purchasers of health care as defined in section 3, none of which is primarily involved in the provision of health care or health insurance, [three] two of which shall be appointed by the President pro tempore of the Senate and [three] two of which shall be appointed by the Speaker of the House of Representatives from a list of twelve qualified persons recommended by the Pennsylvania Chamber of Business and Industry. Three nominees shall be representatives of small business.
  - (5) [Six] <u>Four</u> representatives of organized labor, [three] <u>two</u> of which shall be appointed by the President pro tempore of the Senate and [three] <u>two</u> of which shall be appointed by the Speaker, of the House of Representatives from a list of twelve qualified persons recommended by the Pennsylvania AFL-CIO.
  - (6) [One representative of consumers who is] <u>Four representatives of consumers who are</u> not primarily involved in the provision of health care or health care insurance, appointed by the

Governor from a list of [three] <u>six</u> qualified persons recommended jointly by the [Speaker] <u>Majority Leader and Minority Leader</u> of the House of Representatives and the [President pro tempore] <u>Majority Leader and Minority Leader</u> of the Senate.

- (7) One representative of hospitals, appointed by the Governor from a list of three qualified hospital representatives recommended by the Hospital Association of Pennsylvania. The representative under this paragraph may appoint two additional delegates to act for the representative only at meetings of committees, as provided for in subsection (f).
- (8) One representative of physicians, appointed by the Governor from a list of three qualified physician representatives recommended jointly by the Pennsylvania Medical Society and the Pennsylvania Osteopathic Medical Society. The representative under this paragraph may appoint two additional delegates to act for the representative only at meetings of committees, as provided for in subsection (f).
- (9) One representative of the Blue Cross and Blue Shield plans in Pennsylvania, appointed by the Governor from a list of three qualified persons recommended jointly by the Blue Cross and Blue Shield plans of Pennsylvania.
- (10) One representative of commercial insurance carriers, appointed by the Governor from a list of three qualified persons recommended by the Insurance Federation of Pennsylvania, Inc.
- (11) One representative of health maintenance organizations, appointed by the Governor from a list of three qualified persons recommended by the Pennsylvania Association of Health Maintenance Organizations.
- (12) In the case of each appointment to be made from a list supplied by a specified organization, it is incumbent upon that organization to consult with and provide a list which reflects the input of other equivalent organizations representing similar interests. Each appointing authority will have the discretion to request additions to the list originally submitted. Additional names will be provided not later than 15 days after such request. Appointments shall be made by the appointing authority no later than 90 days after receipt of the original list. If, for any reason, any specified organization supplying a list should cease to exist, then the respective appointing authority shall specify a new equivalent organization to fulfill the responsibilities of this act.

On the question, Will the House agree to the amendment?

The SPEAKER. On the question of the adoption of the George amendment, 2135, the Chair recognizes the gentleman.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, today, where so many people are concerned about health care and so many people such as you and I are attempting to do something to bring the matter into focus, I thought that perhaps this might be a way, without being drastic, without making a decision that might be harmful rather than helpful, that we would basically upgrade the Health Care Cost Containment Council. What the amendment does is it asks that the Physician General be placed on board as one of the individuals on that board and at least four representatives of the business community, at least one of whom represents some small business, who are purchasers of health care as defined in section 3, none of which is primarily involved in the provision of health care or health insurance, along with two of which shall be appointed by the President pro tempore of the Senate and two of which shall be appointed by the Speaker of the House.

Mr. Speaker, I believe this goes a long way, without taking an ax to the situation, by allowing this board or the composite of the board to have additional members so that we can hopefully work around it and try to come up with ideas rather than go in a pursuit of something we cannot amend.

I ask that we adopt this amendment.

The SPEAKER. The Chair recognizes the gentleman from Lehigh, Mr. Browne, on the question of the George amendment.

Mr. BROWNE. Thank you, Mr. Speaker.

We agree to the amendment.

The SPEAKER. The Chair thanks the gentleman.

# **BILL ON THIRD CONSIDERATION**

The House proceeded to third consideration of HB 788, PN 1662, entitled:

An Act providing for the creation, conveyance, acceptance, duration and validity of conservation and preservation easements; and providing for judicial actions.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Does the lady, Mrs. Miller, desire recognition?

Mrs. MILLER. Yes, Mr. Speaker. I would like to interrogate the prime sponsor of this legislation.

The SPEAKER. The gentleman, Mr. Bunt. The gentleman indicates he will stand for interrogation. You may begin.

Mrs. MILLER. Thank you, Mr. Speaker.

On page 8 of this legislation, it contains language talking about the Agricultural Security Law, Act 43 of 1981, and it says, "...nothing contained in this act shall be construed as altering, modifying or superseding either the method of creating agricultural conservation easements or the rights, duties, powers and obligations appurtenant to these easements under the act..."

My question, Mr. Speaker, is, we recently, in this year's budget, provided additional funding for the existing conservation easement program under Act 43 of 1981. My question is, does this act in any way provide for any easements under this particular legislation to be funded with the funds that are under Act 43 of 1981?

Mr. BUNT. Thank you, Mr. Speaker, for the question.

For purposes of establishing legislative intent, none of these dollars can be used by any private organization for the acquisition of any easements under the purposes of this act.

Mrs. MILLER. Okay. Thank you, Mr. Speaker.

On the bill?

The SPEAKER. The lady is recognized.

Mrs. MILLER. Mr. Speaker, I believe this is much-needed legislation and encourage all my colleagues to vote for it, with the understanding that this in no way diminishes our existing program and the funds that are so sorely needed by our counties that have programs under Act 43 of 1981. Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Yewcic, on the question. Mr. YEWCIC. Thank you, Mr. Speaker.

Will the maker of the bill stand for brief interrogation?

The SPEAKER. The gentleman indicates he will stand for interrogation. You may begin.

Mr. YEWCIC. On page 1 of the act, it states, starting with line 10, the purpose of the act, it says that "The General Assembly recognizes the importance and significant public benefit of conservation and preservation easements in its ongoing efforts to protect the natural, historic, agricultural, open-space and scenic resources of this Commonwealth."

Does this legislation mean that a government body or a charitable institution can file an easement against a landowner?

Mr. BUNT. There have to be two willing people put together for the acquisition of the conservation or preservation easement.

In other words, there would have to be a willing seller or conveyor of the easement to a public entity or to a charitable or private entity, similar to the Lands Trust or the Farmland Lands Trust.

Mr. YEWCIC. In other words, a government entity or charitable institution could not arbitrarily decide to file an easement against a landowner for any reason, unless it is an agreed-to easement.

Mr. BUNT. I think what the gentleman is referring to is the right of a municipality or governmental entity to acquire property through right of eminent domain. I do not believe that figures into this, and in fact, it does not. This would have to be an agreement by the landowner or property owner wishing to retain some aspect of the property to be conveyed for the conservation protection or the preservation protection of that property. I think what the gentleman is referring to is an act of eminent domain, which is not within the context of the bill.

Mr. YEWCIC. On page 2, under the definition of "Conservation easement," lines 4 through 8, there is a lot of legal language, and I am not sure exactly what it means. Can you describe that language in other terms?

Mr. BUNT. In layman's terms?

Mr. YEWCIC. Well, I will read it, starting with line 4: "A nonpossessory interest of a holder in real property, whether appurtenant or in gross, imposing limitations or affirmative obligations, the purposes of which include, but are not limited to, retaining or protecting for the public benefit the natural, scenic or open-space values of real property..."

Mr. BUNT. "A nonpossessory interest of a holder in real property..." – I will try to give you a hypothetical situation, Mr. Speaker.

If you own a 100-acre farm and the Cambria County Lands Trust, which is a private organization whose intent is to acquire through negotiation for a fee an easement on a property so that that property could not be developed, they would be holding a nonpossessory interest in the property. In other words, they would not own the property, they would not be able to convey the property, but they could stipulate that the property not be able to be developed.

Mr. YEWCIC. In other words, they could prevent a landowner from developing his property because of some public good?

Mr. BUNT. But only for a fee that would be conveyed to the property owner. They could not arbitrarily come in and acquire the conservation easement or the preservation easement without entering into an agreement with the property owner.

Mr. YEWCIC. Thank you, Mr. Speaker. That ends my interrogation.

The SPEAKER. The Chair thanks the gentleman.

Mr. YEWCIC. On the bill?

The SPEAKER. The gentleman is in order.

Mr. YEWCIC. Mr. Speaker, I read the bill. It is not clear to me that someone cannot arbitrarily file an easement against a property owner to prevent that property owner from doing what he wants to do to his property, and I am going to vote against this bill for that reason. I have not seen this language before, and I am concerned about the rights of property owners.

You know, we had recent sewer projects in my district. Easements were filed on people who live in the country for eminent domain and other reasons. This legislation says that these easements will be created in the same manner as other easements, and I am concerned about the rights of the property owner. Even

if it is agreed to or not agreed to, it is not clear in this legislation. It seems that if someone likes your property, that it is an open area or it is of scenic value, that someone could create a lien and stop you from developing or doing what you want to do with your own property, and I think that needs to be more firmly debated, at least on this floor, so we have an understanding of what this legislation does. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
