DELEGATION FROM SOUTH AFRICA PRESENTED

The SPEAKER. Members, please take your seats at this time.

The Chair and Representative Evans have some guests that we would like to introduce to the House. I met these fine people here a moment ago; they are seated over in the area to the left of the Speaker.

Members, please take your seats. The conversations in the back of the House, please break up.

We have guests from South Africa. As I was over talking to these fine people a little while ago, I noticed that one of them bore a remarkable resemblance although somewhat in better shape than the Democratic Appropriations Committee chairman. So you probably heard me ask that Mr. Evans report to the floor, and he did so promptly – the first time he has ever followed my directions – and he came up to the rostrum and I introduced him to his long-lost cousin, I suspect, because I thought there was a great resemblance between these two fine gentlemen, both fine gentlemen. And I am not going to single out this one, but I am going to ask you to determine for yourselves if the Speaker was seeing things or if maybe he was on the right track.

Now, I am apologizing now, folks, for my ability to pronounce names. I cannot pronounce Gaelic names, so you can imagine the difficulty I will have pronouncing some of your names. I would ask you to bear with me. This delegation from South Africa is here in Harrisburg for 3 days this week. Now, let me try. First, Imelda Sizakele Nkosi. Did I get that, or was I close? I was close; that is good. Next is Phelela Zenzele Phakathi. No, stand up. Who does he look like? Maybe we could put him in that Appropriations Committee slot for another couple of weeks and get some things done. Next is Christopher Thsepo Matlhako. Next is Gladstone Dumisani Gwadiso.

This gentleman, I am told, is the spokesperson for the group. I believe two or three of you are elected officials, is that not so? Yes, and we are so happy to have you. They are accompanied by Kim Robinson from the United States Department of State.

I am going to ask at this time if Chief Gwadiso would be kind enough to come to the rostrum and address the House for a moment. We are very thrilled to have these folks here with us, and it is a great honor to introduce this gentleman to the House.

CHIEF GWADISO. Mr. Speaker, honorable members, honored officials: Mr. Speaker, allow me, first of all, to thank you for this opportunity. We feel highly honored as the delegation from South Africa to have been afforded an opportunity to visit your honorable House.

Our mission is a factfinding mission. South Africa at long last has achieved its democracy. We are indeed in a transitional stage, but of great importance is the hospitality of the people of this part of the world, the manner in which we have been received, the warmth, and if this is how things happen, we see no reason why people cannot live together. This is a lesson and also a commitment to us. We are looking forward to strengthening the international relations with other countries and states.

I do not necessarily have a prepared speech, but this was our appreciation to the staff and to the members to have allowed us to visit your House. Thank you, sir.

The SPEAKER. Thank you very much, and thanks to every one of you for participating here this morning and joining with us for a short while. We enjoyed your visit; we hope you come back again, and if Dwight is missing, I would expect you, sir, to sit over there and take care of his switch for him.

The SPEAKER. On the question of the adoption of the resolution, Mr. Staback. The gentleman will yield for a moment. Members, please.

Mr. Staback.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, this resolution simply asks Congress to approve HR 701, commonly referred to as CARA, the Conservation and Reinvestment Act. CARA, which has the support of our Governor and 317 members of Congress, is very, very important to the Commonwealth, and I would like to explain why.

Nationally, the money that is spent on protecting our wildlife resources is both inconsistent and inadequate. Over 85 percent of our nation's fish and wildlife species have been left unattended. Many end up on the endangered species list.

Year in and year out our wildlife agencies have to fight with Congress for appropriate funding. Year in and year out the hunters and anglers of this State have had to pick up the bill. They simply cannot do it anymore, Mr. Speaker. We are losing about 3 percent of this population annually, and with it, our funding base as well.

CARA, which derives revenues from outer continental shelf proceeds – that is indeed money collected annually from private companies that pay for the opportunity to extract oil and gas from offshore operations on the outer continental shelf – provides a permanent, stable funding base for wildlife, and it does not stop there, Mr. Speaker.

Because we are one of the Great Lake States, we will receive money to conserve coastal habitats and stop the invasion of nonindigenous species like the zebra mussel. DCNR (Department of Conservation and Natural Resources) and the Pennsylvania Fish and Boat Commission will benefit from this title. Local governments as well will be eligible for grants. Local governments, Mr. Speaker, will be able to apply for funding for urban parks and recreation programs. The Pennsylvania Historical and Museum Commission will be eligible for increased grants provided by the Historic Preservation Act. Private landowners will be provided incentives to aid in the recovery of endangered and threatened species.

In total, Mr. Speaker, CARA could send about an additional 49 million new Federal dollars into the Commonwealth. Mr. Speaker, some are calling CARA the most significant environmental program ever acted on by Congress.

With that being said, Mr. Speaker, I would request an affirmative vote on the measure, and thank you.
