#### **BILL ON THIRD CONSIDERATION**

The House proceeded to third consideration of HB 2209, PN 3233, entitled:

An Act amending the act of December 4, 1996 (P.L.893, No.141), known as the Volunteer Health Services Act, allowing doctors with volunteer licenses to prescribe medication to family members.

On the question,

Will the House agree to the bill on third consideration?

Mr. **GEORGE** offered the following amendment No. **A2102:** 

Amend Sec. 1 (Sec. 10.1), page 1, line 15, by striking out "members of his" and inserting

any member of his

Amend Sec. 1 (Sec. 10.1), page 2, lines 1 through 6, by striking out "his own care or whether the family members" in line 1, all of lines 2 through 6 and inserting

that member's own care or whether that member is being treated at an approved clinic.

Amend Sec. 1 (Sec. 10.1), page 2, by inserting between lines 14 and 15

(d) Definition.—As used in this section, the term "family member" means a volunteer license holders's spouse, child, daughter-in-law, son-in-law, mother, father, sibling, mother-in-law, father-in-law, sister-in-law, brother-in-law, grandparent, grandchild, niece, nephew or cousin.

On the question,

Will the House agree to the amendment?

The SPEAKER. On the question of the adoption of the amendment, Mr. George.

Mr. GEORGE. Mr. Speaker, on 2102, there is language in it saying that whom you could attend to is a matter of family members. This amendment simply adds niece and nephew to the list of family members for which a volunteer licensee may prescribe medication.

So often I find myself, Mr. Speaker, trying to help individuals who fall through the cracks in regard to our State laws. A niece or a nephew who is in need of a medical prescription should be considered a family member for the purpose of this act.

This amendment does not hurt the bill, Mr. Speaker. It only makes it more complete by adding these important family members to the list. I urge an affirmative vote.

## NURSING HOME CONSUMER INTERNET INFORMATION ACCESS

Section 501. Nursing Home Consumer Information Report.

In addition to the information required by the Department of Health on a form provided by the Department of Health pursuant to the provisions of the act of July 19, 1979 (P.L.130, No.48), known as the Health Care Facilities Act, and regulations promulgated pursuant thereto, each nursing home shall provide to the Department of Health no later than 90 days after the close of each calendar year the following information on the above-referenced form:

(1) Nursing hours worked per patient per day and nursing hours required by the Department of Health per patient per day. Actual hours worked per patient per day are for the most recently concluded fiscal or calendar year.

- (2) Average length of service of professional nursing staff and the average length of service of nurse aide personnel at the nursing home completing the form.
- (3) Average length of licensure and/or certification of professional nursing staff and the average length of licensure and/or certification of nurse aide personnel.
- (4) Nursing hours per patient per day of temporary agency professional nursing staff and nurse aide personnel.
- (5) Whether a resident council exists and meets on a regular basis.

Section 502. Nursing home consumer information.

- (a) Guide .-
- (1) The Department of Aging shall produce, in a timely manner, a nursing home information site on the Internet. It shall include:
  - (i) The items listed in section 501.
  - (ii) Information obtained from the annual Long-Term Care Facilities Questionnaires submitted to the Department of Health.
  - (iii) Information obtained from the Health Care Financing Administration Ownership Disclosure Form.
  - (iv) A comparative list of nursing homes developed in the manner provided in subsection (b).
  - (v) The Nursing Home Consumer Inquiry Telephone Hotline telephone number required under subsection (c).
- (2) If errors are found in the Consumer Information Internet Guide, all facilities shall be sent a correction sheet within 30 days of the Department of Aging's receipt of notification of the error. For the purposes of this section, an error shall be defined as information incorrectly transcribed from the forms provided to the Department of Health to the consumer guide.
- (3) The Department of Aging will send final proofs to the nursing home of its data profile that will be published in the consumer guide prior to publication. The nursing home will have five days to notify the Department of Aging of any errors to be corrected. If the Department of Aging receives no notification of errors, the data profile will be considered accurate and will be published.
- (b) Comparative list.—The comparative list of nursing homes shall be developed and included in the Consumer Information Internet Guide by the Department of Aging. It shall include the following information:
  - (1) Name of facility.
  - (2) Facility address and telephone number.
  - (3) Bed capacity.
  - (4) Owner of facility and managing company, if applicable.
  - (5) Type of sponsorship, including, but not limited to, governmental, nonprofit and for-profit or religious affiliation, if applicable.
  - (6) Payment sources accepted, including, but not limited to, Medicare, Medicaid, Veterans' Administration, long-term care insurance and private pay.
  - (7) Current license, deficiency and certification status as determined by the Department of Health; whether, within the previous five years, the facility has been subject to a provisional license, a ban on admissions, penalties imposed in connection with the licensure or certification process, a license revocation or appointment of a temporary manager to operate the facility or Medicare or Medicaid decertification and the corresponding dates.
  - (8) Nursing hours per patient per day and nursing hours required by the Department of Health per patient per day. Actual hours worked per patient per day are for the most recently concluded fiscal or calendar year.

- (9) Average length of service at the nursing home of professional nursing staff and the average length of service of nurse aide staff.
- (10) Average length of licensure and/or certification of professional nursing staff and the average length of licensure and/or certification of nurse aide personnel.
- (11) Nursing hours per patient per day of temporary agency professional nursing staff and nurse aide personnel.
- (12) A listing of existence and availability of specific therapy services, including, but not limited to, physical therapy, occupational therapy, speech therapy and respiratory therapy.
- (13) Whether a resident council exists and meets on a regular basis.
  - (14) Name and telephone number of a local ombudsman.
  - (15) Costs per day, month and year.
  - (16) Visiting hours.
- (17) If there are telephones available for private conversations.
  - (18) If there is a registered dietitian.
  - (19) If there is a written emergency evacuation plan.
- (20) The nearest hospital and the distance in miles from the nursing home.
- (21) If there are isolation rooms for patients with contagious illnesses.
  - (22) If there is an Alzheimer/Parkinson disease program.
- (23) Whether there are qualified physical therapists onsite.
- (24) Whether there is a written description of patients rights and responsibilities.
- (25) Whether there are written policies on "do not resuscitate orders," physical restraints and chemical sedation.
- (26) What medical services are available onsite, including dentists, podiatrists, pharmacists, ophthalmologists.
- (27) The current resident profile, including average age, race and sex.
- (28) Information on how to contact the local area agency on aging, including the services available to persons over 60 years of age through the local area agency on aging.
- (29) Information on community resources that can assist in the selection of a long-term care facility, such as trade associations or consumer advocacy groups.
- (c) Nursing Home Consumer Inquiry Telephone Hotline.—The Department of Aging shall establish a Statewide telephone number to serve as the Nursing Home Consumer Inquiry Telephone Hotline. This number shall be a toll-free number. The purpose of this telephone number is to respond to calls regarding the current licensure, deficiency and certification status of nursing homes. All data provided by the hotline shall be updated each week using information provided by the Department of Health in a timely fashion. This telephone number shall be prominently displayed in the annual Consumer Information Internet Guide.
- (d) Disclosure.—The State Long-Term Care Ombudsman in the Department of Aging shall mail at least the address of the Consumer Information Internet Guide to the local long-term care ombudsman of each area agency on aging, to each nursing home and to the Pennsylvania Council on Aging annually.
- (e) Availability.—Each nursing home shall post next to its Department of Health license an exact copy of its listing as found in the Consumer Information Internet Guide. A nursing home shall provide to each prospective resident and family member of such prospective resident who visits the facility, or any member of the public upon request, during normal business or visiting hours, Sunday through Saturday, an exact copy of its listing as set forth in the Consumer Information Internet Guide.
- (f) Inspections.—The Department of Health shall verify the availability of the listing during annual licensing surveys. The Department of Health shall monitor compliance with the requirements

- of this act for regular filing of the Long-Term Care Facilities Questionnaire with the Department of Health.
- (g) Update.—The Department of Health shall issue modifications to the Long-Term Care Facilities Questionnaire resulting from changes in the reimbursement system for nursing homes. Such modifications shall provide the same information in an updated format.
- (h) Regulations.—The Department of Aging shall promulgate regulations setting forth proposed additions, changes, or both, if the department does any of the following:
  - (1) Expands the scope of the consumer guide beyond those topics expressly set forth in subsection (a).
  - (2) Expands the scope of the comparative list beyond those topics expressly set forth in subsection (b).
  - (3) Expands the scope of any topic expressly set forth in subsection (a) or (b).

Section 503. Complaints.

Complaints of noncompliance with this act shall be filed with the Department of Aging. A complainant shall include a local ombudsman, a nursing home employee, a nursing home resident, a prospective nursing home resident, or any person representing the interests of a nursing home resident or prospective nursing home resident. Section 504. Additional consumer information.

Each nursing home shall provide to each prospective resident or representative thereof at the time of initial inquiry, a companion consumer guide which describes how to select a nursing home. This information can be either a publication of the Department of Aging, a camera-ready copy of a publication provided by the Department of Aging or a comparable publication that will inform the consumer on how to choose a nursing home.

Section 505. Penalties.

The Department of Aging shall have the authority to assess a \$1,000 civil penalty for each violation of this chapter. Any person aggrieved by an adjudication by the Department of Aging shall have the right to appeal under 42 Pa.C.S. (relating to judiciary and judicial procedure).

The SPEAKER. On the question of the adoption of the amendment, the Chair recognizes Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, amendment A2111 is an amendment that requires the department to establish certain nursing home consumer information on the Internet.

Mr. Speaker, growing older is a fact of life for every one of us. Here in Pennsylvania, by the year 2020, it is estimated that almost 25 percent of our population will be over 60. This number is staggering, and it also means that most of our families will be faced with making a very important decision about putting one of their loved ones into a nursing home, and they need all the information that they can get.

Now, every one of us has senior citizens in our district, and every one of us should want to help these families know that when they make these decisions, they are well informed about the information pertaining to this difficult decision. Currently Pennsylvania has provided very little information to help them make an informed decision about one of the most difficult yet

important decisions they may face: choosing the right nursing home for those whom they love.

You know, we work hard to ensure that proper care and treatment is provided inside our nursing homes, and as we are doing with this bill, however, we are doing very little to help those who are in the process of placing a family member in one of these homes. Those citizens have so many questions, so many concerns, and that is what this amendment is designed to do, is to help ease those fears and anxieties for our constituents who must make that life-changing decision.

Many of those decisions must be made immediately, and with very little time for writing letters, requesting booklets, visiting many different facilities, and comparing many varieties of reports that can be overwhelming to a stressed family member.

My amendment is simple. It says, in the information highway that we are on today, that we need to place this information in a useful, easy-to-read format on the Internet. The amendment calls for useful, practical information — information families want and need — accurate and up-to-date information to be placed at their fingertips.

Technology is moving at the speed of light, and the Internet is becoming a natural, commonplace location to turn for information. My amendment would ensure that our Commonwealth makes the best use of today's technology and enhances the printed information already available.

Now, Mr. Speaker, we all have our State Website address on our license plates. All we are asking today is, let us use this technology to help our families gain the knowledge they need to increase their comfort and decrease some of the stress that accompanies this decision.

Let me also say that this amendment was also a bill that was reported in the last session out of committee. It was reported June 15 of 1999 overwhelmingly out of committee. The time has come for this type of legislation, and I ask you for your consideration and your vote on this type of legislation. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the lady, Mrs. Vance, on the amendment, the DeLuca amendment.

Mrs. VANCE. Thank you, Mr. Speaker.

I rise to oppose the DeLuca amendment not because it is a bad idea, and a year ago this information was not available. The Department of Health recently posted on their Website a survey of all the nursing homes in Pennsylvania. You can see the deficiencies and the pluses of each nursing home, and you can see what each nursing home has done to correct it. Also, I would be happy to provide anybody with a Medicare Website that compares nursing homes side by side in each county so that you can compare them and know which is the best home for your loved one.

At one time in my career, I was a charge nurse in a nursing home, so I truly care a great deal about the care that these patients get. The information is now available. As Representative DeLuca, the prior speaker, said, it was not available a year ago. It is now available. But the best way to determine the best site for your loved one is a personal visit.

But again I ask for a "no" vote, only because it would replicate what is already there. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the lady.

The Chair recognizes the gentleman, Mr. Rooney.

Mr. ROONEY. Thank you, Mr. Speaker.

Mr. Speaker, I would like to ask the gentleman, Mr. DeLuca, to stand for a brief interrogation.

The SPEAKER. The gentleman indicates he will stand for interrogation. You may begin.

Mr. ROONEY. Thank you.

Mr. Speaker, you and I have worked on this issue for a long time, and I would like to just follow up on what the previous speaker suggested about the information that is contained in your amendment that would be offered to the people of Pennsylvania and the argument that it is not necessary, that the information already exists. Could you address that, because it is my understanding that that is not the case.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, although the department has made strides to put some of this information onto the information highway, which is voluntary – let me say this, it is not in statute; it is voluntary right now – a lot of this information, after researching it and having my staff people pull up some of the nursing homes in Allegheny County and talking to the Department of Aging in Allegheny County, we find out that a lot of this information is not available.

Let me just allude to what we are asking to be put on this informational highway which people do not have access to.

We are asking for the name and telephone number of the local ombudsman person there. We are asking for the cost per day, month, and year. We are asking for visiting hours. If there are any telephone numbers available for private conversations. Is there a registered dietitian on board? Is there a written emergency evacuation plan? What is the nearest hospital? If there are isolation areas and rooms for patients with contagious diseases. Is there an Alzheimer's or a Parkinson disease program? Whether there are qualified physical therapists on board. Whether there is a written description of the patient's rights and responsibilities. Whether there is a written policy on "do not resuscitate" orders, physical restraints, and chemical sedation. What medical services are available onsite, including dentists, podiatrists, pharmacists, ophthalmologists.

This is some of the information we are asking. Although some of that information is on a voluntary basis — it is not in statute — this is what we are asking for, to put in statute.

Now, I have contacted my Department of Aging in Allegheny County, and I had my staff person who is very well familiar with the Internet process, it took her a half hour to go through the different sites, and we got very little information pertaining to one of our nursing homes, which is a big nursing home, Beverly Nursing Home in Allegheny County, which is throughout the Commonwealth. We talked to the people of the Department of Aging. They could not access it themselves. They put us on to the ombudsman, who said there is certain information they could not give us.

But this is commonsense legislation, commonsense issues, requirements that somebody who is placing their loved one in this facility should know, to make an intelligent decision. We are in a busy world today. This is one of the toughest decisions a person has to make, and they should have this information. We are wiring up our schools, our libraries. Everybody is getting the Internet. The Governor is specifying that we do that on our license plates. Any one of you, turn on our Website on

our license plate and see what you can get as far as this information pertaining to your district.

That is what we are asking for, Mr. Speaker.

Mr. ROONEY. Mr. Speaker, I have concluded my interrogation. May I speak on the amendment?

The SPEAKER. The gentleman is in order.

Mr. ROONEY. Thank you, Mr. Speaker.

The SPEAKER. Will the gentleman yield for a moment.

There continues to be a loud, I cannot even call it an undercurrent anymore of conversation on the floor, and it is distracting to the people who are engaged in debate.

Mr. Rooney.

Mr. ROONEY. Thank you, Mr. Speaker.

Mr. Speaker, I commend the gentleman, the maker of the amendment, the Democratic chairman of the Insurance Committee. What this amendment would do would be to provide people with much-needed information. He referenced the fact that oftentimes choosing a nursing home for one's parent or loved one is the most difficult decision a family can face. I know that firsthand. And let me say that, you know, oftentimes family members do not all live in the same community as their parent. They may have moved after having gone to school. Whatever the case may be, they are not there. And for a child of a parent who is about to be placed into a nursing home, they care as deeply about how their parent will be treated as the people, their siblings, who live in that community, who have access to go to the facility, to be able to understand all the programs that are in place and how well their parent will be treated. But if you live in California and your mother is being put in a nursing home in Bethlehem, that can be very difficult to accomplish. What the chairman, Mr. DeLuca, has offered through this amendment is some very simple and basic information that I think is not in any way, shape, or form unreasonable to ask be posted on a Website so that people can have access to this very basic information. I do not think it is excessive. I do not think it is intrusive. I think it is something that needs to occur.

As he indicated, the chairman had this bill reported out of committee and voted on, as I recall, in the last session of the General Assembly. The time to act on this important issue is today. We have the vehicle to do that through amendment A2111, and I would just ask my colleagues to stand in support of providing Pennsylvania consumers with information that they need to make informed, reasoned, intelligent decisions about the care that their loved ones will be receiving in their remaining days.

So I ask my colleagues for an affirmative vote.

The SPEAKER. The gentleman, Mr. Blaum.

Mr. BLAUM. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the DeLuca amendment, and I have got to tell you, it is a little difficult to sit here and listen to the comments of those on the other side opposing this amendment when for years this department opposed the efforts of Representative Veon to amend legislation to get the very same information out to the people of Pennsylvania.

This information that is currently available is inadequate, and it is there at the whim of the department. It can go away at any time, and I daresay, Mr. Speaker, there is nothing on that Web page that the nursing home industry does not want on that Web page.

The people of Pennsylvania and the families of Pennsylvania deserve this information. They deserve it to be part of statute in Pennsylvania, that this information is required to be put before the public via the Internet and other means that may be available to us so that Pennsylvania families are knowledgeable about what information is contained in various reports submitted on various nursing homes.

We need only go back a few months, and we see the shortcomings of more than one department, as documented by the Auditor General in the inspections of nursing homes across Pennsylvania. This is basic information for Pennsylvania families. It should be in statute, and I ask the members for an affirmative vote.

The SPEAKER. The gentleman, Mr. Grucela.

Mr. GRUCELA. Thank you, Mr. Speaker.

Mr. Speaker, I, too, rise in support of Representative DeLuca's amendment. I believe it makes a good bill better. And like my good friend and colleague, Mr. Rooney, Representative Rooney, I have firsthand experience, and that experience, for 2 1/2 years my mother was in a nursing home. Luckily, having had county background and county experience, most of the information I was able to understand or know how to access. But I can tell you that many, many times there were members from other families who approached me for information, and that should not have to happen. I think this information is necessary. I think anyone who visits a nursing home or would have any member of their family in a nursing home would certainly appreciate this.

So I ask my colleagues to please support this amendment. I think it is a good amendment, and if you ever have the opportunity to visit these places firsthand, I think you can understand the intent.

So I ask for your support for Representative DeLuca's amendment. It makes a good bill better. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the lady, Mrs. Vance, for the second time on the amendment.

Mrs. VANCE. Thank you, Mr. Speaker.

I asked that we oppose it because the information was there and is repetitive, but I will say that I will not allow old people to become a political issue, so it is there already; I pulled my nursing homes up without any problem, but we will put it in again. So we will all vote "yes." Thank you.

The SPEAKER. On the question of the adoption— Do not lose this now, Mr. DeLuca.

Mr. DeLUCA. I thank the Representative from Cumberland County for her remarks, but let me say this to you: I did not skirt the committee process. This bill came overwhelmingly out of committee on June 15, 1999. The information is not available. I disagree with my colleague. We have been on the Internet. We could not ascertain it, and I hope that each one of you would try to ascertain it as an individual to see what information that you could find out about a nursing home in your district.

So I appreciate and I thank her for supporting the amendment. I just hope that it will stay in in the Senate. Thank you very much.

Mr. GORDNER. Final passage.

The SPEAKER. The gentleman is in order.

Mr. GORDNER. Thank you, Mr. Speaker.

I am going to vote "no" against this bill, and I may be one of the few that do. I happened to take the time to pull up the Volunteer Health Services Act, and in section 2 of the act, it talks about the purpose, and it says. "It is the purpose of this act to increase the availability of primary health care services by establishing a procedure through which physicians and other health care practitioners who are retired from active practice may provide professional services as a volunteer in approved clinics serving financially qualified persons and in approved clinics located in medically underserved areas or health professionals shortage areas."

The purpose of this act, again, was to do three things: one, to allow folks to be in approved clinics serving financially qualified persons or to be in approved clinics located in medically underserved areas or health professionals shortage areas. This bill allows those volunteer folks to take care of their cousins and their sisters-in-law and their brothers-in-law and their nephews and nieces and everyone else, and it goes beyond what the intent of this Volunteer Health Services Act was supposed to do, and as a result of that, I am going to be voting "no." Thank you.

The SPEAKER. Ms. Steelman.

Ms. STEELMAN. Thank you, Mr. Speaker.

I am joining the gentleman who just spoke in opposing the bill, which is a little bit embarrassing because I originally signed on to it, but the more I look at this legislation, the more

I am concerned that there is a potential for abuse here when we have physicians prescribing drugs for members of their own families that we should not overlook. As the previous speaker pointed out, this language, generous and thoughtful though it may seem to be, actually violates the original intention of the volunteer licenses. Regretfully, we have to recognize the fact that medical professionals themselves have higher rates of drug addiction and abuse than the general population. Looking at the potential here for abuse within the family, I do not think I can support this bill.

The SPEAKER. Mrs. Vance.

Mrs. VANCE. Thank you, Mr. Speaker.

I believe perhaps a clarification may be in order.

Several years ago we passed the volunteer health license bill for retired health-care practitioners. Retired physicians have always been able to prescribe for their family. That has never changed. That has always been the practice. So some of them started to work in volunteer clinics with a volunteer license, giving of their time. The Department of State said, well, the legislation that we had passed earlier did not specifically give them the right to continue to do that. So we need to do this in order for them to keep volunteering in clinics. We had physicians who were already volunteering in clinics who decided, well, if I cannot continue to prescribe for my family, as I had for generations and generations, I am not going to volunteer my time.

The bottom line, by voting "no" on this, is that you are impacting people that are getting much-needed service in clinics because these retired health-care professionals are volunteering their time, and I urge you to vote "yes" in order to facilitate these clinics. Thank you, Mr. Speaker.
