LANCASTER'S ALL-AMERICA CITY DELEGATION PRESENTED

The SPEAKER. The Chair recognizes the gentleman from Lancaster County, Mr. Sturla.

Mr. STURLA. Thank you, Mr. Speaker.

Mr. Speaker-

The SPEAKER. Will the gentleman yield.

Members, please take your seats. Sergeant at Arms, move the group from the rear of the well. The conference to the right of the Speaker, please break up. Members, please take your seats.

The Chair recognizes the gentleman from Lancaster County, Mr. Sturla.

Mr. STURLA. Thank you, Mr. Speaker.

Mr. Speaker, as we get started here, I am going to be joined by Mayor Charlie Smithgall, who is the mayor of the city of Lancaster; Jose Lopez, who is with the Spanish American Civic Association; Alice Yoder, who is representing Lancaster General Hospital, who is one of the prime sponsors of our group; Vernon Fisher from the Lancaster Partnership; and Sherri Rigg of the Lancaster Campaign.

Mr. Speaker, recently Lancaster, Pennsylvania, won a rather prestigious award in Louisville, Kentucky, when we were

named an All-America City. Comprised of approximately 55,000 residents, the city of Lancaster was one of the 10 winners to receive this coveted award. The 10 winners were chosen from 30 finalists, which had originally been part of the 130 applicants.

Lancaster sent a delegation of 90 residents to Louisville, Kentucky, to perform a skit about the city's programs before a panel of 12 judges. The performance, entitled "Building Up Our Streets," displayed the works of the SACA Development Corporation, the Lancaster Campaign, the Partnership Charter School. The selection of the winners was based on each delegation's performance and the efforts of their communities to promote social and civic improvements.

By being chosen an All-America City from cities across the nation, the city of Lancaster has truly proven itself as a vital component of this Commonwealth and has brought great credit upon itself and its residents and I believe all Pennsylvanians.

So I would like to present this citation to the group today for display in Lancaster. We are going to be doing a bunch of celebrating in Lancaster tonight, and then we have a brief presentation from the students themselves. So if I could present this.

If I could, if the students want to do their thing in the back there, you are on.

(A song was sung by a group of Lancaster residents.)

And I think the members can see why we were a winning city this year with that kind of enthusiasm. Thank you.

JAMIE BEAM PRESENTED

The SPEAKER. Mr. Sturla, you are recognized.

Mr. STURLA. Thank you, Mr. Speaker.

Mr. Speaker, this is a big day for Lancaster. We, obviously, had the previous presentation, but I am also joined today by Jamie Beam, and her father is here, John Beam, and her coach, Jacques Viau.

I just want to introduce you to a rather outstanding athlete. She has been a standout athlete—

Mr. STURLA. She is a three-term varsity starter on the basketball team and has amassed an outstanding 776 career points. She was named All-Lancaster-Lebanon League First Team and was named the first team of the All-Lancaster-Lebanon League. She was named the New Era Athlete of the Year and earned accolades as the most valuable player in the East-West All-Star Roundball Classic. She has innumerable successes in the track and field team, and her accomplishments include winning the javelin, discus, and shotput in the 1999-2000 Stanley Morgan Invitational Track Meet and being named the co-outstanding female athlete of the meet. She was also named the New Era Athlete of the Week and earned first place at several PIAA meets.

She is an outstanding athlete and a compassionate individual and is truly deserving of the praise and recognition, but the reason she is here today is because she is also the State discus champion, and so in addition to all those other

accomplishments, we are here today to recognize her for her accomplishments as being the State discus champ.

THOMAS JEFFERSON HIGH SCHOOL VARSITY ICE HOCKEY TEAM PRESENTED

The SPEAKER. Mr. Levdansky.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, I want to extend a hearty welcome to the coach and to the members of the Thomas Jefferson hockey club. This team has traveled to Harrisburg to visit with us today, and I am joined today also with Representative Harry Readshaw. Representative Readshaw and I represent the municipalities which comprise the West Jefferson Hills School District, which is where these fine young athletes attend school.

Just a little bit of background about this fine team. This team this year won the State championship. The team has been in existence for 20 years and the league has been in existence for 25 years, and in that period of time, no team in the State has ever won the State championship 3 consecutive years. That is what this team did this year.

Sixty players comprise this hockey club. Those 60 players are in three different divisions — the freshman division, the junior varsity, and then the varsity team.

We are joined at the podium today by their coach, Mr. Don Powell, and three fine athletes on this team — E. J. Greco, Brian Hartman, and John Kirk.

As I mentioned, this team has won the State championship 3 years, and this year the team posted a record of 29 and 1. That was a little bit better than last year's, although maybe not. Last year's team set a record in this State for going undefeated. They had a 26-and-0 regular season record. What that translates into is in the last 2 years, this team has comprised a record of 55 and 1 over the last 2 years, and in the last 3 years, they are an astonishing 77 wins and only 4 losses.

Mr. Speaker and members of the House, not only are these people successful in their sport, but I also want to pay tribute and just, you know, briefly note the sacrifice that these people make for their love of hockey. Hockey in most school districts and in the Thomas Jefferson School District is not a sport that is funded with taxpayer dollars. So these players and their families and their fans and their supporters and their coaches must work to raise the necessary funds in order to finance their equipment, their ice time, their traveling expenses, and all the other things that comprise their budget. So they have to work to raise that money because they do not get regular ongoing support from the local school district, but the school district does help in other ways.

So today I just want to offer my congratulations to these fine young men and to the coaches and to the parents not just because of their accomplishments in 3 consecutive years of victory as State champs, but also, also for their dedication and their spirit of volunteerism in working together to raise the necessary funds on their own in order to finance their team activities

So with that, Mr. Speaker, again I want to welcome them to Harrisburg and thank you for this opportunity.

I, too, would like to extend my heartiest congratulations to the coach and the members of the Thomas Jefferson hockey club that are here with us today on their great accomplishments of winning a championship, not only once but 3 years in succession.

I am pleased and honored to have this opportunity as we welcome them to the State Capitol, and I spoke to the coach before, and I understand it is the first time for several of them. So I hope they enjoy their visit, and once again, on behalf of the House, I extend our heartiest congratulations, and I wish them great success in the future years. Thank you, Mr. Speaker.

LOWER MERION HIGH SCHOOL GIRLS 4 X 100 METER RELAY TEAM PRESENTED

The SPEAKER. The Chair recognizes the lady from Montgomery County, Ms. Connie Williams, who is invited to the podium, and the lady from Montgomery County, Mrs. Cohen.

Ms. Williams.

Ms. WILLIAMS. Thank you, Mr. Speaker.

Mr. Speaker, we are very glad to bring some women to the podium today. Representative Cohen and I are honored to introduce to you today the Pennsylvania State champion girls 4 x 100 meter relay team from Lower Merion High School. These young women are also the All-State first team in Pennsylvania and have made the National Honor Roll of Best Times in the United States. This team, coached by Sandra Hoopes, captured the gold medal at the 2000 PIAA Class AAA girls track and field championship at Shippensburg University on Saturday, May 27, 2000. This is the first girls track and field State title in Lower Merion's history, and we are very proud of them. Their time of 48.14 seconds beat out Norristown's 48.26 and Strath Haven's 49.2.

I would like to present Allison Gibbs of Ardmore, who is cocaptain. She will be attending Virginia Union University.

Avise Hayes of Wynnewood, cocaptain, will be attending Spellman College; Dominique Adger of Bala Cynwyd, the only freshman but she ran in middle school; and Lorraine Weldon of Bala Cynwyd, the anchor who will be next year's captain. Also with us today are Dana Hunting, a sophomore, who is the alternative and ready to go next year with the departure of the two seniors; Coach Hoopes; and her prime cheerleader, who is in the back of the House, her husband, David.

Coach, you have coached track and field for 26 years at Lower Merion. You were Representative Cohen's daughter's coach, and to you and to our dazzling runners we offer all our congratulations and wish you great success in all the races you have yet to run.

May I present our great track team.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER pro tempore. The Chair recognizes the lady from Chester County, Mrs. Taylor.

Mrs. TAYLOR. Thank you, Mr. Speaker.

I would like to submit my remarks for the record on SB 8.

The SPEAKER pro tempore. The lady will submit the remarks to the clerk. The Chair thanks the lady.

Mrs. TAYLOR submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

As chairperson of the Tuition Account Program Advisory Board, I urge you today to support SB 8 – the TAP Enhancement Act.

As amended, SB 8 improves the existing TAP program and offers families the option of a mutual-fund-style investment program, with earnings tied to the performance of the financial markets.

This is an exciting time for the Tuition Account Program. I am pleased to report TAP is enjoying unprecedented growth — more than doubling enrollment since 1997. There are now nearly 38,000 accounts and the TAP Fund is valued at more than \$195 million. Pennsylvania families opened more than 7,500 new accounts last fiscal year and more than 9,000 new accounts this year.

But we can do an even better job of making a college education available to everyone by increasing accessibility to the program. SB 8 will further broaden the appeal of TAP and make it a truly inclusive program.

One key provision would enable Treasury to share strong investment returns with TAP account holders, potentially increasing the value of individual accounts even faster than tuition inflation. TAP will be the only State-sponsored plan that both guarantees to match tuition inflation and make it possible for accounts to grow faster than inflation.

Other improvements will:

- Allow families to pre-purchase private college tuition, with the TAP guarantee. (TAP accounts can already be used at any college, public or private. The act, however, would enable families to buy credits and get the guarantee at private college average tuition levels, or at individual private colleges that choose to participate.)
- Permit families to use TAP to save for room, board, and other expenses, in addition to tuition. (Recent changes in Federal law clear the way for TAP to also help families save for other approved educational expenses, such as room and board, while still getting all of TAP's tax breaks.)
- Provide fairer refunds and simplify refund provisions. (The act would simplify refund provisions and allow TAP to refund as much as permitted by Federal law, creating fairer refunds for account termination.)
- Enable organizations to provide scholarships featuring TAP's benefits. (Under the current law, a beneficiary must be designated at the time a TAP account is opened. TAP has had to turn away community and business organizations interested in opening TAP accounts to be used as scholarships. The act would enable such organizations to create scholarship accounts, with the recipient to be named later.)
- Ensure TAP retains its Federal tax benefits by fully complying with Federal law.

For families who deem the TAP savings program too conservative an investment, SB 8 will also allow participants to enroll in a new investment program similar to a mutual fund — with earnings tied to the performance of the financial markets.

(A market-based program offers potential for greater return than could be achieved under the existing program. Participants would enjoy the same tax benefits offered with the existing program. That is, your account grows entirely free of State and local taxes while Federal tax liability is deferred until the account is used — then charged at the child's lower rate.)

(Most new State-sponsored college tuition programs are investment-style programs, and national publicity about these types of programs has generated interest in Pennsylvania to establish a similar program. It is important for Pennsylvania to offer both types of programs to effectively serve the needs of all our families.)

SB 8 is similar to a companion bill I introduced last year which many of you, on both sides of the aisle, cosponsored. I would like to thank my colleagues who helped build a consensus on the bill's final language. This bill, as it is before you, includes amendments requested by Representatives Stetler and Williams.

Mr. Speaker, this legislation fundamentally deals with a mine subsidence insurance program. This amendment hopefully clarifies how that program will work in that it places some limits on the grants that an individual homeowner would be eligible to utilize if their home was subject to subsidence. It also creates a little better definition as to what homes would be subject to the mandatory subsidence insurance, as well as providing a means to appeal that decision should someone feel that it does not apply to their home.

I think that it certainly improves the intent of the bill to provide an insurance program for these folks and would ask the members for their support.

The SPEAKER pro tempore. On the amendment, the Chair recognizes the gentleman from Washington County, Mr. Solobay.

Mr. SOLOBAY, Thank you, Mr. Speaker.

This is an agreed-to amendment to the bill, and we ask the body's support.

The SPEAKER pro tempore. Mr. Daley, do you seek recognition as well? The gentleman is recognized.

Mr. DALEY. Thank you, Mr. Speaker.

I rise in support of the Smith amendment. This amendment inserts a definition of "Dwelling requiring mine subsidence insurance," and it requires that for a claim to be considered valid, the department must determine that the mine subsidence event occurred during the term of the mine subsidence insurance policy. It also requires that an application for assistance be submitted to the department within 45 days of occurrence of the mine subsidence event, provides that grants may be used for temporary housing, and changes the interest-rate provisions on loans. Furthermore, it requires that individuals who receive loans must continue to maintain mine subsidence insurance during the duration of that loan, requires that repairs for which grants and loans are provided must be completed within 1 year of the receipt of the loan, and provides for a report on mining subsidence damage as it relates to the effective date of this legislation.

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Clearfield County, Mr. George.

Mr. GEORGE. Mr. Speaker, this amendment requires the Legislative Budget and Finance Committee to conduct a study on the amount of time that elapses from the point that banks or financial institutions receive money that is payable to the Commonwealth and to the time it takes for the Commonwealth to be credited with that money. This report shall include the amounts of possible interest that these financial institutions are gaining from such funds; in 1998 nearly \$62 billion in profits, a figure that was topped again in 1999 for the ninth straight year. Meanwhile, a bank-friendly legislature continues to ignore laws that will protect and inform consumers, communities, and taxpayers.

I think we should adopt this amendment. Thank you.

The SPEAKER pro tempore. On the amendment, the Chair recognizes the gentleman from Schuylkill County, Mr. Allen.

Mr. ALLEN. Thank you very much, Mr. Speaker.

I support the gentleman from Clearfield's amendment. Thank you.

The SPEAKER pro tempore. Those in favor of the amendment will vote "aye"; those opposed, "no." The members— The Chair apologizes. Mr. Fargo.

Mr. FARGO. Thank you, Mr. Speaker.

Could I ask the maker of this amendment a question?

The SPEAKER pro tempore. Mr. George, are you willing to stand for interrogation? The gentleman indicates that he is. You may proceed, Mr. Fargo.

Mr. FARGO. Thank you.

Mr. Speaker, I do not have a copy of the amendment here but it was on our computer here, and it indicated that any time a bank receives cash or checks that are owed to the Commonwealth or payable to the Commonwealth. How does a bank receive cash other than checks that are supposed to go to the Commonwealth that the Legislative Budget and Finance Committee could track, cash that comes to a bank that belongs to the Commonwealth, to track the time that the bank holds that cash until it gets to the Commonwealth? I understand the checks, but I do not fully understand what you mean by cash received by a bank.

Mr. GEORGE. Mr. Speaker, I assume that a wire transfer could in some way be classified as "cash." I think we all know what the amendment does. Whether it says cash and there is no cash, it does not hurt the amendment; it does not hurt the banks; it does not hurt anything. I think you know the purpose of the amendment. I know you should. You are an accountant, I am told, and a very smart one, so you know all the amendment does. It intends to keep government in the position where people understand that we that are here doing their business are

doing it in an appropriate way to watch out for their money. That is all it does, and I know that if it says cash and they do not take any cash, I have never had an opportunity to deal with the banks like maybe you have, Mr. Speaker, but I am just assuming that the terminology does not hurt a thing, sir.

Mr. FARGO. Thank you, Mr. Speaker.

I am in full sympathy with what you are attempting to find out and control, but I am just still concerned that the use of the term "cash" is incorrect.

The other question I would ask is, have you contacted the chairman or any person in authority in the Legislative Budget and Finance Committee to find out if they can do this within the year after this bill has been signed and becomes effective? I have been on that committee in the past, and I know that it is their procedure to approve or accept the suggestion that it takes on audits like this. I am curious, have you asked anybody in the Legislative Budget and Finance Committee if they can handle this job?

Mr. GEORGE. Mr. Speaker, truthfully, I have not. I assume that they work at our will and beckoning and, therefore, did not feel that we had to send them a postmortem and ask them whether they could do this or whether they should have the choice on what they do or what they do not do. I think this legislation mandates that they do it, and that is why I have introduced it, Mr. Speaker.

Mr. FARGO. Thank you, Mr. Speaker.

Could I make a statement?

The SPEAKER pro tempore. The gentleman is recognized.

Mr. FARGO. In my short experience on the Legislative Budget and Finance Committee, I know that they have a regular schedule. They have so many people that are auditors, and they accept certain things that the legislature asks them to do, and I agree with the maker of the bill on this. But I know that they accept this; they put their auditors out on individual jobs, and they have these things scheduled a year in advance. And I just do not believe that they are going to be able to take care of what we are requesting here in this amendment, and I think that we should be checking with that before we require or even ask them to take over a job like this. I am still concerned about the controlling of cash that comes to a bank and how you determine to make sure that that cash gets to the Commonwealth in any period of time.

I would suggest that we do not accept this amendment.

The SPEAKER pro tempore. On the amendment, the Chair recognizes the gentleman from Delaware County, Mr. Raymond.

Mr. RAYMOND. Thank you, Mr. Speaker.

Mr. Speaker, I serve as secretary of the Legislative Budget and Finance Committee, and the prior speaker was correct in what he said, that we have certain staffing problems that we have encountered and we have certain things we must do. In a case like this what we might do is go to outside help, and we do appreciate when members have requests like this if they do talk to us ahead of time. We try, you know, to do what we can to resolve all questions that members of the House or the Senate have with regard to things like this, and we will find a way, probably, to get this thing done if it is passed by the House.

I am not so sure how we would go about doing it. I have been on it a number of years. It is a difficult thing to go back and do. I am not so sure we had the expertise in-house that we had going out of house when we had to to accomplish issues like this. So if it is passed, I think that we will be able to address it in the proper form and fashion and do the best we can. Thank you.

The SPEAKER pro tempore. Mr. George, for the second time. The gentleman is recognized.

Mr. GEORGE. I guess I do not need an actuarial study to tell me this is the second time.

I will say I thank the gentleman for his confidence, but I want to remind the men and women of this body that if we choose to do something right, I am sure that fine committee will act responsibly. We have given them a year to do it, and therefore, I think we should pass this amendment, Mr. Speaker.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Fargo, for the second time.

Mr. FARGO. Thank you, Mr. Speaker.

I really am concerned about whether this is a function that the Legislative Budget and Finance Committee can do even if they have the time. I do not know how many banks, I wish I knew how many banks there were in Pennsylvania, and how many checks and cash, if that is an item that is traceable, will be received by the banks and to get the information as to how much time it took them, from the time they received the check from the person who is cashing the check until it gets to the Commonwealth, and for 1 full year determine how much time it is. The idea is excellent. I believe that there should be some control over the amount of time that a bank keeps the cash or holds the cash. It is sort of a float that they have, and I am sure they would like to be able to keep it for a long period of time. But I just question that it is possible within reason to expect this commission to do this or even if they can do it, and I think that we should have checked with the commission before we put this job on their shoulders. So I would really request that we do not accept this amendment.
