Unfortunately, hepatitis C is one of the risks that they face in saving lives.

Last year I had hoped that the city of Philadelphia would deal with this issue and accept responsibility for helping the professionals who protect everyone who lives in, works in, and visits Philadelphia. Unfortunately, the city chose not to. That is why we are here today, Mr. Speaker, to make sure that the job gets done. Thanks to Representatives Thomas and Belfanti and their amendments, we are going to help police, firefighters, paramedics, corrections officers from all across this Commonwealth.

I started this legislation with law enforcement officers, and then we added the firefighters, paramedics, and corrections officers. This legislation offers protections to our volunteers as well. In most communities, as you all are well aware, volunteer firefighters and paramedics are the backbone of our communities. We have a moral responsibility to these brave men and women.

The changes we are making in the workers' compensation law are simple. We want to make sure emergency responders and corrections officers are given legal presumption that if they contract hepatitis C, that it is considered job related.

As you know, some of the valiant heroes are here with us today, Mr. Speaker, in the hall. As first responders, these people deal with blood and exposure to disease virtually every day. They risk their lives for each and every one of us. It is simply unbelievable to think that someone would question them on this. To me the connection is clear.

Last September California changed its workers' compensation laws to do what we are trying to do here today. One of the examples that they cited as a reason for protecting their emergency responders was Philadelphia, Mr. Speaker.

The facts are clear. Our moral calling is clear. I ask the members to support HB 1633 on final passage. Thank you, Mr. Speaker.

What Mr. Bunt's amendment does is simply insist that the word "untested" be provided, and I am in agreement thus far, and my opinion is that the important part of the amendment is in there and that it goes a long way to protecting those of our citizens in the Commonwealth in regard to materials being dumped that we do not know anything about, but yet we know automatically that they are either hazardous or they are of a residual nature and, therefore, could compound the problem.

So I am asking that we adopt this amendment also.

Mr. GEORGE. If it would not impoverish you, I certainly would.

Mr. GEORGE. I would hope. I might as well get something out of you this session; I have got darn little, if you know what I mean. You are grinning.

The SPEAKER. Of course I am. The gentleman is recognized.

Mr. GEORGE. I thank the gentleman.

Mr. Speaker, it is my understanding that 1493 creates a crime for the destruction of crops. Now, Mr. Speaker, if I go on your land and destroy something of value, there are at least three crimes — vandalism, trespassing, and agricultural vandalism — that you could be charged with. So HB 1493 does not change anything or change something that is not legal today, but it simply sets a new crime or this crime as a way to make tougher penalties. And I am not against this, but it is a fair question to ask why, and I think you would answer that you are doing this because you want to protect Pennsylvania farmers. Well, Mr. Speaker, I want to protect Pennsylvania farmers, too.

Just last week, Mr. Speaker, DEP (Department of Environmental Protection) reported that they think they caught a trucker who was trying to mix infectious waste with municipal waste and trying to hide it from that landfill and the regulators. So, Mr. Speaker, hiding waste and mixing waste, that is the type of problem that this amendment is trying to stop, and we can do something about it in this bill. All my amendment says is if you mix hazardous and residual waste with sewage sludge, and then if that combination destroys crops or hurts the land, you can be charged under this act also. So, Mr. Speaker, I say if you destroy our farmlands whether by fire or vandalism or, as my amendment proposes, through the use of dangerous chemicals, you should be charged, and if convicted, you ought to pay the price.

I ask that we adopt this amendment.
