Section 1. Section 202 of the act of July 31, 1968 (P.L.805, No.247), known as the Pennsylvania Municipalities Planning Code, reenacted and amended December 21, 1988 (P.L.1329, No.170), is amended to read:

Section 202. Planning Commission.—If the governing body of any municipality shall elect to create a planning commission, such commission shall have not less than three nor more than nine members. [All members of the commission shall serve without compensation, but may be reimbursed for necessary and reasonable expenses.] Except for elected or appointed officers or employees of the municipality, members of the commission may receive compensation in an amount fixed by the governing body. Compensation shall not exceed the rate of compensation authorized to be paid to members of the governing body. Without exception, members of the planning commission may be reimbursed for necessary and reasonable expenses. However, elected or appointed officers or employees of the municipality shall not, by reason of membership thereon, forfeit the right to exercise the powers, perform the duties or receive the compensations of the municipal offices held by them during such membership.

HB 1498, the numbers that are being allocated in that bill are not available to the members, and I would at least like to see what we are doing with this bill in terms of the public transportation funds that are being allocated to the different areas of the Commonwealth.

The SPEAKER pro tempore. Hold, please.

The Chair recognizes the gentleman, Mr. Markosek.

Mr. MARKOSEK. Thank you, Madam Speaker.

Madam Speaker, HB 1498 would remove the cap from the supplemental transit funding. Act 3 of 1997 was passed 4 years ago that indicated that 1.22 percent of the sales tax would be dedicated to mass transit funding with a cap of \$75 million. If we multiply 1.22 times the current sales tax estimates, there would actually be, if we did not have a cap, an additional \$16.8 million that would be beneficial to the transit fund. This bill, HB 1498, would remove the cap, which would allow the transit funds to accept that money over the \$75 million, which, as I indicated, is estimated to be \$16.8 million.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Dally, for the second time.

Mr. DALLY. Madam Speaker, a question for the prime sponsor.

The SPEAKER pro tempore. The gentleman agrees. You may proceed.

Mr. DALLY. Thank you, Madam Speaker.

I have been handed a distribution of the funds under the proposed bill, and I notice that the Lehigh Valley area of Pennsylvania is receiving only a 4-percent increase whereas State College, for instance, is getting a 10-percent increase and the two urban areas, Philadelphia and Pittsburgh, 30 and 33 percent respectively. I am wondering, is there a formula that is utilized to determine where these excess funds go?

Mr. MARKOSEK. Madam Speaker, there is a formula. These funds go into the transit formula and are divvied up that way. The formula will not change with the passage of this legislation. The only thing that will change is the amount of money that will go into the fund and be divvied up by the formula. So all of the transit organizations in Pennsylvania will receive the same percentage that they currently receive, but there will be a bigger pie that they will be able to receive it from. So all of the transit agencies will receive some increase.

Mr. DALLY. Okay. Thank you, Madam Speaker.

STATEMENT BY MR. GANNON

The SPEAKER pro tempore. The gentleman, Mr. Gannon, is recognized.

Mr. GANNON. Thank you, Mr. Speaker.

Mr. Speaker, on unanimous consent.

The SPEAKER pro tempore. The gentleman is recognized.

Mr. GANNON. Mr. Speaker, today the Legislative Budget and Finance Committee issued its report on the cost benefits of the mental health insurance coverage as required under Act 150 of 1998. This report is being issued and sent to the members of the Insurance Committee of the House and Senate, and I would urge every member of the House to obtain a copy of this report that contains very, very critical information about the impact of Act 150 with respect to mental health insurance coverage in Pennsylvania, and most significantly, it shows and demonstrates quite clearly the insignificant cost of expanding mental health coverage to those folks in need in Pennsylvania.

As you know, this issue has been vigorously resisted by the insurance lobby in Pennsylvania, and over the course of the past couple years, they have issued studies and reports showing astronomical cost increases if we require that mental health coverage be covered as equal as physical health coverage.

However, this report, this report belies all of those fabrications. This report is based on actual numbers, actual experience under Act 150. And, Mr. Speaker, it is time to move forward now in Pennsylvania and provide mental health parity coverage for every Pennsylvanian. Thank you, Mr. Speaker.
