The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On the question of final passage, the Chair recognizes the gentleman from Delaware County, Mr. Vitali. The gentleman will yield for a moment.

Members, please take your seats. The gentleman, Mr. Vitali, desires the courtesy of the floor.

Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the bill stand for brief interrogation?

The SPEAKER. Mr. Egolf? Mr. Egolf indicates he will stand for interrogation. You may begin.

Mr. VITALI. Mr. Speaker, how does this differ from current law? Every classroom I have been in, there has been a flag, and every class I have seen commence, the Pledge of Allegiance has been recited. How does this differ from current law?

Mr. EGOLF. Current law does not require that there be a flag in every classroom. It does not require that every schoolday is started with the pledge or national anthem. This bill would require that, but students could opt out of it. It is not a requirement that they do the pledge, but it is a requirement that the school offer it. Current law does not require that. Current law just says that a school must have a flag on the school property and that they have to provide some instruction on the flag, the care of the flag, history, and so on.

Mr. VITALI. Now, is there any problem we are trying to address here? Are you aware of any instances where there are not flags or there are not recitations at the appropriate times?

Mr. EGOLF. Yes. In fact, members of the veterans organization had come to me and said that there were problems out there, that a lot of schools were not doing it anymore, as we were all used to when we grew up, and would I be interested in putting legislation to require it. So I was not aware of a problem either, so I thought I would check, and the first student that I asked in my home district, who happened to be a piano student of my wife's, I asked her if they started the day off with the Pledge of Allegiance to the flag, and she said, well, at the beginning, on the first day of school, the teacher asked the students how many would like to do this, and as we know, students are reluctant to put their hand up first; none of them did, and so they did not do it. They said, okay, we will not do the pledge, and they did not do it for the rest of the year. That was the first incident, and then I found out that a number-Well, there is one school in the local area here that does it once a week, and I have been told of other incidents. I do not know the numbers, but yes, there certainly are schools that I have been told that do not have this as a regular tradition.

Mr. VITALI. Now, this bill, as I understand it or as I read it quickly, if a student did not want to recite the Pledge of Allegiance, the only way he could not do that would be to get his parents' permission not to do it?

Mr. EGOLF. Right. Maybe for religious reasons or whatever, so if the parents want to— Apparently, there are some religions that do not do the pledge, so they can opt their child out of that.

Mr. VITALI. And to what grades does this law apply?

Mr. EGOLF. To what grades?

Mr. VITALI. Yeah.

Mr. EGOLF. To all grades, 1 through 12.

Mr. VITALI. So if you had a senior who, for whatever misguided or exploratory reasons, decided he simply did not want to do this and his parent would not give him permission not to, he could be compelled to say the Pledge of Allegiance?

Mr. EGOLF. Well, it is offered for them. I assume, you know, it is up to the classroom teacher. Just like anything else, if the student does not want to participate in class, the teachers do whatever they can to get them to participate, so I would assume they would do the same here, unless the parents have actually opted the student out of it. But, you know, that is up to them locally. You cannot make a person say something, I suppose, but if they stand there and do not create a disturbance, that is up to the teacher.

Mr. VITALI. What would be the sanctions for noncompliance with this law of having a flag or not saying the Pledge of Allegiance?

Mr. EGOLF. It would be whatever sanctions the school does for other disciplinary things. If there are other things, which we know the school requires a lot of things that the students must do, and if they do not, then it is the local school's determination how they want to handle it.

Mr. VITALI. So the law itself does not provide any sanctions?

Mr. EGOLF. There is no punishment in the bill; nothing specified. It is just like all the other requirements in school. Again, it is the local school's determination how they want to handle any disciplinary action.

Mr. VITALI. Has the School Boards Association taken a position on this bill?

Mr. EGOLF. They have not. It is more neutral. They say that there are provisions now for schools to have flags. I am not sure— They say that they already do it.

They really say there is not a problem. They are not opposed to it at all. They just say that they think it is being handled now, but obviously, from my findings, it is not.

Mr. VITALI. Okay. Thank you.

That concludes my interrogation. I would just like to speak briefly.

The SPEAKER. Are you going to advocate that those who do not comply be drafted?

Mr. VITALI. No; no.

The SPEAKER. That would have been my suggestion.

Mr. VITALI. I know I am too old.

The SPEAKER. The gentleman, Mr. Vitali. I am sorry.

Mr. VITALI. Thank you, Mr. Speaker.

I love my country as much as everyone else, and it is important to be united in these times. I am just a little uneasy about government compulsion of pledging allegiance to the government, and there is just something I am a little uneasy with here. I expect to vote for this, but I am just a little uneasy with what we are doing here. Thank you.

The SPEAKER. Ms. Josephs.

Ms. JOSEPHS. May I interrogate the maker of this bill, please?

The SPEAKER. Mr. Egolf indicates he will stand for interrogation. You may begin.

Ms. JOSEPHS. Thank you, Mr. Speaker.

Mr. Speaker, we have gone through a dialogue about a child who does not want to say the pledge and what may or may not happen to that child. Teachers, principals, administrators, adults employed by the school district may have religious and moral reasons for not wanting to participate in a fairly compulsory exercise, proving basically nothing. What answer does your bill have for a teacher who never salutes the flag and does not particularly want his or her students to be put under this regime?

Mr. EGOLF. My bill does not address that. I am sure that is in the School Code now as to how the school would handle teachers who become a problem and do not fulfill the requirements of the—

Ms. JOSEPHS. I am sorry. I am really having a hard time hearing you.

The SPEAKER. Will the lady yield.

Let the gentleman, Mr. Egolf, answer the lady's question, please.

Mr. EGOLF. Okay. If I understand, your question was a teacher that does not want to fulfill this requirement, does not want to offer the pledge at the start of the schoolday. My bill does not address that, because the School Code would address how a school would handle teachers that do not do what they are supposed to do now under the School Code. I am sure the code addresses that; my bill does not.

Ms. JOSEPHS. Thank you, Mr. Speaker.

My interrogation is finished. May I address the issue?

The SPEAKER. The lady is in order.

Ms. JOSEPHS. Thank you.

It appears by the answer of the speaker to my interrogation that the problems that he talked about in various school districts, where administrators and teachers were not following the code as it now stands, will not be in any way changed by this legislation. So the problems that he seeks to address by his own admission are not going to be addressed, and I would suggest that this is a burden on our children, proves nothing.

We have schools in this district, we have plenty of schools in this State that do not even have books. Let us work on the books, not the flags. Thank you, Mr. Speaker.

The SPEAKER. Go ahead.

Mr. DeLUCA. Mr. Speaker, I was just sitting back here, and I just had to make this comment: I would hope there would never be a teacher in our schools who would not follow this bill, and if they are in our schools, then I hope we terminate them.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
