Mr. GODSHALL. Thank you, Mr. Speaker.

I had an amendment filed to this bill, and what the amendment was going to do— If I could have your attention just for a couple of minutes, I would appreciate it.

The SPEAKER. Conferences on the floor, please break up. Staff people on the floor not involved in matters presently pending, please take your seats.

Mr. Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

The amendment that I filed to this bill would have gutted the bill and replaced it with another amendment that we had passed unanimously some time ago in this chamber. It was our MTBE (methyl tertiary butyl ether) bill, which is a gasoline additive, which is polluting our drinking water and killing, literally killing our people where MTBE is added to the gasoline.

We had a hearing on this bill last week in Philadelphia. We had a doctor, Peter Joseph, Ph.D. in physics from Harvard University and now teaching at the University of Pennsylvania, tell us of the research he has done on MTBE. We had Thomas Jefferson University corroborate that testimony with their own findings.

Right now in the city of Philadelphia where asthma is being monitored, since MTBE has been added to the gasoline with a countrywide average of 7 percent, the schoolkids in Philadelphia are experiencing a 27-percent asthma rating. The number of fatalities since MTBE has been added to the gasoline from asthma has increased - this goes back 5 years - from 2,000 to over 5,500 people dying from asthma. There is an absolute correlation between asthma and even attention deficit disorder and MTBE in the gasoline.

I have been doing my best to get this bill run in the Senate, and I have not been able to do so. I had every intention today of running that bill as a substitute, gutting the bill that was before us, which, as you know, came from Senator White over in the Senate,

and putting in the MTBE legislation. I have been assured by my leadership that there will be another opportunity, and this bill is part of a package of bills that have been agreed to by both sides.

So at this point I am going to withdraw this legislation, but I can assure this caucus and I am going to supply – not this caucus, this House – I am going to supply the members of the House with the information that we have as to the volatility of MTBE. It is polluting our water, it is making our kids sick, and it is killing our people. Eleven to twelve other States have banned it already. Chicago just recently banned it for use in their city, and Anchorage, Alaska, has done the same thing because of the asthma problem. You know, we have to do something, and it is going to be done. But I will withdraw the amendment as of this time, and I thank you, Mr. Speaker.

The SPEAKER. May I have your attention, please. Conferences in the vicinity of the Democratic leader's desk, please.

Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, it has been on the minds of all of us along with our constituency in the past several months to have read and to have been notified where there have been a multitude, a great number of trucks that have been involved with the waste industry that were stopped in one given day and there were more than 412 violations of safety that were involved with those individual trucks.

Now, Mr. Speaker, this so-called investigation was carried on with the previous administration; it is carried on today, rightfully so, but there has got to be an action, and the action that I suggest and offer to you as responsible legislators is that these big trucking companies that care very little about the safety of the motorist on the highway – and the fact is that the law insists that their trucks be safe - we recognize that many of these trucking fleets have their own inspection apparatus where they inspect their own trucks. So, Mr. Speaker, I am saying where you have this violation, then I believe that it ought to be the obligation of the department to take an action to remove, if one of those trucks is found in violation of the safety of the rules and regulations that the Department of Transportation insists upon, that we remove that opportunity for them to inspect their own trucks.

So, Mr. Speaker, this has gone on and on and on, and it can only be stopped if we say to those people, if you want the right to be trusted, if you want the right to be able to conduct the business, if you want the right and the obligation to do your own truck inspection, then you make darn well they are safe for the roads and that they will not be responsible for killing someone, and I would urge that we would accept this amendment, Mr. Speaker.

The SPEAKER. Mr. Casorio.

Mr. CASORIO. Thank you, Mr. Speaker.

I rise in support of the George amendment.

As the floor knows and the constituents in my district know, I have a landfill, one of the 50 operating landfills, in my district, and I also have a parking facility, a truck depot, a storage depot, that Secretary Hess and the DEP (Department of Environmental Protection) came to inspect last July and August that put 80 percent, 80 percent of the trucks, several hundred garbage

trucks, out of service for mechanical defects, safety violations, that were rumbling through our community.

This amendment goes a long way in helping the residents of my community. I witnessed that firsthand; the people of my district witness that every single day. This is a good operations bill. This bill allows Secretary Hess of the DEP to continue to inspect waste haulers, make sure that they provide service, and make sure that those trucks are safe when they rumble through our communities, Mr. Speaker, where our children and our senior citizens work and play.

I would ask that for all of those individuals in this chamber that have landfills and parking facilities for waste disposal trucks to support the George amendment to HB 46.

The SPEAKER. The gentleman from Philadelphia County, Mr. Waters, has a number of guests seated in the gallery this morning. I am going to take this opportunity to welcome them to the floor while I am awaiting some paperwork from the minority leader's desk prior to completing the bill that is before us.

These guests are students from the Anderson Elementary School, Catherine Elementary, and Walnut Street Elementary. They recently participated in the Representative's "There Ought To Be a Law" contest. Tyree Robinson was selected as the winner on behalf of the House, and we congratulate you and all of the students for your participation.

I would like to mention that Mrs. Maxine Collier, the principal of Anderson Elementary; Ms. Sallie Flanagan, principal of Catherine Elementary School; and Ms. Lynn Sharps, the vice principal of Walnut Street Elementary School, are also in attendance. We welcome all of you and your sponsors and officials of the schools. Welcome to the House of Representatives. At this time the gentleman, Mr. Waters, has a few remarks to make in connection with this visit.

Mr. WATERS. Thank you, Mr. Speaker.

The clerk read the following amendment No. A0773:

Amend Title, page 1, line 2, by removing the period after "crossings" and inserting

; and further providing for refunds.

Amend Bill, page 2, by inserting between lines 5 and 6

Section 2. Section 9017(d) of Title 75 is amended and the section is amended by adding a subsection to read:

§ 9017. Refunds.

[(d) Off-highway recreational vehicles.-

(1) When the tax imposed by this chapter has been paid on fuel used in off-highway recreational vehicles within this Commonwealth, an amount equal to the revenue generated by the tax, but not derived therefrom, may be appropriated through the General Fund to the Department of Conservation and Natural Resources. It is the intent of this chapter that all proceeds from the tax paid on fuel used in off-highway recreational vehicles within this Commonwealth be paid without diminution of the Motor License Fund.

(2) The Department of Conservation and Natural Resources shall biennially calculate the amount of liquid fuel consumed by off-highway recreational vehicles and furnish information relating to its calculations and data as may be required by the Appropriations Committee of the Senate and the Appropriations Committee of the House of Representatives.

(3) The General Assembly shall review the fuel consumption calculations of the Department of Conservation and Natural Resources to determine the amount of liquid fuels tax paid on liquid fuels consumed in the propulsion of off-highway recreational vehicles in this Commonwealth and may annually appropriate to the Department of Conservation and Natural Resources the amount so determined.

(4) Money appropriated under paragraph (3) shall be used for the benefit of motorized and nonmotorized recreational trails by the Department of Conservation and Natural Resources as provided in the Intermodal Surface Transportation Efficiency Act of 1991 (Public Law 102-240, 105 Stat. 1914).]

(d.1) Motorized recreational vehicles.—An amount equal to 50% of the tax imposed by section 9004(a) (relating to imposition of tax, exemptions and deductions) on fuel consumed in the operation of motorized recreational vehicles within this Commonwealth, but not to exceed \$1,000,000, shall be refunded out of the Liquid Fuels Tax Fund to the Department of Conservation and Natural Resources in the following manner:

(1) There is hereby established a special nonlapsing restricted receipts account in the State Treasury to be known as the Recreational Trails Trust Fund.

(2) One-half of the tax revenues, not to exceed \$1,000,000, generated by the tax imposed by section 9004(a) on fuel used in motorized recreational vehicles used within this Commonwealth, as determined by the Department of Conservation and Natural Resources, shall be annually refunded to the department through the Recreational Trails Trust Fund.

(3) All moneys in the fund are hereby appropriated on a continuing nonlapsing basis to the Department of Conservation and Natural Resources for the activities referred to in paragraph (5).

(4) All interest earned by the fund and refunds or repayments shall be credited to the fund and are hereby appropriated in the same manner as paragraph (3).

(5) All money in the fund shall be used by the Department of Conservation and Natural Resources in accordance with the recommendations of the Snowmobile and ATV Advisory Committee for the acquisition, creation and maintenance of trails used by motorized recreational vehicles and for enforcement in State forests and State parks. * * *

Amend Sec. 2, page 2, line 6, by striking out "2" and inserting

On the question recurring, Will the House agree to the amendment?

The SPEAKER. On the question of the adoption of the amendment, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the amendment stand for brief interrogation? The SPEAKER. The gentleman indicates he will. You may proceed.

Mr. VITALI. Thank you, Mr. Speaker.

Quite frankly, this amendment really slipped through before I had a chance to scrutinize it, and the only thing I really saw as it was being considered was the issue of ATVs (all-terrain vehicles), which is a sensitive issue in some circles. So I just wanted to ask the maker of the amendment some questions to understand more fully what we are voting on. I know this might be of particular concern to sportsmen and environmentalists.

Mr. Speaker, I mean, just briefly could you initially outline the intent of this amendment before any more specific questions. Just outline, what does this amendment do?

Mr. WILT. Mr. Speaker, this amendment does two things: number one, it clearly defines what a recreational trail is in Pennsylvania; and number two, it takes \$1 million out of the Motor License Fund, which has been contributed by snowmobilers and ATVers into the Motor License Fund at PENNDOT. There is about \$7 1/2 million over there on an annual basis, and we take \$1 million of that and give it to DCNR (Department of Conservation and Natural Resources) so that their trail advisory group can push that money out through trail projects throughout the Commonwealth.

Mr. VITALI. Mr. Speaker, is the expected result of this amendment to expand the creation of ATV trails in State parks and forests?

Mr. WILT. The expansion of any trails would be at the discretion of the trail advisory group, of which all the stakeholders are members. They meet on a regular basis. They review plans and grant requests from around the State, and as they see fit, they approve projects, and those projects are funded through the fund that is over at DCNR.

Mr. VITALI. But the moneys that we are appropriating today, it is contemplated that some of those funds will be used for additional trails in State parks and forests. Am I reading that correctly?

Mr. WILT. That would only occur if the trail advisory group approved those trails to be built in those areas. This does not mandate that they are built in those State parks and State forest lands. That is not what this legislation is all about. That is what the trail advisory council is all about – approving those trails where they see fit – and all the stakeholders are in that process at this point, and we are going to keep them at the table reviewing these projects as they come through.

This is simply an additional appropriation from the Motor License Fund to DCNR for the construction of more

recreational trails in Pennsylvania as approved by the trail advisory group.

Mr. VITALI. This would be up to \$1 million for more trails in

State parks and forests. Would that be correct? Up to \$1 million for more trails in State parks and forests?

Mr. WILT. Mr. Speaker, I do not think you are getting my point. We are not mandating where the trails go. That is left to the trail advisory group. We are simply adding another million dollars to create opportunities for recreational trails in Pennsylvania. The source of the million dollars is the Motor License Fund.

Mr. VITALI. Okay.

I am looking at your amendment. This would be the final page, page 2—

Mr. WILT. Mr. Speaker, can I interrupt you for one second? Mr. VITALI. Sure.

Mr. WILT. Over the past several years-

The SPEAKER. Mr. Vitali, for what purpose do you seek to interrupt?

Oh, Wilt. Mr. Wilt, you are interrupting.

Mr. WILT. Just as a point of clarification, Mr. Speaker, because I want to make a point to the person asking me questions, because I keep getting the same question and I keep issuing the same answer. So I want to add one thing to my answer and hope that I will not get the same question again.

Mr. VITALI. Sure.

The SPEAKER. Go ahead and try.

Mr. WILT. During the budget process over the last few years, we have, through our budget process, taken \$1 million out of the General Fund and matched the million dollars that we get from the Federal government in our trail program that is administered by DCNR. What this amendment does, and we have passed this amendment several times in this body, it replaces that General Fund amount of \$1 million with fees from the Motor License Fund, and the fees at the Motor License Fund are created by the snowmobilers and ATVers at the gas pumps in Pennsylvania. Right now, all that money is being spent by PENNDOT. All we want to do is take \$1 million of about \$7 1/2 million that is created every year and use that as the money to match the Federal funds. That is all we are doing.

Mr. VITALI. Am I incorrect in assuming right now, Mr. Speaker, that the department is not using funds right now to build new trails in State parks and game lands? Is that correct, they are not using it now? Is that correct?

Mr. WILT. That is correct.

Mr. VITALI. Okay. Now, I am reading this; I am reading page 2, section (5). It talks about creation of trails – I am skipping a few words – but creation of trails in State parks and forests. Is that correct?

Mr. WILT. No; you are leaving out the key word, Mr. Speaker—

Mr. VITALI. Okay.

Mr. WILT. —which is on the last line. This is going to be used for enforcement, which is the biggest problem we have with off-road users in Pennsylvania.

Mr. VITALI. Okay.

Mr. WILT. So to the extent that we can improve enforcement where these ATV or snowmobile trails already exist – in my area, it is the Allegheny National Forest, which is obviously done through the Department of Interior, not through DCNR – but those sections that do come onto State lands, we want to make sure that there is enough money there to repair any damage and to enforce illegal use, and that is what we are trying to accomplish through the definition, and that is something that DCNR has asked for, it is something that the trail advisory group needs, and all we are doing with this piece of legislation is creating the funds to do what they have said they have not had funds to do in the past.

Mr. VITALI. The question is, can this money be used to create new trails in State parks and forests?

Mr. WILT. Mr. Speaker, with all due respect, there is nothing in this amendment that lifts the current moratoriums, that changes the parameters, that does anything to change the authority that the trail advisory group has already in the process of reviewing applications for recreational trails in Pennsylvania. The stakeholders already exist. We want to give them the resources to do a better job of creating recreational opportunities within Pennsylvania and maintaining the trails that exist and enforcing the laws as they pertain to illegal use. That is it. We are not stepping on anybody's toes; we are not making any mandates. We are simply creating a funding source that can go on in perpetuity so that we have a process for driving these dollars out to be used in efficient and effective ways throughout the Commonwealth. That is why we need to have this transfer, so that we do not have to come back to the well every year and match the money that we get from the Federal government through the General Fund process, that we have gas-tax dollars being transferred over. It makes a lot of sense to do it this way. It is the same model that we use for the Fish and Boat Commission on our waterways in Pennsylvania, where boaters have their gas taxes transferred over to the Fish and Boat Commission. The same model, the same thing we do; I cannot say it any better than that.

Mr. VITALI. Mr. Speaker, have any groups such as the sportsmen's groups or the environmental groups taken a position pro or con on this amendment?

Mr. WILT. They have never opposed it before. We have passed it in this body a number of times. Those are the stakeholders that I am referring to that sit on the trail advisory council, that have an opportunity to review trail requests as they come in for either reconstruction or new construction. They make the call over there. All I am doing is providing them with a funding source.

Mr. VITALI. Thank you, Mr. Speaker. That concludes my interrogation.

The SPEAKER. On the question of the adoption of the Wilt amendment, those in favor—

Mr. SURRA. Mr. Speaker?

The SPEAKER. Mr. Surra. Pardon me.

Mr. SURRA. Thank you, Mr. Speaker.

Will the maker of the amendment rise for a brief interrogation? The SPEAKER. The gentleman may proceed.

Mr. SURRA. Thank you, Mr. Speaker.

When a gallon of gas is purchased in Pennsylvania, Mr. Speaker, approximately how much of that in dollars and cents goes to taxation?

Mr. WILT. I cannot answer that in total, but I will say this: When it comes to the amount of gas taxes that are generated by off-road users – and these are numbers given to us by the Department of Transportation – it equates to about \$7 1/2 million a year based on the number of registered vehicles, the amount that they are used, and there is a formula – obviously they do not have odometers on a lot of them, so it is difficult to say exactly – it is the same formula we use for the boats, for the transfer that occurs for the Fish and Boat Commission.

Mr. SURRA. I was under the impression, Mr. Speaker, that it is somewhere around 45 cents a gallon for the—

Mr. WILT. Well, that is the total excise tax; end total, yes. Mr. SURRA. So thenMr. WILT. That is Federal and State.

Mr. SURRA. People that use dirt bikes, ATVs, snowmobiles, then are putting in about \$7 to \$8 million a year into the motor vehicle license fund?

Mr. WILT. Correct, and this amendment takes only a million of that and transfers it.

Mr. SURRA. And we would take a million dollars of the \$7 or \$8 million that these operators pay every year then and use that to develop trails. Is that what you are attempting to do?

Mr. WILT. Correct.

Mr. SURRA. And also provide additional enforcement.

Mr. WILT. Most importantly.

Mr. SURRA. Thank you, Mr. Speaker.

On the amendment?

Mr. Speaker, I support the Wilt amendment. You know, we recently passed legislation which requires all ATV users in the State of Pennsylvania to register them, to license them, and physically place a plate on them, and right now in the State of Pennsylvania, Mr. Speaker, I think there are 188 miles of trails that they can ride. Now, I invite everyone to go up on Interstate 80 on some Friday afternoon and watch SUV (sport utility vehicle) after SUV pulling a trailer with three or four ATVs on them from your areas, and they are coming up into the north-central part of Pennsylvania. They are not bringing those vehicles up there to wash and wax them, Mr. Speaker; they bring them up to ride them, and we do absolutely nothing or very little to provide opportunities for these people.

Now, I understand that Pennsylvania State forests are utilized by many groups, but I believe that they are big enough that we can utilize them with proper enforcement to provide some trails. Mr. Speaker, people are leaving Pennsylvania to other States that recognize how these enthusiasts can bring revenue into their States. Those other States are building trail systems so they can ride them and enjoy them. They are riding on the State forests and State game lands right now, and they are doing it illegally. It is happening everywhere. What we need to do is provide them someplace where they can legally enjoy this sport. There are hundreds of millions of dollars in ATVs being bought every year in Pennsylvania, and we provide very little places for them to ride.

I think the Wilt amendment is very fair. When somebody buys gasoline for their boat, we take that revenue and we use it to build docking ramps and places where people can access the waterways of Pennsylvania. The ATVers pay this tax and they get absolutely nothing for it, and we are taking \$1 million to provide additional enforcement and hopefully provide some trails which will be approved by a committee. I think it is a reasonable amendment. It is something we passed in the past, and I encourage the members of this Assembly to vote "yes."

Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Hanna, on the question. Mr. HANNA. Thank you, Mr. Speaker.

I rise in support of the amendment as well. I would point out to the members that this is one area where I think the environmentalists and the ATV enthusiasts agree. In fact, what we need to do a better job with ATVs and with off-road transportation in this State is more money, and we need it for enforcement and we need it for trail development. So both sides agree that we need more money to do this, and Representative Wilt's amendment does that. So I rise in support of it, and I encourage all of you to vote in favor of it.

STATEMENT BY MR. LAWLESS

The SPEAKER. Mr. Lawless.

Mr. LAWLESS. Thank you, Mr. Speaker.

Mr. Speaker, I want to update the members on that very important issue to me about a young girl in my district, Erin Jacobs, and what we attempted to make was Erin's Law to make E. coli a reportable disease in Pennsylvania and set sanitary standards in Pennsylvania.

As you know from previous conversations that I have had on the floor, this bill has been held up by the Senator from York. In fact, basically he has said it is dead and will not be reported out of his Agriculture Committee in the Senate, even though it passed this House unanimously.

Mr. Speaker, yesterday that same Senator from York reported a bill very similar to Erin's Law that we reported. He reported it out of committee yesterday. There is one huge difference. He has deleted petting zoos that would last for 2 days or less. They are exempt from such legislation. Mr. Speaker, why is this important? This is important very simply because E. coli bacteria is not exempt from animals who attend zoos, petting zoos, or 4-H events of 2 days or less. See, E. coli bacteria does not know when an animal is going to go for only 2 days into a petting zoo. So it is not like the bacteria itself makes a decision and says, this is only going to be a 2-day affair; we will not attack these children.

Mr. Speaker, this legislation, which I assume moved through the Senate and will be coming over to the House, is absolutely ridiculous. The parents of Erin have asked me to oppose this legislation in the House when it comes here. We intend to amend the same language and send it back to the Senate, and hopefully the colleagues in here will understand that animals do not know whether it is 2 days or 3 days when they carry a bacteria that attacks children's kidneys, appendix, colon, large intestine, small intestine. See, animals do not understand as the gentleman from York, the Senator, thinks that animals do understand and have a brain to say to someone, no, we will not attack that child if you only keep us out here for 2 days. This is absolutely ridiculous legislation. It does nothing to protect the children of Pennsylvania.

Politics are still being played over in the Senate by the man from York. It is time we stopped playing politics. Move legitimate legislation to protect the children of Pennsylvania, and I would ask my colleagues to look at this bill closely, this Senate bill when it comes over, because it is nothing more than politics. It does not save one child in Pennsylvania from a deadly bacteria.
