  - (iii) Interest rates shall [be fixed at 5%.] <u>not</u> exceed 5%, except as provided in clause (iv).
  - (iv) Loans made to a small business enterprise that is an agricultural producer shall be made at an interest rate of not less than 2% for the term of the loan if a declaration under 35 Pa.C.S. § 7301(c) (relating to general authority of Governor) is in effect for a natural disaster. A small business enterprise that is an agricultural producer must be physically located in the area of the natural disaster

and must make loan application within nine months of a declaration specified in this subparagraph.

- [(iv)] (v) All loans must be adequately secured.
- (3) (i) Applications for assistance under the Capital Loan Fund Act which have been approved prior to the effective date of this chapter will be processed in accordance with the act of July 2, 1984 (P.L.545, No.109), known as the Capital Loan Fund Act. An Act amending the act of August 9, 1955 (P.L.323, No.130), known as The County Code, further providing for compensation of solicitors appointed by county officers.

On the question,

Mr. **GEORGE** offered the following amendment No. **A1240**:

Amend Title, page 1, line 10, by removing the period after "officers" and inserting

; and providing for investigative powers relating to solid waste disposal.

Amend Bill, page 2, line 2, by striking out all of said line and inserting

Section 2. The act is amended by adding a section to read:

§ 2102. Investigative powers relating to solid waste disposal.

The county commissioners may designate a county employee and an authority established under 53 Pa.C.S. Ch. 56 (relating to municipal authorities) and may designate an authority employee with the investigative power granted to the Department of Environmental Protection under section 1707 of the act of July 28, 1988 (P.L.556, No.101), known as the Municipal Waste Planning, Recycling and Waste Reduction Act, on property or facilities that are presently permitted by the department under the environmental laws and regulations of the Commonwealth in order to investigate whether solid waste is being disposed of within the county in violation of the Municipal Waste Planning, Recycling and Waste Reduction Act. Such designated employees are authorized to share information gathered in this investigation with their employer, State and local government officials and the courts.

Section 3. This act shall take effect in 60 days.

The bill we have under consideration here is a Local Government Commission bill. It is correcting an inconsistency in the code, a very simple inconsistency, which currently does not explicitly allow for solicitors for controllers, and I would ask the members to oppose all amendments to it so that we can get it out cleanly. It is a very simple bill, and I do not think it ought to be a vehicle for other more complicated issues.

Thank you.

The SPEAKER. Mr. George, on your amendment? Do you wish recognition on your amendment?

Mr. GEORGE. I am sorry. I did not hear something that was said.

The SPEAKER. He said your amendment was not worth voting for. Now it is your turn.

Mr. GEORGE. I would hope that a man of your intellect would not be taken in with such dribble.

The SPEAKER. Not without listening to you, no.

Mr. GEORGE. You know, Mr. Speaker, if individuals such as this lowly individual do not stand up on this House of

Representatives, which I have been privileged to be a part of for 28 years, coming from a rural area, I may not be much, but it is the best they have, and I am going to continue— Oh, you go ahead and holler, because there will be a day when things will change, and I pray to God that I will be here when they do, because I do not believe there is much difference in a Republican or a Democrat when we are hurting or we are bleeding—

The SPEAKER. Mr. George, on the amendment.

Mr. GEORGE. I am on the amendment. I just take a heck of a long time to get there, Mr. Speaker.

The SPEAKER. You are right again.

Mr. GEORGE. So, Mr. Speaker, I got a call from my solid waste county organization here 2 weeks ago, and they said, you know, we see trucks that are going into this dripping, and they are dumping solid waste illegally, and I said, well, why do you not go in there and do something about it? Down here in Harrisburg we are all talking about that we need to handle that waste project, but no way should we be relegated to accept what they are doing to us. Dave Hess and his troops are out daily to stop the infiltration of solid illegal waste. They are out there daily, Mr. Speaker, trying to stop these trucks and their illegal actions. And it is only the actions of a small few; it is not all of them, but they say we have no authority to go in there and look, only the DEP (Department of Environmental Protection) does. So by the time you call the DEP and they come down the road 2 days later, that big bulldozer has bulldozed all of that solid waste in with a couple hundred thousand tons of soil that you could not even have a trace.

So the amendment is not any good? Maybe you think it is not, but I think there are a lot of people in Pennsylvania that will agree with us that we ought to be able to have our local authorities and give them the authority to go in and investigate these matters. I think it is a heck of a good idea, I think it is an idea that has long gone by, and I think responsible people will join with me. If you do not, we will be back.

## STATEMENT BY DEMOCRATIC LEADER

The SPEAKER. The gentleman, Mr. DeWeese. Do you desire recognition?

Mr. DeWEESE. Thank you very much, Mr. Speaker.

Just a momentary comment on the State Government Committee's report. The measure that was just brought forward from committee through the Speaker's dais and will be reported to the floor in short order on congressional reapportionment is one that needs a couple minutes of commentary.

I feel that what was reported was just a rendition of the unconstitutional work that came from this process not too long ago. The committee that just met a couple minutes ago in the back of the hall of the House had the chance to incorporate a bill that I had introduced on behalf of my colleagues – we were attempting to make it an amendment – and it was tacitly agreed to by the court. It would have allowed for zero deviation; number two, it would have allowed for fewer incumbents to be pitted against each other, in conformance with Federal case law; and it would have allowed for zero precincts in the State to be sundered.

These were three manifestly important elements of the court

decision that hurled reapportionment back to us, Mr. Speaker. If we had fewer incumbents running against each other and fewer precincts sundered and we comported with Federal case law, as our amendment did, on deviation, then we think that we would have had a rock-solid piece of legislation to be voted on and signed by the Governor.

Notwithstanding the party-line vote, with one exception, our effort did fail, and we will be anxious to debate the issue in subsequent opportunities here on the floor.

Thank you very much, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

# STATEMENT BY MAJORITY LEADER

The SPEAKER. Mr. Perzel, the majority leader, is recognized. Mr. PERZEL. Thank you, Mr. Speaker.

It is interesting that we would hear about a no-deviation plan. The gentleman voted along with me when we did the House reapportionment for the House of Representatives and the Senate where we had a deviation of around 1,500, plus or minus. So nobody could have expected that the courts would have thrown out a plan that had a deviation of, plus or minus, roughly 19, Mr. Speaker.

Nobody mentioned in any of the decisions that we saw the fact that there were fewer incumbents who were put together; no one mentioned that fact whatsoever.

The plan as we have it right now, which we expect to be amended probably Monday, will not have any broken precincts in it, Mr. Speaker.

So the issues that the court brought up will be directed and will be fixed. We will have a standard deviation of zero, Mr. Speaker, when we are done with the plan, and we will make sure that we do not break any precincts, and that should take the test of the Constitution out of the courts, put it back where it belongs, allow the reapportionment plan to go forward, and have our primary on the day that was selected of May 21, Mr. Speaker.

So we are hoping to be able to accomplish that. The vote on this will be on Monday, and I believe that we will have a majority of the members of both parties, as we did last time, for this plan.

So thank you, Mr. Speaker.

The SPEAKER. Mr. DeWeese.

Mr. DeWEESE. Just to make certain that the record reflects, Mr. Speaker, that the reason I voted on final passage for the last plan was, it was the best alternative at the moment. It was certainly unpalatable, but as this process reflects again and again and again and as I have said at least 10 times in 26 years, Bismarck said that politics is the art of the possible, the art of the next best, the art of the deal. I want the record to reflect that although I did vote, as the gentleman from Philadelphia has observed, on final passage in favor of the measure, I did so with great reluctance and dubiety.

I would like to add one additional point before I relinquish the microphone, Mr. Speaker, and that would be that as much as I am favorably disposed and full of admiration for the majority party's effort to go to zero deviation and to sunder no precincts, I still believe there is potentially a fatal flaw in the proposal, and that is that we still, against Federal case law, are pitting incumbent against incumbent and incumbent against incumbent and incumbent against incumbent and incumbent against incumbent, and it is unnecessary; it just is unnecessary. So we still may be stymied by our jurisprudential brothers and sisters on the Federal court because of this phenomenon.

We have some time to think about it, and hopefully in the spirit of harmony, we will come up with a good proposal that will be acceptable to the United States Federal courts. Thank you very much.

The SPEAKER. The Chair thanks the gentleman.

Mr. PERZEL. Mr. Speaker?

The SPEAKER. Mr. Perzel.

Mr. PERZEL. I wish the gentleman on the other side of the aisle had felt the same way on reapportionment for the House of Representatives, where we did try to protect incumbents from having their seats done away with, but he did not bother to practice what he is preaching to us right now when it was his turn to do so for the House of Representatives. So I would just like to bring that up, and we are not, I guess, in the business of protecting incumbents; we are in the business of making sure that our congressional delegation goes from the 21 it has now to 19, because that is what we are mandated by the Federal government to do, Mr. Speaker.

We are doing everything possible right now, Mr. Speaker, to avoid a September primary, and I would hope that we do not have to go to something like that.

The SPEAKER. Mr. DeWeese.

Mr. DeWEESE. The gentleman's lamentations to the contrary notwithstanding, he voted for it along with me.

The SPEAKER. So did I.

Mr. DeWEESE. And so did the honorable Speaker.

But anyway, again, for the record, there is a different body of case law. The Federal case law obviously is different than the State case law, and again, for the record, I do momentarily feel that the absence of some of our future departed members will be keenly felt by all of us.

## PARLIAMENTARY INQUIRY

The SPEAKER. Mr. Rooney, do you desire recognition on this? Mr. ROONEY. A parliamentary inquiry, Mr. Speaker.

Mr. ROONEY. I know it was stated earlier, but if you would be kind enough to restate the timeline for filing amendments to the bill that was just reported from committee.

The SPEAKER. Under the rules of the House, it would be necessary to file amendments by 2 o'clock tomorrow, unless the rules are suspended at some later date. Without suspension of the rules, you must file your amendments by 2 o'clock Thursday.

Mr. ROONEY. Thank you, Mr. Speaker.

The SPEAKER. Any further business?
