Mr. BENNINGHOFF. Thank you, Mr. Speaker.

I just wonder if the maker of the bill would rise for a moment for two questions.

The SPEAKER. The gentleman, Mr. Browne, indicates he will stand for interrogation. You may begin.

Mr. BENNINGHOFF. Thank you.

The SPEAKER. The gentleman will yield.

Please. The House will come to order.

Mr. Benninghoff.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

I was recently reading through a report put out by the Pennsylvania Health Care Cost Containment Council, and I was curious as I read through this; it was a pretty comprehensive report on what our managed-care organizations are doing here in the Commonwealth. Specifically, it talks about patient safety, patient satisfaction, what services are available, referrals to the managed-care organizations, and what was denied. I was just curious if this legislation is really going to provide anything differently.

I think it is important to note that here in the Commonwealth we have a lot of information already available to us. In the sake of trying to maintain costs here in the Commonwealth, I do not want to be redundant in order to do that, and I see as I look through this current legislation that we will be appropriating another \$100,000 to provide a report that is already available us to.

Additionally, the National Committee for Quality Assurance program could be accessed on the Net through "www.ncqa.org" for those who are computer literate and able to access information through the Internet. So I think this information is readily available, and I am concerned that as a government we are being redundant. I would like to ask the maker if he feels that there is something else that will be provided through this legislation that is not currently available in this report.

Mr. BROWNE. Mr. Speaker, the purpose of this legislation, as it was last year, is to provide a statutory mandate for what HC-4 is doing. HC-4 is providing performance-based measures now, but there is no statutory mandate for it, so I believe with the change in administrations, the priorities in terms of what HC-4 does and how they report information delivered to them from hospitals and national data sets may change. I think the General Assembly has a vested interest in making sure that we continue this process, and the primary purpose of this legislation is to give a statutory

mandate for this.

Mr. BENNINGHOFF. Mr. Speaker, just to follow that up, while I have the greatest respect for the gentleman who has introduced this legislation, my second question, is there going to be an annual cost of \$100,000 to do this or will that be the initial cost?

Mr. BROWNE. The annual cost, fiscal note annual cost, is \$100,000 a year.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

I guess I would ask the members to take that into consideration at a time we are looking at some fiscal constraints in our budget and vote accordingly. One hundred thousand dollars is a significant amount of money. While I appreciate the efforts of the member, I do believe as a government body we need to not be redundant in the services that we provide, and more importantly, I believe this report is very comprehensive.

Thank you, Mr. Speaker, and I thank the maker of the bill for his comments.

The SPEAKER. The Chair recognizes the gentleman, Mr. Nickol.

Mr. NICKOL. Thank you, Mr. Speaker.

I would like to agree with the concerns expressed by Representative Benninghoff.

First of all, the sponsor said there is no statutory mandate for H-4C to produce this report, and he is correct about that. However, Act 68 of 1998, the patients' bill of rights legislation that most of us voted for and we passed back in 1998, does require all Pennsylvania-based HMOs to be accredited by the NCQA or a similar organization, and NCQA is essentially the Good Housekeeping seal of approval for managed-care plans nationwide, and they maintain this Web site with this information on all the HMOs or virtually all of them in Pennsylvania.

I am very familiar with their Web site. I am a member of the Public School Employees' Retirement System. We maintain HMOs for many of the retirees across the State, and I researched NCQA just to judge the quality of the HMOs that we are making available to our members to participate, and in looking at those, I mean, all you have to do is put in your ZIP Code and it gives you all kinds of detailed information on all the Pennsylvania HMOs.

So my question, similar to Representative Benninghoff's, is, why do we need this? Why do we have to spend additional money through the Pennsylvania Health Care Cost Containment Council to give us something, information we have already required by law and is already available? I would urge members to take careful consideration in approving this bill for that reason. Thank you.

The SPEAKER. The gentleman, Mr. Browne.

Mr. BROWNE. Thank you, Mr. Speaker.

While I appreciate the comments of the prior speaker in regard to the merits of this bill, the report put out by NCQA is a report that is based exclusively on a HEDIS (Health Plan Employer Data and Information Set) data set, and they structure it in such a way that it aligns itself in four major categories, unlike HC-4's report that takes a lot of that information and splits it out so it is a lot more specific for different measures of treatment. Both reports actually encompass a customer satisfaction survey, but in the HC-4 report it takes the customer satisfaction survey and makes it in a lot more detailed, a lot more customer-friendly method.

One of the things that makes this bill valuable and a merit to the citizens of Pennsylvania is HC-4 can structure their report to meet the needs of the citizens of the State, specifically in treatment and in prevention that may be different for Pennsylvania as opposed to

other places throughout the country. NCQA's report is something that is a national report, and they could set generic standards for the entire country.

You must understand that HC-4 is a product of State government; NCQA is not, and it is a function primarily financed by the insurance industry, and we have a lot more independent control over what is reported by HC-4 in terms of what is important to Pennsylvania consumers. It is an independent agency that we can rely on to provide customer-based satisfaction measures and performance-based measures on our health plans.

So in terms of the independence of HC-4, the differences in the reports, the differences in the information that they report on, I think it has value outside of what NCQA reports, and that is why this investment by our Health Care Cost Containment Council is important, and I ask the members to consider that when casting their vote.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

STATEMENT BY MR. LAWLESS

The SPEAKER. Mr. Lawless, do you seek unanimous consent? The Chair recognizes the gent— May I have your attention, please?

Members, please come to order. There will be no further votes. The Chair, however, has recognized Mr. Lawless for unanimous consent. Please be courteous enough to be quiet.

Mr. LAWLESS. Thank you, Mr. Speaker.

Mr. Speaker, I am sorry to hear of your illness, and I did not want to bring this up today because I just sent you a letter last week concerning an issue I believe needs to be addressed on the House floor.

Mr. Speaker, the Republicans decided to come into my district and do a push poll. We all know what a push poll is. They have misled the public into believing what my record is. They have stated that I have missed 39 percent of committee meetings. Mr. Speaker, after looking at the Chief Clerk's record, there is a drastic difference. It is clearly misleading the public. Mr. Speaker, I inquired about this poll because it was given to me anonymously through a Republican staffer, and I thank that staffer for taking that risk at losing his job.

Mr. Speaker, politics is what it is, we all understand; we all understand the election process, but to blatantly mislead my constituents into my record is an attack on me, my family, and the people that I represent. Mr. Speaker, therefore, under rule 64 of

this House, it is my understanding, and I am sure the Parliamentarian could clear this up for us, the sentence says, "No member shall be permitted to vote and have his vote recorded on the roll unless he is present in the Hall of the House during the roll call vote."

Mr. Speaker, it is my understanding that the poll that was done on me about my record in my district, which misled the public, was done by the majority leader and ordered by the majority leader. Mr. Speaker, the majority leader was not on the House floor for any votes today, and yet he was recorded on the House floor

Mr. Speaker, I intend in the future, if this is the way we are going to do it, and I know that your answer will be, we give latitude to the leaders, but the House rules do not talk about latitude to leaders. In fact, the majority leader sets the time and the date as to when we will be on the House floor, so he should not have any meetings, because it is his ability to set the date and the time for the rest of us to be present on the House floor. Therefore, his schedule is even more flexible than each of us House members. Therefore, it would be my wish that you as Speaker of this House would enforce House rule 64, because if in fact I am going to be judged and misled in my district with my attendance record, I will challenge the majority leader's record as to my attendance versus his attendance on this House floor any day, any week, any year that we have been in session.
