REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair recognizes the gentleman, Mr. McCall.

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, I would like to submit some remarks for the record.

The SPEAKER. The gentleman is in order and may proceed.

Mr. McCALL submitted the following remarks for the Legislative Journal:

As an athlete and as a gentleman, James Francis Thorpe excelled. He has been honored by ESPN as an athlete of the century and had his photograph placed on the front of a Wheaties box. But to those of us from Carbon County, Jim Thorpe means much more.

Once again I have introduced a resolution – HR 189 – to draw Pennsylvania's attention to this extraordinary man and athlete, who was laid to rest in Carbon County in a town that now bears his name. The resolution declares May 17, 2003 – the anniversary of Jim Thorpe's birth – as James Francis Thorpe Day in Pennsylvania.

A little background about Jim Thorpe and why he deserves this honor:

James Francis Thorpe, or Wathahuck (his Indian name, of which the English translation means Bright Path), was born in Oklahoma and schooled at the Carlisle Indian School.

As an amateur in track and field, Jim Thorpe won the pentathlon and the decathlon at the Amateur Athletic Union's National Championship Trials held in Boston in May 1912, prior to the Olympics.

He represented the Sac and Fox Nation and the United States in the 1912 Olympic Games in Stockholm, Sweden, and became a citizen of the United States in 1917.

King Gustav V of Sweden, in presenting Thorpe with two gold medals, proclaimed, "You, sir, are the greatest athlete in the world."

Jim Thorpe was the first United States athlete to win the decathlon and pentathlon during one Olympic year.

In 1913 he was stripped of his Olympic medals on the grounds that he was a professional, having played semiprofessional baseball in the summers of 1909 and 1910. These medals were returned to his family in 1983, after he was exonerated and his amateur status returned.

He was the founding father of the Professional Football Association, becoming the first elected president of the American Professional Football, now the National Football League.

Thorpe was voted America's greatest all-around male athlete and was chosen the greatest football player of the half-century in 1950 by an Associated Press poll of sportswriters. In 1997 Thorpe was named the greatest American football player in history.

Jim Thorpe, because of his unsurpassed sports achievements, has long inspired young Americans to excel and do their best.

As an athlete and as a gentleman, it is fitting that we honor and recognize the achievements of this great Pennsylvanian.

This resolution is about remembering. If you are aware of the Korean Conflict – it was called a conflict – you have probably heard it referred to as the "Forgotten War." That is unfortunate. That phrase almost validates the way the country chose to ignore almost every aspect of the Korean War and the issues that those who fought in it experienced during the battles and even after peace and, yes, even to this day.

The resolution tells us that Korea is no longer the "Forgotten War."

It has been 50 years since the Korean Conflict drew to a close. However, even today American military men and women remain stationed in that faraway land, and the threat from the North is also still on our minds.

This resolution is for all those who served their country during the Korean War, and especially for those who paid the ultimate price and those who suffered as POWs (prisoners of war). May we always keep the memory of their sacrifices alive.

There is a quote which is fitting for the occasion. It is the theme of "LEST WE FORGET." It dates to the days of the First World War and is a part of O.L. Binyon's poem "For the Fallen":

"LEST WE FORGET"

They shall grow not old, as we that are left grow old: Age shall not weary them, nor the years condemn. At the going down of the sun and in the morning We will remember them.

July 27 marks the 50th anniversary of the ending of the Korean Conflict. With this resolution, we once again remember all of the battles and all of the men who fought those battles.

Again I say thank you to Representative Nailor for bringing this very important resolution and all that it represents to our attention. We should have an affirmative vote, and it should be unanimous

The House proceeded to third consideration of **HB 558**, **PN 1259**, entitled:

An Act amending Titles 24 (Education) and 71 (State Government) of the Pennsylvania Consolidated Statutes, further providing for management of fund and accounts.

On the question,

Will the House agree to the bill on third consideration?

The SPEAKER. The Chair recognizes the gentleman, Mr. Daley.

Mr. DALEY. Thank you, Mr. Speaker.

Amendment 0414 has a precarious problem to it. As we know, this amendment is the so-called 30-and-out amendment, and it does not have an actuary note, so it places it in a precarious position for our consideration today.

But if I would have provided this amendment for your consideration today, I would have told you that this had two windows in it for public school teachers over the next 2 years for retirement. I also would have told you about the window of opportunity for public employees over the next 2 years.

I can tell you this, that the Pennsylvania State Employees' Retirement System—

The SPEAKER. Will the gentleman suspend.

The gentleman has a right to be heard. Please, let us give the gentleman consideration.

The gentleman may proceed.

Mr. DALEY. Thank you, Mr. Speaker.

I can tell you, the Pennsylvania State Employees' Retirement System and the Pennsylvania School Retirement System are asking for an actuarial note today collectively, which is good news for this particular amendment.

If I could have told you about the school districts in Pennsylvania that we all represent are facing cataclysmic budgets, like the Belle Vernon School District that is facing a 59-percent tax increase; the Brownsville School District has a \$1.5 million deficit; we know what is going on in Philadelphia and Pittsburgh, from Bucks to Berks, from Juniata, all over the Commonwealth, we would have discussed that today.

But I could tell you that when this amendment comes back as a bill, we are going to talk about in July, if we pass this bill, an immediate \$150 million savings to the school districts, which is about 3 percent of their budget for all the school districts, and we are talking about \$117 million regarding the State employees.

And we do not want to mention about the brain drain. We heard through various channels and sources from the Governor's Office that they were concerned about HB 130 and this amendment 0414, that we would not have replacement teachers to replace those that are retiring, but let me say this to you, that of the 7,000 to 11,000 teachers that would retire under this amendment, we have 15,000 young people graduating from our schools of higher education in Pennsylvania right now that can go into those positions.

And I want you also to know, Mr. Speaker, that about 52 percent of our young people between the ages of 18 and 35 are leaving Pennsylvania for jobs elsewhere, and this does deal with the brain drain.

We will be back, Mr. Speaker, and I hereby withdraw this amendment for future consideration. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman, Mr. Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

I would like to interrogate somebody on this bill. If there is somebody that can explain the bill, I would appreciate it.

The SPEAKER. Mr. Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Regarding HB 558, HB 558 amends the State and school retirement codes to require that SERS (State Employees' Retirement System) Board and PSERS (Public School Employees' Retirement System) Board to each adopt and maintain a written proxy voting policy.

As you can imagine, both retirement systems are entitled to cast many proxy votes by virtue of their ownership of domestic and international stocks. Proxy votes cast by large institutional investors, like SERS and PSERS, can have an impact on corporate policy and performance and thus can directly affect beneficiaries of these retirement funds.

The bill enhances legislative oversight of the proxy voting process by, number one, directing SERS and PSERS to cast all proxy votes in accordance with the proxy voting policies that they develop; number two, requiring SERS and PSERS to vote each proxy in a manner that best serves the funds' beneficiaries; finally, allowing SERS and PSERS members to request and obtain information on any proxy vote cast.

Mr. Speaker, this bill is one of 15 legislative initiatives recommended by the bipartisan Joint Finance and Judiciary Special Advisory Committee on Financial Security. We have already debated and approved a number of these measures in this package during the past few sessions. I urge approval of this bill as well.

Thank you, Mr. Speaker.

The SPEAKER. Representative Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

I just wanted some clarification. As serving as your designee on the board, I wanted to have some clarification as to the bill, and I did not have all the information before. Thank you very much

The SPEAKER. The Chair thanks the gentleman.

The gentleman from Allegheny, Mr. Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, I also had an amendment to this bill today that because of the fact of the short time involved, I was unable to get an actuarial note on my particular amendment, but had I introduced it, it would have been very similar to my HB 101, which was a modified 30-and-out plan for teachers only. That bill also included a clause which would have dealt with what we call the military drop problem, which affects some Vietnam veterans who are now currently teachers, because of the fact that when they left the service 30 years ago, they were able to leave slightly early and, as a result, would have missed the 30-and-out window of June 30 of this year, had Representative Daley's amendment passed.

However, since his amendment has not passed, my amendment does not become relevant. Therefore, I cannot amend this particular bill. However, HB 101 I would hope would be given some consideration at some future time, which would be a modified 30-and-out plan for teachers.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Philadelphia, Mr. Horsey.

Mr. HORSEY. Thank you, Mr. Speaker.

Mr. Speaker, may I interrogate the maker of the bill?

The SPEAKER. Yes, if the gentleman will suspend for one moment. Please try to keep the noise down. The gentleman deserves to be heard.

Mr. HORSEY. Thank you, Mr. Speaker.

The SPEAKER. The chairman, Mr. Clymer, will take the questions.

Mr. HORSEY. Thank you, Mr. Speaker.

Mr. Speaker, I understand that this bill outlines procedures in the area of SERS and PSERS, State employees involving their retirement program and schoolteachers involving their retirement program. Is that not true? Does it outline some procedures regarding those two types of employees?

Mr. CLYMER. Yes. It outlines how those proxy votes are to be cast and asks that each of these two pension funds develop guidelines, procedures, in the casting of those proxy votes. That is correct.

Mr. HORSEY. Thank you, Mr. Speaker.

Mr. Speaker, is there a reason why we are not placing all municipal workers, whether they are State or schoolteachers, under the same type of guarantees?

Mr. CLYMER. Yes, Mr. Speaker, because the recommendations by the bipartisan Joint Finance and Judiciary Special Advisory Committee on Financial Security have only recommended these two particular funds, and that is why this bill is so restricted, if you will, to these two funds.

Mr. HORSEY. Mr. Speaker, based on that presentation, do you understand why they have— I know that as the legislature and as the Senate, our authority is under those two immediate groups and that they are State employees, but would you sort of give me an idea, if you know, if you know, why they have restricted it to these two groups and not to municipal workers also?

Mr. CLYMER. While the gentleman has asked a very compelling question, I do not know that, because what we were doing is just taking the recommendations from this advisory group and then putting them into bills. So I really cannot go further than that, Mr. Speaker.

Mr. HORSEY. Thank you very much.

On the bill, Mr. Speaker?

The SPEAKER. The gentleman is in order and may proceed.

Mr. HORSEY. Mr. Speaker, I am going to vote in favor of the bill. I think it is a good bill because it involves public dollars and how those public dollars are to be used, letting the Senate/House know, thus making it public.

In the city of Philadelphia, Mr. Speaker, there is an incident going on right now in the area of actuaries and who should have access to them, and it involves public dollars being spent by a public official who refuses to give public information about those public dollars, and that person's name is Carl Greene, and it involves the Philadelphia Housing Authority.

Now, if it is good for State employees, Mr. Speaker, because it involves, again, State dollars/tax dollars, then it should be good for any public agency that is spending public dollars.

So while we cannot amend it now because it is on the floor, rest assured that some resolution or some bill might come forward to do this for all municipalities that are spending taxpayers' dollars be made public to the taxpayer.
