Members of the House, I stand before you with a very fine young man from the 41st District and his swimming coach, Cece O'Day. I have here with us today Cameron Hollinger. I got to meet Cameron some years ago when he came and helped us out with cutting the grass. We knew he was a swimmer. We knew he was very dedicated. There were times he had to make meets or go to practice, and his family is a

wonderful family. They would come and help him out with his grasscutting chores, and we kind of followed his career, and I am very pleased that he can be with us on the floor of the House today.

Cameron Hollinger is the 2002-2003 AAA Boys Swimmer of the Year and Lancaster-Lebanon League Most Valuable Swimmer. Cameron has two State records, won two State records in 2003: 100 freestyle and 200 freestyle, breaking his own record set in 2001. He has seven career gold medals: 2003, 100 and 200 freestyle, All-American; 2002, 100 and 200 freestyle, All-American; and in 2000, 500 freestyle, All-American consideration.

As a member of the Penn Manor relay team, he holds records in the 200 medley relay and both 200 and 400 freestyle relays. Individual records: 50-yard freestyle, 100-yard freestyle, and 200-yard freestyle.

I do not know if any of you had occasion to watch the relays on PCN (Pennsylvania Cable Network). I did. It was very exciting to see such a fine young man receive his medals, and I congratulate you very much, as your coach, Cece O'Day.

JASON MITKOWSKI PRESENTED

Mr. YUDICHAK. Thank you, Mr. Speaker.

I have a special honor today to welcome to the hall of the House an outstanding student athlete, Jason Mitkowski. It is a special honor for me because Jason happens to be from my hometown of Plymouth Township; he also happens to be from my alma mater, Greater Nanticoke Area; and he also happens to be a member of my extended family. Jason is my cousin.

The SPEAKER pro tempore. Will the gentleman suspend.

Mr. YUDICHAK. If the members get a good look at Jason, I think they would want to be quiet. I do not think you want him down on the floor.

With Jason today are his parents, and everyone understands that great students and great athletes begin at home and begin with family. I would ask them to rise. They are in the rear of the House. Jim and Theresa Mitkowski, please rise and be recognized by the members of the House.

And where parents leave off, that is where coaches take up, and I also want to recognize a former teacher of mine. I am very proud to have him here in the hall of the House. Jack Breita is Jason's coach.

The outstanding student athlete that I have behind me, Jason Mitkowski, an all-State running back, set all kinds of records, conference and team records in the Wyoming Valley Conference as an all-State tailback, but that is not the reason he is here today. He did something remarkable in his senior year at Greater Nanticoke Area. He made the decision after the football season had concluded to go out for wrestling, a sport that many of my friends here in the House – we have spoken with Representative Wilt and Representative Surra and Representative Eachus – all their sons are involved in the sport and know how hard it is to become a champion in the sport of wrestling.

Mr. Speaker, I know that cutting all taxes all the time is very popular, and I assume this resolution will pass, but it seems to me, Mr. Speaker, that while in the middle of a fiscal crisis in the Commonwealth of Pennsylvania, a crisis due very substantially to our cutting taxes for several years in a row, we ought to show some degree of caution about further tax cuts.

This resolution only deals with Federal taxes. Right now, I believe, people with estates of under \$1.5 million are exempt from the inheritance tax. Eventually the inheritance tax will phase down to zero, but it is not going to go away entirely. Congress will have to reenact the inheritance tax's gradual abolition.

In my personal opinion, it would be the hope that they not do that. If Congress cuts out the inheritance tax, that is a massive source of governmental revenue that the overwhelming majority of Americans do not pay. There are not huge armies of our constituents with assets of \$1.5 million or more. The average American has assets of considerably less than \$50,000, and not inconsiderable Americans die with no net worth at all.

Mr. Speaker, we are told when we discuss taxes that if we tax work, people will work less. We are told that if we tax businesses, people will invest less. It does not seem to me, Mr. Speaker, to be terribly horrible if people die less as a result of our taxing the inheritance tax.

Americans believe that there ought to be tax fairness. People ought to be taxed according to what happens if they are taxed and how much injustice it is. I really believe, Mr. Speaker, that taxing wealthy people upon their death is hardly outrageous, and the alternative to taxing wealthy people upon their death is taxing the vast majority of us who are not wealthy on our wages, on our property, in our businesses.

There is no such thing as a free lunch, as Milton Friedman said, and by giving the wealthiest people in our society a free lunch, we are raising the taxes upon everybody else, and therefore, I urge a "no" vote on this resolution.

Mr. Speaker, I have remarks I would like to submit for the record.

Mr. McCALL submitted the following remarks for the Legislative Journal:

With only a miner's lamp to guide them, generations of coal miners tunneled into the earth to retrieve the fuel we needed to operate our industries and to heat our homes.

Pennsylvania's coal miners became the catalyst for the American industrial revolution, even as they performed one of the most difficult and dangerous jobs available. It is only fitting that the nation recognize our coal miners, both past and present.

Just last year the reality of just how dangerous this occupation is struck every Pennsylvanian, as accounts of the fearful Quecreek Mine accident were paraded across our television screens and newspapers.

No one gave up hope during those tense hours, as family, friends, and Pennsylvanians everywhere offered their prayers for a safe rescue.

This story has a happy ending, but it also served as a wakeup call to the dangers of mining. It drew our collective attention to this honorable occupation, reminding us that even with the latest technology, our coal miners risk their lives every day for a valuable resource.

These men and women are deserving of recognition.

In 1996 and 2000 I contacted the Citizens' Stamp Advisory Committee to recommend a coal miners' postal stamp as part of its "America at Work" series. The series will highlight various occupations in the labor workforce that contributed to the development of the United States.

My legislative district in Carbon County is the heart of the anthracite coal region and holds great historic significance in the discovery of anthracite coal in 1754.

Mining anthracite profoundly affected the location, output, technology, and organization of American industry and rail transportation. It was individual coal miners who played an undeniably important role in the new economy, while at the same time working in harsh and unsafe conditions.

This year I introduced HR 104 that would memorialize the United States Postal Service to issue a coal miners' postal stamp. Today I ask your support.

Our coal miners have toiled to help build this country. It is only fitting that they have a commemorative stamp recognizing their great achievements.

So this is very important, Mr. Speaker, to increase these penalties and to do something for these types of people, because these types of people have no place in Pennsylvania, anybody who would maim, beat, hurt, or do anything to an animal. So I think that we should send a strong message today with a unanimous vote on this piece of legislation, and I am hoping the Senate takes this matter as seriously as the House, because there is no place in this Commonwealth to do anything to hurt animals.

So I encourage my colleagues to support this legislation.
