TRINITY HIGH SCHOOL BOYS BASKETBALL TEAM PRESENTED

Mr. Speaker, I am so pleased to welcome to the House of Representatives the Class AA PIAA boys basketball champions, the Trinity High School Shamrocks. Section 1. The act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, is amended by adding an article to read:

ARTICLE IX-C

OFFICE OF CONSUMER ADVOCATE FOR INSURANCE

Section 901-C. Definitions.—As used in this article:

"Consumer" means any person who is a named insured, insured or beneficiary of a policy of insurance or any other person who may be affected in any way by the Insurance Department's exercise of or the failure to exercise its authority.

"Department" means the Insurance Department of the Commonwealth and includes the Insurance Commissioner.

<u>"Fund" means the Consumer Advocate for Insurance Fund</u> established pursuant to section 906-C.

"Insurer" means any "company," "association" or "exchange" as such terms are defined in section 101 of the act of May 17, 1921 (P.L.789, No.285), known as "The Insurance Department Act of 1921" or any entity subject to 40 Pa.C.S. Ch. 61 (relating to hospital plan corporations) or 63 (relating to professional health services plan corporations) or Article XXIV of "The Insurance Department Act of 1921" or the act of December 29, 1972 (P.L.1701, No.364), known as the "Health Maintenance Organization Act."

Section 902-C. Office of Consumer Advocate for Insurance.—(a) There is hereby established as an independent office within the Office of Attorney General an Office of Consumer Advocate for Insurance appointed by the Attorney General to represent the interest of consumers before the department.

- (b) The Office of Consumer Advocate for Insurance shall be headed by the Consumer Advocate for Insurance appointed by the Attorney General who by reason of training, experience and attainment is qualified to represent the interest of consumers. Compensation shall be set by the Executive Board.
- (c) No individual who serves as a Consumer Advocate for Insurance shall, while serving in the position, engage in any business, vocation or other employment, or have other interests, inconsistent with the official responsibilities, nor shall the individual seek or accept employment nor render beneficial services for compensation with any insurer subject to the authority of the office during the tenure of the appointment and for a period of two years immediately after the appointment is served or terminated.
- (d) Any individual who is appointed to the position of Consumer Advocate for Insurance shall not seek election nor accept appointment to any political office during the tenure as Consumer Advocate for Insurance and for a period of two years after the appointment is served or terminated.

Section 903-C. Assistant Consumer Advocates for Insurance; Employes.—The Consumer Advocate for Insurance shall appoint attorneys as assistant consumer advocates for insurance and additional clerical, technical and professional staff as may be appropriate, and may contract for additional services as shall be necessary for the performance of the duties imposed by this article. The compensation of assistant consumer advocates for insurance and clerical, technical and professional staff shall be set by the Executive Board. No assistant consumer advocate for insurance or other staff employe shall, while serving in the position, engage in any business, vocation or other employment, or have other interests, inconsistent with official responsibilities.

Section 904-C. Powers and Duties of the Consumer Advocate for Insurance.—(a) In addition to any other authority conferred by this article, the Consumer Advocate for Insurance is authorized to and shall, in carrying out the responsibilities under this article, represent the interest of consumers as a party, or otherwise participate for the purpose of representing an interest of consumers, before the department in any matter properly before the department, and before any court or agency, initiating proceedings if, in the judgment of the Consumer Advocate for Insurance, the representation may be necessary, in connection with any matter involving regulation by the department, whether on appeal or otherwise initiated.

(b) The Consumer Advocate for Insurance may exercise discretion in determining the interests of consumers which will be

advocated in any particular proceeding and in determining whether to participate in or initiate any particular proceeding and, in so determining, shall consider the public interest, the resources available and the substantiality of the effect of the proceeding on the interest of consumers. The Consumer Advocate for Insurance may refrain from intervening when, in the judgment of the Consumer Advocate for Insurance, intervention is not necessary to represent adequately the interest of consumers.

- (c) In addition to any other authority conferred by this article, the Consumer Advocate for Insurance is authorized to represent an interest of consumers which is presented for consideration, upon petition in writing, by a substantial number of persons who are consumers of an insurer subject to regulation by the department. The Consumer Advocate for Insurance shall notify the principal sponsors of the petition within a reasonable time after receipt of the petition of the action taken or intended to be taken with respect to the interest of consumers presented in that petition. If the Consumer Advocate for Insurance declines or is unable to represent the interest, written notification and the reasons for the action shall be given to the sponsors.
- (d) Any action brought by the Consumer Advocate for Insurance before a court or an agency of this Commonwealth shall be brought in the name of the Consumer Advocate for Insurance: Provided, That the Consumer Advocate for Insurance may name a consumer or group of consumers in whose name the action may be brought or may join with a consumer or group of consumers in bringing the action.
- (e) At a time as the Consumer Advocate for Insurance determines, in accordance with applicable time limitations, to initiate, intervene or otherwise participate in any department, agency or court proceeding, the Consumer Advocate for Insurance shall issue publicly a written statement, a copy of which shall be filed in the proceeding in addition to any required entry of appearance, stating concisely the specific interest of consumers to be protected.
- (f) The Consumer Advocate for Insurance shall be served with copies of all filings, correspondence or other documents filed by insurers with the department unless the Consumer Advocate for Insurance informs the insurer that specific types of classes of documents need not be so served. The department shall not accept a document as timely filed if the document is also required to be served on the Consumer Advocate for Insurance and the insurer has not indicated that service has or is being made on the Consumer Advocate for Insurance. Insurers shall provide any other nonprivileged information or data requested by the Consumer Advocate for Insurance to the extent that the request is reasonably related to the performance of his duties under this article.

Section 905-C. Duties of the Department.—In dealing with any proposed action which may substantially affect the interest of consumers, including, but not limited to, a proposed change of rates and the adoption of rules, regulations, guidelines, orders, standards or final policy decisions, the department shall:

- (1) Notify the Consumer Advocate for Insurance and provide, free of charge, copies of all related documents when notice of the proposed action is given to the public or at a time fixed by agreement between the Consumer Advocate for Insurance and the department in a manner to assure the Consumer Advocate for Insurance reasonable notice and adequate time to determine whether to intervene in the matter.
- (2) Consistent with its other statutory responsibilities, take action with due consideration to the interest of consumers.

Section 906-C. Consumer Advocate for Insurance Fund.—(a) There is hereby established a separate account in the State Treasury to be known as the Consumer Advocate for Insurance Fund. This fund shall be administered by the State Treasurer.

(b) All moneys deposited into the fund shall be held in trust and shall not be considered general revenue of the Commonwealth but shall be used only to effectuate the purposes of this article. The fund shall be subject to audit by the Auditor General.

- (c) Prior to the first day of April following the effective date of this article and prior to the first day of April of each year thereafter so long as this article shall remain in effect, each insurer who writes coverages for fire and casualty, accident and health, credit accident and health under life/annuity/accident, health and life including annuities in this Commonwealth, as a condition of its authorization to transact business in this Commonwealth, shall pay into the fund in trust an amount equal to the product obtained by multiplying five million dollars (\$5,000,000) by a fraction, the numerator of which is the direct premium collected for all coverages by that insurer in this Commonwealth during the preceding calendar year and the denominator of which is the direct premium written on such coverages in this Commonwealth by all insurers in the same period. Any insurer who fails to pay the required assessment under this section shall be prohibited from writing any insurance within this Commonwealth.
- (d) In succeeding years the General Assembly may vary the base amount of five million dollars (\$5,000,000) based upon the actual funding experience and requirements of the Office of Consumer Advocate for Insurance.
- (e) Assessments made under this section shall not be considered burdens and prohibitions under section 212 of the act of May 17, 1921 (P.L.789, No.285), known as "The Insurance Department Act of 1921."
- (f) In the event that the trust fund is dissolved or the Office of Consumer Advocate for Insurance is terminated by operation of law, any balance remaining in the fund, after deducting administrative costs for liquidation, shall be returned to insurers in proportion to their financial contributions to the fund in the preceding calendar year.

Section 907-C. Reports.—The Consumer Advocate for Insurance shall annually transmit to the Governor and to the General Assembly, and shall make available to the public, an annual report on the conduct of the Office of Consumer Advocate for Insurance. The Consumer Advocate for Insurance shall make recommendations as may, from time to time, be necessary or desirable to protect the interest of consumers.

Section 908-C. Savings Provision; Construction.—(a) Nothing contained in this article shall in any way limit the right of any consumer to bring a proceeding before either the department or a court.

(b) Nothing contained in this article shall be construed to impair the statutory authority or responsibility of the department to regulate insurers in the public interest.

Section 2. Section 2001.3(a), (c), (d) and (g) of the act, amended June 22, 1982 (P.L.573, No.166), are amended and the section is amended by adding a subsection to read:

Amend Sec. 2, page 3, line 25, by striking out all of said line and inserting

Section 3. This act shall take effect as follows:

- (1) The addition of section 906-C of the act shall take effect in 90 days.
- (2) The amendment or addition of section 2001.3(a), (c), (d), (g) and (h) of the act shall take effect immediately.
 - (3) This section shall take effect immediately.
- (4) The remainder of this act shall take effect July 1, 2004, or immediately, whichever is later.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1018**, **PN 1193**, entitled:

An Act amending the act of July 9, 1990 (P.L.340, No.78), known as the Public Safety Emergency Telephone Act, further providing for definitions, for local government immunity and for powers and duties of the Pennsylvania Emergency Management Agency; establishing a Statewide integrated wireless E-911 State plan; establishing a wireless E-911 Emergency Services Fund and disbursements therefrom; further providing for collection of an E-911 surcharge from wireless customers and for annual reporting; establishing a wireless E-911 Emergency Services Advisory Committee; and providing for rules and regulations.

On the question,

Will the House agree to the bill on third consideration?

Mr. ZUG offered the following amendment No. A0323:

Amend Title, page 1, line 9, by inserting after "Fund" and an Emergency Services Fund

Amend Sec. 6 (Sec. 11.4), page 17, line 16, by striking out "\$1" and inserting

\$1.25

Amend Sec. 6 (Sec. 11.4), page 17, line 22, by inserting after "services."

Twenty-five cents of this monthly fee shall be placed in a separate fund established in subsection (b.1).

Amend Sec. 6 (Sec. 11.4), page 18, by inserting between lines 24 and 25

(b.1) Emergency Services Fund.—There is hereby established in the State Treasury a nonlapsing restricted interest-bearing account to be known as the Emergency Services Fund. This fund shall consist of 25¢ for each fee collected under subsection (b). Moneys in the fund and the interest it accrues shall be appropriated annually to the

Pennsylvania Emergency Management Agency to be disbursed by the agency for grants to paid and volunteer fire and rescue companies and ambulance services.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Zug.

Mr. ZUG. Thank you, Mr. Speaker.

What the amendment does is simply put a quarter tax on cellular phones, has that money go to volunteer and paid fire companies and emergency responders throughout the Commonwealth.

The House last session passed this I think unanimously, and I would ask you for your support. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring, Will the House agree to the amendment?

(Members proceeded to vote.)

VOTE STRICKEN

The SPEAKER. The clerk will strike the vote.

The Chair recognizes the gentleman, Mr. Tigue.

Mr. TIGUE. Thank you, Mr. Speaker.

Mr. Speaker, I think the members should take a look at this amendment. I believe that every one of us here in this chamber supports giving money to volunteer fire companies and paid fire companies to try to help the firefighters and the municipalities that they protect.

Today we will vote on a number of bills which will provide the distribution of funds to fire companies, et cetera. The maker of the amendment, his goal is right but I think the means are wrong. I do not think we should be adding an additional surcharge on top of the wireless which is used to fund the 911 system. I think we have to be very careful when we start adding on to things that are for one specific use.

With the proliferation of wireless communications, telecommunications, I think we are going to see – and we have, in many cases – a decrease in the amount of money that control centers, 911 centers, receive from wired communications, and I think we should be careful that when we need extra money, we may have to go back to wireless because more and more people are using it; fewer and fewer people are using the wire things.

This amendment Mr. Zug is offering will probably pass, but I would ask you to really think about this, and I would ask those who can — and I know it is not the politically smart thing to do at this point, most people think, but I believe it is; it is the right thing to do — is please to defeat this amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the amendment stand for brief interrogation?

The SPEAKER. Mr. Zug?

Mr. VITALI. I just want to be clear. Does this amendment charge an additional 25 cents to every Pennsylvania resident per month who owns a cell phone?

Mr. ZUG. It is a 25-cent surcharge on every cell phone in Pennsylvania, yes.

Mr. VITALI. Okay.

This is not diverting— Okay.

How much will this raise?

Mr. ZUG. Today the fiscal note says about \$15 million.

Mr. VITALI. Okay. Now, this is going into— Now, what account is this going into?

Mr. ZUG. Well, it is really just a holding account. There is no program that goes with it. I just believe firmly that if we are going to provide relief for our emergency service providers, we need to establish a program to raise the money before we establish the program to spend the money. This simply raises the money and lets PEMA (Pennsylvania Emergency Management Agency) hold it until we establish a program to distribute it.

Mr. VITALI. This would be a new fund then?

Mr. ZUG. Yes.

Mr. VITALI. Okay. Thank you.

I have no further questions.

The SPEAKER. The gentleman from Lehigh, Mr. Semmel.

Mr. SEMMEL. Thank you, Mr. Speaker.

One of my concerns that I want to raise here today, I think in the previous bills we have tried to do some of the things that our first responders need. We are trying to support them financially.

On first blush I think this amendment has as its very goal of providing more money to our responders, but I have some concerns about our telecommunications industry. If you and I would look, whether they be Federal or State taxes on the telecommunications bill, one of the first things we may be doing is adding another page to be in your monthly phone bill, but that is an aside.

I think perhaps Representative Zug's thought is to help, but I am not sure if we really are. I am going to ask for a negative vote here today because I think the committee and the various bills that were presented today are helping our emergency responders. Thank you very much.

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. Horsey.

Mr. HORSEY. Thank you, Mr. Speaker.

Mr. Speaker, may I interrogate the maker of the amendment? The SPEAKER. The gentleman indicates that he will stand for interrogation.

Mr. HORSEY. Mr. Speaker, I remember a month ago, 2 months ago, the Governor said he wanted to tax cellular use and that we could possibly raise \$200 million. Is this a competing tax with what the Governor anticipates doing?

Mr. ZUG. Mr. Speaker, I could not hear the question.

Mr. HORSEY. Mr. Speaker, I will repeat it.

Mr. Speaker, I understand 2 months ago, 3 months ago, the Governor said he wanted to tax cellular use of phones and he wanted to raise \$200 million through that process. Is this a competing tax? Are you attempting to do the exact same thing?

Mr. ZUG. I am not sure what the Governor was intending to do. What I am doing, what I am doing is what we did last session, which is to try to provide money directly to our emergency service providers in the Commonwealth, paid and volunteer. It has nothing to do with what the Governor wants to do.

Mr. HORSEY. Thank you, Mr. Speaker.

Mr. Speaker, on the amendment?

The SPEAKER. The Chair recognizes the gentleman.

Mr. HORSEY. Mr. Speaker, I believe that the gentleman is doing the right thing for the wrong reason or doing the wrong thing for the right reason. I believe that emergency preparedness, as Representative Tigue said, needs the additional funding, but I believe this is not the right way we need to do it. I believe that when we do 911, we will be able to take some of the 911 funds, when we do that bill, and dedicate it to emergency preparedness, but I think just cutting a piece, 25 cents, out when we know the Governor is going to try to do the same thing is creating and expanding government unnecessarily or the influence of government unnecessarily. We are going to double-tax cellular telephone people, and I am sure that people on that side of the aisle are opposed to the expansion of government.

So I am going to ask for a "no" vote on this particular amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Westmoreland, Mr. Casorio.

Mr. CASORIO. Thank you, Mr. Speaker.

May I interrogate the maker of the amendment, please?

The SPEAKER. The gentleman will stand for interrogation.

Mr. CASORIO. Thank you, Mr. Speaker.

Mr. Speaker, just for clarification, does your amendment take the current \$1 surcharge on cell phones to \$1.25 per cell phone?

Mr. ZUG. Yes, which is still smaller than the surcharge on landlines.

Mr. CASORIO. All right.

Mr. Speaker, I may have missed this answer earlier, but can you tell me what you believe at the current date that this additional 25 cents will raise?

Mr. ZUG. In the beginning, \$15 million.

Mr. CASORIO. And that is projected on what basis, Mr. Speaker?

Mr. ZUG. Annually.

Mr. CASORIO. Mr. Speaker, the moneys in this fund, are they going to be distributed just to 911 centers or will they be distributed to emergency service and volunteer rescue groups as well?

Mr. ZUG. It does not go to 911 centers. It goes to fire companies and emergency responder groups throughout Pennsylvania, both paid and volunteer.

Mr. CASORIO. And that, Mr. Speaker, is just the additional 25 cents that will go to the volunteer fire and EMS (emergency medical services) groups. Is that correct?

Mr. ZUG. That is what this amendment does. It is the 25 cents. Yes.

Mr. CASORIO. Mr. Speaker, can you tell me if there is and, if there is, what the mechanism is for PEMA to distribute these grants to the fire departments?

Mr. ZUG. We have not arrived at a distribution system. We have not done that intentionally, because I feel that, particularly in the environment we have today in Pennsylvania, that we need to figure out how we raise the money before we figure out how to spend the money. Spending it is always easy. So what this simply does is raise money that we will at some future juncture, if this passes, distribute that money to volunteer fire companies

and ambulance units at a future date, but that has not been decided as of today.

Mr. CASORIO. And, Mr. Speaker, I think again we can all agree that our local volunteer and emergency services groups, they need the money quite desperately.

And again I will ask you about the funding mechanism, and I know you have just told us that there is no mechanism set in place, which would lead me to wonder a question: if all of my 25 volunteer fire departments and EMS groups would receive similar amounts, if they would receive amounts based on number of calls, based on population. Can you give us some sense of how that might be set up?

Mr. ZUG. Well, that is really the job of this General Assembly at some future date. We passed a bill earlier that I think will ultimately hand out, as we did a couple years ago, a certain amount to every fire company in the State. We can choose to do that or we can set up a different system. That is up to the discretion of the General Assembly.

Mr. CASORIO. Mr. Speaker, as the amendment is worded, and correct me if I am wrong, we are leaving this up to PEMA to disburse the grant money to the volunteer fire and rescue companies. Is that correct?

Mr. ZUG. PEMA is going to hold the money until we decide how we are going to allocate it.

Mr. CASORIO. All right. Well, then maybe I am reading this wrong, "Moneys in the fund and the interest it accrues shall be appropriated annually to..." PEMA "...to be disbursed by the agency" – I am assuming the agency is PEMA – "for grants to paid and volunteer fire...companies and ambulance services."

Mr. ZUG. Again, Mr. Speaker, what we will do, if this ultimately passes, is come back and revisit how we are going to distribute the money, whether it be annually to each fire company the same that applies or based on calls. That is something I think the General Assembly will decide in the future.

Mr. CASORIO. Thank you, Mr. Speaker.

Mr. Speaker, on the amendment, please?

The SPEAKER. The gentleman is in order.

Mr. CASORIO. Thank you, Mr. Speaker.

Mr. Speaker, there seems to be some unanswered questions as far as the disbursement and distribution of these some \$15 million in additional taxes from cell phones.

Again, I think this House stands in unanimity in our belief that volunteer fire and rescue companies should receive additional funding from the State. That is a unanimous vote at any time we would take that, Mr. Speaker, but to consistently go back, as the previous speaker from Philadelphia has pointed out, consistently go back to individuals and ask them to be taxed more and more for the privilege, for the right to use their cell phones I think is unfair.

This takes the \$1 fund to \$1.25, and we have no mechanism, no assurance that each of our volunteer fire departments or EMS companies will be given a \$2,000 grant, a \$5,000 grant, a \$9,000 grant. We have no assurance, no mechanism set for that, Mr. Speaker.

So until I think that is clarified, and quite frankly, I do not know that any of my constituents knew this morning, this afternoon, that they would be paying an additional 25 cents per line per cell phone, taking it to \$1.25 from \$1, I do not think they have had time to digest this, and I am sure that once they realize that this is going to happen, we may hear from a few of

them, and at this point I would ask for a "no" vote on the amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Zug, for a second time.

Mr. ZUG. Thank you, Mr. Speaker.

This amendment does one thing: it provides monetary relief to our local fire companies and emergency service providers. It is \$15 million a year. It is not a lot of money by our standards, but it is a lot of money when you talk about providing simply a grant to our volunteers and our paid emergency service providers at home. It is a tax ultimately that will be less than the landlines. It is only \$1.25 when landline is \$1.50.

We continuously tell these people that we are looking to help them. We are providing relief in this budget because Ed Rendell had it in the budget, and I think that is great, but we did not last year and we probably will not next year. A couple of years ago we passed a bond saying they should get \$100 million, \$100 million, and we do not have that.

So what this does is ultimately provide a year-in, year-out program that says we appreciate what you do and here is a stipend to help you do what you do.

Thank you for your support.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Lackawanna, Mr. Cawley.

Mr. CAWLEY. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose this amendment.

There are many legislators here that represent municipalities that have paid fire departments, and those same residents that live in those municipalities are now going to be taxed an extra 25 cents to fund volunteer fire companies. We should be funding both, paid and volunteer, and I think it is totally unfair for anyone that represents a paid fire department, which consists of 25 percent of all the firemen in Pennsylvania, and this ought to be done a separate way and it ought to be funding volunteer and paid fire departments. So therefore, I rise to oppose this.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Blair, Mr. Geist.

Mr. GEIST. Thank you very much, Mr. Speaker.

Will the maker of the amendment stand for a brief interrogation?

Mr. ZUG. Yes, thank you.

The SPEAKER. The gentleman indicates he will.

Mr. GEIST. Would you please tell me what effect this would have on third-class cities who have paid fire departments?

Mr. ZUG. They would be able to participate in the program. It is for paid and volunteer.

Mr. GEIST. Thank you, Mr. Speaker.

That is all I wanted to clear up.

I just want to stand up and say I support the amendment and would urge a "yes" vote.

The SPEAKER. The Chair thanks the gentleman.

Mr. HERMAN. Mr. Speaker, I move that the rules be suspended for immediate consideration of HB 51.

On the question,

Will the House agree to the motion?

The SPEAKER. For what purpose does the gentleman, Mr. Vitali, rise?

Mr. VITALI. Mr. Speaker, we have not caucused on this bill as it has been amended by the Appropriations Committee. So I would ask that we just pass over this issue until the House Democrats have a chance to caucus on it.

It is my understanding in Appropriations yesterday afternoon around 3, a quite substantial substantive amendment was added to this which we did not caucus on. So I am just going to ask that we pass this over.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Philadelphia, Mr. Cohen.

Mr. COHEN. Thank you, Mr. Speaker.

Mr. Speaker, I would join in Mr. Vitali's request. It was a very complex amendment that was adopted. My understanding is that all the Democrats on the House Appropriations Committee voted against it. We need more time, and I would strongly join in urging this bill be passed over.

The SPEAKER. Would the gentleman, Mr. DeWeese, please come up to the podium.

(Conference held at Speaker's podium.)

The SPEAKER. The Chair recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

This is not a partisan issue. We have a lot of members on our side of the aisle that want to support this and want to cast a favorable vote on Monday. We are confident that some Republicans would also like to do just that same thing.

So I would like to think that the motion to suspend the rules could be countervailed and that we could vote on this measure on Monday. But again, I do not think this is a partisan effort. The amendment that went in rapidly has not been digested by a great deal of the membership, and I think a vote on this next week would be very helpful.

Thank you very kindly.

The SPEAKER. The Chair thanks the gentleman.

This issue is debatable by the floor leaders only, unless Mr. Herman has been designated by the majority leader, and he has.

The Chair recognizes the gentleman, Mr. Herman.

Mr. HERMAN. Mr. Speaker, this really puts me in a difficult position, not because of my interest in support of this legislation

but in terms of fairness in giving the minority party that opportunity to caucus on the measure.

However, you know, this bill was amended yesterday in the Appropriations Committee, and I have been informed that the Democratic Party has been informed that it was amended and that we were going to vote on this today, that there would be a suspension of the rules, a motion being made which I have made, and that they did not meet for whatever reason that might be.

I am not going to belabor the point except to say that this legislation is the result of a lot of negotiation between the various entities that are involved – the Pennsylvania Municipal Authorities Association, the Pennsylvania Builders Association. It has been over 2 1/2 years of negotiation, and, you know, we are ready to vote the bill today and get the issue behind us and over to the Senate.

So I am going to continue to hold fast to my motion to suspend the rules, and I would encourage the members to pass the motion.

Thank you very much, Mr. Speaker.

The SPEAKER. Mr. Vitali, at this time the only people that could speak would be Mr. Herman or Mr. DeWeese, but at this time we would like to take the vote on the suspension of the rules. Should the motion pass, at that point in time we would be glad to debate the issue itself.

Mr. BELFANTI. Thank you, Mr. Speaker.

Prior to my brief remarks I would like for some guests of Representative Veon who are Vietnam veterans to join me here, and I would like any member of the House who served in Vietnam to also join us here at this podium, if that would be in order

The SPEAKER. Any member that is a Vietnam veteran that wishes to join them, please do so.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, last week we heard some eloquent remarks from my colleague from Northumberland County, Representative Merle Phillips, also a very longtime friend of mine; we began serving together, and his remarks were quite eloquent about the Korean Conflict. Mine will probably not be, as I have no notes, no speech. I am going to speak here briefly from the cuff and from my heart.

Representative Phillips last week referred to the Korean Conflict as the "Forgotten War." In my opinion, the Vietnam Conflict, which we are memorializing the soldiers and sailors and airmen and marines who served today, will probably be remembered as the war America will never forget, but perhaps for all the wrong reasons.

Mr. Speaker, 60,000, almost 60,000 Americans died in America's longest conflict, a war that lasted longer than any other. It went through stages of four different Presidents, beginning with Dwight Eisenhower's decision after the 1954 Geneva Accord to support the splitting of the two countries into two, into John F. Kennedy's decision to send in advisers, L.B.J. (Lyndon Baines Johnson) who was in office when I served in 1968, and Richard Nixon who came to office when I was still there in 1969.

But I am not here to talk about any of my experiences. I would like for the record for people to understand that America never lost a battle in Vietnam. We never lost one major battle. If the war was lost by America, it was lost here at home on our shores. The gentlemen and women who served during that long conflict went through some trying times, not only while they were in country but, as most of you know, as they returned home.

In the late sixties the country began to wane on what we were doing in that small country and why we were there. By the early seventies, of course, most of the country had completely turned against the war and the war policies. But what is upsetting to most of us who wore a uniform in that war is that people back in those days did not hold the war and its policies and decisionmakers against the decisionmakers but in large part against the men and women who wore uniforms, who bled and died and the 300,000-plus who were wounded, many of whom are still paraplegics and quadriplegics today.

So, Mr. Speaker, I am here to say that I believe that Americans have finally realized the suffering that our veterans have gone through. I think recognition has been slow coming, but it has arrived, and I commend those men and women who are presently serving in uniform in the Gulf region.

I would like to conclude by just saying that it does me good, and I am sure my colleagues who are here who are joining me at the rostrum, to drive through the small towns and urban areas of this country today and see the yellow ribbons and the flags hanging on people's homes in support of our troops. I do not think we had that. We belatedly received it, and better late than never.

GUESTS INTRODUCED

Maj. Dale Vonstein, and I do not have the years down, I apologize; and Staff Sgt. Edward Noyes, who served in the Army in 1969 and 1970. Also in the gallery in the first row there are a number of other distinguished comrades of mine who served in the Republic of South Vietnam. I would like them to stand and be recognized as well.

Thank you, Mr. Speaker.

Mr. Speaker, again, I arrived with no printed remarks or speech, and I said I was going to talk off the cuff and I think I have said what I had to say. If there are any other House members who have joined me here who would like to add some comments, I would certainly welcome them, and thank you very much for your attendance.
