BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 951**, **PN 1117**, entitled:

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, further providing for sales and use tax definitions, for sales and use tax exclusions, for personal income tax definitions and for classes of personal income; providing for a credit against personal income tax; further providing for realty transfer tax definitions, for realty transfer tax exclusions and for penalties for failing to fulfill a historic covenant; and conferring powers and duties on the Pennsylvania Historical and Museum Commission.

On the question,

Will the House agree to the bill on third consideration?

The SPEAKER pro tempore. The gentleman, Mr. Egolf, offers the following amendment, which the clerk will read. Sorry; the gentleman has withdrawn that amendment.

On the question recurring, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On the question, the Chair recognizes the gentleman from Westmoreland, Mr. Tangretti.

Mr. TANGRETTI. Thank you, Madam Speaker.

Madam Speaker, we have been dealing with this issue for a number of years now. As a matter of fact, you and I have passed this out of this House on a previous occasion. This is a many-member bipartisan effort. Many of you in this chamber are cosponsors of this bill for obvious reasons. This concept has been recognized and adopted in one fashion or another by 43 other States, and I think it is about time that we as Pennsylvanians adopt it as well.

We need to come to realize about how providing these tax incentives for historic districts and properties can revitalize our cities and small towns and boroughs. It has been very, very effective, as I mentioned, in other States in stabilizing neighborhoods; enhancing the market value of those communities, those residential areas; providing a quality of lifestyle that is becoming more and more desirable among those who move from job to job. There is a study by a Carnegie Mellon University professor that says that we have a whole range of job opportunities where young entrepreneurs and engineers and software experts and computer experts and all these folks who can go anywhere in the country to live would prefer to live in a city or a small town with the kinds of amenities that this bill will create. And it provides a very positive alternative to sprawl, in addition to which it has been proven to be an economic development tool not only from historic tourism but the relocation criteria for these various companies that look to relocate businesses in other parts of the country.

I think that it is something that we as a State have an absolute duty to do, and I think the Governor has recognized that in his economic stimulus package by adopting Representative Freeman's Elm Street bill concept, the Main Street concept, and various other methods of providing economic stimulus to revitalize our small cities and towns. And I am happy to report that Governor Rendell has embraced this bill as well as 952, Representative Frankel's bill, as part of that stimulus package.

So I would ask again for your support for this bill. We will send it to the Senate. We believe that the Senate is on board with this concept, not only as part of the stimulus package but as a concept unto itself. So, Madam Speaker, I would ask for an affirmative vote from my colleagues.

My bill, 952, is the State historic tax credit for commercial property, and it, like 951, enjoys broad bipartisan support. This bill will leverage dollars at the Federal level that 21 other States across the country have been using to renovate and revitalize downtowns across the United States.

Here in Pennsylvania many of our older cities have major white elephants in their downtown commercial districts that have gone for years undeveloped, unrehabilitated, because we lack the essential tools necessary to create the partnerships with private developers to make these happen. In the city of Pittsburgh we have a number of these types of projects that I think are reflected in other communities across Pennsylvania that we have had no shortage of developers who have been interested in looking at, but when it comes down to trying to make the deal, we always have a gap. This State historic tax credit will bridge that gap and make many of these developments come to reality and help restore the downtowns of cities across the State of Pennsylvania, and I hope that all of you will join me in supporting it.

Section 1. Section 914-A(5) of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, added May 4, 1970 (P.L.311, No.102), is amended to read:

Section 914-A. Powers and Duties of the Intermediate Unit Board of Directors.–An intermediate unit board of directors shall have the power and its duty shall be:

* * *

(5) To adopt a program of services. Each intermediate unit may provide, but shall, except as hereinafter provided, be limited to, the following services: (i) curriculum development and instructional improvement services; (ii) educational planning services; (iii) instructional materials services; (iv) continuing professional education services; (v) pupil personnel services; (vi) State and Federal agency liaison services; and (vii) management services. Each additional service to be provided shall be first approved by a majority of all the boards of school directors comprising the intermediate unit at a meeting called by the intermediate unit board of directors for the express purpose of approving or disapproving any such additional service. Each intermediate unit may provide for the furnishing of any of the services mentioned in this clause or elsewhere in this act to nonpublic, nonprofit schools which schools are hereby authorized to contract for and purchase services from intermediate units so as to participate in the intermediate program. An intermediate unit may provide software, data processing and related professional services associated with subparagraphs (v), (vi) and (vii) to only those school districts which are both served by that intermediate unit as set forth in section 902-A and which have not previously purchased such services from the private sector. * * *

Section 3. This act shall take effect as follows:

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Maher, for a brief explanation of his amendment.

Mr. MAHER. Thank you, Mr. Speaker.

This amendment would provide guidance for intermediate units as to who they may serve, the districts that they currently serve and not beyond those boundaries, particularly on matters dealing with management services and computer software.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Will the gentleman stand for brief interrogation?

The SPEAKER. The gentleman indicates that he will.

Mr. VITALI. I am just trying to understand this a little bit better. How will this change existing law? Maybe if you could give a concrete example of something that can happen now and cannot with this legislation, or cannot happen now but can with this legislation.

Mr. MAHER. Thank you, Mr. Speaker.

What this amendment would do is to clarify, intermediate units' purposes are to serve school districts, not to compete with the private sector. There are businesses across the State that employ folks in good family-sustaining jobs in the free market by offering a variety of computer software to customers. Some of those customers happen to be school districts. A couple of intermediate units have decided to go into the computer software business, directly compete with these homegrown Pennsylvania businesses that employ families, and without the burdens of being taxpayers, without the burdens of regulations that attach to private industry, it creates an unfair competitive advantage for the intermediate unit. And frankly, with the education challenges we have today, I would think we would all be in agreement that intermediate units would be well served to focus their efforts on matters pertaining to the education of the children of Pennsylvania and not with putting Pennsylvanians out of work.

Mr. VITALI. Could you, what intermediate units are doing this? Do you know of any specifically?

Mr. MAHER. Mr. Speaker, I am not in a position to give you an exhaustive study of intermediate units across the State. What we are dealing with here is a matter of principle that should IUs (intermediate units) be using their tax-exempt government status to reap an unfair competitive advantage and put Pennsylvanians out of work who are in homegrown businesses across the State, and I think it is a pretty clear question of principle.

Thank you, Mr. Speaker.

Mr. VITALI. That very well may be, but it really did not answer the question I asked. The question was, could you name any specific intermediate units involved here? Mr. MAHER. Again, Mr. Speaker, and perhaps you did not hear me-

Mr. VITALI. If the answer is no, that is okay; I will listen to that.

Mr. MAHER. —I have not done a study of all those intermediate units and their range of software offerings.

Mr. VITALI. Okay. I am not asking for an exhaustive list; I just asked for one. What intermediate units are doing this? I am just trying to get a sense for the problem. Can you name one?

Mr. MAHER. Mr. Speaker, at the risk of misrecollecting, I believe IU-16 is one which is undertaking this.

Mr. VITALI. Okay; IU-16.

Now, give me a sense. Is this a for-profit enterprise? Do the intermediate units provide this software service for a profit?

Mr. MAHER. Mr. Speaker, I am afraid I did not understand what it is that you are asking, and in terms of the interrogation, are you trying to learn something about the amendment or are you trying to learn something about market conditions? I am a bit confused.

Mr. VITALI. Let me just ask the question again just to see if you can answer it. The intermediate unit in question, are they providing these software services for a profit or not for a profit?

Mr. MAHER. Well, Mr. Speaker, I do not have access to their books. Obviously, one would hope that they at least can make sufficient wealth from exploiting their competitive advantage to destroy the profitmaking businesses that are employing Pennsylvanians. It seems to me, I do not understand really what your question is, and I have not studied whether or not they are making money doing this.

Mr. VITALI. Well, let me just ask it again then. You are prohibiting intermediate units from providing software services. I am trying to understand the current practice. Are they doing this for a profit now or are they doing this as a public service?

Mr. MAHER. You would have to ask them what their theory is. My understanding is in terms of public service, there certainly is not a public service with coming in and destroying the jobs of Pennsylvanians who are homegrown businesses and have built a practice in a very competitive marketplace and that government should come in and use its advantages that it cannot go out of business. It does not have to worry about cash flow; it does not have to pay taxes; it is not subject to regulations—

Mr. VITALI. But my question again, if you could just listen to my question, are they doing this for a profit or not? I am trying to get a sense for—

Mr. MAHER. Mr. Speaker, I—

Mr. VITALI. —the practice you are trying to prohibit.

Mr. MAHER. Mr. Speaker-

Mr. VITALI. Profit? Yes or no?

Mr. MAHER. —I attempted to answer that question repeatedly. I am sorry you do not like the answer, but I have no further answer than the same answer I provided repeatedly.

Mr. VITALI. Do you know what they are charging for their services?

Mr. MAHER. I do not have a price list with me, Mr. Speaker.

Mr. VITALI. Do you know who they are providing services to?

Mr. MAHER. They are providing services and what this amendment gets to are to school districts beyond the intermediate unit service area. Mr. VITALI. So your amendment would prohibit intermediate units from providing computer services to school districts beyond their service area.

Mr. MAHER. That is correct.

Mr. VITALI. Okay. You are not aware of what is being charged or if there is a charge for these services.

Mr. MAHER. There most definitely is a charge, but as I replied to you earlier, Mr. Speaker, I do not have a price list.

Mr. VITALI. But this could be money flowing in and out of the school districts we are talking about.

Mr. MAHER. Well, that would stand to reason, Mr. Speaker.

Mr. VITALI. Okay. Well, if that stands to reason, could you tell me what the fiscal note is for this amendment?

Mr. MAHER. The fiscal note is, I believe, available on your machine, Mr. Speaker, and it will conclude that there is no fiscal impact on the Commonwealth. Again, we are dealing with subdivisions of the Commonwealth, an intermediate unit.

Mr. VITALI. Okay. That concludes my interrogation. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Bucks, Mr. Corrigan.

Mr. CORRIGAN. Thank you, Mr. Speaker.

I congratulate Representative Maher on his initiative. I think the intermediate units across the State have been out of control for an awful long time. We have an intermediate unit in Bucks County that services 14 school districts, and they have grown to such proportions that it is unfathomable the kind of money that is spent and the service that is provided for the money that is spent. I think we ought to address intermediate units in more depth.

Again, I thank Representative Maher for his initiative, and I strongly recommend a "yes" vote on the amendment. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Philadelphia, Mr. Cohen.

Mr. COHEN. Thank you, Mr. Speaker.

Mr. Speaker, I confess some puzzlement about this amendment. Intermediate units are set up to serve school districts. That is why we created them; that is their purpose. What this amendment does is it says an intermediate unit cannot serve a school district in terms of providing data services if the school district is getting those services or has gotten them at any time in the past from some private firm. It seems to me that this is an odd thing to do. It seems to me odd that we should be stopping one governmental unit from helping another governmental unit. It seems that if a local school district wanted to contract with an intermediate unit instead of a private business, presumably the local school district would only contract with the intermediate unit if it felt it was either getting a lower price or was going to get better services, and here we are setting forth a legislative obstacle toward the local school board contracting with its own intermediate unit.

I really do not understand the merits of this. I do not understand the rationale for it. Mr. Maher did not go into much rationale in discussing this with Mr. Vitali. I am very suspicious about what the benefits of this amendment are, and I would urge a "no" vote.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Lehigh, Mr. Browne.

Mr. BROWNE. Thank you, Mr. Speaker.

I rise in strong support of the Maher amendment.

There is currently a discussion going on in the Intergovernmental Affairs Committee regarding the issue of government competition in areas that are traditionally the function of private enterprise, and that debate and that discussion will continue. However, one thing that we as an Assembly should be able to stand by and state as a majority opinion of this Assembly is that in matters that are statutorily provided, when government entities or agencies are established through statute, that they should not be able to go outside the original intent of that statute in regard to the service they provide.

Now, there is a debate currently in court regarding what an intermediate unit can provide, but I think based on my reading of the enabling statute, that intermediate unit is only allowed to provide services to the school districts in the region where they were originally established, and the Maher amendment would put in greater detail the fact that if an intermediate unit is providing services, it should only provide the services to the school districts that they are contracted with.

I think it is a very important amendment to clarify the intermediate unit statute, and I request its unanimous support. Thank you.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair recognizes the gentleman from Montgomery, Mr. Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

I would like to present some remarks for the record, please.

The SPEAKER. The gentleman is in order and may proceed to put the remarks on the record. The Chair thanks the gentleman.

Mr. GODSHALL submitted the following remarks for the Legislative Journal:

HB 1068 will change the Public School Code to stop penalizing school districts for choosing the most cost-effective renovation or expansion plans for their schools.

Currently, the code stipulates that a school district may not be reimbursed for a percentage of the cost of renovation and additions to existing "brick and mortar" buildings when they would normally be entitled to if modular units are not removed and replaced with brick and mortar classrooms.

My bill will remove this restriction and allow school districts to qualify for reimbursement from the State even if it does not plan to remove relocatable or modular classrooms upon completion of the renovation project.

I introduced this legislation to amend the School Code because of a situation faced by the North Penn School District, which is in my legislative district.

Following a demographic study conducted by the Pennsylvania Economy League, North Penn decided to renovate and add seven classrooms to Gwyn-Nor Elementary School. The school currently uses six modular classrooms to handle overflow.

The demographic study revealed that the present student population will decline in about 4 or 5 years, so the board decided that rather than increase the costs of new construction to include classrooms that will not be needed in a few years, the six modular units would continue to be used for the time being.

The Education Department ruled that it will not reimburse the district its entitled-to reimbursement percentage for the project because the plan does not call for removal of the existing modular units.

North Penn is appealing, but if the Education Department does not reverse its decision, it could mean the loss of approximately \$500,000 for the district.

This antiquated rule fails to recognize the high quality of today's modular classrooms, which are constructed the same way modular homes are. They are not easily torn down, and it can be quite costly to remove them.

More importantly, this antiquated rule could result in school districts spending more taxpayer dollars than necessary in order to qualify for a reimbursement from the State.

Now more than ever we need to work with our school districts to ensure tax dollars are spent responsibly.

The Pennsylvania School Boards Association supports the bill.

providing for court authority upon petition to remove child from foster parent; and

Amend Bill, page 1, lines 6 and 7, by striking out all of said lines and inserting

Section 1. Title 42 of the Pennsylvania Consolidated Statutes is amended by adding a section to read:

§ 6351.1. Authority of court upon petition to remove child from foster parent.

(a) Order required.-Notwithstanding sections 6324 (relating to taking into custody) and 6351(a) (relating to disposition of dependent child), if a county agency petitions the court for removal of a child because the foster parent has been convicted of an offense set forth in 23 Pa.C.S. § 6344(c) (relating to information relating to prospective child-care personnel), the court shall immediately enter an order removing the child from the foster parent.

(b) Limitation on placement.-If a court enters an order under subsection (a), the following apply:

(1) Except as set forth in paragraph (2), the court may, under section 6351(a), enter an order of disposition best suited to the child's safety; protection; and physical, mental and moral welfare.

(2) Notwithstanding section 6351(a), if the court finds that the foster parent has been convicted of an offense set forth in 23 Pa.C.S. § 6344(c), the court has no authority to place or return the child to the foster parent who was named in the petition filed by the county agency under subsection (a).

Section 2. Section 8331.3 of Title 42 is amended to read:

Amend Bill, page 2, by inserting between lines 8 and 9

Section 3. The addition of 42 Pa.C.S. § 6351.1 shall apply to petitions filed on or after the effective date of this section.

Amend Sec. 2, page 2, line 9, by striking out "2" and inserting 4

Mrs. TRUE. Thank you, Mr. Speaker.

Over the years of my being in the House, most of the legislation I have championed has been about protecting children, and this amendment, I am very hopeful, will continue along that path. Typically, I do not read on the House floor, but I would like to be very specific about just what this amendment does and ask for the support of the House.

This amendment will require a court to remove a dependent child placed in the care of a foster parent if children and youth services subsequently learns that the foster parent was convicted of an offense that would have prevented approval of the foster parent in the first place. The amendment also prevents the court from sending the child back to this foster parent after the child has been removed for this reason.

This is common sense, and I would ask for your support. Thank you.

Section 1. Section 215 of the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, reenacted and amended June 29, 1987 (P.L.32, No.14), and amended or added December 9, 2002 (P.L.1653, No.212) and July 17, 2003 (P.L.63, No.15), is amended to read:

Section 215. Wine Marketing.-[(a) There is hereby established within the board the Bureau of Wine which shall be responsible for the purchasing and the wholesale and retail marketing of premium wines so as to make these wines available to Pennsylvania consumers at competitive prices and in a convenient atmosphere.

(b) The management of the bureau shall be vested in a director, who shall be assisted by such other personnel as the board deems necessary.

(d)

(2) The term "wine," as used in this section, shall mean liquor which is fermented from grapes and other fruits, having alcoholic content of twenty-four per centum or less. The term "wine" shall not include malt or brewed beverages, nor shall wine include any products containing alcohol derived from malt, grain, cereal, molasses or cactus.]

The board is authorized to participate in or sponsor (e) wine events for the purpose of educating consumers as to the wines available in this Commonwealth. The wine to be used for the event may be acquired through the State store system or may be donated from outside this Commonwealth. Participation in the tastings may be conditioned on the purchase of a ticket to the event. The event may include events occurring on premises licensed by the board, and the board may sell wine for off-premises consumption in an area designated by the board for such sale.

Section 2. Section 406(a) of the act, amended May 31, 1996 (P.L.312, No.49), February 18, 1998 (P.L.162, No.25), November 10, 1999 (P.L.514, No.47), December 20, 2000 (P.L.992, No.141) and December 9, 2002 (P.L.1653, No.212), is amended to read:

Amend Sec. 2, page 4, line 27, by striking out "2" and inserting 3
