BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1618**, **PN 2746**, entitled:

An Act establishing the Science Technology Partnership Program; and providing for State grants.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Does the gentleman from Delaware, Mr. Vitali, wish to be recognized?

Mr. VITALI. Yes, Mr. Speaker. This caught me a little off guard. Just a brief explanation. I am sure it is harmless, but I just do not know what is in it.

The SPEAKER. Mr. McIlhattan. The gentleman, Mr. Vitali, has asked for a brief explanation of the bill. Would the gentleman please give that brief explanation.

Mr. McILHATTAN. Mr. Speaker, this legislation would codify the existing Science in Motion program. Specifically, the Science in Motion program is a program whose purpose is to improve science education in the public and nonpublic school districts that participate in this program. This is accomplished by making high-tech scientific instruments and equipment available to school districts and providing professional development to science teachers employed in the participating school districts.

We call this program the Science in Motion program, Mr. Speaker, because regional consortiums are formed between institutions of higher education and a group of school districts. The higher education institution buys or leases the high-tech scientific equipment and loans it out to the school districts, and they instruct the teachers in the school districts how to use the equipment to teach their students and to develop advanced courses in their science curriculum. This program is really a

great asset to the poor school districts in Pennsylvania that do not have the funds to purchase the state-of-the-art science equipment.

This program has been very successful. Peter Jennings recently did a 5-minute segment on this program on the NBC Nightly News. Just 2 months ago, the Council of State Governments recognized this program for being so innovative and cost effective.

Last year the program served 145,000 students in 120 school districts, Mr. Speaker. This is a very successful program. It deserves to be codified in State law, and this is what HB 1618 does.

The SPEAKER. The Chair recognizes the gentleman from Westmoreland, Mr. Stairs.

Mr. STAIRS. Thank you, Mr. Speaker.

I join my colleague, Representative McIlhattan, in strongly urging the members to support this legislation.

To make a long speech short, during these very difficult fiscal times we are in, this is one of the best ways to improve education with the least amount of dollars. The different colleges across the Commonwealth that go to our schools, particularly in rural areas, to educate our children about science and get them excited about science, you cannot beat this.

So I hope that members support this 100 percent, because it is a great way to bring our Pennsylvania schools up to world-class competitiveness in a short period of time and give a great bonus to our children.

So thank you, Mr. Speaker, and again, this is a great, great way to improve Pennsylvania education. Thank you.

The SPEAKER. The Chair apologizes, Mr. Vitali. I thought you asked for a brief explanation of the bill, and Mr. McIlhattan provided that explanation. I did not realize you wished to seek further recognition. The Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

I guess I just wanted to continue with the interrogation.

You mentioned this changes the existing program. My question really is, how does it change the existing program?

Mr. McILHATTAN. It does not really change the existing program. What it does is codify a good program into statute and law. Historically, this program is not written into law. It is something we have to negotiate every time at budget time, give-and-take and everything else, and I think this program has deserved a rightful place in statute at this time, because it has been so successful.

Mr. VITALI. Thank you. That concludes my questioning.

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. Horsey.

Mr. HORSEY. Thank you, Mr. Speaker.

Mr. Speaker, 1,000 years ago the great equalizer was the ability of just a few people to read textbooks. We have come a long way in that now the great equalizer is not just to read but to have at people's disposal and primarily our kids, which is our intellectual capital, to have at their disposal technology, Mr. Speaker. It is the next level. It supersedes books, and it supersedes, really, part of the ability to just flat out read.

If we can expose our kids to technology – and this bill does in fact expose our kids to technology – we need to do it, Mr. Speaker, and we need to do it as rapidly as we can, because there is no cold war anymore; there is no war between philosophies, between communism and democracy.

Democracy has won that war. The next war will be the war concerning who are the smartest group of people in the world and who are not, and this bill helps say something about America; it helps say something about Pennsylvania. When this legislature passes this bill – and I want to encourage everyone to support this bill – this bill is about who will be producing the highest level of intellectual capital, and I would like Pennsylvania to be in the foreground of that.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Huntingdon, Mr. Sather.

Mr. SATHER. Thank you, Mr. Speaker.

I am pleased to stand in support of this legislation.

Some 4 years ago, maybe 5 years now, I had the privilege of offering legislation that would place \$300,000 in our State budget – we had to change a line item – so that this program could continue. At that time it was only one college, Juniata. Now there are 10 or 12 colleges and universities and more who want to participate in this program. It not only whets the appetite of the student body by bringing projects to them in the vans, but it also brings the teachers into the curriculum of learning in the summer months, expressing further desire to have the most modern equipment so that our young people can compete in the future with science and science technology.

It is now the intent to put an item in the budget, and I wholeheartedly support this effort, and I hope everyone will support it.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Northampton, Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker.

I did not plan on speaking, but I wanted to respond to one previous comment that was made.

One of the speakers was very effusive in his praise for this program, and it is a wonderful program. The science technology partnerships are in place at between 15 colleges and local high schools in 15 areas of the State. It is a marvelous program.

But the one comment that was made earlier was that technology supersedes books, and I do not think there can be anything further from the truth. In fact, the debate we are having in Harrisburg right now on our State budget includes a very important element: finding a way to restore funding to our public libraries. We all know that as we speak today, our public libraries are being cut by \$37.6 million, and that is one of the parts of the budget negotiations. Many of us are trying to put that money back. We have to restore our commitment to our public libraries, and we have to change that.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Horsey, for the second time.

Mr. HORSEY. Thank you, Mr. Speaker.

I by no means meant to denigrate books and/or libraries, but, Mr. Speaker, if you come from my community, if you come from a rural community, the reality is, this bill does not go far enough. Books are antiquated. If we provided every student – books are antiquated – if we provided every student with a computer, with that computer he can access every book ever produced in the entire world, with one simple computer, Mr. Speaker.

So in a sense, we have got to move our society to the next level, and the next level is technology, and the next level is to push books out of the classrooms, to push books out of the libraries, and to go to science technology, which allows one computer to access every single book ever produced in the history of mankind.

Thank you, Mr. Speaker.

An Act providing for the licensure of individuals providing sign language interpreting and transliterating services to individuals who are deaf or hard of hearing; and imposing duties on the Office for the Deaf and Hard of Hearing in the Department of Labor and Industry.

On the question,

Will the House agree to the bill on third consideration?

Mr. NAILOR offered the following amendment No. A3873:

Amend Title, page 1, lines 1 through 5, by striking out all of said lines and inserting

Providing for the establishment of standards for providing sign language interpreting and transliterating services for individuals who are deaf or hard of hearing in this Commonwealth who hold themselves out as qualified sign language interpreters and transliterators.

Amend Bill, page 1, lines 8 through 16; pages 2 through 7, lines 1 through 30; page 8, lines 1 through 23, by striking out all of said lines on said pages and inserting

Section 1. Short title.

This act shall be known and may be cited as the Sign Language Interpreters and Transliterators Registration Act. Section 2. Definitions.

The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Applicant." An individual who is applying for registration as a qualified interpreter or a qualified transliterator.

"Deaf." A natural person who is deaf and hard of hearing.

"Department." The Department of Labor and Industry of the Commonwealth.

"Interpreting." The process of conveying English in grammatically correct American Sign Language and the process of conveying American Sign Language in grammatically correct English.

"Office." The Office of Deaf and Hard of Hearing within the Department of Labor and Industry.

"Qualified interpreter." An individual registered under this act who engages in interpreting.

"Qualified transliterator." An individual registered under this act who engages in transliterating.

"Registrant." An individual registered under this act as either a qualified interpreter for the deaf or a qualified transliterator.

"Transliterating." The process of conveying spoken or written English in an English-based sign system and the process of conveying an English-based sign system in spoken or written English.

Section 3. Department responsibilities.

The department shall have the power and duty to do all of the following:

- (1) Administer this act.
- (2) Register applicants in accordance with section 5.
- (3) Maintain a list of all registered interpreters and transliterators and make this list available upon request to the public and to Federal, State and local agencies.
- (4) Promulgate regulations necessary to carry out the provisions of this act.

Section 4. Registration required.

- (a) Registration.—It shall be unlawful for a person to hold himself out as a qualified interpreter, qualified transliterator or to use similar titles or designations in any manner whatsoever unless the person is currently registered under this act.
- (b) Exceptions.—A person who violates this section commits a summary offense and shall, upon conviction, be sentenced to pay a fine of not more than \$300 or to imprisonment for not more than 90 days, or both, for a first violation. A person who is convicted of a subsequent violation of this section commits a misdemeanor of the third degree and shall, upon conviction, be sentenced to pay a fine of not less than \$300 nor more than \$1,000 or to imprisonment for not more than 90 days, or both.
- Section 5. Registration, qualifications, renewal fees and records.
- (a) Application.—An individual may apply to the office for registration. The applicant shall submit to the office the following:
 - (1) A completed application for registration.
 - (2) Payment of the required fee.
 - (3) Proof that the applicant meets one of the following requirements:
 - (i) The applicant is certified by the National or local Registry of Interpreters for the Deaf, Inc., or the National Association of the Deaf.
 - (ii) The applicant meets registration requirements established by the office pursuant to its regulations.
- (b) Renewal.—A registrant shall renew registration on a biennial basis by submitting to the office the information and fee required by subsection (a).
- (c) Registration cards.—The office shall review each completed application for registration and renewal and issue a registration card to an applicant when it is satisfied that the individual meets the criteria of this section.
- (d) Fees.—The fee for registration or renewal of an existing registration shall, unless modified by regulations, be \$10. Section 6. Proof of registration.

A registrant shall provide proof of current registration under this act to the person receiving transliterating or interpreting services. Section 7. Change of personal information.

A registrant shall notify the office of any change of name or mailing address within ten days.

Section 8. Confidential communications.

A registrant who acquires information protected by law as a confidential communication in the course of providing interpreter or

transliterator services to or on behalf of a person who is deaf may not be required to disclose this information in any legal proceeding, trial or investigation before any governmental unit without the consent of the individual receiving transliterating or interpreting services. A registrant shall hold the legal privilege that applies to the individual receiving the services.

Section 9. Registration violations.

- (a) Violations.—The department shall have authority to impose disciplinary or corrective measures, or levy civil penalties on a registrant for any or all of the following reasons:
 - (1) Obtaining a registration or biennial renewal through fraud, deceit or misrepresentation.
 - (2) Being convicted of a felony or of a crime in this Commonwealth or any other jurisdiction relating to the providing of transliterating or interpreting services.
 - (3) Being the subject of disciplinary or other administrative action taken against a registration, certification or license to provide transliterating or interpreting services by the authority of another state or government agency.
 - (4) Committing fraud, gross negligence or misconduct relating to transliterating or interpreting services.
 - (5) Engaging in any other misconduct related to the provision of transliterating or interpreting services as determined by the office pursuant to its regulations.
 - (6) Being incompetent to provide interpreter or transliterator services.
 - (7) Violating any provision of this act or the office's regulations.
 - (8) Failure to comply with a lawful order entered in a disciplinary proceeding under this act.
- (b) Procedure.—Actions relating to violations of this act under this section shall be subject to the right of notice, hearing in adjudication in accordance with 2 Pa.C.S. (relating to administrative law and procedure). The department shall have the power to subpoena witnesses and to compel the production of documents, books and papers in a hearing and to administer oaths.

Section 10. Disciplinary or corrective action.

- (a) Action.—When the department is empowered to take action for registration violations pursuant to this act, the department may:
 - (1) Suspend, deny, refuse to renew or revoke a sign language interpreter registration of an individual.
 - (2) Issue a public reprimand.
 - (3) Require the registrant to take refresher educational courses or training.
 - (4) Require the registrant to provide transliterating or interpreting services under supervision or other conditions or restrictions as the department finds is in the best interest of the public health and safety.
- (b) Surrender of registration.—If a registration has been suspended or revoked, the individual shall return the registration to the office in the manner the office directs. An individual who fails to return the registration in accordance with this section commits a summary offense.
- (c) Reapplication.—An individual whose registration has been revoked may reapply for registration in accordance with section 5 no earlier than five years after the date the previous registration was revoked.
- (d) Civil penalty.—In addition to any other action provided for in this act, the department may levy a civil penalty of up to \$500 per violation on any registrant who violates this act or upon any person who provides or offers to provide transliterating or interpreting services without being currently registered. The department shall levy this penalty only after affording the accused party the opportunity for a hearing as provided for in section 9(b).

Section 11. Effect of order.

A decision and order of the department from which no timely appeal is taken to a court of competent jurisdiction shall be a final order and shall be enforceable by a court of competent jurisdiction.

Section 12. Injunctive relief.

If an individual violates this act, the director of the office, the office or an affected consumer of interpreting or transliterating services may maintain an action in a court of competent jurisdiction for an injunction or other process restraining or prohibiting the individual from engaging in the activity. In any proceeding under this section, it shall not be necessary to show that any person is individually injured. If the court finds that an individual has violated this act, it shall enjoin the individual from engaging in the activity.

Section 13. Applicability.

The provisions of this act shall apply to any interpreting or transliterating service that is provided on or after the July 1, 2004. Section 14. Effective date.

This act shall take effect in 60 days.

Mr. NAILOR. Thank you very much, Mr. Speaker.

Mr. Speaker, it is an agreed-upon amendment, and what it does is, the initial bill that started in the Senate, with Senator Lemmond – and I have worked very closely with him – actually asked for the licensure of interpreters and transliterators in Pennsylvania. We felt that was a bit much, and it was a duplication of national tests that are recognized throughout this nation, so we are looking more at certification and registration, and this amendment would allow us to do that in Pennsylvania, and it is supported by the deaf and the hard-of-hearing community.

STATEMENT BY DEMOCRATIC LEADER

The SPEAKER. The Chair recognizes the gentleman from Greene, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

There is a wonderful line from Macbeth—

The SPEAKER. Would the gentleman suspend one moment.

The gentleman is entitled to be heard. Please keep the noise levels down.

I apologize, Mr. DeWeese.

The Chair recognizes the minority leader, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

There is an especially poignant reference from Macbeth: "O, full of scorpions is my mind, dear wife!" I do not really know what the State Senate Republican leaders are saying to their wives at night, but I am rather confident that they should be full of scorpions.

Weeks and weeks ago, Mr. Speaker, we sent a proposal to the State Senate. It would allow for \$1 billion in property tax cuts and a simultaneous realization in the Commonwealth of legalized slot machines at racetracks and additional venues. It would have provided \$250 million in education funding for prekindergarten in Pennsylvania, kindergarten, and smaller class sizes. That proposal has languished in the anonymous arms of the Pennsylvania Senate.

Now, they seem content to languish; they seem content to be casual. They have told us again and again, Mr. Speaker, what they are against. For some reason they are quite chary about telling us what they are for.

We have spent months in deliberation, and this chamber, to its infinite credit, carved a bipartisan proposal, a compromise. The most important word in the political lexicon is "compromise." Thanks to the Republican nabobs from Jefferson County and Philadelphia County and Lycoming County and the rugged platoon that followed them into the fray, we were able to send a proposal to the State Senate.

Now, this proposal, Mr. Speaker, if not beloved and embraced unanimously by the Republican Party, at least had some wings. It went to the State Senate. It was embraced by the Governor, Edward G. Rendell. It paralleled his campaign platform of last year. It was embraced by the House Democrats with overwhelming numbers, and there is no doubt that our colleagues in the Senate Democratic Caucus will be there on line ready to move forward for Mr. Rendell's package.

So out of the five entities, the four caucuses – Republicans in the House, Republicans in the Senate, Democrats in the House, Democrats in the Senate – and the Governor, out of five entities, essentially when you boil it down to the nub, the State Senate Republicans are intransigent, recalcitrant, and bereft of any positive momentum. Where are the Republican Senate leaders? O how full of scorpions is my mind, dear wife. I do not think they are full of scorpions. They should be. They seem so insouciant, Mr. Speaker, and it is about time the people in this State realize that property tax reduction is hanging in the balance.

The Governor already compromises \$1.5 billion in property tax reductions down to \$1 billion. He already took that personal income tax increase of 3.75 down to 3.1. What is wrong with this picture? Republicans in the House, Democrats in the House, Democrats in the Senate, the executive apparatus of Governor Rendell moving toward a completion of the State budget. We are the only State among 50 that is destitute of a final budget authorization. It makes no sense.

Slot machines at the racetracks and other venues has enough support in the State Senate rank-and-file Republican team, but their leaders will not bring it up for a vote. I think it is imperative that we put the microscope of public focus and attention on the Senate Republican leadership and ask them to generate momentum, ask them to come to the table, ask them to tell us what they are willing to embrace. It is imperative, if not incumbent, upon them as leaders in the State to work with the Governor who prevailed with 57 percent of the vote and who has compromised again and again and again for month after month after month, and yet at the same time we have gotten absolutely no action fromthe State Senate.

I use the bully pulpit today to once again respectfully request that our brothers and sisters in the State Senate Republican Caucus do something, do something.

Most of the people agreed it was a pretty good idea. Along the way I do not know what happened. I do not know what happened. I do not know who is involved. I really am not concerned. Out of this frustration a new word has been coined. It is called "greedlock." "Greedlock," Mr. Leader; "greedlock," Mr. Speaker, and until we correct this problem, nothing, sadly, is going to happen.
