NORTH PENN HIGH SCHOOL FOOTBALL TEAM PRESENTED

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Godshall, who has a citation presentation. Members, please take your seats.

Would Representatives Harper, McGill, and Fichter please come to the rostrum. Members, please take your seats.

The gentleman, Mr. Godshall, may proceed.

Mr. GODSHALL. Thank you, Mr. Speaker.

This is a very auspicious occasion, to have the privilege of introducing to my House colleagues the winning PIAA AAAA football team for 2003, the North Penn High School Knights. The North Penn School District is represented by myself and Representatives Fichter, Harper, and McGill, who are joining me for this occasion.

Before I introduce the team and the team members, I would like to give you a little background on North Penn High School's athletic and academic achievements. Since 1976, North Penn has won 21 State athletic championships. Two members of the 2003 football team – namely, Kevin Akins and Jim Casertano – have been named to the All-State first team. In 2003 North Penn had eight National Merit Scholarship finalists and won the National Achievement Scholarship Program. The class of 2004 has 9 National Merit semifinalists, 22 commended students, and 5 seniors with perfect SAT (scholastic aptitude testing) scores of 800 in either the verbal or math portion of the test. This is quite a feat for any school district.

And now back to football. Led by the North Penn tailback, Kevin Akins, North Penn Knights took the lead in the third quarter and never looked back, for a 37-to-10 win against Pittsburgh Central Catholic.

The weather was raw at Hersheypark Stadium, but the team did not seem to notice. They broke open at halftime and turned the game into a rout, pounding Central Catholic for 419 yards rushing with a total of 454 yards in total offense. The teammates, with the expert guidance of head coach Dick Beck and assistant head coach Jay Jones, can take great pride in completing the first 15-and-zero season and bringing home the school's first State championship in football.

The Knights, as their name indicates, charged into the second half of the final game for 61 yards in 9 plays. They went on to score 17 points in the third quarter. The big play of the drive came when quarterback Adam Hearns hit fullback Jim Casertano with a screen pass that Casertano turned into a 35-yard gain. Three plays later Casertano bulled his way into the end zone.

In recognition of their outstanding performance, not only at the championship game but also throughout the season, I am proud to present each player and coach with a House of Representatives citation. The citation congratulates the team on its AAAA championship and heartily commends the team and coaches for their ability, dedication, and tireless pursuit of athletic excellence, and expresses the wishes of the entire House for success in their future endeavors.

At this time I would like to introduce some individual members. First of all, from the team, All-State Kevin Akins; All-State and cocaptain Jim Casertano; and cocaptains George Farrell, Chad Finney, and Chris Tribanas.

I now would like to introduce the head coach of the North Penn Knights, coach Dick Beck. I also want to acknowledge the assistant coaches who are with us today: Ryan Major, Bob Taggart, Josh Klotz, Dave Franek, Ken McLarnon, Jim Williams, Todd Thatcher, Ed Harkins, Jason Munn, and William Bannak. Would you please stand up. They are in the rear of the House.

And over here on the side we have some of the administration who are with us: Dr. Donald Venema, assistant superintendent; we also have Burton Hynes, principal at North Penn; and Don Ryan, the athletic director.

Guess what? You know, after all this careful planning I did make a mistake, and he is the first one on the list, another cocaptain, and I apologize, Jeff Ball.

And at this time – I do not think I made any more mistakes – you know, I would like to have stand and be acknowledged the championship AAAA football team from North Penn in Montgomery County, the North Penn Knights. Please stand up.

And I would like to let my friends from the Pittsburgh area know that this team is only 77 strong, you know, and I believe we have about 10, 12 assistant coaches here, so you might have something to look out for next year. We may be back.

This information shall be available to the public generally, and to prospective candidates for the available teaching position specifically, at least 30 days before the department may issue the emergency permit to the school district.

CONSIDERATION OF HB 1827 CONTINUED

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Yudichak, from Luzerne County on final passage.

Mr. YUDICHAK. Thank you, Madam Speaker.

Madam Speaker, the bill before us, HB 1827, is a bipartisan effort to modernize Pennsylvania's unemployment compensation laws. The current law penalizes older Pennsylvanians who reenter the workforce. These senior workers who earn their wage, who pay their taxes on those wages, are denied full benefits under the unemployment compensation laws of this Commonwealth. This bill, HB 1827, will change that and treat our seniors fairly.

Madam Speaker, several other States across this nation have recognized that the labor force of the 21st century is evolving and will include older workers. Pennsylvania must keep step with our competing States and remove the 50-percent offset that currently reduces unemployment benefits for our seniors.

And, Madam Speaker, if I may, I want to take a moment to thank the chairmen of the Labor Relations Committee, Representative Allen and Representative Belfanti; former chairman of the Labor Committee, Bob Flick, who did an excellent job in helping and assisting Representative Adolph and me in putting this legislation together.

And I also want to note for the record, the gentleman from Delaware County has been very generous and very bipartisan in his approach to this issue. He and I had competing bills that were introduced at different times on the same issue that would have resolved the offset that penalizes our seniors in Pennsylvania. When it became politically expedient to draft this legislation into one bill, Representative Adolph had an opportunity, had an opportunity, to set aside this junior member from the minority party and champion the bill on his own.

He chose not to do that. He chose to extend a hand in bipartisanship; he chose to give me an opportunity to work with him on this legislation, and I wanted to say thank you to that member, the gentleman from Delaware County, who, in my opinion, lives up to the term "gentleman" on this issue. He certainly is a gentleman of the highest caliber.

Mr. HORSEY. Thank you, Madam Speaker.

Madam Speaker, in the State of Pennsylvania we have PACE (Pharmaceutical Assistance Contract for the Elderly), and PACE services seniors, and it is a great idea and a great concept. There is only one other State that has more seniors in it than Pennsylvania, and that is Florida. The bill we are about to pass today, Mr. Speaker, is a great tribute to a great State, meaning Pennsylvania. It allows the prorating and adjustment to income to affect seniors, and it is probably, other than the PACE program, one of the greatest pieces of legislation that we have voted on in the Pennsylvania State House.

With that, I would urge support of HB 1827.

Thank you, Madam Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Lycoming County, Mr. Cappelli, on final passage.

Mr. CAPPELLI. Thank you, Madam Speaker.

I, too, rise in support of HB 1827.

I want to commend Representative Adolph and Representative Yudichak for their leadership on this issue.

Fairness and equity relative to unemployment compensation and those who are retired receiving Social Security is a commonsense issue, and by eliminating that 50-percent Social Security offset, which far too often completely negates any unemployment benefit when a senior is laid off, is simply wrong and unfair.

HB 1827 brings fairness and equity to the unemployment system for older Pennsylvanians, and I urge its passage.

Thank you, Madam Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Northumberland, Mr. Belfanti, on final passage.

Mr. BELFANTI. Thank you, Madam Speaker.

I also rise in support of HB 1827.

The gentleman, Mr. Yudichak, mentioned that several other States have amended their unemployment laws. In fact, 37 other States have done it. We are 1 of 13 States that penalize senior citizens who, because of today's economy, find that they cannot survive on Social Security and reenter the workforce.

The important thing to understand here, Madam Speaker, for the members of both sides of the aisle, is that the employers who employ these seniors are paying unemployment compensation into the State fund. The employees themselves are also paying a portion of their paycheck into the unemployment fund, only to find out, when and if they are laid off, that there is a 50-percent offset of their Social Security check.

It is most unfair. Thirty-seven other States have recognized this. Today is a great day in Pennsylvania that the House, I am sure in overwhelming numbers, will address this issue and bring fairness to our seniors who, as again I mentioned, are now in a position, because of today's tax structure, utility bills, medical bills, and others, are forced back into the workforce, and again, they are paying for these benefits and they are not receiving them.

So I urge members on both sides of the aisle to please support this bill. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Delaware County, Mr. Adolph, on final passage.

Mr. ADOLPH. Thank you, Madam Speaker.

Madam Speaker, I want to thank the previous speakers for explaining the bill and also giving thanks where thanks is due, especially Chairmen Allen and Belfanti. Chairman Allen showed his political wisdom on this, and we were able to get this bill to the floor without any amendments.

I urge a "yes" vote, and I also urge my colleagues to contact your State Senator, and please have this bill moved out of the State Senate as soon as possible.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 51, PN 3049,** entitled:

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, further providing for powers and duties of authorities.

On the question,

The SPEAKER pro tempore. It is moved by the gentleman, Mr. Herman, that the House concur in the amendments inserted by the Senate.

On that question, the Chair recognizes the lady from Montgomery County, Ms. Harper.

Ms. HARPER. Thank you, Madam Speaker.

Is there somebody who will stand for a question on the Senate amendments?

The SPEAKER pro tempore. The gentleman agrees. You may proceed.

Ms. HARPER. Madam Speaker, we got this bill today, and each and every page of the bill has been amended, and I have a

question on page 5, where the Senate deleted from the calculation of the capacity portion of the tapping fee facilities that provide future service.

Mr. HERMAN. Madam Speaker, I cannot hear the question. Could you get some order in the chamber, please.

The SPEAKER pro tempore. That is very fair.

The gentleman who is being interrogated cannot hear the questions. Could we please have some quiet in the hall, and would members please take their seats. Would the Sergeants at Arms restore some quiet.

Ms. HARPER. Madam Speaker, should I repeat the question?

The SPEAKER pro tempore. I do not believe that he heard you, so please repeat the question.

Ms. HARPER. Thank you very much.

This is a bill that deals with a recalculation of the sewer and water tapping fees, and on page 5, the Senate has deleted five words from the calculation. They have deleted the words "or will provide future service," indicating that the tapping fee capacity portion may only be based upon facilities which provide existing service. My concern is that because the other part of the bill talks about future acquisitions or future construction, that the municipal authorities will not be able to recoup the cost of presently existing facilities that serve future customers.

Perhaps an example would be helpful. If a sewer plant is rated for 100 homes and the existing service is only 50 homes, is the municipal authority required to calculate its tapping fee as if it only had half of its capacity, which, of course, it paid for?

Mr. HERMAN. Madam Speaker, we are going to try and find that information for you as we struggle to find page 5. Could you hold just a minute, please?

Ms. HARPER. Madam Speaker, I am going to rephrase my question. Okay?

The SPEAKER pro tempore. You may proceed.

Ms. HARPER. I would like the gentleman to help me see where a municipal authority can in its tapping fee recoup the cost of existing facilities that serve future customers or whether that cost is lost.

Mr. HERMAN. Madam Speaker, with some help, I would like to refer you to page 7. Page 7, line 19, spells out very, very specifically, "Where the cost of facilities to be constructed or acquired in the future are included in the calculation of the capacity part as permitted herein, the total cost of the facilities shall be divided by the system design capacity plus the additional capacity to be provided by the facilities to be constructed or acquired in the future." Therefore, the costs are included in that calculation.

Ms. HARPER. Madam Speaker, that does not answer my question. The Senate amendments change the calculation of facilities to be constructed or acquired in the future. My question is with regard to page 5, existing facilities that have been built at some expense to the authority's ratepayers that cannot be included in the tapping fee because they are for future customers. The language of the bill as amended by the Senate used two different terms, and the portion that the Representative pointed out to me does not answer the question.

Mr. HERMAN. Madam Speaker, apparently, in talking with some of our other members associated with this bill and our staff, we have some confusion about her reference to page 5.

So I suggest we go over this bill, and maybe we can work this out on the floor instead of wasting the members' time as we try to determine what was the House version versus the Senate version that we are doing, plus the changes for concurrence.

CHAPTER 86
MUNICIPAL PUBLIC SERVICE

AND SAFETY FEE

Sec.

8601. Scope.

8602. Definitions.

8603. Municipal public service and safety fee.

§ 8601. Scope.

This chapter deals with municipal public service and safety fees. § 8602. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Fee." A municipal public service and safety fee imposed pursuant to section 8603 (relating to municipal public service and safety fee) to support public service and safety including the maintenance of streets, street lighting, police, fire and emergency management services.

"Political subdivision." Any city, borough, incorporated town, township or home rule municipality except a city of the first class. § 8603. Municipal public service and safety fee.

- (a) Imposition.—Notwithstanding any other law, the governing body of a political subdivision may impose by ordinance a fee pursuant to this section on all persons who work within the political subdivision.
 - (b) Amount.—Any fee imposed under subsection (a) shall be:
 - (1) Fifty-two dollars per person per calendar year.
 - (2) Collected in two equal installments of \$26.
 - (c) Situs.-The following shall apply to situs of fee:
 - (1) The following shall apply to place of employment:
 - (i) The situs of the fee imposed under subsection (a) shall be the place of employment except as provided in subparagraph (ii).
 - (ii) If a person is engaged in more than one occupation or an occupation which requires his working in more than one political subdivision during the calendar year, the priority of claim to collect the fee imposed under subsection (a) shall be in the following order:
 - (A) First, the political subdivision in which a person maintains his principal office or is principally employed.
 - (B) Second, the political subdivision in which the person resides and works, if the fee imposed under subsection (a) is levied by that political subdivision.
 - (C) Third, the political subdivision in which a person is employed and which imposes the fee imposed under subsection (a) nearest in miles to the person's home.
 - (iii) The place of employment shall be determined as of the day the taxpayer first becomes subject to the fee imposed under subsection (a) during the calendar year.
 - (2) No person shall pay the fee or an occupational tax more than once in any calendar year irrespective of the number of political subdivisions within which the person may be employed within any given calendar year.
 - (3) In case of dispute, a fee or tax receipt for that calendar year declaring that the person has made prior payment constitutes prima facie certification of payment to all other political subdivisions.
- (d) Restrictions.—A political subdivision that imposes a fee under subsection (a) may not collect any portion of the occupational privilege tax under the act of December 31, 1965 (P.L.1257, No.511), known as The Local Tax Enabling Act.

- (e) Exemption.—A political subdivision may exempt any worker from a fee imposed under subsection (a) whose total income from all sources is less than \$7,500 annually.
- (f) Property tax deduction.—Beginning in the second calendar year that a fee is imposed under subsection (a) and each year thereafter, a person may deduct the amount of the fee paid for that calendar year from any property taxes owed to the political subdivision if the person:
 - (1) resides and works in the same political subdivision;

and

(2) pays the fee imposed under subsection (a) for that calendar year.

Section 3. All acts and parts of acts are repealed insofar as they are inconsistent with the addition of 53 Pa.C.S. Ch. 86.

Section 4. This act shall take effect as follows:

- (1) The following provisions shall take effect in 60 days:
 - (i) The addition of 53 Pa.C.S. Ch. 86.
 - (ii) Section 3 of this act.
- (2) The remainder of this act shall take effect immediately.

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from York County, Mr. Stetler.

Mr. STETLER. Thank you, Madam Speaker.

Madam Speaker, amendment 4218 would cause for the creation of a municipal public service and safety fee. I introduced this legislation in HB 2201.

This amendment allows for all municipalities statewide, with the exception of the county of Philadelphia, to put in place an annual fee of \$52 for all resident and nonresident workers of that municipality. This fee would allow those municipalities to augment their costs for police and fire services, for ambulance and emergency services, for street lighting and street maintenance, and any other safety expense that a municipality might have.

It is important to realize, Madam Speaker, that this fee is not mandatory and that Philadelphia is excluded. Each municipality will look at their own employment base and their budget to determine if the fee is appropriate to their own community. Municipalities that would opt to charge this fee must first repeal the levy of the occupational privilege tax. The fee itself would be deducted from the individual's paycheck, beginning each year with the first two paychecks, in the amount of \$26 per paycheck.

Included in this would be a poverty exemption. Any worker in a municipality earning less than \$7,500 would be exempt from this fee, and in addition, any person who works and lives in the same municipality, beginning in the second year, would be allowed to deduct the \$52 from their municipal property taxes.

Madam Speaker, given the other subjects that we are going to be discussing tonight regarding the city of Pittsburgh and their financial issues, this piece of legislation, I think, should be viewed not just within the context of the city of Pittsburgh but within the context of all municipalities. I represent the 95th District in York County. It has the city of York, but it also has two boroughs and several townships in that district.

There is a need for older boroughs and for cities and for townships to be given some latitude in the way they raise fees to pay for their police and fire and other public services. This piece of legislation, I think, will go a long way not just dealing with the city of Pittsburgh's issues but with all municipalities across the Commonwealth, and I would appreciate a "yes" vote.

Thank you, Madam Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Allegheny County, Mr. Stevenson, on the amendment.

Mr. T. STEVENSON. Thank you, Madam Speaker.

I commend the gentleman for introducing his bill. It is a bill that we need to discuss in this House and in our committees. However, I do not commend the fact that he tried to amend his bill into my bill.

This bill really should be subject to public discourse and talk amongst ourselves in our committees to decide if we can improve the bill, and one area that we can improve the bill and why this is a bad amendment to vote on is the fact that it hurts our municipalities. Even though he is trying to help, if you pay your \$52 a year, you have to give a credit or the municipalities will give a credit to you for \$52 worth of real estate tax. So it is really an offset. It is not an additional tax, which our municipalities are seeking.

And secondly, as was stated in our caucus, this amendment would be extremely detrimental to seasonal workers, who would have to pay the \$52, and it would not be prorated.

So for those reasons I ask for a negative vote on this amendment, Madam Speaker. Thank you.
