An Act authorizing and directing the Department of General Services, with the approval of the Governor, to grant and convey to the Philadelphia Regional Port Authority certain lands situate in the 39th Ward of the City of Philadelphia; and authorizing the Department of General Services, with concurrence of the Department of Environmental Protection, to lease to Isle of Capri Associates land within the bed of the Delaware River in the City of Philadelphia.

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for license to carry firearms.

On the question,

Will the House agree to the bill on third consideration?

The SPEAKER. The gentleman, Mr. Maitland, moves—The Chair recognizes the gentleman, Mr. Maitland.

Mr. MAITLAND. Thank you, Mr. Speaker.

I would ask for consideration of amendment 4579, please.

The SPEAKER. The clerk will read the amendment.

On the question recurring,

Will the House agree to the bill on third consideration?

Mr. MAITLAND offered the following amendment No. A4579:

Amend Title, page 1, line 2, by striking out "license" and inserting

issuance of licenses

Amend Sec. 1, page 1, line 6, by striking out "6109(e)(3)" and inserting

6109(e)(1) and (3)

Amend Sec. 1, page 1, line 7, by striking out "is" and inserting are

Amend Sec. 1 (Sec. 6109), page 1, by inserting between lines 10 and 11

- (1) A license to carry a firearm shall be for the purpose of carrying a firearm concealed on or about one's person or in a vehicle and shall be issued if, after an investigation not to exceed 45 days, it appears that the applicant is an individual concerning whom no good cause exists to deny the license. A license shall not be issued to any of the following:
 - (i) An individual whose character and reputation is such that the individual would be likely to act in a manner dangerous to public safety.
 - (ii) An individual who has been convicted of an offense under the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act
 - (iii) An individual convicted of a crime enumerated in section 6105.
 - (iv) An individual who, within the past ten years, has been adjudicated delinquent for a crime enumerated in section 6105 or for an offense under The Controlled Substance, Drug, Device and Cosmetic Act.
 - (v) An individual who is not of sound mind or who has ever been committed to a mental institution.

- (vi) An individual who is addicted to or is an unlawful user of marijuana or a stimulant, depressant or narcotic drug.
 - (vii) An individual who is a habitual drunkard.
- (viii) An individual who is charged with or has been convicted of a crime punishable by imprisonment for a term exceeding one year except as provided for in section 6123 (relating to waiver of disability or pardons).
- (ix) A resident of another state who does not possess a current license or permit or similar document to carry a firearm issued by that state if a license is provided for by the laws of that state, as published annually in the Federal Register by the Bureau of Alcohol, Tobacco and Firearms of the Department of the Treasury under 18 U.S.C. § 921(a)(19) (relating to definitions). This subparagraph shall not be applicable to any individual who is either a law enforcement officer to the United States, any other state or the District of Columbia, or licensed as a manufacturer, importer or dealer of firearms pursuant to 18 U.S.C. § 923 (relating to licensing).
 - (x) An alien who is illegally in the United States.
- (xi) An individual who has been discharged from the armed forces of the United States under dishonorable conditions.
- (xii) An individual who is a fugitive from justice. This subparagraph does not apply to an individual whose fugitive status is based upon nonmoving or moving summary offense under Title 75 (relating to vehicles).
- (xiii) An individual who is otherwise prohibited from possessing, using, manufacturing, controlling, purchasing, selling or transferring a firearm as provided by section 6105.

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the gentleman, Mr. Maitland, for a brief explanation of the amendment.

Mr. MAITLAND. Thank you, Mr. Speaker.

This amendment would address a problem raised by the Adams County sheriff in that he is not allowed to issue permits to carry to out-of-State police officers or licensed Federal firearms dealers.

A particular problem is Maryland, which will not issue a permit to carry to anybody. And in Maryland a police officer's badge is his license to carry, but when a police officer from Maryland then comes to Pennsylvania and requests a permit, they do not have a permit from their State, so the sheriff is not permitted to issue them a permit, and this similar problem exists for licensed Federal firearms dealers. This amendment would correct that problem, Mr. Speaker, and I ask for the members' support.

The SPEAKER. The Chair thanks the gentleman.

(k) Reciprocity.—The Attorney General may enter into reciprocity agreements with other states providing for the mutual recognition of each state's license to carry a firearm. Reciprocity agreements shall not provide for recognition of another state's license to carry a firearm which has been issued to a Pennsylvania resident who does not possess a valid license to carry a firearm issued under this section.

On the question,

Will the House agree to the amendment?

The SPEAKER. The House has immediately before it amendment A0089. On that purpose, the Chair recognizes the gentleman, Mr. Maitland, for an explanation.

Mr. MAITLAND. Thank you, Mr. Speaker.

The purpose of this amendment is to prevent someone who is denied a permit to carry a firearm in Pennsylvania or otherwise is ineligible or had their permit revoked to go to another State and get a permit in that other State and then come to Pennsylvania and use that out-of-State permit to force Pennsylvania to issue a permit.

For example, Florida does not have access to any of Pennsylvania's mental health records, so if someone is denied or ineligible for a permit under sections 302, 303, or 304 of the Mental Health Procedures Act, Florida would not know that. Florida may issue that person a permit, and then that ineligible person could come to Pennsylvania and try to get a permit on the basis of the Florida permit. This language would prevent that situation from occurring, and I ask for the members' support.

Mr. Speaker, will the gentleman, Mr. Maitland, consent to interrogation?

Mr. COHEN. Thank you.

Mr. Speaker, in the first amendment that you passed, which is now in the bill, section (1)(ix) deals with out-of-State manufacturers, dealers, of guns. Could you explain what the purpose of that exemption is?

Mr. MAITLAND. Yes. There is a licensed Federal firearms dealer from Maryland who has his place of business in Pennsylvania. Maryland will not issue a license to carry to that individual, so therefore, he cannot get one in Pennsylvania. But licensed Federal firearms dealers are very thoroughly vetted before they are ever given their Federal firearms license, so therefore, this exception would allow an individual in that situation to be granted a license to carry in Pennsylvania – a very narrow circumstance.

Mr. COHEN. Do you have any idea how many such people there are in Pennsylvania?

Mr. MAITLAND. One in Adams County is all I can say.

Mr. COHEN. Okay. Mr. Speaker, some time ago – I do not have it – the Philadelphia Daily News ran an expose about large numbers of people who are gun dealers who, in the opinion of the Daily News at least, should not have been gun dealers, so I was conscious of that. I will try to do some research on that and share it with the gentleman if it turns out to be any kind of problem.

CONSIDERATION OF HB 696 CONTINUED

On the question recurring,

Will the House concur in Senate amendments?

The SPEAKER. It is moved by the gentleman, Mr. Keller, that the House concur in the amendments inserted by the Senate.

The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Mr. Speaker, this transfer involves two separate parcels, a 47-acre parcel in the 39th ward of the city and another parcel in the 5th ward of the city of Philadelphia, and it very well may be that these are wonderful transfers that will do great things for the economic development of the city, but I think I have some very serious questions about these transfers that I would like to discuss.

With regard to the original parcel of property that was in the Keller bill, HB 696, I think it is important for members to know that the Department of General Services, who owns this property, opposes the bill. Let me just repeat that: The Department of General Services opposes this bill, and their stated reason is that the title is clouded, and until that title's cloud is lifted, they do not think it would be appropriate to transfer that property.

With regard to the second part of this, and the second part of this parcel involves some riparian rights in the fifth ward of Philadelphia, I think some serious questions are raised, because this has not gone through the normal committee process and has not been subject to scrutiny by the legislature. This was introduced, rather than going as a bill on its own as it typically proceeds, this was done as an amendment by Senator Fumo on the Senate floor to the Keller bill. The Department of General Services has not had the opportunity to scrutinize this transfer. The property involves the authorization for a 99-year lease with the option for another 99-year lease, which is, in effect, a transfer of the property, but because it is going through the lease posture as opposed to the transfer, outright sale, it circumvents a lot of legalities. I do not know why it is being done in the context of a lease as opposed to an outright transfer, and I think that raises some questions.

I know that with regard to this second property, it is being transferred to an entity known as, I believe, Isle of Capri Associates among others, and I believe that about 780 condominiums are planned. So an enormous amount of money potentially is involved. What we do not know is whether

the Commonwealth is or will be getting fair value, whether the taxpayers will be getting fair value.

I think again, I know, that the sponsors of the bill on the House side from Philadelphia I know have the best interests of their district at heart and I know they are doing what they believe are the right things, but I just have concerns that because of this not going through the proper channels and because the State Government Committee and the Department of General Services really have not had a chance to scrutinize it, there is a risk that I do not think we should be willing to take, that the taxpayers are not getting fair value for this.

MOTION TO RECOMMIT

Mr. VITALI. Again, the Department of General Services opposes it, and I am not going to ask for a "no" vote on this. I am simply going to be asking and making a motion more to the point that we recommit this bill to the House State Government Committee so that we can take a closer look at it. We can have the Department of General Services take a closer look at it, and we can just make sure, just be doubly sure, that the right things are happening here.

So I would so move that HB 696 be rereferred to the House State Government Committee.

The SPEAKER. The Chair thanks the gentleman.

The gentleman moves that HB 696, PN 3141, be recommitted to the State Government Committee.

On the question,

Will the House agree to the motion?

The SPEAKER. On that question, the Chair recognizes the chairman of the State Government Committee, the gentleman from Bucks, Mr. Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, let me just share some insights to the members here in the House regarding that HB 696, which is the first component of the bill, Representative Keller's bill. We did exhaustive hearings on his legislation, and yes, it is on record that General Services did oppose that legislation, but it passed the House by a very unanimous vote some months ago. The bill went over to the Senate and at that time there was an amendment put in, and that is the object of discussion by the Representative from Delaware County.

If we do not, if the House does not move to report the bill back to the State Government Committee, I will have more details and a further explanation as to why I feel and others feel that this bill can move forward today here in the House, and therefore, I would urge that we do not recommit the bill to the State Government Committee.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Philadelphia, Mr. Keller.

Mr. KELLER. Thank you, Mr. Speaker.

This bill has been, if you could just punch up on the computer and do a history of the bill, I think this is what we should teach the kids, how a bill becomes law. This bill has been scrutinized, been in and out of committees, been recommitted. This bill has had more airing than any bill, I think, this session.

The first part of this bill, the 47 acres, is a riparian problem, and the bill transfers this land, the 47 acres, to the Philadelphia Regional Port Authority, which is a State agency. So we are taking 47 acres of land that is riparian land and removing the cloud on the deed, and we are giving it to a State agency, the Philadelphia Regional Port Authority, so it belongs to the people of the Commonwealth.

The second part is an amendment that was put in in the Senate. The question is about the lease instead of the transfer. We just had a discussion, as the gentleman from Delaware knows, with DGS (Department of General Services), and they said that even though it is a lease, DGS still has the ability to get the fair market value for the Commonwealth in the lease, and that is their intention.

So I do not see any reason to commit this bill. Check the history of the bill; you will see that this bill has been everywhere. And this is a bill that should be voted today; we want to get it out of here. Please vote "no" to recommittal.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Northampton, Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker.

I appreciate the gentleman's comments about how a bill becomes a law, and I did check the history, and what he said may be very true for the first 9 months of this bill's history. It was introduced in March, and it went to the State Government Committee. It was voted out of the State Government Committee in the House, passed the House. It went to the Senate State Government Committee, was voted out of the State Government Committee, and went to the Senate.

On the night of December 19 an amendment was added in the Senate, and that has not received review by the State Government Committee. The amendment that was added in the Senate takes up most of page 5, all of page 6, and all of page 7.

Now, I understand that Senator Fumo introduced that on the night of December 19, but I would appreciate the State Government Committee having a chance to review that language. The State Government Committee did review the initial language of Representative Keller's very fine bill, but I do not believe the State Government Committee has had a chance to review the Senate amendment, and so I would argue in favor of Representative Vitali's motion to recommit this to the State Government Committee.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Delaware, Mr. Vitali, for the second time.

Mr. VITALI. To be clear, this is on the motion to— The motion, it is my first time at the mike.

The SPEAKER. The gentleman is correct.

Mr. VITALI. Just a few quick points. I do not want to be repetitive.

The extensive hearings were only on the 39th ward property, and despite those extensive hearings, the Department of General Services still opposes, because there is an outstanding issue with regard to the first part of the bill, and that is the clouded title. It is DGS's position that we should not be transferring property with a clouded title, so that is one good reason to move this to State Government Committee and perhaps keep it there until the title issue can be resolved.

The second point with regard to the fifth ward of Philadelphia property, the Senator Fumo transfer, again, this has had no hearings at all, has had no committee consideration at all. We do not know, we do not know really what is happening here but have reason to ask questions. Even though it just authorizes DGS to enter into a lease, it really sort of does not explain why we are leasing as opposed to selling, as we conventionally do, and that raises some questions in my mind.

I am not a real estate expert, but I think there is ample reason here just to slow this process down. If this second transfer, if this fifth ward transfer, was going the way it should, it should have been a bill in its own right, it should have moved through the committee system, it should have been considered by both chambers, and it has not. It sort of, at the last second, got tacked on as an amendment, and that deserves just a little bit of scrutiny.

I do not think we prejudice ourselves by having the State Government Committee take a closer look at this. What I do not want to be is the subject of an embarrassing newspaper article, you know, next year, saying this is just another land grab and it resulted in moneys being transferred by some private entity into someone else's—

The SPEAKER. Mr. Vitali. Mr. Vitali, please stay to the bill that is at hand.

Mr. VITALI. Thank you, Mr. Speaker.

I will summarize.

I think it is just prudence in protecting the taxpayers' interest that we just take the scrutiny of this bill that our responsibility requires to take, take a closer look, and so I would ask that this be recommitted to State Government. Thank you.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, I certainly share the concerns of the two members who had expressed anxiety and concern about the amendment that was put in over in the Senate, and I have available for any members the Philadelphia Business Journal, and they have written about that very issue in their publication, and for the record, for the record, I want to read what this amendment will do, because, again, I share the concerns of all the members, but in particular, those two members who had spoken.

"A major \$280 million gated condominium community has been planned for Piers 36-39 along the Delaware River in Philadelphia. The project, Waterfront Square Condominiums and Spa, will be on the northern edge of Penn's Landing and will consist of five buildings ranging from 22 stories to 35 stories with a total of 780 condominiums. In all, 1.3 million square feet will be constructed. The buildings will surround a three-acre park and face the Benjamin Franklin Bridge, abutting Festival Pier.

"The land in which the project will sit totals 10 acres. The developers bought the property from the Tabas family, known for its local real estate and banking operations.

"The overall project will include a 12,000-square-foot fitness facility that will house a spa and year-round swimming pool.

"The developers plan to break ground on the first phase – a \$50 million, 24-story tower of 129 condos – in January."

Mr. Speaker, that is in essence what will take place. I will be glad to give this literature out to any member who so requests it.

Again I would ask that the members support HB 696 as amended. We have done our very best in talking to various and sundry persons about, is this indeed what will happen. We trust their word.

I have read the report across the floor of the House so that we are on record as to what this amendment surely is planned to do for the piers there in the city of Philadelphia.

I would ask for a concurrence vote.

Mr. DeWEESE. Thank you, Mr. Speaker.

I would like to ask the majority leader, the gentleman from Jefferson County, Mr. Smith, a couple of questions, please.

The SPEAKER. The gentleman, Mr. Smith, is at the microphone. The gentleman is in order and may proceed.

Mr. DeWEESE. Just asking for scheduling and strategic purposes, does the gentleman have a rough draft? I have seen comments from your spokespersons in the media, but with the Governor's press conference this morning being very timely, many of the folks in our caucus would like to know the rough-draft plans — obviously, nothing specific — but rough-draft plans that the majority party has relative to property tax reduction and gaming, and do we have to wait until May or June, as has been reported on National Public Radio and in some press reports, or are we going to roll up our sleeves and attack these efforts in February and March?

And again, this is not an admonition; it is a request for information, in an admonitory tone, of course.

Mr. S. SMITH. Well, of course, Mr. Speaker.

Mr. Speaker, obviously, this House, under a lot of debate and discussion, passed a property tax proposal along with the gaming proposal back in July. There obviously has been a lot of discussion in the Senate. I hear a lot of the overflow of their discussions. They brought that nearly to a head in December. At this point, quite frankly, given the announcements and pronouncements of the Governor and the level of debate in the Senate, it would be my intention to see what comes out of the Senate, given the two bills that we sent over there, to give them a little bit more time to send us a responsive piece of legislation to what we sent them back in July.

An absolute timeframe, I am not really willing to commit to, but I would say I am more than willing, over the next 2 or 3 weeks of session time, to allow the Senate to respond. At some point, obviously, if it becomes clear that they are unwilling or incapable of coming to a resolution between the various competing interests in the Senate and the administration's office, then we will look at bringing other options to the table.

Mr. DeWEESE. Thank you very much, Mr. Majority Leader. That concludes my interrogation.

Just one final comment, if I may, Mr. Speaker.

The SPEAKER. The gentleman is in order.

Mr. DeWEESE. The Governor did have a press conference this morning, and we are poised to work with the administration and with our Republican colleagues in trying to generate additional revenue for the State of Pennsylvania.

In the ensuing weeks I hope we can put our shoulders to the wheel. We had an amendment today from Mr. Pallone of the Alle-Kiski area on video gaming, and due to some technical reasons and some tactical reasons, we pulled that amendment, but we are as a Democratic Caucus poised, anxious, and focused to move forward to generate additional revenue for Pennsylvania in the ensuing months, and we ask that this forum allow us to show our enthusiasm to Mr. Smith and his troops, and hopefully in the next several weeks we will get down to business.

I do understand the tactics, and I do understand his hesitation. It is not inappropriate that we see what is coming out of the State Senate, but again, I wanted to get this on the record, and we are anxious for our Senate colleagues to react with us as a chamber.

I think we have been every bit on the forefront. We have come up with different ideas that we are in fact evaluating and considering as alternatives, in case the current 5-for-1 gambling/property tax proposal does not sustain the necessary support in the Senate and subsequently in the House and the administration. We are looking at alternatives, and we are equally committed to trying to resolve this issue for the people of Pennsylvania.

So I just want that to be reflected in a fair and accurate manner, Mr. Speaker. Thank you.
