# 125TH ANNIVERSARY COMMEMORATION OF 28TH INFANTRY DIVISION, PENNSYLVANIA ARMY NATIONAL GUARD

The SPEAKER. Would the members please take their seats.

We are very proud to have with us today many distinguished members of the Pennsylvania National Guard's 28th Infantry Division. In honor of another historic milestone for Pennsylvania's National Guard and the Pennsylvania citizen soldiers who have served their country as part of this storied 28th Infantry Division, I would ask Representative Tigue and Representative Egolf to inform the members of the milestone, followed by an introduction of a very special guest.

Please give them every sign of respect.

Mr. TIGUE. Thank you, Mr. Speaker.

Mr. Speaker, today is indeed a momentous occasion for Pennsylvania's National Guard and the men and women who fill the ranks of what is the finest National Guard organization in our country.

Today, we would like to take time to honor the 28th Infantry Division as it celebrates its 125th anniversary as a military division in the United States Army. In fact, there are units which can trace their origins back to the Associators in Philadelphia, which were organized in the mid-1700s by Benjamin Franklin. But since its creation as a division in 1879,

Pennsylvania's 28th Infantry Division has always remained at the ready to be called upon by her nation in a time of war or by the Governor of our Commonwealth in a time of civil unrest or disaster.

We are truly proud and eternally grateful to those who are veterans or who are presently serving in the 28th Division. It is because of their unselfish sacrifices that our Commonwealth is a beacon of virtue, liberty, and independence.

And now Representative Egolf will introduce our special guest, the commanding general of the 28th Division, Gen. Wes Craig.

Thank you, Mr. Speaker.

Mr. EGOLF. Thank you, Representative Tigue.

It is my distinguished honor to have the privilege of introducing Maj. Gen. Wesley E. Craig, commanding general of the Pennsylvania National Guard's 28th Infantry Division.

General Craig, welcome to the House chamber, and thank you and your troops for honoring us with your presence here today.

General Craig was promoted to his current rank and appointed to his current command in October of 2003, and in this position he commands a National Guard mechanized infantry division consisting of 7 major subordinate commands and 25 battalions, all stationed in 95 communities in Pennsylvania, Ohio, and Virginia.

General Craig was commissioned as a distinguished military graduate from Temple's ROTC (Reserve Officers' Training Corps) program, and upon completion of active military duty, he joined the Pennsylvania National Guard in 1971 and has held numerous commands which have led him to the current position of division commander.

And on a personal note, I had the pleasure of accompanying General Craig to Washington just a few weeks ago for "National Guard Education" meetings with our congressional delegation, and I can tell you this, that each member in this chamber has quite a bit to be proud of. The 28th Division, made up of citizen soldiers from the many communities in our legislative districts across the State, is on the move. With the implementation of the division's new Stryker Brigade, which the general will mention in a few minutes here, our National Guard is indeed out in the forefront, and I can think of no better leader for this division than Maj. Gen. Wesley Craig.

Having said that, on behalf of the Speaker, the members of the House, the Veterans Affairs and Emergency Preparedness Committee, and the members of the entire House of Representatives, it is my honor to welcome General Craig and ask him to address this body on this momentous occasion. General Craig.

MAJOR GENERAL CRAIG. Thank you very much. Thank you. Thank you very much. Please be seated.

Mr. Speaker, honorable Representatives, General Wright, the Adjutant General of Pennsylvania, Lieutenant Colonel Blanchart from Belgium, today we honor the 125th anniversary of the 28th Infantry Division, Pennsylvania Army National Guard's Keystone Division, as we are known. We also pause to remember the 4,000 soldiers who have given their lives over our century and a quarter of service.

It is fitting that we come here to this august chamber in the heart of Pennsylvania to celebrate the great deeds of the division. It is often in beautiful places such as this that great soldiers are born. As has been mentioned, the journey of the 28th began in a similar place, colonial Philadelphia. In 1747 a famous printer, scientist, and politician named Benjamin Franklin published his pamphlet called "Plain Truth." In it, he warned of the looming dangers of privateers sailing up the Delaware River and burning and sacking the city of Philadelphia. In the face of strong Quaker passivism of the day, he called for a voluntary association of disciplined fighters to be picked from the middling people – farmers, shopkeepers, and tradesmen – just as we are today.

The response to his call was great. The voluntary associations of militia, called Associators, were formed. They served in the Revolution, the War of 1812, the Mexican War, and the Civil War with great distinction. On March 12, 1879, Gov. Henry Hoyt banded together all the Associator units into a single division, the only one then in service in the entire Army. He appointed John Hartranft, the Civil War Medal of Honor winner, as the first division commander. Thus was born the 28th Keystone Division. We have been in continuous service ever since.

Our first annual training period was held that summer for no pay. Unit members were paid only for their days of annual inspection. Privates in that day earned all of \$1.50.

A pause of our remarks at this point; the division colors are present.

Post the division colors.

(The colors were presented and posted by the 28th Infantry Division, Pennsylvania Army National Guard.)

MAJOR GENERAL CRAIG. Thank you. Please be seated.

The battle streamers on our colors represent all the campaigns from the division, including the Associator regiments, that go back as old as 1747.

After we were formed in 1879, the division grew quickly, and within the next several years a Regular Army inspector wrote, and I quote, "...I know of no other State...that can put into the field on as short notice, so well equipped and so efficient a body of men as Pennsylvania."

The Spanish-American War caused the entire division to be voluntarily mustered into Federal service. Three regiments of infantry, three batteries of artillery, and three cavalry troops saw service overseas in both Puerto Rico and the Philippines.

In 1904, after our return home, another Regular Army inspector wrote, "...Every time I saw the division...it was a marvel to me how so many citizens could be brought together from multitudinous callings from every town and city in the State and maneuvered with such" great "precision and order. Every credit is due the citizens of the Guard for the sacrifice they make and the good work they..." do, have done, and are continuing to do. The same is true today.

On June 22, 1916, the division was mobilized at Mount Gretna for the border campaign with Mexico. By July 25, we were assembled outside of El Paso, Texas, and spent the next 9 months chasing Pancho Villa. On March 17, 1917, we returned home. One month later, World War I began. The whole division was promptly drafted into Federal service and sent to Camp Hancock in Augusta, Georgia. Eight months of training later, we were shipped to England and then to France. France, as you know, is a lovely country, but unfortunately for her, it hosted one of history's greatest horrors, the trench warfare of World War I. We were committed to stop,

on the Champagne Marne, to stop the Germans' last offensive of that war. We stopped them cold. Within a week, we were counterattacking. Our coolness under fire and deadly marksmanship caused General of the Army John J. Pershing to come to visit. When he reviewed the force, he said, why, "You are not soldiers, you are men of iron," and hence we have carried that nickname as the "Iron Division" ever since. We went on the offensive and stayed on the offensive until the end of the war in 1918. Our return home resulted in a tumultuous parade of 8 1/2 miles through the city of Philadelphia on May 15, 1919, that was witnessed by the 2 million people in that city.

We were reconstituted in 1920. Many World War I veterans joined our ranks. Staff training began. There was a boom in armory construction. Mount Gretna was recognized as being too small to accommodate the size force, so Fort Indiantown Gap was developed and expanded, and by 1939 the division numbered 14,500 soldiers.

On February 17, 1941, we were mobilized for a year of training. Pearl Harbor came along and so did the year of training. We did not return home for  $5 \frac{1}{2}$  years.

We trained under three different division commanding generals. The most famous of them was known as Omar Bradley. We were shipped to England in October of '43, and we passed over Omaha Beach 6 weeks after Dday, on July 22, 1944. We participated in the Saint-Lo breakout, raced on to Paris, and paraded through this city on August 29, 1944. The famous painting showing large masses of soldiers marching 24 abreast under the Arc de Triomphe are none other than soldiers from the 110th Infantry Regiment of the 28th Infantry Division. We went on to liberate parts of Belgium and Luxembourg, and on September 10, 1944, we were the first American troops to pierce the Seigfried Line into Germany. We then committed to the bloody battle of Huertgen Forest, which cost us over 6,000 battle casualties. Later, we were moved to rest into the Ardennes section of France. As all of you who study American history know, the Battle of the Bulge followed a month later. The 28th Division held off eight German divisions and inflicted over 12,000 casualties on the attacking German force. War correspondent Morley Cassidy remarked that "For four days from 16-20 December, the main roads were denied the enemy. The type of resistance offered by the Keystone troops was one of the greatest feats ever ... " of American arms. Victory over the Germans followed in the Colmar Pocket in February of '45. By the end of the war, we had spent 196 days in combat. We had fought against over 45 of the 90 divisions the Germans had on the Western Front. We had lost 9100 soldiers to wounds, 2600 missing in action, and almost 2,000 killed in action.

We returned to Pennsylvania on November 11, 1946. Maj. Gen. Dan Strickler, a remarkable gentleman, an attorney from the city of Lancaster, became the division commanding general. He had the distinct honor and privilege of commanding some of our soldiers in the 28th Division, both in World War I and in World War II, and while he was division commander, we were mobilized once again for the Korean war. We deployed to Germany as part of the NATO (North Atlantic Treaty Organization) force in November of 1951, stayed there – our colors stayed there – until 1954, when we were finally returned once again to Pennsylvania. The division stood at 50 percent strength by annual training 1955. We have since grown to the force we are now of 14,000 soldiers. We are organized into two armor brigades, a division artillery brigade, an aviation brigade, a division support command, and the Stryker Brigade Combat Team that Representative Egolf just mentioned.

The Stryker Brigade is a brand-new concept. There are only five in the Active component and only one in the National Guard or Reserve, and that is our 56th Brigade headquartered in Philadelphia. It is a large brigade of motorized infantry mounted on a new eight-wheeled Stryker infantry armored vehicle. It has a tremendous amount of computer-based digital communications systems that gives it unparalleled situational awareness. It is highly mobile and is trained to work with joint forces. Its impact on Pennsylvania is tremendous and long lasting. More than a billion and a half dollars' worth of equipment and military construction will be invested in the Commonwealth of Pennsylvania in the next 4 years as a result of this brigade being given to the 28th Division.

We here in the division continue to serve our Commonwealth and country. Whether it be duty in response to domestic emergencies such as floods, blizzards, or riots or response to the call of the President in time of war, we will always be ready.

Since September 11, 2001, we have become the most deployed National Guard division in the entire country. We deployed almost 6,000 of our soldiers overseas for 6 months or more. We had 1200 going to Bosnia in SFOR 12; 2,000 to Task Force Keystone, our force protection mission in Europe; 1200 to Kosovo, KFOR5 Alpha. I am happy to take a moment to introduce the returning commander of KFOR5 Alpha who is with us in this chamber; he just got home 2 weeks ago – Brig. Gen. Jerry Beck. Jerry, please stand. Jerry, thank you for representing all of the KFOR5 Alpha. Job well done, and welcome home. It is great to have you back with us again.

As I speak to you in this chamber today, as you all know, there are 1200 of our soldiers currently on the ground in Iraq. We have been given warning orders for up to another thousand to 1200 more to Iraq and Afghanistan sometime in the next 6 months. In addition, we have been active on the homefront, committing over 400 soldiers for security here at home, whether it be at airports, nuclear powerplants, or Army and Air Force bases in the Commonwealth. Whatever the journey of the future, you can be sure that the volunteer citizen soldiers of the 28th Keystone Division will embark on it no matter how perilous.

As all of you know, it is human nature to question the future, wondering if the generations to come will show the same courage that the generations of yours did. In the play "Ben Franklin in Paris," the founder of the 28th Keystone Division had those same doubts: "[Of] those Americans to whom the name American will not be new," he asked, "will they love liberty, being given it outright in the crib for nothing?...And would they die for it" if necessary? The answer, Dr. Franklin, is yes. They still give their lives if necessary, and we still give our thanks.

Today, this great hall is quiet, but if you listen hard, you will hear the marching of thousands upon thousands of Keystone soldiers through the city of Harrisburg and all over the Commonwealth, for our journey never ends, not as long as we choose here in this country to live in freedom and not as long as the 28th Division chooses to fight for that freedom. Thank you all for this time. May God bless the men and Boyd Browne

women of the 28th Keystone Division and the men and women of the Commonwealth of Pennsylvania.

Thank you.

The SPEAKER. General Craig, on behalf of the House of Representatives and the citizens of Pennsylvania, I want to congratulate the 28th Division on its 125th anniversary, and further, I want to thank the fine men and women of our National Guard for the many sacrifices that they have endured in regard to the post-September 11 military deployments of our Armed Forces.

Thank you for addressing this body here today, and rest assured, we in the General Assembly stand ready to assist the Pennsylvania Guard in all of its endeavors.

At this time, in honor of the 125th anniversary, I would like to call up HR 602, which commemorates this occasion. It would indeed be an honor to have a presentation copy of the resolution displayed at your 28th Division Headquarters here in Harrisburg.

And so often we hear about other battles that resonate down through the corridors of history, but Pennsylvania boys in the Huertgen Forest of Belgium, Luxembourg, and after the breakout at Saint-Lo are amongst the most aggressive and trying and challenging moments on a battlefield that American soldiers ever fought upon.

So I wanted to add my own comment and congratulations to the men and women of this division and to make certain one more time that our membership remember October 1944, the battle of the Huertgen Forest.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman, Mr. Tigue.

Mr. TIGUE. Thank you, Mr. Speaker.

Mr. Speaker, I would like to interrogate the sponsor of the bill, please.

The SPEAKER. The gentleman, Mr. Godshall, indicates that he will stand for interrogation. The gentleman is in order and may proceed.

Mr. TIGUE. Thank you, Mr. Speaker.

Mr. Speaker, in looking at this bill, what would the difference be between those who passed a hotel tax, say, now versus before 2000? What would they be not allowed to do under the current proposal?

Mr. GODSHALL. What we did with this was clarify. The original language was "tourism, convention promotion and tourism development." That was the original language. What we did was change that, again, with the agreement Commissioners Association, to "Convention of the promotion...Marketing the area served by the agency as a leisure travel destination...Marketing the area served by the agency as a business travel destination...Using all appropriate marketing tools to accomplish these purposes, including, but not limited to, advertising, publicity, publications, direct marketing, direct sales and participation in industry trade shows...Projects or programs that are directly and substantially related to tourism within the county, augment and do not unduly compete with private sector tourism efforts and improve and expand the county as a destination market...Any other tourism marketing or promotion program deemed necessary by the recognized tourist promotion agency."

Those were the changes, and it was actually clarifying and codifying the original intent.

Mr. TIGUE. Mr. Speaker, one other question: If a county would adopt a hotel tax and want to use it for something other let us say, economic development - would they be allowed to do that?

Mr. GODSHALL. No. If a county adopted this tax now, they could not use it for economic development, because the tax was passed with the intent of the legislature, it was a room tax to be used for tourism purposes. That is originally what the intent of Act 142 was. In fact, it was totally the intent of 142, but there was some misuse because of the nonspecific language.

Mr. TIGUE. Thank you, Mr. Speaker.

Mr. Speaker, I would like to make a statement, please.

The SPEAKER. The gentleman is in order and may proceed. Mr. TIGUE. Thank you, Mr. Speaker.

Mr. Speaker, I am not sure I agree with what the sponsor of the bill said about the intent. I think there are occasions and there are reasons that counties may want to pass a hotel tax and use it for things such as economic development, recreation, or something else. I think they should have the authority and the flexibility to do this.

So therefore, I would not support this bill, and I am asking that you oppose the bill.

The House proceeded to third consideration of HB 2353, **PN 3281,** entitled:

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for staffing levels and limitations on inmate capacity at State correctional institutions.

On the question, Will the House agree to the bill on third consideration?

The SPEAKER. It is the understanding of the Chair that all the amendments have been withdrawn.

On the question recurring, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage. The question is, shall the bill pass finally?

The Chair recognizes the gentlelady from Philadelphia, Ms. Manderino.

Ms. MANDERINO. Thank you, Mr. Speaker.

Mr. Speaker, on HB 2353, I am a little conflicted on the practical matter that it raises but not on the principle that I want to address.

The bill is attempting to put staff ratios into our prisons for prison guards, and I think they have a very legitimate concern with regard to their safety within the institution and their ability to properly manage our inmate population, but I think we have a responsibility in this chamber as well with regard to the management of inmate population. There are a couple of bills that are languishing in Judiciary Committee, for example, that would help address the issue of the overpopulation in our prisons, and the big difference between the bill that is not making it out of Judiciary Committee and this bill is that the bill that is in Judiciary Committee would save us money and this bill is very likely to cost us more money.

We just finished Appropriation Committee hearings, and we lamented the hard decisions that we have to make within our limited budget resources, and at least one of my personal laments is how much we struggle to provide for adequate funding for our public schools, and our public school State average spending is \$9,000, and our public corrections average in spending per inmate is \$31,000, and all I keep thinking when I hear those numbers is \$9,000 for a child's education to do things right or \$31,000 for an inmate's incarceration when we do not get it right and they do something wrong.

And I just as a matter of principle, although I empathize with the correctional officers' needs, I cannot in good conscience vote for this bill that would inflate again our corrections budget. I would rather be voting for bills that would help us better manage the inmate overpopulation; get rid of the long, 9-months-and-more waiting list for parole so that we have people in 9 months longer than their minimum because of backlog and not because of discipline. I would just rather address the issue of inmate population from that point of view and save the Commonwealth a few dollars instead of costing them more, and so for that reason I am going to vote "no."

Thank you.

The SPEAKER. The Chair thanks the gentlelady.

The Chair recognizes the gentleman, Mr. Argall.

Mr. ARGALL. Thank you, Mr. Speaker.

Mr. Speaker, I share the lady from Philadelphia's general observations regarding the need to get, I think, a better handle on some of the State's budget priorities. The specific need for this legislation, however, that Representative DeWeese and I have been working on is so that we can improve safety within our correctional institutions for the inmates, for the people who work inside the institutions as well as the general community. It is very simple. We are just looking for consistency throughout the State with regard to how the State correctional institutions are staffed.

The SPEAKER. The Chair recognizes the Democrat leader, Mr. DeWeese.

Mr. DeWEESE. Thank you very much, Mr. Speaker.

The gentlelady from Philadelphia has some good points, and they are keenly offered, but notwithstanding that, I would concur with the majority Appropriations chairman who just spoke, and I think that we are approaching a potential crisis situation within our State penitentiaries in Pennsylvania. We want to avert the calamity of Camp Hill a decade ago. We want to make certain that our institutions are safe and that they have

enough personnel to do the job. This measure will assure that, and I would ask for an affirmative vote.

Along with my Republican colleague, there has been a great deal of bipartisan support upon this. Every man and every woman who works in a State penitentiary in our Commonwealth is in favor of this proposal, and I am confident that the general population among the 12 million Pennsylvanians will be better served and our people will be incarcerated more aggressively if there is an affirmative vote.

On the question, Will the House adopt the resolution?

## **RESOLUTION RECOMMITTED**

The SPEAKER. The Chair recognizes the gentleman from Lycoming, Mr. Feese.

Mr. FEESE. Thank you, Mr. Speaker.

Mr. Speaker, I would move that we recommit HR 40 to the Committee on Rules.

The SPEAKER. The gentleman moves that HR 40 be recommitted to the Committee on Rules.

On the question, Will the House agree to the motion?

## PARLIAMENTARY INQUIRY

The SPEAKER. On that question, the Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Parliamentary inquiry, Mr. Speaker.

The SPEAKER. The gentleman will state his point.

Mr. VITALI. My resolution was called up for consideration by the House. Now, is it not appropriate in that circumstance that since it is my resolution, that at least I get a chance to lay it out, what the contents are, before we consider any motions on that? In other words, should I not have the floor at the point where my resolution is called up?

The SPEAKER. The gentleman, Mr. Feese, asked to be recognized first, and the Chair did do that.

Under that, it is now the gentleman, Mr. Vitali's turn, and we will allow some leeway, because of the way it was done, for Mr. Vitali to explain what his resolution did.

Mr. VITALI. Thank you, Mr. Speaker.

Mr. Speaker, what HR 40 is, is an amendment to the House rules – specifically, House rule 14 – and basically what it would do would be to prohibit three things. One, it would be to

prohibit using Commonwealth funds so that members could purchase commercial air time, commercial TV and radio time, for the so-called public service announcements; the second thing it would do would be to prohibit using Commonwealth funds so that House members could hire the outside telemarketing firms to call in to their districts; and then the third thing this would do would be to amend the House rules to prohibit Commonwealth funds to be used for bulk e-mailing by members within 60 days before an election.

And the reason for this is, in the last election cycle, we began to see an exponential use in Commonwealth funds for these purposes, for clearly campaigning purposes – an inappropriate use of tax dollars for campaigning purposes. I have no doubts that the messages are good – for example, the message that members are sending, the public service announcements, for example, of the do-not-call list. The problem though, Mr. Speaker, we are using this to build incumbents' name recognition primarily.

If this is such a good message, this message should go out to each and every district, not just districts where there is a contested election, and if these messages are so good, they should go out every year, not just in campaign years. The timing of the message and **h**e selection of what members get the message belies their use. We are spending literally millions of dollars under the guise of doing something good and informing the public to build our own name recognition, to use tax dollars to build our name recognition for reelection purposes, and that is just plain wrong.

Mr. Speaker, it is inappropriate to recommit this to the Rules Committee for a number of reasons.

The purpose of recommitting something to Rules traditionally is to give something a chance to be studied further. Mr. Speaker, we do not need to study this further. Over 60 members in the last election cycle and more this cycle have already used this. We are very familiar with this.

We have been debating this. We brought this up 2 months ago. Members were aware this was coming. This is an issue not like many of the other issues we deal with. This is an issue we ourselves personally use. We are very familiar with this.

Mr. Speaker, we are coming into an election cycle. We have an April 27 primary. To recommit this, to bury this at this point, would just be to allow this misuse to go on for another election cycle.

Mr. Speaker, that is the second reason why we should not recommit.

The third reason is this: If some member is going to make the allegation that this needs to be amended in some way, this resolution has been hanging out there for months. Members have had the ample opportunity to amend this. So we have had the chance to amend it, we know the issue personally, and we are in the middle of an election cycle.

Mr. Speaker, the time to deal with this issue is now. Editorial boards across the State have editorialized against it. Columns have been written against it. Papers are watching. The eyes of your constituents are watching you now. What you do in this motion will be the vote you get to define yourself on this issue, so now is the time to say what you mean.

Elections should be fair. If we can use millions of Commonwealth dollars to get our names out, it is not fair to our challengers. It is not fair. It makes the election process less fair. It causes stagnation in the legislature, and it is just plain wrong. So I ask, vote "no" on this motion to recommit. Let us deal with this thing right now.

Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the majority whip, Representative Feese.

Mr. FEESE. Thank you, Mr. Speaker.

Mr. Speaker, I agree with Mr. Vitali, the gentleman from Delaware, that this resolution probably does not need amended, but if it is not amended by being recommitted to Rules, then in fact the gentleman's intent cannot be achieved.

The gentleman indicated that his intent was to prohibit the use of Commonwealth funds for public service announcements and for telephone banks. The gentleman's resolution, however, does not do that. The gentleman's resolution is incorrectly drafted. The gentleman's resolution, **f** adopted, fails to make any change at all because it is incorrectly drafted. Let me explain.

HR 40 is an attempt to amend our rule 14, which addresses members' and employees' expenses. The language of the rule and the language of the gentleman's resolution states that no money appropriated for members' and employees' expenses shall be used for PSAs (public service announcements) or shall be used for telephone banks. Moneys appropriated to members' and employees' expenses are specific legislative accounts for specific purposes. PSAs and telephone banks on both sides of the aisle have not been paid for out of members' expenses but have been paid for from leadership accounts, which are different, which are defined legislative accounts.

So the gentleman's resolution, if adopted, does not achieve what he wants it to do. I cannot help it, Mr. Speaker, that the gentleman drafted his resolution incorrectly.

Secondly, for those of us who believe that using telephone and television is an appropriate means of communicating with our constituents, it does require further study. I am sure not everyone in this body realizes that you can communicate through a telephone bank with each household in your legislative district for 4.5 cents. Compare that to a price of mailing, if you wish to communicate with your constituents in a fast and effective and inexpensive way; compare that to mailings, which would be much more expensive. I believe the Committee on Rules should have an opportunity among the leaders on both sides of the aisle to look at those cost benefits.

Also, Mr. Speaker, in regard to public service announcements, we can produce a public service announcement and deliver it for our constituents at a cost which is equal to or in some cases, depending upon the media market, cheaper than we can for a mailing, which is accepted within the House, that we mail to our constituents.

So I believe, Mr. Speaker, for those reasons – one, that the leaders on both sides of the aisle on the Rules Committee should examine the cost benefit and what is fair and appropriate to our constituents as well as the taxpayers, who are also our constituents; and two, because the gentleman's resolution does not, as drafted, achieve the intended purpose.

The SPEAKER. The Chair recognizes the Democrat leader, Mr. DeWeese.

Mr. DeWEESE. Thank you very much.

I would accede to the gentleman from Northampton, who is already at the microphone.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. Freeman.

Mr. FREEMAN. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose the motion to recommit.

The gentleman, Mr. Feese, raised some points about the drafting of the resolution. If it is felt that this resolution needs amending, let us do it here on the floor. Let us have a full debate by each and every rank-and-file member of this chamber – not to be sent to the Rules Committee, where its fate may be questionable; not to be sent to the Rules Committee, where only the leadership will have a chance to craft and decide what it will look like. Let us as a body, as an entire body, deal with this issue.

The issues embodied in the gentleman, Mr. Vitali's resolution are timely. We need to be a much more accountable chamber. I think this is the kind of issue we deserve to debate here. If there is need of amendment, if there is need of refinement, let us do it here on this resolution on this floor. Let us not send it off to some committee, where it may never be heard from again.

I urge a "no" vote on the motion to recommit.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Northampton, Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker.

The gentleman from Lycoming said this issue needs further study, and his suggestion is to recommit this bill to the Rules Committee in order to do that. I think we have to take a look at the track record of the Rules Committee on this particular resolution.

This resolution was introduced on February 6, 2003. It was referred on the first day it was introduced to the Rules Committee, and it sat in the Rules Committee for 355 days. It was released from the Rules Committee on January 27 of this year, only because there was a discharge resolution signed by 28 members of this House to force that bill to come out of the committee and be put up for an up-or-down vote before the House of Representatives. And we all know the rules. If 25 members of this House sign a discharge resolution, a bill or resolution does come before the House for a vote. So here we are; today is the day for that vote.

Over the last 355 days that this bill was in the Rules Committee, there were no meetings on this bill; there were no public hearings on this bill. If we recommit it to the Rules Committee, would we be sentencing it to another 355 days in committee? Do we have any guarantees that there would be committee hearings or public hearings on this bill?

Mr. Speaker, I respectfully ask that we vote "no" on the motion to recommit this to the Rules Committee once again. This bill has come out of Rules Committee. It is here before us today. Let us address the issues raised by Representative Vitali with a vote on HR 40 this afternoon.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Mr. Speaker, I wanted the courtesy, if I could have it, of being the last person to speak on this.

The SPEAKER. The floor leaders are allowed the privilege of being the last ones to speak, Mr. Vitali.

Mr. VITALI. Okay. Thank you, Mr. Speaker.

You know, Mr. Speaker, here we go again with another procedural motion to avoid voting on the substance of things we really do not want to vote against. I have been here too long not to know what is going on here, and I agree with my colleague from the Lehigh Valley. If the Rules Committee really was acting in good faith or if the motion to recommit to Rules was really being made in good faith, the Rules Committee would have acted upon that well before now and they simply have not.

Mr. Speaker, what the Republican leadership seems to be saying here is, this is not broad enough; my resolution as drafted is not broad enough. Well, if that is simply the case, we can pass it and then we can amend it at a later date to make it broader, to cover the other accounts that we are dealing with.

You know, Mr. Speaker, some of this language is pretty clear. I am looking on page 4. It says, "No Commonwealth funds, equipment, employees, facilities..." – yadda, yadda – shall be used for bulk e-mailing, and that does not limit it to members' expenses.

You know, Mr. Speaker, this is a good, this is a good first step, which we can make stronger. We are going to kill this if we refer it to Rules. You know, I agree with my other colleague from the Lehigh Valley. What we want to do is not recommit this to Rules and debate it today, and if in the course of this full debate today, if in the course of this full debate today members have the desire to add more, then I would be fully supportive of a motion to pass this over until next Monday so we can file our amendments. This way we will be dealing with it right away, before the next primary.

Let me repeat that: If the members feel after a full debate today this is wanting, I would be willing to support a motion to pass this over till next Monday so we can have a debate and make the necessary modifications. But this motion to recommit is a motion to bury this. It is a motion to take it to a small group of leadership, who have ignored it and will continue to ignore it.

This is your chance to have this issue considered. A motion to recommit is tantamount to killing it. I urge a "no" vote.

Thank you.

The SPEAKER. The Chair recognizes the majority whip, Mr. Feese.

Mr. FEESE. Thank you, Mr. Speaker.

Mr. Speaker, I agree with the gentleman from Delaware that in fact e-mails would be prohibited within 60 days of the election from any Commonwealth funds. The reality of it is, however, that the gentleman's resolution does not apply to all Commonwealth funds as it relates to PSAs and telephone banks.

Now, the gentleman questions whether my motion is made in good faith, and I do not question that the gentleman has made his resolution in good faith, although I could maybe assume that he intentionally drafted it incorrectly so we could be here several times on the floor to talk about it, but the reality of it is, I do not question his good-faith motives. But in fact, if anyone here wants to prohibit tax-funded PSAs and they pass the gentleman's resolution, HR 40, it does nothing; that is the reality.

I am not my brother's keeper, Mr. Speaker. He drafted it incorrectly.

The SPEAKER. The Chair recognizes the Democrat leader, the gentleman from Greene, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

We are making progress on this issue. The majority whip and I, as recently as within the last hour, have adumbrated certain areas of the proposal where there may – and I do not want to put words in anyone's mouth – but there may be progress on the PSAs, the public service announcements, amongst the leadership cadre, and I said "may."

I am very much inclined to agree with the gentleman, Mr. Vitali, and I am not sure that all of my colleagues have arrived at the same conclusion, but the fact is, there are not very many people running against you Republicans and there are not very many people running against us Democrats, and although we institutionally are probably happy about that -I can see from the gentleman from Scranton's beaming physiognomy that he is happy about that, and I cannot deny that I am happy about that also - but you get right down to the nub of the issue, Mr. Speaker: Pennsylvania democracy would be well served by the Vitali effort.

However, it is not well drafted, as has been stated by the gentleman from Lycoming, and I am willing at least at this juncture, in the eighth or ninth inning of the first game of a doubleheader, to go along with the gentleman and recommit.

However, there is a significant caveat to my own point of view, and that is, I am going to work with the gentleman, especially on the public service announcements, and the Democrats certainly are not holier-than-thou. We have been involved in this process just as the Republicans have been involved in this process. A long time ago congressional newsletters were a hot item, and our own newsletters were contested a decade ago or 15 years before as to the propriety of sending out newsletters vis-a-vis the political world. But when we have \$10,000, \$15,000, \$20,000 to invest in a public service announcement, it does become problematic and it is worthy of debate. I do not know exactly how the chamber would vote, but the gentleman does have a point of contention that is worthy of debate, and at the next opportunity, I would advocate a full-blown dialog from 203 House members on this very vital issue. I think it is fundamental to the preservation of a dynamic electoral system and a better Pennsylvania political climate.

I reluctantly, because of draftsmanship preeminently, because I agree with Mr. Feese: this proposal will not do what the honorable gentleman wants it to do. So I am fortunate that I have at least intellectually an easy out on this one, but the next time this train comes down the track, I am going to be with the gentleman, Mr. Vitali, especially on the public service announcement aspect of his proposal.

That, Mr. Speaker, was worldwide. It was not just Canadians. It was the French, the Germans, the English, the Russians, and the Spaniards.

Mr. Speaker, I know that the House joins with me in extending our deepest condolences to King Juan Carlos and, more particularly, to the people of Spain and to the injured and to the persons who were killed in that attack.
