Mariah is now a normal, healthy second grader. She is a budding artist and a karate student.

I would like now to recognize up in the gallery Mariah and her parents, Lisa and Mark Mascara, and her brother, Jameson. If they would please rise. I would like to add that Mariah's father, Mark, is a common pleas judge in Washington County. Also accompanying them is the mayor of the city of Washington, Ken Westcott.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman from Bucks, Mr. Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Would the maker of the bill stand for a brief interrogation?

The SPEAKER. The gentleman indicates that he will stand for interrogation. The gentleman, Mr. Clymer, is in order and may proceed.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, we understand that this is a request, a request that can be submitted by the State Harness Racing Commission or the State Horse Racing Commission. It is a request; it is not a mandate. So is that what it means? It is a "may" provision in the bill?

Mr. DiGIROLAMO. That is correct, Mr. Speaker. It is a "may" provision. They are allowed to request those background checks.

Mr. CLYMER. Okay. Thank you.

Mr. Speaker, the genesis of the bill seems to be it is for those directors and owners and investors with racetracks. What about stand-alone casinos? Suppose in the legislation we have four or five stand-alone casinos. Can they, since, you know, we are looking at racetracks, can they also ask for background checks for those—

The SPEAKER. Mr. Clymer, none of that is in the bill before the House.

Mr. CLYMER. Okay. Thank you.

Mr. Speaker, some of the racetracks, as we look at the owners and the investors, the people who are involved, they could be international bankers, people who are investing in Pennsylvania gambling. Do the State Police have the capability to investigate these international bankers, whether they are in Asia or whether they are off the coast of the United States? Do they have that capability?

Mr. DiGIROLAMO. If they are applying for licensure in some way in the horse racing industry, yes, they have the ability to require a background check for those individuals.

Mr. CLYMER. I did not quite understand; I did not get the response. Is it a yes, that they do have the capability?

Mr. DiGIROLAMO. Yes; that is correct.

Mr. CLYMER. Okay.

That ends my interrogation. I thank the gentleman for standing for interrogation. I would like to speak on the bill.

The SPEAKER. The gentleman is in order.

Mr. CLYMER. Mr. Speaker, two points.

Number one, it is a "may" provision that the Horse Racing Commission and the Harness Racing Commission can ask. If for some reason they do not want to follow up, they do not have to. And then what happens if they find that there is a criminal background history to these people whom they investigated? Are they going to then say that they are disqualified from being involved? That is a concern.

Also, Mr. Speaker, the fact that we are not sure whether or not they can do the background investigations, and I think this is key to the four or five stand-alone casinos. If they cannot do the background check, well, then who will do it? I think that is a legitimate question and needs to be answered.

And then finally, Mr. Speaker, as we all know that this is a vehicle that is being sent to the Senate so the Senate can— That is their prerogative, of course, if they want to use this for a gambling bill, but it is going to be moving over there for that reason. Now, the Senate has numerous Title 18 bills. They certainly do not need this bill to do their gambling promotion. And I remind the members of the chamber that if by chance this bill should move out of the House and it is amended by the Senate, it comes back on concurrence, and so we have no opportunity to put our amendments into the bill except to have the rules—

So, Mr. Speaker, there is a real problem here, and I would ask that the members, based on the information that we have—We do not have complete information here. To try to suspend the rules to put our amendments in will be a very difficult time. Last time we dealt with this legislation, we recognized the difficulty it was to suspend the rules to add our amendments.

And if we are going to be doing the auctioning amendment, if for some reason the Senate fails to get that in, I think that is a very important amendment that we need to put into this legislation, and so we will not, in all probability, perhaps we will not have that capability.

So, Mr. Speaker, I, for one, am going to vote "no" against this legislation. Thank you.

### MOTION TO SUSPEND RULES

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

I am going to make a motion at this point to suspend the rules. I have an amendment filed to this, so it would be a motion to suspend the rules to consider amendment 692, and I would like to briefly lay that out, if I could.

The SPEAKER. The gentleman is entitled to give a brief description of the amendment before suspension of the rules proceeds.

Mr. VITALI. Thank you, Mr. Speaker.

This amendment corrects the defects we had cited by Republican leadership last week on the issue of public service announcements, such that this amendment would prohibit, one, using Commonwealth funds for members to run public service announcements buying commercial air time; two, using taxpayer dollars to hire outside telemarketing firms, with the exception of limited surveying purposes; and three, prohibiting using tax dollars for members to do bulk e-mailing within 60 days of an election.

This corrects, I believe, the problems cited by Representative Feese last week.

The SPEAKER. The Chair thanks the gentleman.

### PARLIAMENTARY INQUIRY

Mr. S. SMITH. Mr. Speaker, I have a parliamentary inquiry. The SPEAKER. The Chair recognizes the majority leader for the purpose of his inquiry.

Mr. S. SMITH. We just suspended the rules to consider HR 617 without amendment. What is the motion that the gentleman from Delaware County is proposing? Would not the

only thing really in order be voting "yes" or "no" on adopting HR 617?

The SPEAKER. That is a good question, Mr. Smith. Give me one moment.

Would the gentleman, Mr. Vitali, come to the rostrum.

(Conference held at Speaker's podium.)

The SPEAKER. It is the ruling of the Chair that the gentleman, Mr. Smith, when he made his motion, made his motion subject to no amendments being offered to the House resolution. The gentleman, Mr. Vitali, has offered an amendment and asked to suspend the rules.

# MOTION TO RESCIND RULES SUSPENSION

The SPEAKER. At this time the Chair will recognize the gentleman from Delaware, Mr. Vitali, who was given several options of things that he could do at this point in time.

Mr. VITALI. Mr. Speaker, after discussion with yourself and the Parliamentarian, I think the next thing I would like to do is to move that we rescind the motion of Representative Smith for the limited purpose of being able to consider amendment 692, which deals with the public service announcements and prohibiting Commonwealth funds to be used by members to buy air time for public service announcements.

So this would be a motion to rescind the Smith motion.

The SPEAKER. The gentleman's motion is to rescind the motion made by the gentleman from Jefferson, Mr. Smith. A "yes" vote is to rescind; a "no" vote is to sustain the motion made by the gentleman, Mr. Smith.

On the question,

Will the House agree to the motion?

The SPEAKER. On that motion.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, I have to oppose this motion to rescind the previous motion.

The fact is, the resolution before us, if this motion to rescind were approved, basically we would be retreating from considering HR 617. This is a resolution that is necessary for us to implement in order for us to continue through the normal budget process that the House undertakes and just for the function of the House in order to go about the business of dealing with the future budget issues.

I would urge the members to oppose, to vote "no," on the motion to rescind.

The SPEAKER. On that motion, does the gentleman, Mr. Vitali, wish to be recognized?

Mr. VITALI. Yes, Mr. Speaker.

I would urge a "yes" vote on this motion to rescind for a couple of reasons. One, this is not going to stop the budgetary process in any way. If we suspend, consider my motion, vote it up or down, we will then consider the resolution in chief and the budget process will proceed forward. So I would disagree on that point.

The second point is this: The realities of this House and the parliamentary maneuvering involved, we really have to struggle

to get a vote on this controversial issue of public service announcements. We have to take votes like this. We have to do it via the amendment process, because we all know we are simply not going to get a clean vote. So if you are concerned about the issue, it is a way to say to your constituents you support the principles of my amendment. So this may be the best shot you get on this issue.

So I would urge a "yes" vote on the motion to rescind so that we can consider this amendment.

The SPEAKER. The Chair thanks the gentleman.

Those voting to rescind will vote "aye"; those voting to sustain the motion made by Mr. Smith will vote "no."

For the information of the members, it would take 135 votes to rescind.

## BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 1423, PN 3386,** entitled:

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, further providing, in adoption, for voluntary relinquishment to adults, for an alternative procedure, for reports of intention and for consent.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. It is moved by the gentlelady, Mrs. True, that the House concur in the amendments inserted by the Senate.

On that question, the Chair recognizes the gentlelady from Lancaster, Mrs. True.

Mrs. TRUE. Thank you, Mr. Speaker.

Just for reference, the Senate amendments extended the timeline of this bill from 20 days to 30 days. I was in agreement with that just because of the support I was getting when they did that, and I very much wanted this bill to go to the Governor.

I am really proud to be on the House floor today when we are working on concurrence of this bill, because when I stood here and you so kindly helped me pass it out of the House, I told you that our son, Peter, and his wife, Kendra, who are at the left of the Speaker, were looking to adopt a baby, and they were praying that the baby did not come from Pennsylvania. Delaware was better, New Jersey was better, anyplace but Pennsylvania because of the timeline as far as terminating parental rights, because they were fearful that they might lose this child after bringing a child home to be one of their own.

Well, brave as they are, I stand before you, today with baby Owen, who is a Pennsylvania baby, and he came into our family a week after he was born, and we love him so much.

I wanted to introduce him to you and tell you, because of this legislation, other families and other parents can have the same feeling of security that we do now knowing that Pennsylvania will be absolutely on the family side and allow people to have

faith in Pennsylvania that if they do in fact adopt a child, that they can not be fearful that they will lose that child.

I would ask you— Before I— Now, wait a minute. I am a little rattled, because it is hard not to tear up when you have this little guy that we waited for so long.

Representative Ross and I worked together on this. It seems like a long time since we talked about doing this. There is more to be done on adoption, but we will do— And this is what he thinks of the House floor – we are yawning.

I thank the Speaker's indulgence, and I would just encourage you to vote for HB 1423.

Thank you, Mr. Speaker.

The SPEAKER. I doubt, Representative, he will be the first or last to yawn here.

The Chair recognizes the gentleman from Chester, Mr. Ross. Mr. ROSS. Thank you, Mr. Speaker.

I should know better than to try and follow that particular act, but I will keep my comments brief and to the point.

I want to thank the prime sponsor of this legislation. We worked on it together, because I had a sad story in my district where a family actually had the custody of a baby for a number of weeks, I think months actually, and then the birth mother changed her mind and pulled that child out of the home, and they were absolutely devastated. And the message I heard was that we were not going to have adoptions of Pennsylvania children because of the inequities in the existing law.

So I want to again thank the prime sponsor and also urge all my colleagues here to vote for this bill. It will make a huge difference in many, many families' lives who wish to adopt here in Pennsylvania.

Mr. Speaker, I also rise to urge concurrence in this legislation.
