#### STATEMENT BY MR. DALEY

The SPEAKER pro tempore. Could we please have some order in the House, please.

For what purpose does the gentleman, Mr. Daley, rise?

Mr. DALEY. On unanimous consent, Madam Speaker.

Mr. DALEY. Thank you, Madam Speaker.

I would like to announce to the House of Representatives and all of Pennsylvania that is watching today on PCN (Pennsylvania Cable Network) that the California University of Pennsylvania women's basketball program over the weekend played in the NCAA Division II championship game in St. Joe's, Missouri, and they beat the tar out of Drury University, 75 to 72 – the women's national championship in Division II.

As an alumni of California University and a member of the council of trustees and a supporter of the State System, as we all are, I wish our congratulations to the California University Fighting Vulcans. We will have them on the floor in a couple of weeks, and God bless you all.

The SPEAKER pro tempore. The Chair thanks the gentleman.

#### STATEMENT BY MR. MARKOSEK

The SPEAKER pro tempore. The gentleman, Mr. Markosek, is recognized under unanimous consent.

Could we please have order. It is impossible to hear what the gentleman is saying.

Mr. MARKOSEK. Thank you, Madam Speaker.

Madam Speaker, I rise today under unanimous consent to kind of commemorate an event that occurred in my own personal life, a significant event 25 years ago, but it was also a significant event not only for me personally but for most of the folks in Pennsylvania and in fact the world.

Twenty-five years ago this week I was a young engineer at the Westinghouse water reactor division in Monroeville when a staff person came in to a meeting that I was attending and announced that there had been an incident at the Three Mile Island nuclear plant which was located in Middletown, Pennsylvania.

At that time those of us in the nuclear industry were all very, very much interested in this, because there really had not been any significant accidents at any commercial nuclear plants prior to that. One of the things that happened immediately after that accident was the management of the Three Mile Island plant called upon many, many, many different areas of industry to come to Three Mile Island and help repair the plant. I was, I guess, fortunate enough – at least at the time I considered myself that, and I would still consider myself to be fortunate – to have been called upon to become one of the members of the recovery crew at Three Mile Island. It was an experience that, obviously, I will never forget.

I had been born and raised in Pennsylvania but had never traveled to Harrisburg prior to that. I had never seen the State capital prior to that. But having come down here— And it is interesting to note also that right after that accident, Governor Thornburgh ordered the evacuation of pregnant women, ordered the evacuation of many other people, and, of course, most citizens fear the unknown, so as a result, many people left on their own. It is ironic that folks like me and several thousand other people that worked in the nuclear industry were actually coming down here while everybody else that lived around here was leaving. We were coming down here to work on the plant, to straighten it out, to repair it, and to decontaminate it. I spent 3 weeks down here, and it was a very interesting and productive 3 weeks certainly in my life.

I can say this about the accident at Three Mile Island, looking back: Three Mile Island was an example of a nuclear plant that worked, not one that did not work, and there was obviously a significant cleanup, obviously significant costs involved, but the one thing that did happen at Three Mile Island is all of the backup, safety, the redundancy that was built into the plant, actually worked and saved the plant, saved the citizenry from this area from any significant harm. There was some slight amount of radiation released, but given past history we know that it was a very limited amount. It was an amount that at the time and even now is thought to have been insignificant in terms of public health. However, of course, as we know, there has been a long-lasting remainder of problems, particularly psychological results of that accident.

I can say a couple of other things about that, Madam Speaker, about the accident, some of the things that I recollect. One was it was my first-ever confrontation, if you will, or at least experience with the media, and the media did not do a very good job of covering Three Mile Island, unfortunately. Part of that was due to the fact that the nuclear industry sent us their spokesmen, mostly engineers, who were not very good at dealing with the public and spoke in kind of an engineerese, if you will, that most people cannot understand. I think that heightened the problems. But I recall walking, being sent down to the little town of Middletown to get supplies for our crew, the Westinghouse crew that was there at the time, and one of the things that happened while I was walking along the street was there was a crowd of people that had gathered, and I was wondering what was going on, and I walked up and there

was a police officer saying "Stand back; stand back." And I thought there had been an auto accident there, and by the time I got up there, the people started walking along and moving along and nothing was there, and I asked one of the people standing there – there was a fellow with a camera – and I said, you know, "What's going on? Why was everybody held up here?" And he said, "Well, we held everybody back." He said, "We're from the Los Angeles Times; I'm a photographer, and we needed to get a picture of a deserted street." So you can see right from the start there that it was an indication to me that the media does not always handle these things correctly and sometimes even creates news that is actually not even there; they sensationalize, and none of us here in this room are surprised to hear that, I am sure.

There is another story I can tell about radiation, and I had never dealt with a lot of radiation issues before my time at Three Mile Island, but one of the things that I was able to do when I was there was operate a Geiger counter, a radiation detector, and I was standing no further than from where I am now to this wall away from the wall of the containment building at Three Mile Island. Now, inside that containment building was about several hundreds of thousands of gallons of highly radioactive wastewater that had spilled out of the reactor and into that containment building. However, standing this far away outside the building and operating a Geiger counter, there was no reading on the Geiger counter, and I asked the technician if he would show me what I was doing wrong or perhaps I had not operated this piece of equipment correctly, and he looked at it and he said, "It's on." And I said, "Well, why aren't we getting any reading?" He said, "Because there isn't any. None of that radiation is coming through that wall," which was very hard for me to believe, but I think it says something about the safety of these plants, the fact that these containment buildings are built to withstand all of that radiation, which that did; it worked. It was a passive system; the containment building was something that no one had to turn on. But I think it was a good example, another example, of some of the aspects of that story that have never been told.

Also there was a great human interest story with Three Mile Island. You have to realize that during the accident, there were literally thousands of employees from various parts of the nation and the world from the nuclear industry that came to Three Mile Island at that time to work on the plant, and after a day or so of this, the operators of the plant realized that they would have to feed all these people and take care of them. There was a logistics problem in just taking care and dealing with that many people. One of the things they did was they set up kind of a MASH (mobile army surgical hospital) unit. The National Guard came in and set up tents where people could eat, and these tents were open 24 hours a day, as most of us who were working on the plant were working 24 hours a day and could go get something to eat at any time of the day or night. It might not be breakfast food at breakfast or it might not be dinner food at dinner, but nevertheless, you could go get something to eat. I recall going in for breakfast about 8 o'clock in the morning and having lima beans for breakfast. But it was something, and it was a way of dealing with the thousands of people that came in to work on that plant and to repair the plant.

And as we look back now 25 years later, we can say that, you know, the Three Mile Island situation has been finally cleared up. It has left a long-term, indelible mark on the psyche

of central Pennsylvania for sure, but I think it is important to note that even today, as then, we definitely need nuclear energy as part of our energy mix here. We cannot go it alone with just coal or oil or gas or even some of the renewable resources such as wind or sun. We definitely need those things, but they are all a part, and nuclear has to be a part of that as well, and if we are going to have energy independence, we need to have safe and reliable nuclear energy systems here in the United States, which we do in fact have. And the fact that there has only been one major accident here and nobody was harmed, nobody was killed, nobody was injured, I think speaks volumes to the safety of the nuclear industry.

There are a lot of other problems with it for sure and I am not going to debate them here today, but I thought it was interesting to note that 25 years ago – it is hard to believe it has been that long – that I was called upon to proudly serve on the Three Mile Island recovery team, and I can say today that I was very proud of that service and I think it was worthwhile, and we need to move on now to a bigger and brighter future.

# STATEMENT BY MR. B. SMITH

The SPEAKER pro tempore. The Chair recognizes the gentleman from York County, Mr. Smith, on a point of personal privilege.

Mr. B. SMITH. Thank you, Madam Speaker.

I had not planned to make a speech on the 25th anniversary of the accident at Three Mile Island because I regard it as an infamous date, and I do appreciate Representative Markosek's remarks and the fact that he came to central Pennsylvania after the accident. But as an individual who was a resident of the Harrisburg area, of central Pennsylvania, at the time of the accident – I was a teacher at Cedar Cliff High School; I was a township supervisor in Newberry Township, which is the largest municipality on the west shore of Three Mile Island – I can tell you that our problems at Three Mile Island began that very first day when Metropolitan Edison lied to us and said there was no meltdown. Time proved that there was a meltdown, but that meltdown of trust began that very first day of the accident.

And the other thing that Representative Markosek is not aware of, for those of us who lived in the area at the time, was the fear of the unknown. We knew we were being lied to, we knew there were releases of radiation, but we did not know how much and we did not know what to believe. The accident

occurred on a Wednesday. On Friday there was a division among the NRC (Nuclear Regulatory Commission) as to whether there was a hydrogen bubble which may explode. Those individuals who lived in the area at the time remember the streams of people who evacuated because of their fear of the unknown. They also evacuated because Governor Thornburgh recommended an evacuation of children and pregnant women. Tough, tough decisions had to be made by families, and the Patriot-News recently had a memorable article in which they said they watched streams of people going to the railroad station to evacuate.

It is fitting that we have junior firefighters here today, because the one thing that I learned through the accident is that there were volunteers who stayed regardless of the fear of the unknown. I did not evacuate, but my family did. Because I was in charge of Newberry Township's police department and chairman of the board, I stayed.

I will share one story with you to indicate what people went through. Schools within a 5-mile radius were evacuated 15 miles away. I went back to the police station, and about 5 o'clock a truck driver came in because he went to Newberry Elementary School and could not find his child, and he had no idea where his child was because the child was supposed to be at Newberry Elementary School. That is just one example, and all you have to do to find out the fear of the unknown is talk to people who lived here at the time of the accident.

The accident was a wake-up call about nuclear power and the negative effects of living near a nuclear powerplant. Granted, improvements have been made. At the time of the accident there were only two sirens on the west shore of Three Mile Island to warn people about a nuclear accident. Many sirens have been improved. Many sirens have been added as a result of the accident

Secondly, the evacuation plans were terrible. The evacuation plans approved by the utility in my area had my 10,000 residents congregating at an elementary school within the 5-mile radius – totally ridiculous – and they have been improved since. The firefighters in Newberrytown stayed. I had 75 firefighters, men and women, who stayed to help with an evacuation if necessary. You cannot imagine the psychological stress that people experienced as a result of the accident.

The media did a great job; they did a necessary job, and they knew that they were lied to, and that is why you had the stream of media coming to central Pennsylvania – because they did not believe what they were being told.

Lastly I want to say, this 25th anniversary is still a wake-up call to the dangers of nuclear power for populated areas. Improvements have been made, but the last thing I want to share with you is a quote that I gave at the United States Senate. I testified before the Energy Committee, Senator Gary Hart and Senator Simpson, and I said that the fallout of trust was like this: Loss of confidence is like loss of virginity; when it is gone, it is gone forever, and that is what nuclear plants must realize as a result of Three Mile Island.

The people in this area that experienced Three Mile Island remember what it was like 25 years ago. We will not forget.

# **RESOLUTION PURSUANT TO RULE 35**

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Centre County, Mr. Herman.

Mr. HERMAN. Thank you very much, Madam Speaker.

And this is Penn State's day to shine under the Capitol dome, Madam Speaker, as we take up HR 600, which has been cosponsored by Representative Benninghoff and myself, Representative Hanna from Centre County, and so many of you in this House of Representatives who wish to convey congratulations to the Pennsylvania State University on its sesquicentennial celebration of its founding and also reaffirming its land-grant mission to the Commonwealth of Pennsylvania.

Madam Speaker, I thank you very much for holding this General Assembly together in this House, but we held a press conference under the Capitol dome where we all expressed how we are all so Penn State proud, but today, Madam Speaker, as we take up this HR 600, I wanted to make my remarks that I made in the Capitol rotunda in the press conference part of the official record for the essence of sparing the time, and I will submit those to the clerk on that occasion.

But I would like to read just one paragraph of HR 600 which re-sums why we are here today and going to be voting on this, hopefully unanimously. It says that "...In response to the interests of the State Agricultural Society, created by the General Assembly in 1851, in establishing an educational institution to bring general education and knowledge of modern farming methods to the farmers of this Commonwealth, the General Assembly first issued a charter to" what was then "the Farmers' High School of Pennsylvania in 1854;..." – 150 years ago, Madam Speaker. And today, 150 years later, that Farmers' High School has made the transformation from the Farmers' High School in Centre County to Penn State College, and now, governed by the board of trustees as the Pennsylvania State University.

But still its commitment and dedication to the education of children throughout the Commonwealth of Pennsylvania and fulfilling its mission as Pennsylvania's singular land-grant institution in this State reaches all corners of Pennsylvania, Madam Speaker, through its agricultural research and its agricultural extension in making sure that Pennsylvania's number one industry is agriculture in this State. Their education commitment, their commitment to economic development and jobs, to its research facilities, to its State-related university status – all of this, Madam Speaker, goes such a long way to reaffirming its mission and its purpose in the Commonwealth of Pennsylvania, and with that, Madam Speaker, I encourage an affirmative vote for HR 600.

### REMARKS SUBMITTED FOR THE RECORD

Mr. HERMAN submitted the following remarks for the Legislative Journal:

Good afternoon.

I am State Representative Lynn Herman of Centre County, and we are...Penn State proud. I thank you for being with us on this very historic day for Penn State and the Commonwealth of Pennsylvania.

Immediately after this press conference, first the House of Representatives and then the State Senate will adopt resolutions congratulating The Pennsylvania State University on the start of its sesquicentennial celebration and its designation as Pennsylvania's land-grant university.

In response to the interests of the State Agricultural Society, the General Assembly established an educational institution whose mission was to bring general education and knowledge of modern farming methods to the farmers of Pennsylvania. The establishment of that institution, the Farmers' High School – and its subsequent designation as Pennsylvania's land-grant college – was one of the most significant actions undertaken by the Pennsylvania General Assembly in the 19th century.

Just a few months ago, as its chairman, I announced the revitalization of the House history caucus. The purpose of the history caucus is to encourage and promote the study of the history of America and Pennsylvania through the presentation of lectures and living-history exhibits in the State Capitol and throughout the Commonwealth. And today we celebrate a great moment in Pennsylvania history – the upcoming 150th anniversary of Penn State's founding and service to the Commonwealth of Pennsylvania.

Above the columns of Old Main are words from the July 2, 1862, act of Congress signed by Abraham Lincoln: "To promote liberal and practical education in the several pursuits and professions of life." This is followed by words from the April 1, 1863, act of the State legislature: "And the Faith of the state is hereby pledged to carry the same into effect."

That pledge is as binding to us today as it was in 1863. To quote from the House resolution, "...The missions of instruction, research, outreach and extension continue to be the focus of..." the university "and have grown to where the Commonwealth's land-grant university is now one of the most highly regarded research universities in the nation...."

Land-grant institutions have often been termed "democracy's colleges," and it is fitting that the first "democracy college" was established in Pennsylvania, the nation's "cradle of democracy." Clearly, the education provided at Penn State has made success possible for thousands of people here in Pennsylvania and throughout the nation.

As I mentioned earlier, today's events represent a preview of the sesquicentennial celebration of the university, which officially begins July 1. As the emcee of this press conference, I am delighted to have Penn State president Dr. Graham Spanier, vice chairman of the Penn State Board of Trustees, Mr. James Broadhurst, Senators Jake Corman and Michael O'Pake, and State Representatives Kerry Benninghoff and Bill DeWeese, and so many members of Penn State's official family with us today.
