She has a foundation, and on June 12 there will be over 275 Alex's Lemonade Stands all over the United States of America. Alex will be staffing her own lemonade stand in Lower Merion, and I will be running the lemonade stand in Upper Merion at my home.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 832**, **PN 3805**, entitled:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for tattooing; prohibiting certain body piercing; and defining the offense of greyhound racing.

On the question, Will the House concur in Senate amendments?

The SPEAKER. It is moved by the gentleman, Mr. Maitland, that the House do concur in the amendments inserted by the Senate.

MOTION TO SUSPEND RULES

The SPEAKER. On that question, the Chair recognizes the gentlelady from Philadelphia, Ms. Josephs.

Ms. JOSEPHS. Thank you, Mr. Speaker.

Several weeks ago we voted on a bill to make tongue splitting, strange as that is, a more safe procedure. What I would like to do is suspend the rules in order to introduce the same amendment, which passed unanimously; no objection.

I think it would be irresponsible if we did not grab this bill and do that, so I ask for a positive vote on my motion to suspend the rules on HB 832 concurrence.

Thank you, Mr. Speaker.

On the question, Will the House agree to the motion?

The SPEAKER. For the information of the members, only the leadership can debate this issue, so with that, the Chair recognizes the majority leader, the gentleman, Mr. Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, the prior speaker is correct that the substance of this amendment was considered and passed by the House. It is in the Senate.

Given the timeframe and the fact that this particular bill before us is ready to go to the Governor's desk based on the probable concurrence of the House, I would oppose the suspension of the rules. I would like to see this bill go ahead and have its opportunity to be on the Governor's desk for his consideration. The issue embodied in the amendment is something that we have passed, and I am more than willing to deal with it if the Senate refuses at some point. I mean, I understand the tactics here.

But at this point in time, Mr. Speaker, I would appreciate a vote against the suspension of the rules so that we can allow this particular piece of legislation to clear its way to the Governor's desk.

Thank you, Mr. Speaker.

The SPEAKER. Does the minority leader defer to the gentlelady, Ms. Josephs? Does the minority whip defer to the gentlelady, Ms. Josephs? Does anybody defer to the gentlelady, Ms. Josephs? Thank you, sir.

Ms. Josephs.

Ms. JOSEPHS. Thank you, Mr. Speaker.

I am sorry that I have to do this rules suspension, but part of the problem was, we did not hear about this bill – nobody did – until this morning. Nobody on our side did. So you know, I am sorry about that, and I do think that if we had— The reason why we have a deliberate procedure in the legislature is so that everybody gets a chance to participate. All of us voted on the substance of my amendment. If it takes a couple more weeks to come back again, then it will be a better bill for that time.

Please support me and vote "yes" on suspension of the rules. Thank you.

Less than a majority of the members required by the rules having voted in the affirmative, the question was determined in the negative and the motion was not agreed to.

On the question recurring, Will the House concur in Senate amendments?

The SPEAKER. On the question of concurrence, the Chair recognizes the gentleman, Mr. Maitland.

Mr. MAITLAND. Thank you, Mr. Speaker.

HB 832 makes it a third-degree misdemeanor for anyone to pierce or tattoo a minor unless a parent or the guardian of that minor gives consent at the time of the tattooing or piercing, and for a second or subsequent offense, it would be a second-degree misdemeanor.

The Senate put two amendments in this bill. The first is to make greyhound racing a misdemeanor of the first degree: "A PERSON WHO HOLDS, CONDUCTS OR OPERATES A GREYHOUND RACE FOR PUBLIC EXHIBITION IN THIS COMMONWEALTH FOR MONETARY REMUNERATION COMMITS A MISDEMEANOR OF THE FIRST DEGREE." The second amendment, under part (b), "Body piercing," the Senate added the words "FOR COMPENSATION": "A person commits an offense if FOR COMPENSATION he punctures a part of the body...," et cetera.

And in discussing the legislative intent of the words "for compensation," I would like to put on the record that we do not mean a commercial establishment can avoid criminal culpability by saying if you buy a piece of jewelry here for the piercing, we will perform your piercing for free. That is not the sense of the Senate. What that phrase "for compensation" is intended to mean is like children at a slumber party that decide to pierce their ears. That is the sense of what "for compensation" means.

So I would ask for the members to concur with the Senate amendments in HB 832, with that understanding that for the courts, should they come to interpret that phrase, this is not a dodge for a commercial establishment to give away free piercings.

Thank you, Mr. Speaker. The SPEAKER. The Chair thanks the gentleman.

(b) Notice.-Local authorities or school districts may post a sign or signs approved by the department in advance of a school zone to indicate that the use of a mobile telephone while operating a motor vehicle or school bus in a school zone is prohibited during the restricted hours of operation of the school zone.

(c) Exceptions.-The section shall not apply to the following:

(1) Use of a mobile telephone for communicating with any of the following regarding an emergency:

(i) an emergency response operator or police dispatcher;

(ii) a physician's office, medical clinic or hospital;

(iii) an ambulance service or rescue squad;

(iv) a fireman or fire department; or

a law enforcement officer or police (v) department.

(2) Use of a mobile telephone to call for assistance in the event of a mechanical breakdown or other mechanical problem which impairs the safe operation of the motor vehicle or school bus.

Use of a mobile telephone, which has a digital (3) two-way radio, service capability owned and operated by the school district, when that device is being used as a digital two-way radio to communicate to and from a central dispatch, school transportation department or its equivalent.

(4) Use of a mobile telephone for the purpose of communicating with law enforcement officials or emergency service providers regarding a nonemergency police, public safety or medical situation.

(5) When the motor vehicle or school bus is parked.

(d) Nature of offense.-A summary conviction under this section: (1) Shall not constitute a moving violation under the applicable provisions of this title, unless the offense involves a motor vehicle accident or other serious traffic offense.

(2) Shall not be a criminal offense of record and shall not be reportable as a criminal act.

(3) Shall not be placed on the criminal record of the offending individual if any such record exists.

(e) Affirmative defense.-It is an affirmative defense to prosecution under this section, which must be proven by a preponderance of the evidence, that the motor vehicle or a school bus driver's use of a mobile telephone was necessitated by a bona fide emergency or a nonemergency public safety, police, medical or vehicle mechanical situation.

(f) Penalty.-Any person who violates this section commits a summary offense and shall, upon conviction, pay a fine of not more than \$50.

(g) Definitions.-As used in this section, the following words and phrases shall have the meanings given to them in this subsection:

"Local authorities." County, municipal and other local boards or bodies having authority to enact laws relating to traffic.

"Mobile telephone." Any handheld wireless, cellular mobile or cellular telephone that uses radio wave transmission or a combination of radio wave transmission and conventional telephone switching to permit communication to and from users within a specified area.

Amend Sec. 1, page 1, line 9, by striking out "and 1519" and inserting

, 1519 and 3742(b)

Amend Sec. 1, page 7, by inserting between lines 27 and 28 § 3742. Accidents involving death or personal injury.

(b) Penalties.-

(1) Except as otherwise provided in this section, any person violating this section commits a misdemeanor of the first degree: and the sentencing court shall order the person to pay a fine of not less than \$300 and serve a minimum term of imprisonment of not less than 48 consecutive hours. (2) If the victim suffers serious bodily injury, any person violating subsection (a) commits a felony of the third degree, and the sentencing court shall order the person to serve a minimum term of imprisonment of not less than 90 days and a mandatory minimum fine of \$1,000, notwithstanding any other provision of law.

(3) If the victim dies, any person violating subsection (a) commits a felony of the [third] second degree, and the sentencing court shall order the person to serve a minimum term of imprisonment of not less than [one year] three years and a mandatory minimum fine of [\$2,500, notwithstanding any other provision of law.] \$5,000. An additional fine and term of imprisonment under this paragraph shall be imposed for each victim whose death is the result of the violation of subsection (a).

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Let me say this. I asked for a reconsideration, because as these bills were going by quickly, some language in this caught my eye, and I wanted to make sure of what I was voting on, and so if I could interrogate the maker of the amendment.

The SPEAKER. The gentleman, Mr. Corrigan, agrees to interrogation. The gentleman, Mr. Vitali, is in order and may proceed.

Mr. VITALI. What I was really focusing in on was, does this increase a minimum mandatory sentence? And I was looking in subpart (3). Could you tell us what the amendment does and whether this involves any increase in mandatory sentencing?

Mr. CORRIGAN. Thank you, Mr. Speaker.

No, it does not involve an increase in mandatory sentencing. Let me give you a little bit of a background.

Representative Rooney and I had a similar incident in our districts a year ago, in April, where young people were killed. In my situation, a young boy was returning home with his brother from a fishing expedition, just about 500 yards from his home; was struck crossing a highway, driven 150 feet, and of course, killed. The person fled the scene of the accident. The thought is that the person fled the scene because they were drinking and driving. Sometime later that person turned themselves in, after time enough to sober up or to become more presentable.

What this bill does is create a deterrent in the case where somebody might want to flee. It increases the fines and penalties, hopefully causing people to stop at a scene of an accident rather than to flee the scene of an accident because of a drinking situation.

Mr. VITALI. Now, what I am really concerned about is the years of incarceration, and what caught my eye was, I am looking at line 27 of this amendment when it says, "term of imprisonment of not less than," and then it has bracketed out "one year" and underlined "three years."

So are we by this amendment tripling the amount of incarceration in a situation where a person leaves the scene of an accident where a victim dies? Are we increasing the mandatory sentence, the minimum mandatory, from 1 to 3 years with this amendment?

Mr. CORRIGAN. Yes, we are, and we are bringing it into line with the DUI (driving under the influence) law.

Mr. VITALI. Okay. So this does increase the minimum mandatory then from 1 to 3 years?

Mr. CORRIGAN. The answer is yes.

Mr. VITALI. Okay. I just wanted to underscore that and inform those members who have concerns with minimum mandatory sentencing that this amendment in fact does that.

Thank you.

Mr. Speaker, I want to take the extraordinary step of asking that this paper, the New York Post, in its headline, and it says it all - "SAVAGES" - be read into the record so history never forgets the movement that we are fighting against.

I know that I speak for every Pennsylvanian when I send our deepest condolences to the Berg family and hope and trust that this fate is not shared by any individual.
