# MEMBERS OF 628TH DIVISION AVIATION SUPPORT BATTALION PRESENTED

The SPEAKER. The Chair recognizes the gentlelady from Berks, Mrs. Sheila Miller. Sheila.

Mrs. MILLER. Thank you, Mr. Speaker.

It is truly an honor to have with us on the floor of the House today five soldiers from the Pennsylvania National Guard who recently returned from a mission in the Middle East. These men of the 628th Division Aviation Support Battalion, like many other Pennsylvania soldiers, have been serving our country with great honor under very difficult circumstances in this time of war.

When these gentlemen were deployed last spring, they knew of the dangers and challenges that were ahead of them, yet they thought it was important to demonstrate their loyalty not only to our country but to our Commonwealth of Pennsylvania as well. I was proud when they contacted me and asked me to provide them with a Pennsylvania State flag. It was wonderful to know these soldiers would fly this flag with great patriotism and pride while on their aircraft maintenance mission in Kuwait.

These men were stationed at Camp Doha, Kuwait. Their in-country deployment ran from June 27, 2003, to March 2, 2004, and total deployment was from April 22, 2003, to

March 27, 2004. Their unit was attached to the 131st of the Alabama National Guard, and the group was charged with providing aviation intermediate maintenance to all aviation units in theater that did not already have AVIM (aviation intermediate maintenance) support. The unit's primary responsibility was preventive maintenance or phases that consist of inspecting and, if necessary, replacing components of aircraft before they fail or break in order to save both lives and money in major repairs.

After completing their mission, these brave soldiers returned to Pennsylvania and presented the flag, this important piece of our State's history, during a ceremony at Fort Indiantown Gap. I accepted this flag in behalf of the people of Pennsylvania, and today I am pleased to have these guardsmen as my invited guests as they join me in presenting this flag to the Speaker of the House of Representatives and representatives of the Pennsylvania Historical and Museum Commission.

I would like to thank our legislative members of the PHMC (Pennsylvania Historical and Museum Commission) – Representative Steve Maitland and Representative Tom Corrigan – for their work with the commission and for representing the commission here today. By giving the flag to the PHMC, we can preserve this flag and ensure its story and the story of the many brave men and women from Pennsylvania who are serving our nation during this war is shared with future generations.

At the back of the hall of the House, the members of the House will find a picture of this flag being flown in the Middle East by this regiment, and I would invite all of the House members who have not yet signed it to please sign it, because this also will be given to the PHMC.

I want to thank Representative Paul Semmel and Representative Tom Tigue, the chairmen of our House Veterans Affairs and Emergency Preparedness Committee, for all of their leadership on issues affecting our soldiers. I should also mention that tomorrow we will be celebrating National Guard Day here at the Capitol with exhibits and displays in the Capitol and Soldiers' Grove, a freedom salute in the rotunda, and a picnic outside.

At this time I would like to introduce our National Guardsmen and special guests: Spc. Nicholas Davis of Etters, York County; Spc. Michael DePugh of Jonestown, Lebanon County; my constituent, Sgt. Benjamin Jordi of Robesonia, Berks County; another constituent, Ssg. Matthew Schreffler of Shartlesville, Berks County; and Ssg. Gary Williard of Williamstown, Dauphin County. Spc. Derek Dumas of Lykens, Dauphin County, and Spc. Gregory Whary of Lewistown, Mifflin County, who also served with this unit, unfortunately could not be here today.

Gentlemen, on behalf of the House of Representatives and the 12 million citizens that we represent, thank you for your service to our Commonwealth and our country, and thank you, Pennsylvania National Guard.

# CHRISTOPHER K. BINGAMAN HONORED

The SPEAKER. The Chair at this time would like to recognize Representative Neal Goodman. Representative Goodman.

Mr. GOODMAN. Thank you, Mr. Speaker.

I am thanking you for allowing me this opportunity to address the House of Representatives on this somber occasion. I am here today, along with my colleagues, Representative Allen and Representative Argall, to present a House citation that honors the sacrifice of one of Schuylkill County's finest sons.

The SPEAKER. Excuse me just one second, Mr. Goodman.

The gentleman has every right to be heard.

Mr. GOODMAN. Thank you, Mr. Speaker.

I am here today, along with my colleagues, Representative Allen and Representative Argall, to present a House citation that honors the sacrifice of one of Schuylkill County's finest sons, Army Spc. Christopher K. Bingaman of Frackville, Pennsylvania, who died tragically when the U-60 Black Hawk helicopter he was in crashed during a training exercise on April 26, 2004, near Florence, South Carolina.

Specialist Bingaman served as the flight crew chief and was assigned to Company A, Battalion 1, of the 159th Aviation Regiment at Fort Bragg, North Carolina.

It was told to me that Christopher only wanted to do two things when he graduated from Cardinal Brennan High School in 2000. One was to serve in the U.S. Army, and the other was to make his family proud. Chris did far more than that. He has made all of us proud. He proved himself to be the shining example of what young people can be and what it means to truly love one's country.

Not far from here, also on a very solemn occasion, President Abraham Lincoln stated that "...we here highly resolve that these dead shall not have died in vain – that this nation, under God, shall have a new birth of freedom..." Those who give their all surely do not die in vain but rather for a noble and more just cause.

Chris Bingaman's sacrifice did not occur on a battlefield. However, this does not change the fact that he died while in service to his country and preparing to lighten the burdens of an oppressed people.

He will be remembered not only as a soldier and son but by all of us as the best that America has to offer to a needy world. It is my hope that his spirit lives in all of us, and remember the sacrifice that he and those who have gone before him have made while carrying the guidon of this Commonwealth and of our nation.

Mr. McGEEHAN. Thank you, Mr. Speaker.

Mr. Speaker, as we all are aware, yesterday, June 6, marked the 60th anniversary of the D-day invasion of France, and although today is June 7, it is still appropriate that we talk about the D-day invasion, because this date, 60 years ago, the operation and the success of this operation was still very much in doubt.

Mr. Speaker, this resolution honors the heroic efforts of the servicemen who fought and, yes, for those who lost their lives as Allied Forces stormed the beaches of Normandy. As a nation, we should never forget how in the early hours of June 6, 1944, the huge armada of nearly 1800 vessels, more than half of them American ships, moved across the English Channel bearing 150,000 soldiers. The American troops included 57,000 servicemen and 15,000 paratroopers. Of those, Mr. Speaker, 6,000 were killed or wounded as they met deadly machine-gun fire upon reaching the Normandy shores.

Mr. Speaker, it is important and it is particularly important this year to remind this country and indeed the world and to remind those who are not born in the World War II generation of the huge and selfless sacrifice of what many consider, including myself, the greatest generation. And I say it is particularly important this year because the relentless passage of time has done what no Nazi army could ever do: it significantly diminished the rolls of the World War II generation.

At the height of the war effort, 16 million American men and women, both here and abroad, were part of the war effort. Today, only 4 million of those 16 million remain alive, and what is more troubling and sad is that of those 4 million, over a thousand are dying each day.

Mr. Speaker, these brave young men faced the enemy with faith and courage, and their successful assault marked the beginning of the end for Hitler and the Third Reich. Mr. Speaker, these seemingly ordinary men and women, they did nothing less than save the world.

Mr. Speaker, I urge an affirmative vote.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, I had prepared several amendments to this bill. This legislation appropriates funding to clean up garbage that has been dumped on our beautiful State forests and State gamelands and other public properties across the Commonwealth.

Mr. Speaker, I want to commend Representative Rubley for putting together a good bill that would promote the cleanup of these illegal dumpsites on State forests and State parklands, and I support the legislation, but, Mr. Speaker, this legislation is but a Band-Aid that will only temporarily address this large problem of dumping trash across Pennsylvania's beautiful landscape.

Previously we funded these cleanups on State property with a small portion of the mandatory tipping fee on municipal solid waste, and now we are going to utilize a small portion of the realty transfer tax under this legislation to finance this cleanup.

Mr. Speaker, I think in Pennsylvania it is high time we get at the root cause of illegal dumping in Pennsylvania and one in which many of our municipalities do not require mandatory or universal garbage collection.

Mr. Speaker, in 1989 we passed Act 101 to mandate, to mandate, that we recycle trash in Pennsylvania. So we have mandatory recycling, but we do not have universal or mandatory garbage collection, and I believe because of that, Mr. Speaker, there is a lot of this illegal dumping that goes on, because a lot of communities in Pennsylvania do not provide the basic essential service of picking up garbage. I mean, what more basic service ought a local government to provide than garbage collection or garbage disposal services for its households and its residents? We do not mandate that in Pennsylvania, but we mandate all communities over 5,000 must recycle. So we mandate recycling, but we do not require municipalities to provide garbage collection or universal garbage service.

Mr. Speaker, I think that is an inconsistency. I think part of the reason why we have these illegal dumpsites on our State forests and on our State gamelands and our State property is in fact because these public lands are in a lot of communities that do not provide, that do not provide, mandatory or universal garbage collection services, and as long as that is the case, we are going to continue to use the State taxpayers' dollars to clean up these sites.

Now, while I support this legislation, again, it is a short-term Band-Aid, and I would like to see us get at the root cause of the problem, which is the lack of universal garbage collection services. Mr. Speaker, in the future I will be offering legislation to in fact require this of all municipalities in Pennsylvania, because I think that will be the real long-term, permanent solution to this deplorable problem that we have in Pennsylvania.

So with that, Mr. Speaker, I will withdraw my three amendments and urge my colleagues to support this legislation.

The House proceeded to third consideration of **HB 2262**, **PN 3869**, entitled:

An Act providing for protection of children from obscene material, child pornography and other material that is harmful to minors on the Internet in public schools and public libraries; and providing for the duties of the Secretary of Education.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentlelady from Philadelphia, Ms. Josephs.

Ms. JOSEPHS. Thank you, Mr. Speaker.

I would like to ask the maker of this bill if he would submit to a brief interrogation.

The SPEAKER. Does the gentleman, Mr. Egolf, consent to a brief interrogation? The gentleman indicates that he will. The gentlelady is in order and may proceed.

Ms. JOSEPHS. Thank you, Mr. Speaker.

Mr. Speaker, I would like to know, to begin with, first, how does this bill which controls Internet access in public schools and libraries differ from the existing Federal legislation?

Mr. EGOLF. Thank you.

The difference is, the Federal legislation only applies to schools and libraries that receive Federal funding and this would apply to schools and libraries that receive State funding. That is the main difference.

Ms. JOSEPHS. So that if the library or school is already complying with Federal law, the Children's Internet Protection Act, this bill would not apply to it. Is that correct?

Mr. EGOLF. Essentially, that is correct.

Ms. JOSEPHS. So can you tell us how many libraries in the State of Pennsylvania are not complying with Federal law and which would be affected by this bill?

Mr. EGOLF. No; I cannot tell you that. I do not have the figures.

Ms. JOSEPHS. So it might be none or 2 or 100?

Mr. EGOLF. I do not know; that is right.

Ms. JOSEPHS. You do not know?

Mr. EGOLF. I do not know.

Ms. JOSEPHS. All right.

I think I understand under Federal law that if an adult is using the Internet in a public library and wants free access because of the kind of research that person is doing, that Federal law has a provision which will allow that adult free access to the Internet. Is that correct, according to your understanding?

Mr. EGOLF. That is correct. If they want access and need it for research, that sort of thing, they convince the librarian, and they can—

Ms. JOSEPHS. Do you provide that exception under the bill? Mr. EGOLF. Yes; yes.

Ms. JOSEPHS. The answer was yes, for those who did not hear.

Have you received any complaints from librarians or public school teachers that they are having problems developing or enforcing acceptable-use practices for the Internet?

Mr. EGOLF. You mean for the Federal law or just in general?

Ms. JOSEPHS. Well, just in general.

Mr. EGOLF. Yes; I have received complaints that, for instance, in some schools the students have been on pornography sites—

Ms. JOSEPHS. Excuse me. I am sorry, Mr. Speaker. I am having a hard time hearing the answers of the gentleman.

The SPEAKER. The gentlelady is entirely correct. There is too much noise in the chamber. Please keep the noise levels down or take your conversations outside.

Ms. JOSEPHS. The question was whether the gentleman has received any complaints from librarians or public school teachers that are librarians that they are having trouble developing and enforcing acceptable-use practices.

Mr. EGOLF. I have not had any complaints from them that they are having trouble enforcing. I have had complaints from patrons of libraries, from parents of schoolchildren, and actually some school students that they are not being enforced.

Ms. JOSEPHS. And finally, does your bill include funding, keeping in mind that we have cut library funding in this budget so far, does your bill include funding to help libraries and public schools comply with its requirements?

Mr. EGOLF. I am sorry. The question was, would they withhold funding if they do not comply?

Ms. JOSEPHS. Does your bill include funding to help these institutions comply with its requirements?

Mr. EGOLF. No; it does not supply funding to comply. That would be in their normal budgets.

Ms. JOSEPHS. Thank you.

I would like to make a statement on the bill.

The SPEAKER. The gentlelady is in order and may proceed. Ms. JOSEPHS. Thank you very much, Mr. Speaker.

I do not know about the rest of the people in the General Assembly here, but I do know that I hear a lot from my public libraries and my constituents that use these libraries, and I can tell you that they are very clear about what they need us to do, and that is to provide them with adequate funding so they can remain open for more hours, with more books and more computers. I am not hearing anything about a need for this type of legislation.

I also do not believe that it is our role, and particularly certainly not the ladies and gentlemen from the other side of the aisle who always speak very convincingly about local control, I do not think we ought to be micromanaging our libraries from Harrisburg. We do not need to be telling librarians how to protect readers and particularly not how to protect their customers, and we do not need the Secretary of Education to have the power to threaten our libraries with loss of funding.

And while I am talking about funding, I would like to ask whether there is a fiscal note for this bill.

The SPEAKER. For the information of the gentlelady, it says, "Appropriations, June 7, 2004 Fiscal-Note Attached."

Ms. JOSEPHS. Thank you, Mr. Speaker.

What does the fiscal note say, if somebody would not mind telling us what it will cost?

The SPEAKER. Does the gentleman, Mr. Egolf, wish to answer the question?

Ms. JOSEPHS. If I might ask the maker of the bill what the fiscal note shows.

The SPEAKER. It is the understanding of the Chair, the Appropriations chairman, the gentleman from Schuylkill, Mr. Argall, will be up in just one moment.

The Chair recognizes the gentleman, Mr. Argall.

Mr. ARGALL. Thank you, Mr. Speaker.

Mr. Speaker, according to our fiscal note, this legislation can be met within the existing budget of the department. There should not be an additional cost.

Ms. JOSEPHS. Thank you, Mr. Speaker.

The SPEAKER. The gentlelady, Ms. Josephs.

Ms. JOSEPHS. Thank you, Mr. Speaker.

Notwithstanding, I think that this is probably an unfunded mandate on our libraries and our public schools and a mandate which is unnecessary in light of Federal legislation, to which, so far as we know, every single library in the State is already complying.

I think what we are setting up here is— I mean, I could kind of follow all this if it were true that our libraries had no acceptable-use policies, but I was at a hearing when I was a member of the Judiciary Committee held some 2 or 3 years ago, and every librarian who testified before us told us that they did things like make sure that their screens were in a public area where they could be monitored and that all of them were very satisfied that they were doing what needed to be done in order

to make sure that there was no obscenity on their screens. If there were complaints, they were long ago and far away and should not have been repeated.

I think that this is a bill that we ought to vote "no" for. I intend to vote "no," and I urge my fellow legislators here to also vote "no."

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentlelady.

The Chair recognizes the gentleman from Philadelphia, Mr. Roebuck. The Chair rescinds.

The Chair recognizes the gentleman from Delaware, Mr. Vitali. He had the mike first.

Mr. VITALI. Thank you, Mr. Speaker.

I just wanted to share with the members the discussion I had with the heads of the Haverford Township and Radnor Township libraries, who expressed their opposition to this bill. They simply say legislation like this is not needed. They keep their computer terminals in a public place and can adequately monitor who views what. They also say that these blocking devices, A, do not block all of the bad stuff, and B, block out some perfectly legitimate nonpornographic stuff. In other words, the blocking devices simply are not adequate.

I think it is important to note that according to the current bill, 2262, unlike the Federal bill, this blocking device applies to both children and adults. The bill clearly states, on page 5, line 24 and following, this applies to all library patrons, not just adults, so we are blocking materials to adults also.

We do not want to impose another burden on libraries. Each burden does have a cost, even though it might not be articulated in a fiscal note. I think what we have to do is simply trust our local librarians. I think in the true spirit of local control, we should let our local libraries decide and not have Big Brother from above imposing its will and its sense of morality on our local libraries.

So I would urge a "no" vote.

The SPEAKER. The gentleman, Mr. Roebuck.

Mr. ROEBUCK. Thank you, Mr. Speaker.

I wondered if the maker, the author, of this legislation would stand for brief interrogation.

The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman, Mr. Roebuck, is in order and may proceed.

Mr. ROEBUCK. Thank you, Mr. Speaker.

I wanted to have clarity, if I might have it, on the language that says "material that is harmful to minors." What is the scope of the gentleman's intent under that language?

Mr. EGOLF. Mr. Speaker, that definition is in the Crimes Code, so it is using the exact definition that is already established in the Crimes Code.

Mr. ROEBUCK. Could you clarify as to what that definition is, Mr. Speaker?

Mr. EGOLF. We are trying to get it for you. It does not change anything, but it does refer to the Crimes Code in the bill, so it is not changing anything at all from what now is used.

Okay. In the Crimes Code, the definition of "harmful to minors" means "that quality of any description or representation, in whatever form, of nudity, sexual conduct, sexual excitement, or sadomasochistic abuse, when it: (i) predominantly appeals to the prurient, shameful, or morbid interest of minors; and (ii) is patently offensive to prevailing standards in the adult community as a whole with respect to

what is suitable material for minors; and (iii) taken as a whole, lacks serious literary, artistic, political, educational or scientific value for minors."

Mr. ROEBUCK. So, Mr. Speaker, then we are primarily talking about things that might broadly be under the idea that they are obscene or pornographic? Is that what we are talking about?

Mr. EGOLF. I guess, if you take it from that definition; yeah.

Mr. ROEBUCK. Well, Mr. Speaker, my concern then is that in looking, in using the Internet, I came across a Web site which was called gunsforkids.com. Would your language preclude a young person, a minor, from accessing a site that is called gunsforkids?

Mr. EGOLF. It does not preclude sites according to words.

Mr. ROEBUCK. So in other words, it is perfectly okay under your language—

Mr. EGOLF. Not necessarily; no.

Mr. ROEBUCK. —for minors to access gunsforkids?

Mr. EGOLF. No, it is not. That is not what I am saying.

First of all, if you get the filters through the servers, what they include or prohibit from coming through is according to sites, and this is constantly updated to sites that send out pornographic material and so on and according to the definition. So it is not based on words, because that used to be a problem. On the older filters, it was based on words, and we hear a lot about, well, it will restrict somebody that wants to get a recipe for chicken breast or something. That would not be precluded because of wording. It will be filtered according to the sites, the sites that have shown to be putting out material that is harmful to minors, that is obscene, child pornography and so on.

Mr. ROEBUCK. But, Mr. Speaker, let me be very precise here and very clear. The definition you gave to me in no way seems to impact upon a young person accessing a site that is gunsforkids. That is not obscene, according to your definition.

So, Mr. Speaker, I am going to be clear. Under this language, in no way would you preclude a young person accessing a site that is labeled gunsforkids.

Mr. EGOLF. This does not prohibit a librarian from doing what they want to in the library in addition to what is in this bill.

Mr. ROEBUCK. But your language does not address that. Am I correct, Mr. Speaker?

Mr. EGOLF. No; this does not.

Mr. ROEBUCK. Thank you, Mr. Speaker.

If I might speak on the proposal.

The SPEAKER. The gentleman is in order and may proceed.

Mr. ROEBUCK. Mr. Speaker, I have a very clear problem with this. Certainly, no one wants to open up obscene materials or pornographic materials to young people, but suggesting that that solves a problem is a misnomer. It is wrong. It clearly does not do that.

I have a very real problem, because what we do is we allow kids still to access broad other areas, including a site that says it is intended to encourage young people to have access to guns. That, to me, is a fatal flaw in the language that the speaker proposes. If he wants to do this, at least let us be precise in what we are doing; at least let us be careful in the language proposed.

To suggest that somehow getting rid of obscene materials makes our kids safer while allowing them on the other hand to have access to Web sites such as the one I cited, which encourages them to use, to access, materials that perhaps their parents or others might have reason to not allow them to access,

whether it is obscene or in fact it is merely other materials such as those that would be weapons that they might not be able to handle or use, is fundamentally wrong and flawed, and we ought not to pass this thinking we are doing something when in fact we are not.

The language the gentleman proposes is narrow. It does not address the full scope of the problem. This language needs to be clarified. For that reason the bill needs to be defeated, unless we can have clarity on language and protect, truly protect, our young people. Unless we are going to protect our young people, we should not do this.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Perry, Mr. Egolf.

Mr. EGOLF. Thank you, Mr. Speaker.

I would just follow up on that previous speaker. I would say if he feels that this does not go far enough, he can put in a bill of his own to add that additionally, and then we will debate that.

But this certainly, the areas that it does cover, I think, are very, very necessary, and there have been some very, very strong examples of the need for this recently.

Just this year in Philadelphia, we know we had a child, an 8-year-old child, that was found beaten, raped, left for dead, in a restroom of a Philadelphia library, and it was by a homeless man that they found, they got, and I would just like to read what the librarian said, one of the library employees, who asked that her name not be used for fear of repercussion, said that this individual named McCutcheon "was often disruptive in the library, yelling and using foul language when librarians told him he had used his 30-minute allotted time on the public computers. He looked mostly at pornography, she said, and officials banned him from the library only after he exposed himself to a 16-year-old library assistant."

So I think we have problems in the libraries, and I think the fact that if they allow people to get on the sites that have pornography, child pornography and so on, we have found that those individuals are drawn to the library, and then incidents like this will often happen, and this happened in our own State, right in Philadelphia, and I think that is the kind of thing we are trying to prevent.

Thank you.

The SPEAKER. The Chair thanks the gentleman.

Is the gentlelady from Philadelphia, Ms. Josephs, up for a second time? The Chair recognizes the gentlelady.

Ms. JOSEPHS. Thank you, Mr. Speaker.

I guess I have to get up and say something, because not only did that terrible incident happen in our own State, it happened in my district. And there is absolutely no evidence whatsoever, even from the anonymous librarian, and I do not know about you, but when I hear "anonymous," I discount it immediately, because if a person is convinced he or she is right, her or his name ends up on the bottom of his or her opinion, and so I discount this testimony.

There is no evidence that that awful incident had anything to do with a filter or a nonfilter in the public library in my district, and in fact, if this individual, the perpetrator, had been misbehaving in the library for some period of time before this incident and the librarians did not make sure that he had no more access to the library, that is where the problem lies. It has nothing whatsoever to do with a computer, with filtering it or not filtering it, and I really think that using this poor

little girl's horrible experience to push a bill which has nothing to do with her experience is not proper.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentlelady.

The Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. My only final point here is this: I think that with the proliferation in society of Internet through many home computers, with the proliferation of the type material you see on cable television, the type material kids can see in the adult section of bookstores, I just do not think the answer here, if you want to prevent the type incident you are discussing or you want to protect the moral fabric of society, is to pick one little, narrow window through which kids can see obscene material, given the fact they can see it all over the place, and try to impose burdens on libraries and think that is going to do anything to protect kids from seeing naked imagery. Given it is on other computer terminals, cable, bookstores, I just do not think that is going to happen, and I think it is ridiculous to think it is, and I think our efforts to prohibit it are just wrong, wrongheaded.

The images are out there, like it or not. Those images are out there, and kids are going to see it, if you have not raised a good kid. I have a 15-year-old daughter. I think if you raise them right, they are going to resist temptation; they are going to react well if it is presented to them.

The answer is not to try to just pick this one narrow area and plug it up. I just think it is the wrong way to approach things. The intentions are good, but I think it is just the wrong approach, so I would urge a "no" vote.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. Egolf.

Mr. EGOLF. Thank you, Mr. Speaker.

I would just like to add that filters, filters are really essential to keep children from getting into sites that they do not intend to. They inadvertently get into pornographic sites, and the way they run now, many times they get into them; they cannot exit them; they cannot X out of the site; they cannot go back; it just takes them into more and more sites. And young children especially who have never been into it do not know; they do not want to ask somebody else; they are scared. There have been many instances of this, and it is something, again, they have not gotten into on purpose, but it happens all the time by getting into innocent sites, and of course, the sites are put in with innocent names, such as the one probably best known as the WhiteHouse.com, for example. I can give a number of others, things that have Disney names and so on, and draw children into them.

This is designed to keep them from getting into those kinds of sites, and I just want you to know that that is what is out there and it is what they are facing.

The SPEAKER. The Chair thanks the gentleman.

## REMARKS SUBMITTED FOR THE RECORD

Mr. EGOLF submitted the following remarks for the Legislative Journal:

HB 2262 has a very simple and very important purpose.

It requires each school district and public library to adopt an acceptable-use policy for the Internet which will prevent students, patrons, and employees from accessing visual depictions of obscenity, child pornography, or material that is harmful to minors. In addition,

the bill will require school districts and public libraries to use software programs or to select online servers in order to block access to visual depictions of obscenity, child pornography, or material that is harmful to minors. The bill incorporates the Crimes Code definition of those terms. In order to correct any overblocking by a filter or online server, the bill enables the appropriate library or school personnel to disable the device in order to permit access for bona fide research or other lawful purpose.

In November of 2000, I offered a very similar amendment for the House's consideration, which passed this body by a vote of 178 to 14. Because it passed in the waning days of the lameduck session, it was not taken up by the Senate. One year later, in 2001, the Congress of the United States adopted Internet filtering legislation for public schools and libraries that was very similar to the amendment that passed our House of Representatives in 2000. Because it was very likely that the congressional law would be reviewed by the United States Supreme Court, I made a decision to postpone any further consideration of my legislation until the U.S. Supreme Court had an opportunity to decide the constitutionality of this measure. In June of 2003, the U.S. Supreme Court upheld the Internet filtering legislation by a 6-to-3 vote in the case of United States v. American Library Association. I made a few minor modifications in the wake of the High Court decision, and the House Judiciary Committee made a few other changes as well.

In addition to safeguarding children by limiting access to unlawful pornography on library and school Internet sites, this bill will serve two other very important public purposes, which I would like to mention because they have received somewhat less public attention.

By making it more difficult to access pornography on library computers, the bill will discourage pedophiles and other sexual offenders from frequenting libraries for this purpose, which creates a clear and present danger for little children who use our libraries for innocent educational purposes. A recent case involving the Philadelphia Library illustrates this concern. A February article in the Philadelphia Inquirer reported that police arrested a man for attempted rape and attempted murder when he raped an 8-year-old girl in the bathroom of a Philadelphia Public Library branch. According to the article, the patron choked and sexually assaulted the little girl before jamming her unconscious body between the toilet and the wall. While the articles are silent on whether the rapist was accessing pornography at that particular time, they report that he had a record of accessing pornography at public libraries. The Inquirer article has this interesting quote, and I quote:

"A library employee who asked that her name not be used for fear of repercussions said McCutcheon was often disruptive in the library, yelling and using foul language when librarians told him he had used his 30-minute allotted time on the public computers. He looked mostly at pornography, she said, and officials banned him from the library only after he exposed himself to a 16-year-old library assistant."

End of quote. In summary, this bill sends the message that we do not want our libraries to be magnets for molesters.

One final purpose of this legislation is to protect patrons and library employees against the hostile atmosphere created by the display of sexually explicit material on library premises. In Minneapolis, Minnesota, 12 librarians filed a Federal claim against the library for failure to control the display of such graphic material, and the Equal Employment Opportunities Commission found probable cause that Federal law had been violated because the library had created a sexually hostile environment. An article published last year reported that the library settled the lawsuit for the sum of \$435,000. This bill will create an additional safeguard to protect against potential Federal liability for creating a sexually hostile work environment, and it will

create a much more intellectually congenial atmosphere for library workers and patrons, including children, who use our public libraries.

In conclusion, the overwhelming House support in favor of this measure 4 years ago has been vindicated by a subsequent act of Congress and a subsequent decision of our United States Supreme Court.

I ask for an affirmative vote on this bill.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

The SPEAKER. The Chair recognizes the gentleman from Montgomery, Mr. Bunt.

Mr. BUNT. Thank you, Mr. Speaker.

Mr. Speaker, tomorrow morning the Republicans will caucus at 10 a.m., tomorrow morning.
