PRAYER

REV. RON ERB, Guest Chaplain of the House of Representatives, offered the following prayer:

I am very thankful for the opportunity to pray today. Usually there are just a few pews empty and then a lot of people in the back, but today I have a lot of my congregation up there, and to my left are my wife and my daughter and my father, and I am very grateful to be accompanied by them. I want to thank Representative Scavello for making this possible.

Let us pray:

Father, we recognize the need for Your presence. We live in dangerous times, and we recognize that we have difficult problems to deal with. I thank You for the opportunity to stand in this place to speak to You on behalf of the men and women who, along with many others, lead this great Commonwealth.

You have said that requests, prayers, intercession, and thanksgiving should be made for all those in authority that we may live peaceful and quiet lives in all godliness and holiness, and I stand before them this day to do just that. It has been the prayer of my heart, O God, that Your presence would be felt in a very special way as these people do their work. I thank You for their willingness to give years of their life for public service.

I pray for the families of those in this chamber. The men and women in this House are often away from their own house because of pressing legislative commitments, and I pray for Your protection on their home, their spouse, and their children. May these families find peace from You when their loved one is here doing State business. I pray that You would renew marriages and help these Representatives to balance all their commitments of family and public service. Protect these men and women from those who desire to lead them to compromise their integrity and marriage vows.

Father, they are shepherds, and their flock is the 12 million people of this State. They watch over 2 to 3 million children, many of whom come from single-parent homes or who live in poverty. I pray that the laws they make and the example that they set would lead the way to justice for the poor, the unborn, the aged, and for all. I pray that they would uphold moral principles, take a stand for righteousness and oppose unrighteousness, for You have said righteousness exalts a nation, but sin is a disgrace to any people. I pray that You

would make these men and women the cornerstones of their people.

Father, You have said that by wisdom, kings reign and rulers make laws that are just; by wisdom, princes govern and all nobles who rule on earth. Therefore, I pray that You would give them wisdom as they discuss, debate, and decide important issues that affect all of us in Pennsylvania. Keep them from pride, greed, deceit, and fear, and let them rule by wisdom, knowledge, and understanding. Keep them from yielding to the pressure of those who may push them into laws that are unjust, unrighteous, or immoral.

Father, I pray that they would not listen to lies but that they would hear and yield to the truth, and I pray that each of them would come to know You personally, for it is in the name of the master I pray. Amen.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 2299**, **PN 3199**, entitled:

An Act authorizing the establishment and maintenance of health savings accounts; exempting contributions from taxation; imposing restrictions on health savings accounts; and prescribing penalties.

On the question,

Will the House agree to the bill on third consideration?

Mr. CIVERA offered the following amendment No. A3914:

Amend Title, page 1, lines 1 through 4, by striking out all of said lines and inserting

Authorizing the establishment and maintenance of health savings accounts; providing an exclusion from State income tax; and imposing restrictions on health savings accounts.

Amend Bill, page 1, lines 10 through 15; pages 2 through 9, lines 1 through 30; page 10, lines 1 through 13, by striking out all of said lines on said pages and inserting

Section 2. Legislative intent.

It is the intent of the General Assembly to extend to health savings accounts established pursuant to section 223 of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 223) an exclusion from State income tax.

Section 3. Definitions.

The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Health insurance policy." An individual or group health, sickness or accident policy or subscriber contract or certificate issued by an entity subject to any one of the following:

- (1) The act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921.
- (2) The act of December 29, 1972 (P.L.1701, No.364), known as the Health Maintenance Organization Act.
- (3) The act of May 18, 1976 (P.L.123, No.54), known as the Individual Accident and Sickness Insurance Minimum Standards Act.
- (4) 40 Pa.C.S. Ch. 61 (relating to hospital plan corporations) or 63 (relating to professional health services plan corporations).

"Health savings account." As defined in section 223(d) of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 223(d)).

"Qualified medical expenses." As defined in section 223(d) of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 223(d)).

Section 4. State income tax exclusion.

- (a) General rule.—Any increase in the value of a health savings account and any payment or distribution from a health savings account that is used exclusively to pay qualified medical expenses shall be excluded from taxation under Article III of the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971.
- (b) Nonqualified payments or distributions.—A payment or distribution from a health savings account that is used for any purpose other than to pay qualified medical expenses shall be included in income under Article III of the Tax Reform Code of 1971 to the extent that the amounts paid or distributed were not previously included in income. The cost recovery method shall be used to determine the portion of the payment or distribution to be included in income. Section 5. Mandated benefits.
- (a) General rule.—A health insurance policy that would qualify as a high deductible health plan under section 223(c)(2) of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 223(c)(2)) shall be subject to any provision of law mandating a minimum health insurance benefit or reimbursement.
- (b) Construction.—Nothing in this act shall be construed to prohibit or prevent a health insurance policy that would qualify as a high deductible health plan under section 223(c)(2) of the Internal Revenue Code of 1986 from applying deductibles or copayments to benefits offered under these mandated minimum health insurance benefits.

Section 6. Applicability.

Section 4 shall apply to taxable years beginning after December 31, 2003.

Section 7. Effective date.

This act shall take effect in 60 days.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, HB 2299 would permit Pennsylvanians to take advantage of health savings accounts. The amendment that we

are looking at at the moment, that is before us, would refine HB 2299 to explicitly bring our law into compliance with the Federal law. The HSAs (health savings accounts) receive personal contributions which are deductible from Federal income tax, and money in an HSA can be used for medical expenses. HSA contributions would be treated the same way as IRA (individual retirement account) contributions with respect to the Pennsylvania personal income tax.

Under the Federal statute which allows HSAs, an account owner can carry over balances from year to year, which allows younger and healthy persons to build up a reserve for a time when they might need more funds. HSAs are linked with high-deductible health plans which begin to pay when an agreed-upon deductible limit is reached. Employers can fund HSAs for their employees, and HSAs provide consumers with greater control over how their health-care dollar is spent.

Health insurers or advisers still are figuring out the details of how a health savings account should be structured, offered, and administered. This amendment and the bill to which it is being added would provide all participants with a maximum amount of flexibility to set up plans and accounts that meet individual needs. HSAs will not solve the health-care-cost crisis, but they do provide options that we should empower Pennsylvania to use. HB 2299 with the addition of this amendment does exactly that in a very simple, straightforward way and complies with what the Federal law is.

I would hope that you would support amendment A3914.

Thank you, Mr. Speaker.

That is the issue. And this may help with that problem, but it will put a very small dent in the problem of health care in America.

RESOLUTION

Mr. CIVERA called up **HR 865**, **PN 4540**, entitled:

A Resolution authorizing a study with respect to the regulation and disposition of the reserves and surpluses of health insurers.

The SPEAKER. The Chair recognizes the gentleman, Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker.

This resolution was amended in the Rules Committee about a half an hour ago, and I just ask the sponsor to give us a summary of the amendments that were inserted by the Rules Committee today.

Mr. CIVERA. What we did with that amendment is to extend it and to deal with the social issues, which Representative DeLuca had such language and we put it into Rules, and it went beyond what we were originally doing with HR 865

The SPEAKER. Mr. Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, I am pleased today to speak in favor of passage of HR 865. The resolution would direct the Legislative Budget and Finance Committee to examine the entire issue of health insurance reserves and surpluses and report back to the House by the end of this fiscal year.

The Republican Policy Committee has conducted hearings on health issues across Pennsylvania, and it is no secret that there is a great deal of skepticism throughout the Commonwealth about whether insurers, particularly Blue Cross and Blue Shield plans, are hoarding cash at the expense of their policyholders. Many members of the House share that skepticism. Questions have been raised about whether the insurers have amassed amounts far beyond what could be necessary even under the most extreme circumstances. While hundreds of pages of information have been filed with the Department of Insurance, we still do not have all the answers to those questions. It is time for us to take a step back and assess where we are in comparison with other States and make an objective review of not only the not-for-profit insurers but the others as well. Dramatic increases in premium costs and the very real concerns of families and business required us to do so.

We do not seek to become part of an ongoing dispute between the Blues and the department. This is a matter for the courts to resolve. At some point, however, it is likely that we will have to act. We have to be prepared to address the issue in a thoughtful and well-informed way. HR 865 will help us do that, and I urge all of my colleagues to support this resolution.

Thank you, Mr. Speaker.

The SPEAKER. The gentleman from Westmoreland, Mr. Tangretti.

Mr. TANGRETTI. Thank you, Mr. Speaker.

Mr. Speaker, I wonder if the gentleman from Delaware will answer a couple of quick questions.

The SPEAKER. The gentleman indicates he will.

Mr. TANGRETTI. Mr. Speaker, will the gentleman from Delaware explain the difference between the resolution's intent and what the department is doing now? I know that the Insurance Commissioner and her staff have been collecting data from the Blues, making some determinations about surpluses, determining what and collecting comments for the last 30 or 40 days, and I am curious as to whether this resolution will in fact slow the process down or will it enhance the process or complement the process. I just need to have a clarification.

Mr. CIVERA. My understanding is the department has the right to regulate the surpluses. What this resolution does, it takes it a step back to look into what further amounts could be and what further amounts could not be. So it gives them more of a broader scope of what the problem is and then exactly what the department is charged with without the resolution.

Mr. TANGRETTI. Then if I may, Mr. Speaker, can the gentleman then tell me, if the department determines, for example, the level of surplus, the minimum and maximum that they have been looking at, is determined by the department, are you suggesting then that the department then cannot implement that and make recommendations as to its disposition or—

Mr. CIVERA. No, this would not change anything.

Mr. TANGRETTI. So that the department, therefore, can in fact go forward with their investigation, with their inquiry, make a determination, and in fact can direct the Blues to do a number of things, if they so chose, and this has no effect on that.

Mr. CIVERA. Okay. This resolution does not change anything that presently is in the statute—

Mr. TANGRETTI. Okay.

Mr. CIVERA. —that deals with the Department of Insurance.

Mr. TANGRETTI. Thank you.

SB 1096, PN 1886 (Amended)
