Mr. FLEAGLE. Thank you, Mr. Speaker.

Would the prime sponsor submit to a brief interrogation?

The SPEAKER. The gentleman indicates that he will stand for interrogation. The gentleman, Mr. Fleagle, is in order and may proceed.

Mr. FLEAGLE. Mr. Speaker, I have had several people from the sheriff's department call me about this bill, and they are very supportive of it, but they just wanted to know, for legislative intent on this, are sheriffs in this bill considered "law enforcement"?

Mr. MAITLAND. Thank you, Mr. Speaker.

The Federal law, H.R. 218, defines "law enforcement officers" to include those who are or, in the case of retired officers, were "authorized by law to engage in or supervise the prevention, detection, investigation, or prosecution of, or the incarceration of any person for, any violation of law, and has statutory powers of arrest...." Since the Federal law contains the applicable definition, I did not define it, the term, in my bill. It is possible that there are some agencies which fall into a gray area, and they would need to work that out with the appropriate Federal agency, whether the Department of Justice or the Bureau of Alcohol, Tobacco and Firearms, which is implementing the legislation on the Federal level. But it would seem to me that, at a minimum, this includes the Pennsylvania State Police, our municipal police departments, the Game Commission, and the Fish and Boat Commission law enforcement officers and sheriffs and their deputies. I am sure that I am missing some law enforcement officers by reciting this list, and I do not intend it to be all-inclusive.

First of all, I want to thank the House for reconsidering HB 1116.

Let me just read a little bit of something to the members here when they vote on this piece of legislation. I just want to bring some facts out to the membership.

I want you to know that a retired professional painter collects a pension, on average, on average, Mr. Speaker, 13 months, 13 months, and when you ask yourself why, because with each breath during the workday, they are exposed to a variety of toxins, paints, stains, chemical strippers, and solvents.

Now, this problem is far reaching. Even after workers leave the workplace, studies reveal that their cars, homes, and families are indirectly exposed through personal contact.

HB 1116 will protect workers by requiring special training to learn how to safely handle hazardous material in the workplace. It will protect them by teaching them. Workers will learn how proper ventilation and respirators will protect them. Workers will learn about how body tissues react to chemicals and the proper use of painting tools. They will learn about the laws and regulations that apply to their profession and how these laws give them rights and protection.

Now, some of you may believe that OSHA (Occupational Safety and Health Administration) already protects these workers. In reality, OSHA inspects only a fraction of the construction projects and cannot protect workers with any predictability. Even when inspections do occur, OSHA investigators have discretionary authority to decide which violations merit enforcement action.

Today a vote on HB 1116 is a vote – and let me specify this – a vote for decency and fairness for the hardworking men and women we see every day and we represent. If you look at this ceiling up here, Mr. Speaker, and the walls of this chamber, skilled craftsmen proudly restored this historic structure for the people of the Commonwealth and future generations. Today I ask for your support for these skilled workers and painters.

I know there are problems, some problems, with this legislation, but I believe, in talking to the Senate over there, some of the problems that the other side of the aisle has addressed to me will be taken care of over in the Senate.

So I would appreciate your support on this important bill for workers.

Thank you, Mr. Speaker.

FAREWELL ADDRESS BY MRS. LAUGHLIN

I had two speeches that I wanted to give, and I did not know which one I wanted to give you, but Mike McCue said, "Why don't you give both of them?" So maybe I will do that. I will give the short one first.

As soon as I wake, Will Power helps me get out of bed. Then I go to see John. Then Charlie Horse comes along, and when he is here, he takes a lot of my time and attention. When he leaves, Arthur Ritis shows up and stays the rest of the day. He does not like to stay in one place very long, so he takes me from joint to joint. After such a busy day, I am really tired and glad to go to bed – with Ben Gay. What a life.

P.S. The preacher came to call the other day. He said that at my age I should be thinking about the hereafter. I told him I do, all the time. No matter where I am – in the parlor, upstairs in the kitchen, or down in the basement – I ask myself, "Now, what am I here after?"

Well, that was the end of the first speech.

Dear friends and colleagues:

After 32 years as a public servant, the first 16 years as my husband's, former Representative Charlie Laughlin's legislative aide, unpaid aide, and the second 16 years as the State Representative in my own right, I am honored by the confidence that the people of the 16th Legislative District have placed first in my husband and then in me these many years.

Matt Ryan, who, along with Leroy Irvis, spoke so eloquently at Charlie's funeral. It was there that Matt Ryan referred to Charlie as a statesman. I once thanked Matt Ryan for not giving my opponent any money, and he said, "Republicans don't believe in wasting money." Bill DeWeese, who I have known for 28 years and who has been a friend that I could always count on. Mike Veon and Senator LaValle, who have worked with me tirelessly to help the people of Beaver County. Keith McCall, who sat next to me the day I arrived in this chamber and welcomed me, and he also sat next to Charlie. Thank you for your friendship, Keith. Tony Melio, who also sat beside me. I will miss your enthusiasm for life, which means kisses and hugs. Frank LaGrotta, Vic Lescovitz, and Vince Biancucci for your support and friendship these many years. The Allegheny County delegation, who welcomed me with open arms when the 16th District extended into Allegheny County. John Perzel for never going after my seat, I think.

I would also like to thank the many Sergeants at Arms, pages, and messengers that have been so kind and helpful to me, but certainly, not least, I would like to thank my staff. I know that I could not have been as effective without the good support, working behind the scenes in my office.

Many have asked what I am going to do in my retirement. I am going to enjoy it. I know that when I am lounging on the beautiful beaches around the world, sipping pina coladas, that I will be thinking of you.

It has been a great honor and privilege to be a member of this great governing body and to represent the wonderful people of the 16th District. I have been blessed to learn and grow so much during my time as a Representative. It has been an Ivy League education in friendship, government, and life. It has been the experience of a lifetime, and I am grateful.

As I pass the Laughlin legacy of excellent public service to Sean Ramaley, who is replacing me, I am confident that he will serve the people of the 16th District as well.

My wish for those who will be sworn in for the 2005-2006 session is that you will commit yourselves to bipartisanship and service to the people, that you seek positive solutions for all the people of Pennsylvania.

I wish you all the very best in the future. May you all enjoy life, liberty, and the pursuit of happiness. I will remember you all and my years in this chamber fondly.
