# **CANADIAN DELEGATION INTRODUCED**

The SPEAKER. For the information of the members, today we are pleased to have a group of distinguished neighbors from the north who come to us from the second largest country in the world. Canada has over 2 million lakes, 38 national parks, crosses 6 time zones, and its citizens speak two official languages, French and English. It gives me great pleasure to introduce these notable Canadians. They are Consul General Roger J. Marsham, Consul and Senior Trade Commissioner David Weiner, and Delegate General Michelle Robitaille.

# **REMARKS BY** CANADIAN AMBASSADOR MICHAEL KERGIN

The SPEAKER. Finally, I am honored to have the special privilege of introducing the Canadian Ambassador to the United States, His Excellency, Michael Kergin, who will say a few words. Ambassador, please join me at the rostrum.

The AMBASSADOR. Thank you.

Now, that is what I call a warm Pennsylvania welcome on a cold day. Thank you very much.

Mr. Speaker, members of the House of Representatives of the great State of Pennsylvania, I must say how pleased and honored I am to be today here in Harrisburg, and a particular honor for a Canadian representative to have the privilege of addressing, albeit briefly, the House of Representatives at the beginning of a new 2-year session of your State Assembly.

Thank you, Mr. Speaker, John Perzel; House Majority Leader Samuel Smith; and House Minority Leader William DeWeese, for this unique distinction. The Speaker very kindly introduced my delegation, but I would not want to overlook the two most colorful members of our delegation, our two members of the Royal Canadian Mounted Police, who are there standing at attention in front of you.

You know, Canada and Pennsylvania share a rich and very colorful history. From the pre-Revolutionary era through to the present day, we have been shaped by our common experiences and mutual influences. Pennsylvania's impact on Canada has been significant, from the Pennsylvania loyalists who came to Canada after the Revolutionary War to a common immigrant settlement by Mennonite communities from Europe seeking refuge, to the Underground Railroad that wound its way through Pennsylvania with its terminus in Canada. During the past century, our sons and daughters have labored together to defend freedom and to aid society suffering from dictatorship or

subjugation, and in some cases, regrettably, they paid with the ultimate sacrifice.

Canada and U.S. relations operate on so many levels. Critical to our overall bilateral relationship is the role of State governments. This is particularly true in the case of Pennsylvania, exemplified by Canada's opening of a new consulate in Philadelphia last fall and the appointment of an honorary consul in Pittsburgh last spring.

If nothing else, ladies and gentlemen, we want to be part of Pennsylvania's football prowess, and if we cannot witness an epic final between the Eagles and the Steelers, we can still watch the Eagles soar.

We have brought with us today a wide-ranging delegation of individuals to meet with their respective partners in your State Capitol, and we very much hope to see you at our Canada Night in Harrisburg reception later today in the main rotunda.

In 2003 Canada was Pennsylvania's leading export market. Your State delivered 36 percent of its foreign-bound exports, a total of \$5.3 billion, to Canada. Our total two-way trade is worth over \$13 billion annually, and on an average day, we exchange \$36 million worth of merchandise alone. Of U.S. States, Pennsylvania has the seventh largest trading relationship with Canada, and we are here to make sure that we can do more.

In a recent study commissioned by our Embassy, Canada-U.S. trade supported some 219,000 jobs in Pennsylvania alone. In 2003 over 1.2 million Canadians visited Pennsylvania, enjoying your wonderful Commonwealth as tourists. This year marks the 10th anniversary of the Canada-U.S. Air Services Agreement, resulting in direct air Canada flights between Harrisburg and Toronto, linking the capitals of Pennsylvania and Ontario.

Our common interests cross many fronts, from the highly technological to the natural, for we both claim shorelines to the largest basin of fresh water in the world. With 20 percent of the world's fresh water flowing through the Great Lakes St. Lawrence System, Canada and the United States share an extraordinary resource as well as the responsibility to protect and manage the lakes for the benefit of generations to come, and I believe both countries have risen to the challenge through such historic and precedent-setting agreements as the Boundary Waters Treaty of 1909 and the 1972 Great Lakes Water Quality Agreement.

As great as the challenges before us have sometimes been, the response by our two countries to those challenges has always been greater. Our geography, cooperative spirit, and shared ideals have resulted in agreements across so many sectors, many inspired by actions taken at the State level. For example, much past collaboration between Canada and Pennsylvania was initiated under then Governor Ridge, chairman of the Great Lakes Governors association. More recently, in his role at Homeland Security, State Secretary Ridge with his Canadian counterpart pioneered techniques of risk management, facilitated the use of information technologies, to make our border more secure while minimizing the obstacles to our mutually beneficial exchange. His role as Governor of this Commonwealth and his firsthand experience with Canada have been a great benefit to our wider binational relationship, and I know that the close partnership will continue under Governor Rendell and future Governors-to-be. So we have a long history of friendship, close linkages, and much in common.

More than 50 years ago Winston Churchill pointed to the Canada-U.S. relationship as a model of international harmony when he said, and I quote, "That long frontier from the Atlantic to the Pacific Oceans, guarded only by neighborly respect and honorable obligations, is an example to every country and a pattern for the future of the world," end of quote. That neighborly respect and those honorable obligations are found in abundance in the Canada-Pennsylvania relationship.

So as you embark on your 2-year session, allow me to wish you every success in your deliberations. We look to Pennsylvania's leadership in the region and nationally in strengthening our stewardship over shared natural resources, our economic prosperity, and vibrant and ever-growing partnership.

# FAREWELL ADDRESS BY MR. LEWIS

The SPEAKER. At this time the Chair would like to welcome Representative Kelly Lewis for a few farewell remarks. Kelly.

Mr. LEWIS. Thank you, Mr. Speaker.

Today it is indeed an honor and special privilege to present final remarks to the Pennsylvania House of Representatives. To my House colleagues on both sides of the aisle, Minority Leader DeWeese, Majority Leader Sam Smith, and Speaker John Perzel, I thank you for this opportunity.

My family has lived in Pennsylvania for more than 300 years. All four of my grandparents had ancestors in the Continental Army that fought the English and won our freedom. We helped settle parts of Bucks, Northampton, Lehigh, Sullivan, Lycoming, and Monroe Counties. We have lived in Monroe County since before 1736. We are proud to be Pennsylvanians, and my service in the Pennsylvania House of Representatives was rewarding to many family members, relatives, and to me.

So let me begin where all politics starts, at the family dinner table. I first want to thank my parents, Horace and Sonya Cole and Harry Lewis; my siblings, Kevin, Chris, Brandon, Adam, and Denise; my friend, Deb; my extended family; and especially my two beautiful children, Nashua and McKenna. My children remain the focus of my life, and they make me a very happy man.

Second, I want to thank my district team. I had a great team of energetic leaders, including Gwen Stettler, Jon Jorgenson, Laura Statler, Bob Marinellie, Patty Beecher, Michael Iadarola; my many interns; and from my campaign, Dave Piatt, Robert Weseloh, and my campaign committee members; Daphne Uliana; and my friends at HRCC (House Republican Campaign Committee).

Just like summer patriots, it is easy to support elected officials when everything is going well, when victory is in sight. To my faithful supporters, family, and friends that stayed the course when times were tough, that stayed true to the cause when victory was in doubt, to you I express my deepest thanks, love, and appreciation.

I enjoyed every moment of my 8 years in public service, 4 years as Monroe County controller and 4 years in the Pennsylvania House. To me, politics is about fighting for what you believe. Just like Theodore Roosevelt always said, "The Victory goes to those who step in the ring!" To those of you in the ring, my House colleagues, I send you warm regards and best wishes. Keep fighting the good fight.

Many people, including our excellent committee staff, helped our team get a lot of great things done for Monroe and Pike Counties in a very short amount of time. The public record speaks for itself. Our team helped change the school funding formula and added the growth supplement to help school districts with enrollment growth. I encourage my colleagues to stay the course, increase the growth supplement, and maintain fairness in per-student education funding.

In 2004 we passed Act 72, the Homeowner Tax Relief Act, which provides major school property tax relief to homeowners that need it most. Accordingly, I urge every school district to fully pass and enact Act 72 tax relief as soon as possible.

There is a laundry list of other issues we helped lead, including highway safety, fund balance caps, wireless and statewide radio rollout, electric DSIC (distribution system improvement charge), Megan's Law updates, safe-baby legislation, and Right-to-Know Law protections and many others.

In 2001, in memory of 15-year-old Gregory Moyer, we helped Pennsylvania become the national leader in placing heart defibrillators in our schools and public buildings. Our good work continues to save lives. Many people in this chamber helped advance this issue, and I thank you. I encourage my colleagues to continue to invest in public safety technology and medical technology to improve our lives. When technology advancements provide the cure for killer diseases like colon cancer and other illnesses, I encourage my colleagues to act promptly to save lives and reduce health-care costs.

In our world, technology leadership is vitally important, and I take my leave from public service to help Pennsylvania get the technology and technology investment we need to compete against other States and nations. We are at a dynamic crossroads in history. Today's technology permits the immediate outsourcing of entire industries to other States and nations. As president and CEO (chief executive officer) of the Technology Council of Central Pennsylvania along with our 350 members, I will lead efforts to help our Pennsylvania companies become and remain the technology leaders in their industries so they can compete nationally and globally. To compete, we absolutely need the best telecommunications systems in the world and we need better infrastructure. To remain competitive, we need lower taxes, less red tape, and corporate and public policies that tirelessly promote Pennsylvania.

A lesson can be learned from football. When recruiting high school athletes to play football at Penn State or Pitt, recruiters do not complain about being 45th in this category or 48th in that category. No; instead, football recruiters talk about the positives. They talk about Pitt and Penn State traditions, their game plans for the future, their excellent educational programs, and most importantly, their excellent graduation rates. For economic development, I encourage Pennsylvania to do the same. To keep our top students, we need to promote the great things happening in Pennsylvania right now. We need to promote our strengths and quickly correct our weaknesses.

I end my remarks with some hopes, thoughts, and special thank-yous. To the new members, I encourage you to listen and learn. There is amazing history within these walls and a great opportunity to do great deeds. Very soon I look forward to working with my successor in the House. I believe she will do a great job.

I want to thank my good friend, Mario Scavello, for his friendship and his tireless hard work for Monroe County. I also want to thank my good friend, Craig Dally, for his counsel, diet sodas, and many car rides to dinner.

To the karaoke caucus, you will sound much better without me.

To my House colleagues, House classmates of 2001, I wish you all well.

I thank Representative Sam Smith for his excellent advice, sometimes late into the evening. I thank Representative Dave Argall for his ski tips and his help on our downtown initiatives. I thank Representative Brett Feese for his first pep talk and many others and many long conversations.

I thank my friends at HRCC for letting me help. It was always fun, and as always, no matter who is singing, it is never over.

I also want to publicly thank our former Speaker, Matthew Ryan. He remains an inspiration to me and to many others.

Finally, Speaker John Perzel. In 1999 I met you in a McDonald's in Lake Harmony, and my life has never been the same. On many occasions you stuck with me when others would not and did not, and for that, you have my gratitude, my respect and admiration. Thank you.
