#### RESOLUTION

Mr. S. SMITH called up **HR 45, PN 166,** entitled:

A Resolution providing for the adoption of a temporary rule relating to the consideration of House Resolution No. 2.

On the question,

Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

We have not caucused on HR 45 yet - we caucused on HR 2 - and this is the first we are hearing of this. So I would ask that we pass over this so we can have a chance to caucus on HR 45.

The SPEAKER. The resolution is exactly as written as Resolution No. 2, except for one number. Instead of House Resolution No. 1, it says House Resolution No. 2, Mr. Vitali.

Mr. VITALI. Will the maker of the amendment stand for interrogation?

The SPEAKER. The gentleman, Mr. Smith, indicates he will stand for interrogation on HR 45, PN 166. On that question.

Mr. VITALI. I am a little confused now. As I understood HR 2, what it would have done was to make HR 1, which are the rules in chief, unamendable. Now, what does HR 45 do?

Mr. S. SMITH. Mr. Speaker, as the resolution reads, it is only six lines long, the last two lines providing that HR 2 be an unamendable resolution. That is exactly what it does.

Mr. VITALI. Mr. Speaker, what is the purpose of HR 45?

Mr. S. SMITH. To make HR 2 unamendable.

Mr. VITALI. And what is the purpose of making HR 2 unamendable?

Mr. S. SMITH. I think the answer is obvious. It makes it unamendable.

Mr. VITALI. Towards what end? In other words, Mr. Speaker, why would you want HR 2 unamendable?

The SPEAKER. That is not an appropriate question, Mr. Vitali.

Mr. DeWEESE. Mr. Speaker?

Mr. VITALI. I still have the floor. I do not know; is the gentleman asking for me to yield temporarily?

Mr. DeWEESE. To your benefit, yes, sir.

Mr. VITALI. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Just for the clarification of the members, if the gentleman, Mr. Smith, was inclined to answer the gentleman's interrogatory, it would have been acceptable, and I, again, am not trying to be argumentative in this case, but why would the Parliamentarian say that it was inappropriate, because of the subjective nature of— Okay. I just was curious, because I thought the gentleman, Mr. Smith, was about ready to answer the question in more detail, and if he were not, so be it.

Mr. S. SMITH. Mr. Speaker?

The SPEAKER. It went to the motive of a member of the General Assembly, and motives cannot be questioned.

Does the gentleman, Mr. DeWeese, wish to be recognized again?

Mr. DeWEESE. Yes, sir. I mean, I do not know, this is a very fine line, and you have the gavel, as I am reminded on many occasions. But I think the gentleman, Mr. Vitali, is only anxious for a more capacious explanation, not the motives of the floor leader but why he does not want it amended. And the why does not have anything dealing with what is upwelling within his breast; it is why in his cognitive or ratiocinative processes he does not want it amended. So I think the gentleman Vitali is not being dilatory; I think he wants to know why the majority or all of us that may agree with Mr. Smith are not wanting this amended. Why are we not wanting this amendment or this rule or this resolution amended? So I think it is a close call, but if the gentleman were interested in answering it, it would be informative and helpful to the membership.

The SPEAKER. The gentleman, Mr. Smith.

Mr. S. SMITH. Mr. Speaker, I was simply going to ask you if seeking one's motives, you know, a question that challenges one's motives or seeks one's motives for doing something, was in order and within the rules. I thought that was something that was outside the rules of the operations of the House.

The SPEAKER. The gentleman is correct. That is why Mr. Vitali was told that that question was not to be answered.

Mr. VITALI. Thank you, Mr. Speaker.

May I proceed?

The SPEAKER. Mr. Vitali.

Mr. VITALI. I apologize. I was not clear. When I asked you, why did you do that, I was not asking for your personal motives – my mistake. I was asking, what are the policy reasons for making HR 2 unamendable?

Mr. S. SMITH. Mr. Speaker, I think the purpose is clear. HR 45 would make HR 2 unamendable. The policy reasons, if you want to frame it that way, are to allow us to proceed to

enact the permanent rules of the legislature so that we can proceed with the business of the Commonwealth.

Mr. VITALI. Thank you, Mr. Speaker.

I would like to speak on the resolution.

The SPEAKER. The gentleman is in order and may proceed.

Mr. VITALI. Thank you, Mr. Speaker.

I would call for the defeat of HR 45. It is pure artifice. It is clearly a device to prevent House members from attempting to amend the House rules.

In point of fact, I have six, make that seven amendments to HR 2, which would allow me to deal with, amend, HR 1. These are important amendments that deal with ghost voting, for example. These are amendments that deal with notice of committee meetings. These are amendments that involve reading the title of a bill before voting on it. These are amendments that deal with things like public service announcements and the use of Commonwealth funds for that. These are amendments that deal with lobbying, the rules of lobbying. These are amendments that deal with the scope of debate on concurrence votes.

The bottom line is this: If you want to cut off debate and settle for the ghost voting rules as they are, then you will vote for HR 45. If you want the opportunity to vote on things like lobbyist disclosure and whether lobbyists need to file reports, if you want to vote on things like public service announcements, if you want to limit ghost voting, if you want a title of a bill read, things like that, if you want that sort of debate, you have to vote "no" for HR 45, because by voting "no" for HR 45, we can have a real debate on this issue.

Thank you.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker.

I also rise in opposition to HR 45, which, as stated clearly by the majority leader, is proposed in order to limit amendments, prohibit amendments, on HR 2. Well, amendments are as old as the legislative process itself. They are mentioned in the Constitution of Pennsylvania. They are mentioned in the rules that we had for this House of Representatives just last session. And I just checked HR 1, which is the proposed rules which we will be considering later on this afternoon. HR 1, which is proposed by the majority leader, has at least two pages dealing with amendments. And so amendments are central to our legislative process; they are even part of the rules that we will be voting on later this afternoon, yet the very first substantive bill that we are voting on this year, we are asked to limit amendments. That makes no sense. What are we afraid of?

Let us discuss the rules of the House, let us debate the rules of the House, and let us have the opportunity to consider amendments.

Mr. S. SMITH called up HR 2, PN 114, entitled:

A Resolution providing for the adoption of a temporary rule relating to the consideration of a resolution providing for the Rules of the House of Representatives.

On the question,

Will the House adopt the resolution?

The SPEAKER. Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker.

I would just like to repeat for the public record, the House just passed HR 45, which limits amendment on this one that is before us now, but it does not limit debate, and the substance of what we are voting on now, HR 2, basically says, when we consider the rules of the House, presumably in a few minutes, we will be able to have no amendments. I have an amendment filed

The rules of the House that are going to be before us in a few minutes have a very controversial provision. Currently you have to be in the hall of the House to vote. The proposal that may be before us in a few minutes would change that to you have to be in the Harrisburg area, a very vague term which could be defined a number of ways. I have an amendment that would take the language that is being proposed, the "Harrisburg area" language, and change it back to the tried-and-true rules that we had in place in the 2003-2004 sessions. If HR 2 is approved, I will not be able to offer that amendment. If HR 2 is approved, the other six or seven or eight amendments that have been filed will not be able to be offered.

By voting "yes" on HR 2, you are limiting debate on the rules of the House, limiting debate on amendments that could change the rules of the House, and I urge a "no" vote so that we can debate the rules and consider timely amendments.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

I will not beat a dead horse. I do want for the record to urge a "no" vote on HR 2, and the reason is, it would prevent the seven amendments I have filed to HR 1 from being considered. Those amendments involve narrowing ghost voting. Those amendments involve lobbying registration. Those amendments involve prohibiting Commonwealth funds for legislative public service announcements, notice of committee meetings, and also reading a bill or analysis.

# Mr. S. SMITH called up HR 1, PN 113, entitled:

A Resolution adopting Rules of the House.

On the question, Will the House adopt the resolution?

## CONSTITUTIONAL POINT OF ORDER

The SPEAKER. On that question, the gentleman, Mr. Vitali. Mr. VITALI. Thank you, Mr. Speaker.

I rise for the purpose of making a motion.

The SPEAKER. The gentleman will state his motion.

Mr. VITALI. Mr. Speaker, I move that HR 1 be declared unconstitutional as violative of Article III of Pennsylvania's Constitution

The SPEAKER. Would the gentleman give us the section number of Article III?

Mr. VITALI. I would be happy to make argument at the appropriate time, Mr. Speaker, yes.

The SPEAKER. We need that now, Mr. Vitali.

Mr. VITALI. That would be sections 4 and 5.

The SPEAKER. The gentleman, Mr. Vitali, raises the point of order that HR 1 is unconstitutional. The Speaker, under rule 4, is required to submit such questions affecting the constitutionality of a bill to the House for decision, which the Chair now does.

On the question,

Will the House sustain the constitutionality of the resolution?

The SPEAKER. The Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Sections 4 and 5 of Article III of Pennsylvania's Constitution deal with the passage of legislation, and it talks about members voting for the passage of bills and amendments and concurrence votes and all forms of votes. Nowhere in this section does it authorize a member to have another member vote for him.

Mr. Speaker, the rules in HR 1 would, in my view, unconstitutionally authorize a member, a leader, not duly elected by the constituents of a given district to vote for that district. I see nowhere in this section that allows for proxy voting, and therefore, I would hold that these rules would be unconstitutional.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the majority leader, the gentleman, Mr. Smith.

Mr. S. SMITH. Mr. Speaker, I would urge the members to vote against this constitutionality question.

First of all, I do not believe that the Constitution goes so far as to tell us exactly how we would run the House of Representatives. I think the past practices would indicate somewhat to the contrary. And likewise, I think you could suggest that there has been some precedent set for years by the Senate, which has a similar rule that allows for some type of Capitol leave, where you are not actually on the floor at the moment of a vote.

So given the past practices, given the fact that the Senate has been doing something similar to this for many years and that ultimately the courts have generally given the legislative bodies the freedom to try to run their business as the body, as a majority, sees fit, I would urge the members to reject the motion of constitutionality on HR 1.

The SPEAKER. Would Mr. Vitali please come to the rostrum.

Mr. S. SMITH. Mr. Speaker?

The SPEAKER. For what purpose does the majority leader rise?

Mr. S. SMITH. If necessary, would you clarify which way the vote would be—

The SPEAKER. Absolutely, Mr. Smith.

Mr. S. SMITH. Some of the members were concerned as to which way we were actually advocating, and sometimes those

questions get framed in the negative, so if you would clarify that, if necessary.

The SPEAKER. That will be done, Mr. Smith.

(Conference held at Speaker' podium.)

#### LEAVE OF ABSENCE

The SPEAKER. The Chair returns to leaves of absence.

The majority whip requests a leave of absence for the gentleman from Delaware, Mr. MICOZZIE. Without objection, that leave will be granted.

#### CONSIDERATION OF HR 1 CONTINUED

The SPEAKER. For the information of the gentleman, Mr. Vitali, we will continue with his motion.

The gentleman, Mr. Gannon. The gentleman waives off.

For the information of the members, those voting "aye" will be voting to declare the resolution to be constitutional; those voting "no" will vote to declare the resolution to be unconstitutional.

Mr. DeWEESE. Mr. Speaker?

The SPEAKER. Mr. DeWeese.

Mr. DeWEESE. Just as a matter of record, if the House were to vote "no," we would be declaring the procedures of the State Senate for the last umpteen years to have been unconstitutional. Is that correct?

The SPEAKER. The gentleman has a valid point, but nothing we are doing has anything to do with the Senate, according to our Parliamentarian.

Mr. DeWEESE. I would thank the Parliamentarian for his usual sagacity and his unremitting enlightenment relative to our parliamentary exchanges. I would think, though, on a practical matter that if we were to declare this unconstitutional as the honorable gentleman, Mr. Vitali, desires, we would be in essence saying that our brothers and sisters in the State Senate have been behaving in an unconstitutional fashion for the last several decades.

Mr. S. SMITH. Mr. Speaker, is the gentleman trying to get votes for or against this?

Mr. DeWEESE. I thought the same thing. I better be quiet.

The SPEAKER. For the information of the gentleman, had we had the same rules as the Senate and found this to be unconstitutional, then all of the prior times we voted for the rules for the last, well, in the Senate's case, since 1790, would have been invalid.

Mr. Smith.

Mr. S. SMITH. I will let that one go, Mr. Speaker.

The SPEAKER. One more time. Those voting "aye" will vote to declare that the resolution is constitutional. Those voting "no" will vote to declare that the resolution is unconstitutional.

On the question recurring,

Will the House sustain the constitutionality of the resolution?

The majority having voted in the affirmative, the question was determined in the affirmative and the constitutionality of the resolution was sustained.

On the question recurring,

Will the House adopt the resolution?

The SPEAKER. Mr. Samuelson.

Mr. SAMUELSON. I rise to speak on the resolution.

The SPEAKER. The gentleman is in order.

Mr. SAMUELSON. Thank you, Mr. Speaker.

I rise to oppose HR 1.

I know that this General Assembly previously passed a rule saying that we could not amend HR 1, so before us today are the proposed rules, take them or leave them.

This resolution, on pages 69 and 70, includes a section that would change the current House rules, which say you have to be in the hall of the House to vote, to a much weaker provision that says members of the House of Representatives have to be in the Harrisburg area to vote. This is a significant change, and I oppose this change for several reasons. I believe such a change would demean the institution of the House of Representatives. I believe that it is also unworkable, and I also believe that it would diminish the debate that takes place in the House of Representatives.

Yesterday I had a conversation with my brother, and he asked me what the General Assembly was going to be doing this week, and I said, well, the majority leader is going to propose that we no longer have to be in the House of Representatives; we can be anywhere within the Harrisburg area. He laughed uncontrollably. I believe we are going to hear a lot of that from our constituents. If we pass this rule that says that we only have to be somewhere within the Harrisburg area – you can look it up on page 70; the words "Harrisburg area" are used – we are going to open up this General Assembly to many questions: Who is present to vote? If they are not here, where are they? Who is enforcing? Who is keeping an eye? How do we know that all the Representatives are really in the Harrisburg area as they purport to be?

Our constituents sent us to Harrisburg to represent them. They did not send us to Hershey, to Carlisle, to Grantville, to York, or anywhere in the Greater Harrisburg area. Our constituents expect us to be here in the Capitol; our constituents expect us to be here in this room debating the great issues of the day.

I believe this change is also unworkable. This resolution is 84 pages long, but you will not find a definition of what is meant by the "Harrisburg area." I tried to do some research. I looked up on the Internet, what does Harrisburg Area Community College believe its boundaries to be? Harrisburg Area Community College lists nine counties on its Web site: Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Perry, Schuylkill, and York. What if the interpretation of this rule was as broad as that of the Harrisburg Area Community College and members could be anywhere within those nine counties? The Harrisburg Regional Chamber of Commerce lists three counties. South Central Pennsylvania Counter Terrorism Task Force also lists nine counties.

What about the booklet that we hand out to our constituents about tourism in Pennsylvania? This is a previous version of that booklet. That describes Harrisburg as part of the Hershey, Gettysburg, Dutch country region, and if you open it up, there is a map that has nine counties in south-central Pennsylvania. You see where I am going with this. In the future some legislative leader could perhaps say that we are part of the Susquehanna River Watershed, which connects to the Chesapeake, which connects to the Atlantic. There is no end in sight. What if they start using a definition of "Harrisburg airspace"?

Think of another aspect of how unworkable this provision is. What if you wanted to interrogate another member about the provisions of a bill, and what if at the moment you wanted to interrogate them they were 30 miles away, in the Harrisburg area, which would be permitted by this resolution? It would make our legislative process grind to a halt.

Also, what enforcement would there be to say that we are in the Harrisburg area? Would there be electronic monitoring devices that would have to be worn by the members of the General Assembly? Would we each have to wear a global positioning system? There would be no practical way to know whether this provision would be adhered to.

Finally, I am greatly concerned about the impact such a change would have upon the debate of the House of Representatives. We are the oldest legislative body in the United States. The General Assembly of Pennsylvania has been in existence longer than the United States Congress, and we all know what the legislative process entails. There is give-and-take; there are amendments; there is discussion; there is debate. In fact, when you have a school group visit Harrisburg or when you visit a school in your district, you probably hand out this booklet, which talks about the Capitol and the legislative process. If you get a chance, turn to page 23. We might have to print up new booklets, because on page 23, it says - it has a nice picture of the General Assembly -"On session days, the Chamber is the busy workshop of 203 Legislators and 100 or more clerks, pages and staff assistants," and then it goes on to talk about other aspects of our legislative process. We may have to print a new book to explain why in the future this chamber will get emptier and emptier.

You and I have been present for debates where a persuasive argument can carry the day and a close vote can turn on an argument that is made on the floor of this House. If this rule passes and members can vote from other locations in the Harrisburg area, fewer and fewer members will attend the sessions of this House, fewer and fewer members will hear the debates, and our debates will become less and less effective. Think of it. You could make a brilliant speech on the floor of this House before an empty room, but the votes will be cast in a prearranged fashion, and the debate that you took place in, the argument that you made, will have little effect on the final result.

Over time the value of the public debate in this chamber will be devalued. We serve in the General Assembly of Pennsylvania, and part of being an assembly is to assemble. Our legislative process works only when we are gathered together in the hall of this House – one Representative from each district gathering together to interact, to ask questions, to build coalitions, to share our perspectives, to debate the issues of the day, and to vote in person on the legislation before this General Assembly.

I believe this proposed rule opens up a Pandora's box, and as I said, it is unworkable and would greatly diminish the debate that takes place in this General Assembly.

I urge a "no" vote on HR 1.

Thank you, Mr. Speaker.

Mr. S. SMITH. Mr. Speaker? Mr. Speaker?

The SPEAKER. The Chair thanks the gentleman.

Mr. Smith.

Mr. S. SMITH. May I, on the resolution?

The SPEAKER. The gentleman is in order.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, what I just heard sounded if not out of touch with how this House has operated for all the years that I have been in the legislature, it sounded close to hypocrisy, because if we look at how this House has operated over the years, many times, I hardly think there is a member here that has not left the floor of the House for some legitimate reason, whether it is to

meet with a group of constituents in their office, to just greet some people, to talk to someone in the back of the hall of the House relative to some legislation that they are working on, other legislative-related meetings. All of this, this rule clearly spells out, that their purpose for not being here has to be related to the operations of the House, the legislature, the process here. It has nothing to do with anyone's personal business per se.

The fact is, you are kidding yourself if you think that by not having this type of workable leave rule, everybody is going to be here every minute that we debate every issue in this House. I do not know how the leaders would be able to negotiate a budget if we had to shut down the legislature for hours at a time when we regularly meet with the administration and the leaders of the Senate as we are trying to negotiate some of the items in a budget. I would be breaking the rules to leave the House floor for that purpose.

So, Mr. Speaker, I think it is way overstating the responsibility, and I think it clearly is a slap in the face to the members of this House that work diligently on behalf of their constituents. Whether they are in their seat at the moment the vote is taken or whether they happen to be somewhere else in this Capitol Building, I think the vast majority of the members of this House are here to represent their constituents, and they are doing the right thing, and just because they are out of their seat for a little bit for other legislative business that may be of equal importance or even greater importance in some cases. I mean, there are times we are voting things here that some of us really are not all that interested in. It may be important to me on any given day and not important to you or vice versa. But the fact is, we do have other business that we have to take care of on behalf of our constituents.

To suggest that somehow this rule is going to deteriorate or reduce the quality of the debate, no, that is up to each of us as individuals to carry that torch. If we as individuals cannot make the debate for the cause that we are advocating, that is our fault. That is not the fault of somebody who maybe had some other business in the Capitol area or over at PHEAA (Pennsylvania Higher Education Assistance Agency) or down at the PENNDOT building or somewhere else. That is up to each individual member to carry that debate. And clearly, if a situation occurred where a member who was off on Capitol leave was critical to the order of the debate, as we always have done in the past, we accommodate that through setting something aside or tabling it to the next day, if necessary.

I just think it is a total misrepresentation of what really has been going on here, and to suggest that by voting against this rule and keeping the rule as it has been in the past, that is just phony, that is just being a phony; it is not the truth. The fact is, lots of times half the members are back in their offices doing other things. I say "half" figuratively. So to suggest otherwise is just crazy.

This particular rule allows us something that is more manageable and allows us to stay within our rules more appropriately, and I would urge the members to vote for HR 1.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

## MOTION TO SUSPEND RULES

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

I rise for the purpose of making a motion.

The SPEAKER. The gentleman will state his motion.

Mr. VITALI. Thank you, Mr. Speaker.

I would rise for the purpose of suspending HR 2 to consider amendment 10 to HR 1, and that would tighten up HR 1 so that when you give a proxy for voting to your leader, it would specify the particular thing you are voting on and which way you wanted to vote, and I think that would tighten this up a bit to sort of prevent this devolution of power from rank and file to leadership. So I would so move.

The SPEAKER. The gentleman's motion is in order. It is only debatable by the floor leaders.

On the question,

Will the House agree to the motion?

The SPEAKER. On that question, Mr. Smith.

Mr. S. SMITH. Mr. Speaker, I would oppose the motion to suspend the rules for the consideration of that amendment.

If the purpose of the rules — and this is what I think the purpose of the rules is — is to create a framework where we have some level of predictability as to how the business of the House is carried out, so that we have some framework that we generally will operate under and agree that from time to time we suspend the rules to expedite the business of this House, the short-version description provided by the gentleman I think would only encumber this House and make it even more difficult to carry on the business that we may have at hand.

So I urge the members to vote against the motion to suspend the rules.

The SPEAKER. The gentleman from Greene, Mr. DeWeese. Mr. DeWEESE. Thank you, Mr. Speaker.

These negotiations that result in the proposal that we are considering now have gone back and forth for quite some time with not only leadership and leadership staff but with many of our rank and file.

I think what we have is a tempest in the proverbial teapot. I do not think we need to suspend the rules the way the honorable gentleman, Mr. Vitali, wishes. I think that— And again, I know this is repetitive, but it is all the undergirding of what we are going to be doing the next 2 years in this room. I do not fathom that there will be very many times when people will take Capitol leave. When Representative Shaner has constituents from one of his school districts and he and I have to go to the Department of Education at 1 o'clock till 2 o'clock, heretofore, heretofore, if we had been voted, we had been in gross violation of the rule. Now, with the mechanism that we are trying to employ, the same one that the State Senate has lived with for a long time, Mr. Shaner and Mr. DeWeese could take Capitol leave for 1 hour, it would be read across the desk, and that would be it.

I just cannot think that there is any mischief at hand. I think the gentleman means well, but I certainly do not think we need a suspension of the rules. I am going to agree with the gentleman from Jefferson County, Mr. Smith.

The SPEAKER. The Chair thanks the gentleman.

Less than a majority of the members required by the rules having voted in the affirmative, the question was determined in the negative and the motion was not agreed to.

On the question recurring, Will the House adopt the resolution?

The SPEAKER. The Chair recognizes the gentleman from Lawrence, Mr. Sainato.

Mr. SAINATO. Thank you, Mr. Speaker.

I rise today to oppose HR 1.

Many of the remarks that my colleague from the Lehigh Valley made I would like to echo. I have been in this legislature 10 years. In those 10 years I have been here, I have never missed a day. I come when I am supposed to be here; I leave when we adjourn. What this thing does here today is to totally change the operation of the Pennsylvania House of Representatives, the oldest House of Representatives in the country, and now, Mr. Speaker, someone else can vote for you if you want. You go on Capitol leave, and someone else will be voting to represent the 60,000 people that you represent.

I believe the most important job of a legislator is to be here on the House floor. There should be nothing more important than being here to vote for the 60,000 people you represent. As the prior speaker said, well, you may have to go out and greet some schoolchildren or you may have to go to a meeting at the Department of Education. You schedule those meetings when we are not on the floor. Mr. Speaker, you have done an excellent job of telling us when we are supposed to be on the floor. If I have a group here, they are welcome to sit up there in the House gallery and see their legislator working.

This really disturbs me, Mr. Speaker, this really does, because I believe in this institution, I believe in this House of Representatives, but what we are doing here today will forever change what we have done in the 200-plus years that this institution has been here.

Mr. Speaker, ghost voting is wrong, ghost voting is wrong, and for those who do, shame on you. But, Mr. Speaker, Mr. Speaker, I honestly believe we are making a very big mistake here today. I have a lot of respect for my colleagues on both sides of the aisle, and I think they all work very hard at what they do, and for the few, for the few who have caused problems over the years, shame on you for not being here to represent the people. And if you do not want to be here, I think everyone should know that you are not here, so when you fill out your Capitol leave form to tell everyone that there is something more important than to be here in the House of Representatives, I just hope it is a nice public document so everyone can see what Capitol leave is, that you do not want to be here to represent your 60,000 people. But let me assure the 60,000 people of the 9th District, I plan on being here before the session starts, I plan on being here when the session ends, and I will do the job I was sent here to do, and I do not support ghost voting.

Thank you, Mr. Speaker.

The SPEAKER. The gentleman from Beaver, Mr. Veon.

Mr. VEON. Thank you, Mr. Speaker.

Mr. Speaker, I rise to support HR 1, and I echo some of the comments made by the majority leader here today, and I would like to make some additional, very quick comments.

Mr. Speaker, a number of the folks here on the floor today have talked about the long tenure of this House of Representatives, and that is true, and I had the opportunity to go back and look at some of that long tenure and think about and actually read the record on how those votes were cast over so many years, and there was a time here in this House chamber when the "yeas" and "nays" were literally read off on a roll call, one by one, and a clerk wrote down those votes as they were cast. And then at some point, Mr. Speaker, somebody said

we ought to have an electronic roll call and that would be an improvement in the State legislature, in the House of Representatives, and there were people, if you go back and look at that record, that said you cannot do that; it would be the end of the State legislature as we know it; we have had this long history in the legislature where we have always stood up and given the "yeas" and "nays" in the chamber, and anything different than that will be the end of the State legislature, the State House, as we know it; it will be the end of the world.

Mr. Speaker, we put an electronic scoreboard in, we have our names on lights, and we have an electronic button on our desk, and it has not been the end of the State House as we know it. I think, in fact, you can make the case that in many ways it has been an improvement to the system that we have had here, and in so many other ways, Mr. Speaker, I would make the case that this job has evolved over years; it has changed over years. The assignment of legislators today is different than it was 20 years ago. In many ways it is more complicated and complex. We are expected to deal with more difficult, complicated, complex issues today, each and every one of us, and I am proud of the members that do that on both sides of the aisle and I think do it well.

This rule we are talking about here today, Mr. Speaker, in fact does away with ghost voting, and this rule we are talking about here today, Mr. Speaker, is a rule that the State Senate has had in place for 21 years, and they have survived and they have thrived and they have served the people of Pennsylvania well over the course of those 21 years. This rule is the same as the rule that the State Senate has today. In fact, Mr. Speaker, you could make the case that the Senate rule is even more liberal than what we are offering here today and that you can be on legislative leave somewhere outside of the Harrisburg area and still be voted on the Senate floor by your leader if on legislative leave, and this is more restrictive than that provision, but that more restrictive provision is the same as the Harrisburg area legislative leave in the State Senate. It has served the Senate well. This rule change will serve the House well as we do our job in this century, at this time, under these rules, under these conditions, and in these times.

I would ask for an affirmative vote.

Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Samuelson, for the second time.

Mr. SAMUELSON. Thank you, Mr. Speaker.

The previous speaker said this resolution does away with ghost voting. I respectfully disagree. I believe that the legislation before us would actually enable and encourage ghost voting; that if someone could take a legislative leave anywhere within the Harrisburg area, fewer and fewer members will be coming to the floor of the House.

A couple of the previous speakers talked about Capitol leave and talked about the quick meeting just off the floor of the House or elsewhere in the Capitol Building, yet the bill before us, the legislation before us, does not mention Capitol leave. It is actually called Harrisburg legislative leave, because this legislation is not limited to just the Capitol Building. So the arguments that were used about a quick meeting on the other side of the Capitol, if that is the problem, then why is the solution anywhere in the Harrisburg area, which could be defined as widely as nine counties?

I believe that the current schedule does allow some flexibility. If you read the current House rules, it does not say

you have to be in your seat; it says, anywhere "...within the Hall of the House...." If you are meeting with a school group in the back of the chamber – that is about 40 feet away – you can still vote. If you are just off the floor of the House, sometimes the legislative schedule has breaks. Just this afternoon, at 4:45 there was a 10-minute break in the legislative schedule while the Parliamentarian considered some amendments, and this House was at ease for 10 minutes. We were in caucus earlier this afternoon. There could be even more flexibility built into the schedule at the discretion of the leadership of this House. If we are in a debate that is going to last 6, 7, 8, 9 hours, the leadership of this House could schedule a half-hour break for supper or a 45-minute break for supper.

So I believe the current system does provide some flexibility. If we switch to a system that allows you to vote anywhere in the Harrisburg area, there is no enforcement, there is no definition, and where might this lead in the future? What would the ghost vote of legislatures yet to come be like, with apologies to Charles Dickens? Would the ghost vote of legislatures yet to come, would that then extend to anywhere in Pennsylvania? In the future some members may argue that certain legislators have their district offices within the Harrisburg area and they are permitted to vote from their district offices. Why not every legislator? Would we then be in the future expanding this to anywhere in Pennsylvania? What about a few years from now somebody proposing, why do we not just vote by Internet? Why do we not just vote by our palm pilots?

This is a slippery slope that this legislation seeks to embark down, and I believe that changing our rules to allow voting within the Harrisburg area, an undefined region, will lead to more problems for this General Assembly. Let us keep the current rule. Let us vote down HR 1.

The SPEAKER. The Chair thanks the gentleman.

#### MOTION TO SUSPEND RULES

The SPEAKER. The Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

I rise for the purpose of making a motion.

The SPEAKER. The gentleman will state his motion.

Mr. VITALI. Mr. Speaker, I rise for the purpose of moving that HR 2 be suspended for the consideration of amendment 9 to HR 1, which would install in our House rules the identical rules with regard to lobbying that the Senate has; to wit, registration statements and quarterly expense reports.

On the question,

Will the House agree to the motion?

The SPEAKER. On the motion, the Chair recognizes the gentleman, the majority leader, the gentleman, Mr. Smith.

Mr. S. SMITH. Mr. Speaker, I would rise to urge the members to vote against this motion to suspend the rules.

Clearly, when we put together rules, we could come up with 203 versions of what each of us may view as an ideal set of rules. The fact is, we all cannot have our own set of rules. The fact is that a consensus has to be built where the majority – and hopefully sometimes it is a bigger majority than others – are comfortable with the rules, and there is a certain give-and-take in it. The rules as presented under HR 1 are rules that I think

meet the basic needs of this House to carry on its business in an appropriate and honorable fashion.

Likewise, Mr. Speaker, I would urge the members to vote against the suspension of the rules as presented.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader, the gentleman, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

The inexorable momentum of Mr. Smith's argumentation is obvious. The votes are not there to sustain the honorable gentleman, Mr. Vitali, but this does have much public service value, and I will accede to him. I will relinquish the microphone and let him argue on behalf of our side.

Thank you, Mr. Speaker.

The SPEAKER. You did make an argument, Mr. DeWeese.

Mr. DeWEESE. With all due respect, all I did was try to describe the landscape. I did not make an argument.

The SPEAKER. The gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

What I am suggesting is something relatively uncontroversial and very pertinent to what we are doing right now. We are passing rules, and the Senate rules, which all lobbyists in Harrisburg must conform to, involve lobbyists' initial registration forms and quarterly expense reports.

What I am suggesting is that this is the appropriate time for the House in making its rules to do just what the Senate did, and I think there are very good policy reasons for our rules to conform to the Senate rules. Unfortunately, in the absence of legislation, rules are the backstop, rules are the backstop in the absence of legislation, to deal with the important issue of lobbying, and that is important, and it is also important for consistency with lobbyists. Lobbyists have to adhere to the rules of the Senate, so they are really dealing— Right now it is unbalanced. There also should be a parallel companion set of House rules. What this would do would simply be able to allow the citizens of the Commonwealth to keep track of who was lobbying, for what purposes they are lobbying. The rule requires the general subject of the thing being lobbied, and it also requires those quarterly reports to list expenses for various categories of lobbying, as the Senate does.

So I think this is relatively noncontroversial, and without any legislation dealing with lobbying on the landscape, this is really the time to do this very noncontroversial thing. So we have a chance right now, right now, to deal with an important issue.

So I would ask that the rules be suspended so that we can deal with the important issue of lobbying.

Thank you.
