STATEMENT BY MR. ADOLPH

The SPEAKER. At this time the Chair recognizes the gentleman from Delaware, Mr. Adolph.

Mr. ADOLPH. Thank you, Mr. Speaker.

Mr. Speaker, I want to first of all congratulate the members of the House for concurring with HB 2. It is not the exact language that we passed earlier in this session. I was anticipating a question from the gentleman, Mr. Vitali, from Delaware County regarding what the Senate amendments were, and if I could just keep it real brief, because I know that we have a busy day today.

Exactly what we just agreed on was, number one, the act is renamed the "Growing Greener Environmental Stewardship and Watershed Protection Enhancement Authorization Act." We also reduced the amount of the bond from \$800 million to \$625 million. We eliminated the borrowing increments of \$115 million per year. We also ensured the question adopted by the General Assembly as the exact question presented to the voters and that it must be placed on the spring 2005 municipal primary ballot. Lastly, we waived the requirement for a plain English statement to be prepared by the Attorney General and extended the deadline for absentee ballots cast by uniformed and overseas voters to May 31, 2005, at 5 p.m.

I would have liked to have seen the enabling legislation come back to us at the same time. You know, we have experienced some problems in the past when we put a ballot question on there without having the enabling legislation. I am sure the Senate is going to be working on that, and I am confident that we will have the enabling legislation in a timely fashion. That is what I am hoping for. I am looking forward to working with the Senate on the enabling legislation, and I appreciate the opportunity and I congratulate the administration as well as the Senate for getting this HB 2 back to us. It was a long time in the works, and I think with any type of piece of legislation like this, there is a time for compromise, and I think all four caucuses were able to get something out of it that we can agree on.

Thank you very much, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

STATEMENT BY MR. GEORGE

The SPEAKER. The Chair recognizes the gentleman from Clearfield, Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, I will not be long. I emulate what has just been reiterated by my colleague, the gentleman, Mr. Adolph.

Mr. Speaker, a year ago or 2 years ago, as you know, I was asked by the Governor to sponsor a bill, and unfortunately, that is not the bill that is being voted on at this moment. But again,

even though it may not have our name on, it has our blessing in that we know until this bill is sanctioned and okayed by the general population, the voters in Pennsylvania, Pennsylvania will continue the trend of going down rather than up.

Mr. Speaker, there is not anyone here who knows what will develop always tomorrow, but I firmly believe that as stewards of the environment, which we all are, that we have been in an abyss, we have been in a downtrend, of trying to put forth that which is meaningful.

I pledge to work with the gentleman, Mr. Adolph, and the committee and you, Mr. Speaker, so that what comes back from the Senate, even though it is not identical, even though it is not as we all would want it, I pledge, Mr. Speaker, as the physician's oath, first do no harm. We will not be doing any harm by accepting the challenge that has been put before us by our Constitution, and that is to be stewards of the environment.

Now, as individuals, Republican and Democrat, there are many times we all can be blamed for playing the political stature more so than the intent and the need. I congratulate the Speaker on his perseverance and his ability, but more so I thank you, because none of you will be able to show your constituency any troubled disadvantages, any problems, because even though we cannot take care of it all, even though it is not going to be exactly what we want, it is going to be what you want and what the people back home want.

The SPEAKER. The Chair thanks the gentleman.

STATEMENT BY MR. VITALI

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

I appreciate the somewhat moderate-length explanations by the chairmen of the Democratic and Republican Environmental Committee on the concurrence vote on HB 2. My feeling, though, is that this discussion would have been best made prior to the vote, not subsequent to the vote.

The SPEAKER. Mr. Vitali, no one stood up prior to us running the bill. Had anyone stood up, Mr. Vitali, we would have recognized them in turn. No one stood up. I cannot help that, Mr. Vitali.

Mr. VITALI. Mr. Speaker, it has been the custom of this chamber at the beginning of each session day, as members are filing up, to have the noncontroversial votes before the controversial ones. This was an extremely controversial vote, and the situation occurred today—

The SPEAKER. Mr. Vitali, Mr. Vitali, the Governor of the Commonwealth of Pennsylvania, Governor Rendell, asked us to run that bill as quickly as we possibly could. We honored the Governor's request, Mr. Vitali. I am sorry that does not fit with what you would have liked to have seen.

Mr. VITALI. Mr. Speaker, the situation today is similar to the situation that occurred yesterday with HB 55, a bill that in fact the Governor vetoed that dealt with the closing of firehouses. That was run right at the beginning of session, before members paid attention, and but for the quick work of Representative Wheatley, that would have passed without negative votes.

The SPEAKER. Mr. Vitali, you are on unanimous consent. You no longer have unanimous consent. The Chair thanks the gentleman.

STATEMENT BY MR. QUIGLEY

The SPEAKER. The Chair at this time recognizes the gentleman, Mr. Quigley, under unanimous consent.

Mr. QUIGLEY. Thank you, Mr. Speaker.

I just want to take this opportunity to thank everyone who was involved in HB 2 – our Environmental Resources Committee chairman, Representative Adolph; his staff – for doing a great job in helping out to craft the language. I would like to thank the cooperation of the Senate for bringing them back.

As was stated, it was not the original amount that we had put over there at \$800 million, but I think it is a positive step going forward to get the resources necessary for these environmental programs and that we can work going forward on HB 3 to come up with the necessary funding mechanism and operation to cover the services that we had hoped for.

So again, I thank everyone for the passage of this bill. Thank you, Mr. Speaker.

Mr. MAHER. Thank you, Mr. Speaker.

It is certainly a good and worthy thing to recognize May as Cystic Fibrosis Awareness Month, but more important than that, I am hoping that this May we can correct mistakes that the State, that this administration has made with respect to cystic fibrosis and other chronic conditions.

Historically, Pennsylvania has tested newborns for 29 conditions. Under this administration, there are now just a half a dozen that are tested. As a result, 23 other diagnosable, treatable conditions are not being tested among every child born in Pennsylvania.

The consequences are real and result in terrible effects on quality of life, shortened life spans, and we must address this. And I am hoping that this May, now that the Governor has had a year and a half to correct this mistake, that he may go ahead and make that correction administratively, and if he does not choose to do that, then I will be seeking our action as a legislature to compel Pennsylvania to return to the standard of care that we had for our children up until this administration.

Mr. WILT. The origin of the dollars that are being transferred under this amendment are the fuel taxes that are paid by snowmobilers and ATVers (all-terrain vehicle users) when they

fill up their fuel tanks at gas stations. This transfer is not unlike the same transfer we do to the Fish and Boat Commission.

Mr. VITALI. I just want to be clear. I do not think you have said it yet. This is to be used for highways, roadways, and bridges that are to be used by ATVs and snowmobilers, right?

Mr. WILT. Mr. Speaker, that is exactly what the amendment says.

Mr. VITALI. That million dollars, is that currently being used for that purpose now?

Mr. WILT. There is actually more than \$1 million being used for that purpose. However, none of that money is coming out of the Motor License Fund through the liquid fuels tax. This amendment would create that transfer.

Mr. VITALI. So this is coming out of the motor vehicle licensing fund, this million dollars?

Mr. WILT. That is exactly what the amendment says, Mr. Speaker.

Mr. VITALI. What is the motor vehicle licensing fund using that million dollars for now? My concern is what uses might be displaced were this approved.

Mr. WILT. It is part of the General Fund appropriation within the Department of PENNDOT.

Mr. VITALI. Does PENNDOT have a position on this amendment?

Mr. WILT. They have not given me anything in writing for or against this amendment.

Mr. VITALI. Are they aware of this amendment?

Mr. WILT. This is a continuing appropriation, Mr. Speaker. It was in last year's budget. We are putting it back into this year's budget. I am sure they are aware of it.

Mr. VITALI. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman. The Chair recognizes the gentleman, Mr. Samuelson.

Mr. SAMUELSON. Thank you, Mr. Speaker. I have a further question.

The gentleman said that this came out of the Motor License Fund, yet his amendment also reduces a line item over at PENNDOT by \$1 million.

The SPEAKER pro tempore. Mr. Samuelson, do you seek to interrogate the maker of the amendment?

Mr. SAMUELSON. Yes, I do.

The SPEAKER pro tempore. Does the maker of the amendment agree to interrogation?

You may proceed, Mr. Samuelson.

Mr. SAMUELSON. Thank you.

The earlier description said this comes out of the Motor License Fund, but as you follow the amendment here and look at pages 183 and 184 of the budget bill, this amendment reduces a line item at PENNDOT from 47 million down to 46 million, and in fact, the description of that line item said it is for salaries, expenses for the Department of Transportation, including the State Transportation Commission, which I know has hearings on the 12-year plan all around the State, and the State Transportation Advisory Commission and coordination of municipal services.

So my question is, if you are proposing to reduce that line item from 47 million to 46 million, are you actually proposing 2 million, the million that you speak of plus a reduction in a PENNDOT line item?

I ask for a further explanation from the gentleman.

Mr. WILT. It is exactly what the amendment says, Mr. Speaker. It is right before you to read, where the money is coming from and where it is going to. I do not know what further explanation you need. We are taking \$1 million out of the refunding of liquid fuels, and we are moving it over to DCNR.

Mr. SAMUELSON. Thank you.

I regretfully have to disagree. That is not what his amendment says.

It says that the line item is being reduced from 47 million down to 46 million, and I know that the State Transportation Commission does important work all over the State. It is a statewide benefit that we have, as we develop the 12-year plan for road improvements, in my community, in your community, in every single legislative district. So I would closely look at the language of this amendment, and it is not as it appears when that line item is being reduced by \$1 million.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Wilt.

Mr. WILT. Thank you very much, Mr. Speaker.

The fact still remains that our snowmobilers and ATVers across Pennsylvania put over \$7 1/2 million in fuel taxes over at PENNDOT. They are asking for \$1 million of that \$7 1/2 million that they contribute to the PENNDOT budget to be used for the maintenance and creation of trails on private property. It is a very simple amendment. This chamber has voted for it probably 10 times in the last 8 years that I have been here, and I ask for an affirmative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. McNaughton.

Mr. McNAUGHTON. Thank you, Mr. Speaker.

I rise in support of the Wilt amendment.

I would suggest that if the gentleman on the other side of the aisle is so concerned about highway dollars, he would go to see his Governor and have him restore our \$770 million that he took for rail across the Commonwealth of Pennsylvania so that we can have highway improvements back in our legislative districts.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Surra.

Mr. SURRA. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the Wilt amendment.

This is very simple. Every time you pull up to the gas station and buy gas, there is approximately 40, 50 cents a gallon of tax that goes to the maintenance of our roads, highways, and bridges. Off-road enthusiasts who ride ATVs and snowmobiles pay that same tax, and they get nothing for it. They pay over \$7 1/2 million a year in taxes and get zero back.

Now, if you happen to be a boating enthusiast, there is a provision in the law that some of those tax dollars go to maintain boat ramps and help them with their off-road recreational sport. All this does is take \$1 million of that \$7 1/2 million in taxes that they pay and put it into DCNR to allow for the maintenance and upkeep of trails on private land for off-road enthusiasts.

Now, Mr. Speaker, if you have a problem with ATVs and snowmobiles in your district, like many of us do, we need to do a better job of providing those people opportunities to ride. They are not going to go away. They are in existence. They are riding them now. This lets them take a portion of the tax dollars that they pay and puts it back into trail use, and I would appreciate an affirmative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Levdansky.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, I beg to differ with both the sponsor of the amendment and with my good friend and colleague, Dan Surra, relative to what this amendment would accomplish. It has been stated by these two gentlemen that this \$1 million will be used to improve trails and roads and bridges on private land. But read the amendment. The amendment says we are going to create a fund pursuant to the existing law for the use by DCNR for the improvement of the public roadways, highways, and bridges of the Commonwealth - of the Commonwealth, not of local municipalities, not of the private sector.

This amendment would require DCNR to spend this money to put trails on State forest and State park property. That is where this money would be spent. That is contrary to this administration, to Secretary DiBerardinis, who is working to establish trails for ATV users and snowmobile users on what we call low-value private land. We have plenty of abandoned strip mines across the Commonwealth that this administration wants to utilize to construct trails for ATV and snowmobile users, and I support that policy. That makes a lot of sense.

But State forest and State park properties are sensitive properties and ecologically sensitive, and they have competing demands on State forest properties for hunters, for hikers, for bird watchers, and to add ATVs and snowmobiles into the mix is not really that compatible.

This amendment says that this million dollars will be spent for trails and improvements to public roadways of the Commonwealth. That would be on Commonwealth property. I would not support doing this. I would support it if in fact this money were to be used, were to be used to acquire and improve and build trails on low-value lands in the private sector. But that is not what the amendment says, and for that reason I urge a negative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Hanna.

Mr. HANNA. Thank you, Mr. Speaker.

I would beg to differ with the past speaker.

I think if you look at the bill, it specifically says that these funds go into the restricted account created under Title 75, section 7706, and if you will look at that restricted account and the history of that restricted account, it has not been used to create trails on public ground. And you are correct that Secretary DiBerardinis and this administration are opposed to creation of additional trails on public ground.

So these funds would not be used on DCNR property, not State parks or State forests. It would be used as it has been intended to be used to develop trails, public roads, correct, but they would be roads that would be on private property and it would be roads adjacent to private property, not on our State parks, State game lands, or State forests.

well as to give all people a chance to look at this closely. Unfortunately, when there is an education issue, the public/private sector often collides, and that is unfortunate. I would hope that both groups could work together and help our private universities as we help our public universities. But I oppose this because we did have a chance to inform the members about the intricacy details of the bill. There is \$250 million over 5 years, which is a lot of money, and we want to make sure that every dollar that this State spends is accountable and is spent wisely. Obviously, our State institutions come under very close scrutiny of the legislature as well as State government.

So I do not think we are on a level playing field here, and I would hope that we could vote against this today. Hopefully on another day we could support it, because indeed, our private schools do need help and I do not want to deny them of that. But I think, you know, in a way we are getting a fast one pulled over us today, and I would certainly hope that you would feel like me, that you hate to be taken advantage of and certainly when somebody pulls a quick vote over on you. So let us slow the speed down a little bit and have a speed that we all could have a say-so and be well informed and do what is right and help both the public and the private sectors in education.

So I would ask my members to oppose this at this time.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Zug.

Mr. ZUG. Thank you, Mr. Speaker.

This issue is not new. It did not come out Monday in Appropriations and then today. It has been around since the Honorable Karl Boyes from Millcreek Township in Erie County. I think Representative Good has that seat now. It has been around for a long time. Last year the Appropriations Committee held a hearing on this bill at Lebanon Valley College. Also, the Education Committee held a hearing on this bill last session. It did not move. We are moving it today.

I am not going to spend a lot of time saying why it is a great bill. I will if somebody asks me, but I am just going to try to keep my comments short and ask you to vote in the affirmative on this legislation.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

This is a rather quixotic moment for me because I am inclined to support the measure because I think it will inure to the benefit of private education in the Commonwealth, and the chairman of the Education Committee in the majority made some solid arguments that infer we need to be more solicitous of private education, and that is coming from someone who has been very, very aggressive on behalf of Penn State and Pitt and Temple and Lincoln, our State System, et cetera. But as a leader in the minority, it would be unfortunate if I did not take the opportunity to talk for just one moment politely, respectfully, about the process.

Over the last 10 years, we have as a minority been pummeled and buffeted and trampled by the accelerated speed of the process here in the room. Mr. Zug's comments leaven the other side's arguments that this has been a helter-skelter, full-speed-ahead dynamic, but it does just momentarily, at least for the minority party to hear a decent, well-informed, committed chairman from the Republican Education Committee talk about the great celerity which this process sometimes evokes. It is very helpful for us sometimes, and I do not care today. That is why I said it is quixotic, because this bill is not going to go to the Senate and then to the Governor unmolested; it will be altered. But it just gives me a chance for a moment to say once in a while it is appropriate. Whether today is the day, I do not know, but once in a while, it is appropriate, and from the minority's perspective, Mr. Speaker, we should slow things down once in a while and we certainly should allow our standing committee chairmen and the ranking minority members, especially when they have worked hard over almost two decades to become a chairman, to be involved up to their eyeballs in the process.

So as they say around the floor of the House, vote your conscience, but nevertheless, I hope as the springtime moves forward into summer and our budget debates elongate, we will not have to rush to judgment.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Hanna.

Mr. HANNA. Thank you, Mr. Speaker.

I would like to urge opposition to this bill for a lot of the reasons that were stated by Representative Stairs, but as a supporter of public higher education, I am concerned that we need more time to evaluate this, and I would ask that all of our members vote "no" on this legislation at this time.

Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Daley.

Mr. DALEY. Thank you, Mr. Speaker.

This is not only about process but it is about substance. The eloquent speaker, Mr. DeWeese, was talking about the process.

I serve on the Widener Law School Board of Overseers, I serve on the University of Pennsylvania Veterinary School Board of Overseers, both private schools, and I also serve on California University of Pennsylvania Council of Trustees, and I can tell you this: that we are opening up Pandora's box here. We are talking about \$50 million in bonds that will be released for the Pennsylvania Higher Educational Facilities Authority.

You know, I look at all my colleagues that are very conservative and talked about this budget for the last several days, about how much more this legislature needs to be more conservative fiscally, and we are talking about \$50 million in bonds going to private, independent institutions. Now, I am all for those private, independent institutions as many of you are. As I told you, I am very closely linked to many of them. But this is not, not a prudent decision at this point in terms of the State's process.

I would ask a negative vote. I ask that the Education Committee have the opportunity to review this issue, do hearings, to do the evaluation, because we have everybody, when we go to the nonpreferreds, standing at the trough, trying to get their tongue in the water, and we just want to make sure there is enough water for all those tongues.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Surra.

Mr. SURRA. Thank you, Mr. Speaker.

Mr. Speaker, I rise in opposition to HB 616, and there is good reason that this bill circumvented the Education Committee.

Mr. Speaker, which one of us has not just responded to the letters of the Penn State student or the Slippery Rock or Clarion or Edinboro student of the State System schools that is not lamenting the increase in tuition and the cost of attending one of our State-related or State System schools?

While I certainly appreciate the plight of everybody involved in education and our private schools, we need to make a better commitment to our State System and State-related universities, Mr. Speaker, and allowing the indebtedness of \$50 million per year for the next 5 years of our tax dollars to be drained away from those needs for our State-relateds and State Systems is not the direction that we should be going as a General Assembly.

I often sit here every year when we vote on nonpreferred appropriations and I kind of cringe when I see the millions and millions of dollars that are being spent on non-State-related institutions.

We should not be opening up this Pandora's box, and I urge a "no" vote. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentlelady, Ms. Mundy.

Ms. MUNDY. Mr. Speaker, I rise in support of HB 616.

What the previous speaker just said is absolutely true. We should be doing a better job of making sure that our tuition at all of our institutions is lower. But I would ask you to look at this from a different perspective. We are spending millions and millions and millions of State dollars on economic development, and we should. This bill provides the same level of commitment to the private-sector institutions of higher ed that we have been devoting for years to the public sector, but we should be supporting both sectors because of the economic development opportunities that it ensures for Pennsylvanians.

Look at the number of dollars, and I do not have the booklet with me, but the private and independent colleges and universities have shown us the economic development benefit to the Commonwealth through their institutions. Representative Sturla has made the point over and over again that we need to be looking at higher education as economic development in the Commonwealth. This bill attempts to give more credence to that notion, and that is why I will be supporting the bill.

Thank you.

The SPEAKER pro tempore. The Chair thanks the lady and recognizes the gentleman, Mr. Pallone. The gentleman may proceed.

Mr. PALLONE. Thank you, Mr. Speaker.

I rise today also to support HB 616 to provide this funding for the private colleges and universities throughout Pennsylvania.

Just as the distinguished colleague just said, these universities are a stimulus for economic development in many communities and all throughout Pennsylvania as well as the students who attend those universities come from taxpayer families located in Pennsylvania.

While I am disappointed the Education Committee, of which I serve on under our distinguished chairman, has not had an opportunity to visit this particular piece of legislation, it still has good merit in Pennsylvania.

I am a product personally of both a State-funded university as well as a private university, and I think that you get a quality education in both institutions. The issue is, however, should the taxpayers and the families of those taxpayers throughout Pennsylvania just because they do not attend a taxpayer-funded university not enjoy some of the economic benefits of assistance coming from the Commonwealth?

I absolutely encourage my colleagues to support this legislation and support the private colleges and universities throughout Pennsylvania just like we support public education in Pennsylvania.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Tangretti.

Mr. TANGRETTI. Thank you, Mr. Speaker.

Mr. Speaker, I think there is a misconception among many people when we say private university. Somehow we have this image in our mind that everybody who attends a private university is from a wealthy family and there is no reason that we need to give any support or aid. That is exactly not true. The product mix of students is completely reversed to what that used to be. About 75 percent of the students in the private universities in this Commonwealth are now recipients of various kinds of aid that we provide as well as the Federal government. These universities and colleges provide significant, significant educational benefit to this State, and we should not turn our back on them. Where would we be without the many, many universities that supplement the public schools that we have, the public universities that we have in this State?

I would ask, think about what we are doing here. We are providing the kind of assistance that these schools desperately need to enhance the career and educational opportunities of these students, and we should support this bill, and I would urge all of my colleagues to cast an affirmative vote.

Thank you very much.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Clearfield County, Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, there are very few of us in here that are not reminded daily that our young people are leaving because there is nothing back home. There is not a day that we as legislators, whether in groups or whether down here on the floor, do not attempt to do something to eliminate that tragedy. The fact remains that when many of us were boys or girls, it was a different work force, there was a different demand, but today because of technology in the medical sciences and things of this nature that still are demanding and urging young people to be educated so that that work force can be filled, we would be remiss if we did not do everything we can to make sure these young people are educated in a trade or a vocation that is commensurate with the demand.

I think we fail miserably not to understand it matters not who is providing the education but it matters that there is a young person that is able to get that education. And incidentally, Mr. Speaker, in my area where I have had several places that we helped with millions of dollars that have moved out of the State, if it were not for programs like the TRA (Trade Readjustment Allowance) and programs like that where we could send people who are 40 or 45 years of age back to school, and that was done because of you being able to provide the money to the right programs. So even though you did not know about it, you should take credit for the fact that you are even giving a generation just below us an opportunity to get that education.

I would urge that we vote for it.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Delaware County, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the bill submit to interrogation?

The SPEAKER pro tempore. The gentleman has agreed, and you may proceed.

Mr. VITALI. I apologize because I come at this with a low base of information, and whenever I see a bill that has bonds and large amounts of bonds and a group of five politicians deciding who gets them, red flags arise in my head.

Now, as I understand this bill, there is a board consisting of five people – the Governor, the majority and the minority leaders of both the House and Senate, those five people. Is that correct?

Mr. ZUG. I think that is what it says. It will be worked through PHEAA (Pennsylvania Higher Education Assistance Agency) also as part of the funding source.

Mr. VITALI. I am sorry. I missed what you said.

Mr. ZUG. There are appointments by the General Assembly and the Governor, and there is administration through PHEAA, as the bill reads now. You know, it could change depending on what the Senate chooses to do or a conference committee at a later date.

Mr. VITALI. Now, again, just really quickly, but in that section where it says "Composition" of the board, I am looking at five people. Am I missing something? Are there more than those five people – the majority and minority leaders of the House and Senate and then the Governor?

Mr. ZUG. Yes, that is what it says, Mr. Speaker.

Mr. VITALI. So you have these five people determining who gets these, what colleges get these capital improvement bonds. Is that it?

Mr. ZUG. Yes. But there is a limit on how much each school may get.

Mr. VITALI. Right. Now, I am just wondering, because you know, I am a product of private higher education and I certainly want to see it supported in every way, but my concern is when you have five politicians as opposed to maybe a blue-ribbon panel of some sort making these decisions. Could you tell me what the experience might be in other States with regard to bonds for independent higher education institutions?

Mr. ZUG. No, I cannot, but I think members of the General Assembly are pretty blue-ribbon commission themselves.

Mr. VITALI. I am sorry. I am missing some of what you are saying because of the din of the crowd.

Mr. ZUG. I said I cannot tell you what the other States are doing. I can tell you, though, that members of the General Assembly would, to me, make up a pretty good blue-ribbon commission.

Mr. VITALI. Okay.

Was any consideration given to having a board who decides what colleges get the bonds, nonpoliticians; in other words, maybe college administrators, other people with various areas of expertise other than elected officials?

Mr. ZUG. Well, there is certainly input by anybody who is applying for the grants to make a decision of who is going to get them. Again, if you have concerns over who is handing out the grants, you can also contact the Senate. I know that Senator Pileggi from, I think, your area is very instrumental in this legislation, but as the bill reads now, that is the makeup of the board—

Mr. VITALI. But my question is, did you consider rather than having a board composed of five politicians, maybe a board composed of nonelected officials, perhaps people with expertise in higher education administration? Did you consider that and reject it for any reason?

Mr. ZUG. Mr. Speaker, I am not going to get into the hypotheticals of why or why not somebody is on the board. The board is made up of General Assembly members. I think that they are qualified to make these decisions. They are good people, and that is what the bill says, and that is what I am going to say. If the bill passes today and goes to the Senate, you can certainly talk to somebody in the Senate, but that is what the bill reads and that is what I am going to say on this issue.

Mr. VITALI. Okay. So they decide what applications for bonds are accepted.

What about the administration of the bonds, choosing the underwriters and the other bond service providers like bond counsel and so forth? Whom does it fall upon to choose them?

Mr. ZUG. Well, since the private schools are paying for the bonding, they would certainly have the ability to hire who they wanted to.

Mr. VITALI. Okay. Now, the educational institutions, they float the bonds, each individual education institution floats the bonds, but under this bill, there is some sort of 50 percent reimbursement for the servicing of the bond or the interest payments. Is that how it works?

Mr. ZUG. It is the same way we do with public schools. We float a revenue bond. The bond then gets allocated to the school, and then they pay the portion of the interest that is bestowed upon them.

Mr. VITALI. Okay.

Now, I am looking at the language, and I see language that talks about 50 percent reimbursement of I think it is bond servicing. The way this bill works and the way it helps these schools is that the State itself comes up with 50 percent of the funding to repay the bonds of the selected schools. Is that how it works?

Mr. ZUG. The State would pay the authority 50 percent of the bond and the private institution would pay the other 50 percent of the bonding issue, and again, it is a matching grant program similar to most of the economic development programs we have.

Mr. VITALI. So the schools themselves would float the bond, but the State, for those selected schools, would pay back half of the annual cost of repaying it. Is that how it would work?

Mr. ZUG. The authority floats the bonds, and then the schools pay the authority for their bonding, their liability.

Mr. VITALI. What is the annual cost to the Commonwealth of this bill, the cost of repaying this bond?

Mr. ZUG. If it is the maximum, it is \$8 million a year, and that was passed in an amendment that I had yesterday in the budget we passed today.

Mr. VITALI. Okay. That is all my questions.

Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Hasay.

Mr. HASAY. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of HB 616.

I think it is really important that we support our private colleges and private universities. You know, it is much more difficult for them to raise money than our public institutions, and I think we need to attend to trying to assist them to keep tuition rates down. And also keep in mind that as far as the bond issue goes, under the general appropriations budget, our bond indebtedness is less than 1 percent. So I would not be so concerned about that, because it is less than 1 percent in the general appropriations budget. So please support HB 616.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Union County, Mr. Fairchild.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

I also rise to support HB 616.

I have two great universities in my district, Susquehanna University and Bucknell University, and I can testify the amount of educational excellence that these two universities bring to our area and our State. It is an economic engine in our area in rural Pennsylvania. But I think it is more important to note that it is not an economic engine for Lewisburg or Selinsgrove or Middleburg or Winfield. It is an economic engine for the whole State. These universities bring both paying students and also academic scholarship and need scholarship people to our region. I can witness firsthand those that stay not only in our local region but throughout the State.

I believe this is just an excellent way that we can step up to the bat and we can become a leader in the Northeast United States, and I really believe that we are on the right track here.

Finally, I would just like to take my last sentence, and I know it is a long day, but also to point out that Bucknell University did beat Kansas in the NCAA (National Collegiate Athletic Association) tournament. Go Bisons.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Beaver County, Mr. Veon.

Mr. VEON. Thank you, Mr. Speaker.

Mr. Speaker, I rise to support this legislation.

I do like the concept of being able to provide some bond authorization for construction. I think many members here have already made the case that this kind of work, these kinds of capital needs are needed by many of the smaller institutions all throughout the State, in many of our districts.

However, Mr. Speaker, I do want to make the point here today that I view this as just a first step in this process because I do think there are important capital needs for other educational institutions. My personal priority, for example, for capital improvements would be the community college system in this State, in desperate need of capital improvements. So I see this as a step in the right direction, a step forward. We all recognize that we have a budget to negotiate with the House and the Senate. My hope would be that perhaps we can come up with a package deal, a way to provide the capital improvements not just for the independent institutions listed in this bill but certainly for community colleges.

If I have an opportunity at the end of this fiscal year, as we do this budget, to place a priority, I will be for community college capital needs first, independent institutions second, but I would like to say that we would like to work with members on the other side of the aisle and see if there is a way to put together a package deal and sell that to the Senate and to the rest of our colleagues here.

So it is a step in the right direction. I would urge an affirmative vote. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question recurring, Shall the bill pass finally?

The SPEAKER pro tempore. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
