Mr. CURRY. Thank you, Mr. Speaker.

As I am sure we are all aware, the safety and well-being of our children is of supreme importance, and because of that, I have been working for months to develop legislation aimed at requiring Federal background checks for individuals that are employed in our school districts. Incidents in my own district have shown that efforts to expose issues involving an employee's history are important to make sure our students are safe, but there are holes in our present background check system, and they simply must be closed.

In an effort to move the issue to the forefront, I filed an amendment today, but given the magnitude of this issue, I believe it should be something that is deliberated fully. As such, I am pleased that the chairman of the Education Committee has agreed to have my bill considered in committee later on. Clearly this issue is too important for us to ignore. It is urgent.

With that said, I agree to withdraw my amendment today to this bill. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Samuelson, for comments.

Mr. SAMUELSON. Thank you, Mr. Speaker.

I would like to interrogate the prime sponsor of the bill.

The SPEAKER pro tempore. The gentleman, Mr. Schroder, indicates that he is willing to stand for interrogation. You may begin

Mr. SAMUELSON. Thank you.

My question is, in the text of this bill, this legislation to provide citizens with access to information about school budgets and rights to photocopy school budgets and making the information public applies to second-, third-, and fourth-class school districts, but as I read it, it does not apply to first-class school districts, which would be the school district of the city of

Philadelphia. So I wanted to ask, what is the reason there or would the gentleman be receptive to an amendment to make sure that the Philadelphia School District is also covered?

Mr. SCHRODER. Thank you, Mr. Speaker.

Mr. Speaker, the gentleman is correct in his observation that the city of Philadelphia's school district does not come under these provisions. The reason that is is that the section of existing law that we amended, which is section 687(a) of the Public School Code of 1949, for whatever reason did not apply to the city of Philadelphia in the first place.

So I believe the gentleman does raise a valid point. I would be happy to work on legislation to bring that school district under the same provisions as this, but the only reason it was done this way, it was not intentionally excluding any school district; it was just a matter of the section of the education code that we amended, you know, from however far back did not apply to the city of Philadelphia.

I appreciate the fact that he has brought it to my attention. I would respectfully ask the body that we pass this measure today, and I would be happy to work with the gentleman or any other Representative to fashion legislation that we can bring the city of Philadelphia under, but I believe we would need to do that in a separate provision.

Mr. SAMUELSON. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Schroder, for comments. The gentleman is waiving off.

Any other members wishing to make comments on this particular bill?

The gentleman from Delaware County, Mr. Vitali, is recognized.

Mr. VITALI. Will the maker of the bill stand for brief interrogation?

And the reason I ask is, I mean, the way things work up here, I feel if the issues are separated – the 500 school districts on one hand and Philadelphia on the other hand – the issue with regard to Philadelphia will simply be forgotten.

So my question is, would you be supportive today, or perhaps make it yourself, of a motion to pass over this bill until a time certain, perhaps next Monday or Tuesday, when the appropriate amendment could be filed?

Mr. SCHRODER. I understand the gentleman's concern and the point he is making. Mr. Speaker, as I said before, the existing section of the code that we are amending does not apply to Philadelphia. So I am not sure at this point whether we could amend this bill or have to go to a separate piece of legislation. What I would prefer to do, Mr. Speaker, is see us move this today, and as I said, I will certainly give my support. In fact, the commitment is, I will actually introduce the bill, if Mr. Samuelson or someone else is not already intending to do so, to make sure that that does apply to the city of Philadelphia's school district.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER pro tempore. Why does the gentleman, Mr. Godshall, rise?

Mr. GODSHALL. Mr. Speaker, I would like to submit some comments for the record, and at the same time, I would like to thank the House for their support for this much-needed legislation.

The SPEAKER pro tempore. The Chair thanks the gentleman, and please submit your comments for the record.

Mr. GODSHALL. Thank you.

Mr. GODSHALL submitted the following remarks for the Legislative Journal:

- Since passage of Act 102 of 1994, Pennsylvania has been a national and international leader in organ donation for transplants.
- Organ donations in the State have increased by over 50 percent in 10 years.
- Many other States have copied our law, and now the U.S. Department of Health and Human Services has adopted it as national policy.
- With HB 153, Pennsylvania can retain its place in the forefront of organ donation and transplantation.
- During 2003 there were 2,001 organ transplants in Pennsylvania, an increase of almost 21 percent in just 4 years.
- Of that number, approximately 389, or 1 in 5, involved a living organ donor. Living donors are obviously a crucial part of the donor pool.
- In the vast majority of those cases, about 90 percent, the living donor gave up a kidney for transplantation.
- In some cases a section of lung or liver can be resected and transplanted. This is usually done by a parent or close relative for a young child.
- The current national list of people waiting for life-saving organ transplants is more than 87,000. Of those, approximately 16 die every day due to the lack of available organs.

- In Pennsylvania the waiting list is more than 6,000 people.
 Many of those people would benefit from a donation by a living organ donor.
- Most living organ donors are back at work within 4 to 6 weeks. New surgical techniques for kidney donors can cut that time in half.
- Those who work with organ donors cite possible loss of income or a loss of a job as common disincentives for people to not become living organ donors.
- HB 153 would remove that disincentive for bone marrow donors and for kidney, lung, and liver donors as well.
- There could be considerable cost savings from this bill due to the ability to take many individuals off of kidney dialysis after receiving a donated kidney, thereby reducing all health-care costs, including Medicare and Medicaid.
- Most important of all, it could save lives.

My comments on this bill will be fairly brief.

The House minority leader was very kind yesterday to me and pointed out to the House that we would be voting this bill today, so I do not think I need to do too much speaking here.

I am very proud to stand before the House for this bill, and I do want to talk a little bit about the debate yesterday, which really was not about the merits of the bill. There seemed to be bipartisan support that it is in fact good legislation. Most of the debate of the bill was about pride of authorship, and I want to be the first to admit that this is not a new idea. This has been around the House for a long time, and I want to recognize both Representatives Tangretti and Frankel for their hard work on this legislation. This House has passed this bill on numerous occasions, only to have it go to the Senate floor, to the Senate, and die and never become law, and in the little less than 2 years that I have been here, the one thing I have learned quickly is that many, many pieces of good legislation end up on the cutting floor and never become law.

With this bill, I have been working along with members of the Senate, and I have gotten some commitments from Senators from the two counties that I represent to move this legislation forward, and I think that is important. Now, I may be naive thinking that is actually going to happen, but I am counting on it, and I am hopeful that when the Senate moves this bill, we can count on my friends from the other side of the aisle to have

the Governor sign it, because it is only when this bill becomes law, will we be able to preserve historic properties, both residential and commercial properties, in the Commonwealth of Pennsylvania, treasures just like this room and this building we sit in today that deserve to be protected.

I want to thank all the staff, all the members on both sides of the aisle, that have worked very hard on this bill over many, many years, and in recognition of that, I would ask all members to vote "yes" on HB 504.

and for military tax credits for employers who pay or subsidize the wages of an employee called to active duty.

Amend Sec. 1 (Sec. 315.8), page 1, line 19, by striking out "on or"

Amend Bill, page 4, by inserting between lines 4 and 5

Section 3003.16. Military Tax Credit.—(a) A credit shall exist for an employer who pays an employe's difference in wages between the employe's civilian employment and the employe's military wages pursuant to 51 Pa.C.S. § 7302 (relating to granting military leaves of absence) against any tax due from that employer under Article III, IV, VI, VII, VII-A, VIII, IX, XII or XV of this act and against any payment of estimated tax or payment of tentative tax due from the employer on account of taxes.

(b) The amount of the tax credit available to an employer under subsection (a) who elects to subsidize the employe's difference in wages from the employe's civilian employment wages and the employe's military wages shall be equal to one hundred per cent of the employe's subsidized difference in earnings between the employe's civilian wages and the employe's military wages for the period in which the employe is absent from work due to being granted a military leave of absence in accordance with 51 Pa.C.S. § 7302(a).

(c) The Secretary of Revenue shall promulgate regulations necessary for the administration of this section.

Amend Sec. 2, page 4, lines 5 and 6, by striking out all of said lines and inserting

Section 2. This act shall apply as follows:

- (1) The addition of section 315.8 of the act shall apply to taxable years ending after December 31, 2004.
- (2) The addition of section 3003.16 of the act shall apply to all tax years commencing after December 31, 2005.

Amendment 975 provides for a tax credit that would be equal to 100 percent of the difference between the military and the civilian salaries paid by the employer to the employee while the employee is federally activated for a war or national emergency.

I certainly want to ask for an affirmative vote on this amendment on behalf of Representative Nailor, and this legislation is identical to one that was passed in this chamber in 2001.

Is there any other member wishing to speak on this amendment?

The Chair recognizes the gentleman from Delaware County, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the amendment stand for brief interrogation?

The SPEAKER pro tempore. The gentleman, Mr. Semmel, is willing to stand for interrogation. You may begin.

Mr. SEMMEL. Yes, Mr. Speaker.

Mr. VITALI. I just want to understand this. Does this mean that any employer in Pennsylvania who has an employee who is in the military and goes on active duty, be it National Guard or otherwise, basically, through the tax credit, the State of Pennsylvania would be paying 100 percent of the difference between the employer's pay and the active-duty pay?

Mr. SEMMEL. Yes, Mr. Speaker. It would be 100 percent of what the employer would want to subsidize.

Mr. VITALI. When you say "want to subsidize," I am not sure what you mean by that.

Mr. SEMMEL. Basically, it is not required. It is a voluntary situation.

Mr. VITALI. This description I am reading seems a little different. Let us say the employee works for, you know, ABC Widget Company based in Pennsylvania earning \$100,000 a year and he goes on active duty and now he is getting paid – I do not know what they are paying – \$30,000 a year. Does that mean that Pennsylvania would have to offer ABC Widget a tax credit in the amount of \$70,000 a year, being the differential between his former salary and his military salary?

Mr. SEMMEL. Mr. Speaker, again, if the business chooses to do so. The intent of this is to encourage the employer to participate.

Mr. VITALI. Okay.

What I am not getting is the employer's choice here, and again, I am just basically going from a one-sentence description. I am not getting the employer's choice here. You have an employer whose employee goes on active duty, has to leave the employment, and his salary presumably drops. What is the choice on the part of the employer? I mean, what is the choice here? I am not getting that.

Mr. SEMMEL. Mr. Speaker, again, it is the choice of the employer. It is to encourage so they can get the tax credit.

Mr. VITALI. Well, this is a 100-percent tax credit. Right? So it does not cost the employer a dime to give his employee, in this case, a \$70,000 break of some sort. Right?

Mr. SEMMEL. In response to that, the cost would be administrative.

Mr. VITALI. So I am sure you have a fiscal note. Do you have an estimate for what this will cost?

Mr. SEMMEL. Basically, at this time the fiscal note says "...an estimated \$2.3 million...on approximately 1,200 residents being called to active duty in any one year ranging from 3 days to 180 days."

Mr. VITALI. This would cost, if passed, \$2.3 million.

I am just wondering, you know, someone just cited the example of the professional football player who was called to active duty, and I am sure there are other examples of high-income people who are called to active duty. Has there been any thought given to perhaps limiting this tax credit so that a given employee would not get too much from the State for their choice to go on active duty?

Mr. SEMMEL. At this point in time, certainly we are not aware of how many high-priced professional athletes might be encumbered by this. Again, it is situational.

Mr. VITALI. Right. But I am saying, I mean, have you given any consideration of perhaps limiting the tax credit in circumstances where you do have a high-income employee – in other words, limiting so that a given active-duty member would

not get more than, you know, \$20,000 or \$30,000 or \$40,000 from the State?

Mr. SEMMEL. Mr. Speaker, I think that would be a very distinct possibility working with the sponsor on the bill.

Mr. VITALI. As I understand this, this is not limited to any given war. In other words, this is not limited to the war in Iraq or the war in Afghanistan or should, God forbid, our President get us into a war with North Korea or Iran. This would not be limited, this would not be limited to current wars. Is that correct?

Mr. SEMMEL. Well, the basic premise here, activated for war or emergencies.

Mr. VITALI. Okay. Thank you very much.

Mr. SEMMEL. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Bucks County, Mr. Petri.

Mr. PETRI. Thank you, Mr. Speaker.

For the members, I think there is one other way of looking at this package of bills that we worked on yesterday and today, and one thing that has not been mentioned that all members should keep in mind is the economic impact of our bases located in Pennsylvania and our military contracts. It is literally billions of dollars of revenue to Pennsylvania.

With the Federal government now considering base closings, I wanted to remind members to be very mindful of making sure that Pennsylvania is militarily friendly in order to try and counteract some of those potentials that are occurring at the Federal level.

This is a very, very important issue to our economy, and I would encourage members to vote in favor of this very important bill. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Clearfield County, Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, we have heard what has gone on here, and legitimately, the questions, either pro or con, are honest questions with deep concerns, but the concern that we must face today that we could have faced 3 years ago is that when we asked our men and women who are Pennsylvania residents and are in the National Guard or in the Reserves, as they are placed in an area where there is a war-torn zone, the future is not very bright, and we do not know whether they will all come back.

Some might say, well, you know, these businesses are being put in a very difficult position. I would not want to dare to presume that what we have is perfect here, but you know there is a Federal law that states while an individual is in service and deployed, that you cannot take his or her home and you cannot take the car, and that is one great thing, but the sad thing is, when they get home, there might be 15 or 18 months where they did not make the payments, and from that time on, they have got to catch up with those payments. In many cases they will be paying for something that does not have the worth of the amount of the lien.

Now, listen to what I am saying. Lots of times they will be coming back to make a payment on the car that basically does not have the NADA (National Auto Dealer Association) worth of the 15 or 16 payments that have not been paid.

So what I am saying to you is that here we are. I tried to do this 3 years ago. I am very proud of Mr. Nailor and this House of Representatives. That is why I stood yesterday. I did not want to cut anybody up. I wanted to bring everybody together. You do right. What we do may not be all-inclusive, but we are trying

to do something that is right. I think we ought to vote for this bill and let those fellows and gals over there know we are thinking about them.

Thank you.

The SPEAKER pro tempore. The gentleman, Mr. Levdansky, is recognized.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Would the sponsor stand for a brief interrogation?

The SPEAKER pro tempore. The gentleman, Mr. Semmel, indicates that he is willing to do so. You may proceed.

Mr. LEVDANSKY. Mr. Speaker, essentially, the difference between what the military pay is and their private-sector pay will be a tax credit for the business. Is that correct?

Mr. SEMMEL. That is correct.

Mr. LEVDANSKY. Okay. Now, separate from that, salary and wage costs are an expensive business. So will the business also be able to deduct that salary or wage? Will that count as a business expense?

Mr. SEMMEL. Mr. Speaker, there is nothing in the amendment that prohibits that.

Mr. LEVDANSKY. Okay. I only raise that because on one hand it will be a tax credit, which I think is appropriate, but if it is also going to be an expense, it is going to lower the corporation's tax obligation as well. That could be a situation where they are benefiting twice from essentially the same expenditure.

Mr. SEMMEL. Mr. Speaker, on the State level, you are correct; on the Federal level, it would not.

Mr. LEVDANSKY. Okay. So you say at least for State taxes, it may in fact be counted twice – once as a tax credit and the other as an expense – but it is different for the Federal.

Mr. SEMMEL. I believe this could be taken care of by regulation.

Mr. LEVDANSKY. Okay.

On the amendment, Mr. Speaker.

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. LEVDANSKY. I guess this is one of the times I wish I were a tax accountant instead of an economist. I would understand this probably better.

Also, this might point to the reason why we have a bicameral legislature. If we pass something, fortunately there is an opportunity in the other chamber to look at this a little bit deeper. I just want to go on the record reflecting that concern that this, at least for the State and maybe Federal purposes, is likely a double benefit. I mean, it is both. It will count as a tax credit and it will count as a business expense, which allows for a deduction, you know, from the business expenses, thus lowering the tax obligation of the business or corporation.

So while I have real concerns about that and wish maybe we could clarify this and be certain, I do not think it is appropriate that it counts twice, but I just want to go on the record to reflect this concern and at least somewhere in the process, perhaps in the Senate, this matter could be fleshed out a little more deeply and examined a little more closely so in fact it is not a double benefit. But we want to do everything we can to in fact support our people who serve in the Guard, who serve in the military, and who are defending our country, and I think it is an appropriate, an appropriate tax credit, but I do have some concerns about the business deduction of the salary or wage and would hope that at some point in the legislative process that issue could be further examined and addressed.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

WESTERN PENNSYLVANIA SCHOOL FOR THE DEAF SOCCER TEAM PRESENTED

The SPEAKER pro tempore. At this time we have the guests of Representatives Paul Costa and Ted Harhai with us for a brief recognition by those gentlemen.

Mr. COSTA. Good afternoon, everybody.

Thank you very much.

I am truly honored and privileged to be standing up here today with my colleague, Representative Ted Harhai, to recognize the accomplishments of the Western Pennsylvania School for the Deaf Boys Soccer Team, who has been selected as the National Fraternal Society of the Deaf National Soccer Team of the Year. By the way, this is the fourth time since 1987 that they have received this prestigious title.

Along the way to their national title, WPSD compiled an 11-4-1 record, including winning the First Annual Mid-American Classic and also the Upstate Soccer Tournament.

Accepting the citation on behalf of the team are their head coach, Val Wojton; team members Jimmy MacGill, Josh Sechman, and Anthony Passante. On a personal note, I always felt that I have been very fortunate, especially to represent the 34th Legislative District, and one of the crown jewels that does not shine brighter, there is not one that shines brighter than WPSD school. They are phenomenal. If you ever have the opportunity and you are in Pittsburgh, I would love to bring you over to give you a tour of the facility. They are just such an asset to our community and the Commonwealth of Pennsylvania, and I am honored to stand here to not only represent them but, again, to congratulate them on the success that they have always had.

I also know that Representative Harhai would like to make a couple comments.

Mr. HARHAI. Thank you, Representative Costa.

Mr. Speaker, ladies and gentlemen, it is an honor for me to help honor the WPSD Soccer Champs. If it is not noted, I have a hearing impairment myself, so I have a special place in my heart for these young men and the young people that attend WPSD, whom I have gotten to know pretty well.

I was just out there last week meeting with Don Rhoten, and hopefully we are going to do some good things for the school. I know Representative Costa and also Senator Costa are very involved with the school, and I want to stay involved very much also. But once again, I personally would like to congratulate the team and the school and the administration for the fine job that they do in helping these people.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 182**, **PN 240**, entitled:

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for investment powers for the State Workers' Insurance Board; and making editorial changes.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Is there a member seeking recognition?

The Chair recognizes the gentleman, Mr. Belfanti, for comments on the bill.

Mr. BELFANTI. Thank you, Mr. Speaker.

It is my understanding there are a number of members who may have a question or two about this legislation.

Let me start off by saying that this bill is being introduced at the request of the Department of Labor, who, as you are aware, is the managing agency for SWIF, our State Workers' Insurance Fund. They are the insurer of last resort for all of Pennsylvania's employers who are unable to secure workers' compensation on the open market, and they have been doing a magnificent job, I might add.

The SWIF Board presently is restricted in their portfolio to have 92 1/2 percent of their assets in a fixed account, and they are only allowed to invest 7 1/2 percent in equities. This bill would allow the equity portion of that investment portfolio to go from 7 1/2 percent to 20 percent.

SWIF does not have any foreign or international investments. Their investments are restricted to American companies and the American exchanges, and we believe that on behalf of the business community, who supports this unanimously – again, this is a business bill – it is to insure that the SWIF reserves remain solvent and they can keep their premiums at the lowest possible level by having the option of making a larger investment in equities and not restricting them to only 7 1/2 percent.

So with that, Mr. Speaker, I am asking for very bipartisan support of this measure, and I am again of the impression that there may be a question or two.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Delaware County, Mr. Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, I am not opposed to this HB 182, but if the prime sponsor could just answer a question or brief interrogation on—

The SPEAKER pro tempore. The gentleman, Mr. Belfanti, is willing to stand for interrogation. You may begin.

Mr. CIVERA. Mr. Speaker, SWIF does an excellent job, like you said, but over the years I have always wondered, since 1991 when the General Assembly went in to bail itself out as far as taxes were concerned and they maneuvered with SWIF a little bit, what exactly is the – or if somebody could tell me; I do not know if you could tell me – the exact number, dollar amount, that they have in their fund right at the moment. Does anybody—

Mr. BELFANTI. I do not believe I have that number with me. I certainly can get it. I believe it is— Okay; let me give you the numbers that I have handy. The current total reserves, I believe, and maybe this is your question, are \$1.366 billion; the total premiums written in 2004 for the private-sector employers were \$385 million; and the projected amount of the surplus – that is in moneys in excess of projected liabilities – is about \$158 million at this point in time.

Mr. CIVERA. When we go to the next level – what you want to do here, which I think is a good idea, to go to the 20 percent – what exactly are the dollars that the investment part that you want to, you know, that they put aside, what is that number? Because, see, I just feel that they have more in excess than what they are telling us, and I just wanted to just know what they are doing over there. That is all.

Mr. BELFANTI. I believe it is the surplus dollars that are the subject of their investment policies, and again, at present their portfolio requires 92.5 percent to remain in fixed accounts, which can pay as low as 4 or 5 percent, and only 7 1/2 percent can be invested in the American stock markets, which even in the sluggish economy, the SWIF Board believes that they have lost millions of dollars over the course of the past 3 or 4 years, even with the market not doing that well, by being restricted to this 7 1/2 percent. If the market would really take off, of course, that would be a tremendous asset to SWIF and also, again, help keep the premium dollars down for our employers that cannot write anywhere else.

Mr. CIVERA. Mr. Speaker, if I could just make a brief comment.

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. CIVERA. Mr. Speaker, I think this is a good idea. I think the prime sponsor is doing the right thing, and it is something that I just wanted to be sure that there was enough money in reserves to back the claims up, because what was coming, the information that I was receiving, was not clear, but I have no problem in supporting HB 182.

Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman from Schuylkill County, Mr. Allen.

Mr. ALLEN. Thank you, Mr. Speaker.

The Labor Relations Committee had a thorough hearing and discussion on this bill. The Secretary of Labor and Industry, Secretary Schmerin, came and testified, and I would urge all the members on this side of the aisle to support the bill.

Thank you very much.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Any other members seeking recognition? The Chair recognizes the gentleman from Montgomery County, Mr. Godshall.

Mr. GODSHALL. I would just like to say on this bill, Mr. Speaker – and thank you – that on the SERS (State Employees' Retirement System) Board, which I serve, I think we have someplace between 50 percent and two-thirds of our money in equities, and this limitation of 7 1/2 percent, you know, in this day and age is ridiculous. It costs millions of dollars to the SWIF fund with that restriction in there, and I commend also the author for doing away with the archaic portion of this law.

Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question recurring,

Shall the bill pass finally?

The SPEAKER pro tempore. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
