- (2) An institution of higher education that has not submitted a professional education plan by the effective date of this paragraph may submit within two years of the effective date of this paragraph a three-year professional education plan to the Secretary of Education for approval.

Amend Bill, page 3, line 18, by striking out all of said line and inserting

(o) Definitions.—As used in this section, the following words and phrases shall have the meanings given to them in this subsection:

"Approved provider" is an institution of higher education, school entity, individual, corporation, partnership, limited liability company or association approved by the department to provide continuing professional education credits or hours under this section. Provided, a school entity or an institution of higher education may approve a provider of continuing professional education credits or hours in accordance with department guidelines.

* * *

Section 2. All acts and parts of acts are repealed insofar as they are inconsistent with the following:

- (1) The addition of section 1205.2 (d.1) of the act.
- (2) The amendment of the definition of "approved provider" in section 1205.2(o) of the act.

REMARKS SUBMITTED FOR THE RECORD

Mr. ADOLPH submitted the following remarks for the Legislative Journal:

Mr. Speaker, as many of the members know, under Act 48 of 1999, all professional educators – that is, those who hold State certification as teachers, administrators, et cetera – must complete either six college credits or the equivalent of 180 hours of continuing education in their area of assignment or certification. Professional educators are not just those who teach in the public school system. Many teachers in the nonpublic or private sector are certified; retired teachers are certified; some stay-at-home parents are certified. Many people who live and teach out of State also hold PA certification, and even some faculty members in our colleges and universities are certified. Any of those categories must get the needed continuing professional education required under Act 48 if they plan to keep their certification active.

Remember: You cannot teach in the public schools without active certification.

In Act 48 we provided numerous methods by which a professional educator could acquire compliance. Among them we permit colleges and universities to provide credit for professional educators in the public schools. But we did not approve higher education institutions as approved providers for their own faculty members who hold State certification. This amendment, Mr. Speaker, will specifically add colleges and universities to the list of approved providers for providing continuing education for certified faculty members. Also, the amendment will allow institutions up to 2 years to prepare a continuing professional development plan and submit it to the department for approval. It is my hope that we can add yet another option to the list of methods by which the professional educators can receive continuing education for compliance with Act 48.

I ask for the members' support of this amendment. Thank you.

Mr. SCHRODER. Thank you, Mr. Speaker.

Mr. Speaker, I have amendment A01142 to this bill, which would give an extension to April 30, 2006, for a certain class of educators to achieve their Act 48 certification; namely, only those who were not employed by a school district after June 30, 2000.

Mr. Speaker, this would correct a step that the Secretary of Education has taken which, in my mind and analysis, is clearly outside the law. The Secretary has issued a blanket extension to all employees of 1 year in order to achieve their Act 48 certifications.

Mr. Speaker, Act 48 only allows the Secretary to grant extensions on an individual basis and for extenuating circumstances, so in my mind, the Secretary has clearly acted outside of his authority in doing so.

Furthermore, it is not prudent to provide a blanket extension, because those who have been actively in the field of education over the past 5 years have the protection of having an administration cover their certification requirements and calculate them as well as their union.

Nonetheless, Mr. Speaker, I am going to withdraw this amendment at the request of the prime sponsor because I do support the bill, HB 894, and do not wish to cause any issues in passing that and getting that to the Governor. However, I do believe we will have the chance to address this issue on another day.

Mr. SAYLOR. That is correct.

Many of these retired teachers, when they come back to substitute, do not necessarily do it because of any monetary gains, and in fact, what is now happening with this 5-year extension of Act 48 and having to take credits, if this does not become law, I am afraid that we are going to have more problems obtaining good, qualified substitute teachers in our school districts.

So I would ask the members for their support. I think this is a good bill, and I commend the Representative again from York for introducing such legislation.

The House proceeded to third consideration of SB 69, PN 650, entitled:

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for employer immunity from liability for disclosure of information regarding former or current employees.

On the question,

Will the House agree to the bill on third consideration?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman, Mr. Wansacz, for a statement. The gentleman may proceed.

Mr. WANSACZ. Thank you, Mr. Speaker.

I originally had an amendment proposed for SB 69 which I believe would have made it a better bill, but in all fairness, I believe SB 69 is a good bill and should move forward. So without delaying the process, Mr. Speaker, I am going to withdraw my amendment and move this to the Governor's desk so that we can have a better process for our small businesses to move forward and have some protection where they can give their opinion freely on an employee.

Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

For what purpose does the gentleman, Mr. O'Brien, rise?

Mr. O'BRIEN. Thank you, Mr. Speaker.

I would just like to inform the members of the House that this bill represents an unusual collaboration between the trial lawyers, PSEA (Pennsylvania State Education Association), the hospitals, and the chamber of commerce. So I think we could all vote "yes."

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Leach, for a statement.

Mr. LEACH. Thank you, Mr. Speaker.

Mr. Speaker, I have an amendment on this bill which was originally part of a bill I drafted called the Physicians Apology Act, which says that if there is a bad outcome in a medical case, if the physician has a discussion with the family or the person who was the subject of the bad outcome and there is a discussion of the events or even an apology for a mistake made, that conversation could not be used against the physician at trial.

Frequently medical malpractice suits are filed out of frustration because people cannot get answers. In States that have done this, that have created a physician apology immunity, lawsuits, the filings of medical malpractice suits, have dropped 20 to 30 percent.

So I think this would be a good thing to do for Pennsylvania. However, for today I am withdrawing this amendment, Mr. Speaker, so that we can run this bill clean, and I look forward to the opportunity to have a vote on this amendment in the near future.

Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question recurring,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman, Mr. Wheatley.

Mr. WHEATLEY. Mr. Speaker, I want to rise and speak on final passage or interrogate maybe the chairman of the Judiciary Committee.

The SPEAKER pro tempore. Mr. O'Brien has agreed to be interrogated, and you may proceed.

Mr. WHEATLEY. Mr. Speaker—

The SPEAKER pro tempore. Will the gentleman suspend.

Mr. WHEATLEY. Yes, sir.

The SPEAKER pro tempore. May we have a little order. Members, please take your seats.

You may proceed, Mr. Wheatley.

Mr. WHEATLEY. Mr. Speaker, I appreciate the unusual collaboration that has happened around this bill, and I do not want to take up a lot of the members' time. I just have some clarity questions, if I may.

It is my understanding that currently in law, in order for a plaintiff to bring a civil lawsuit under current law, they have to prove a preponderance of evidence, and with this change in this language, it is to move it to clear and convincing evidence, and if the chairman could just explain to me the difference in the level of evidence needed and necessary.

Mr. O'BRIEN. Thank you, Mr. Speaker.

This bill, very simply, presumes that the employer is acting in good faith. It does not change the standard, but if you wanted to take this to court, you would have to establish by clear and convincing evidence that the employer disclosed information that the employer knew was false or in the exercise of due diligence should have known was false; the employer knew was materially misleading; was false and rendered with reckless disregard as to the truth or falsity of the information; was information the disclosure of which is prohibited by any contract, civil, common law, or statutory right of the current or former employee, and at that point, if you got that back into court, it would still remain a preponderance-of-the-evidence standard.

Mr. WHEATLEY. So, Mr. Speaker, just so I am clear – and for sure, I am probably going to support this bill and vote in the

affirmative – I just want to be clear, under the scenario as today in current law, if I am an employer and I think I have an employee who has possibly been stealing from me, under current law, if I give a recommendation that says I think this employee has been stealing from me but in actuality the employee has not been stealing from me and they can prove it, then they can bring suit against the employer. But if we change the law as proposed in this bill that if I am an employer and I say I think an employee has been stealing from me and that employee can prove that they have not been stealing from me but I truly believe that they have, then they can bring the suit, but under the current law, it is really not valid if we change the law. Is that correct?

Mr. O'BRIEN. What this does, it provides the presumption of good faith may be rebutted by clear and convincing evidence establishing the employer disclosed that type of information.

Mr. WHEATLEY. All right. Thank you. Thank you, Mr. Speaker.

If I can make comments on the bill, Mr. Speaker?

The SPEAKER pro tempore. I am sorry, Mr. Wheatley. Would you repeat your question?

Mr. WHEATLEY. If I can speak on the final passage?

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. WHEATLEY. Mr. Speaker, I—

The SPEAKER pro tempore. Members, please take your seats. It is very difficult to hear the speaker, and he is entitled to be heard.

Mr. WHEATLEY. I am going to presume that the trial lawyers, the ACLU (American Civil Liberties Union), and the business community have really looked at this and worked this bill through, and under their opinions and their information, I am just going to believe that this is going to be a more helpful bill for constituents throughout the Commonwealth.

I do have some concerns about the bill and what it would do as it relates to people being able to, one, know what is being said about them and have an ability to at least offer their own opinion about the situation an employer may have, good or bad, and also, I am not sure if this actually gets to where we are trying to go in the original intent of the bill. But in saying all that, I will probably support this bill, and I hope that it meets what we are trying to do.

So I want to thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Cohen.

Mr. COHEN. Thank you.

Mr. Speaker, my intention also is to vote for this bill based on the large number of interest groups with somewhat conflicting interest who are supporting it, but I share Representative Wheatley's concerns about the establishment of a clear-and-convincing-evidence standard to prove good faith. The clear-and-convincing-evidence standard is much harder to meet than a preponderance-of-evidence standard, and it seems to me we are giving some employers a limited license to lie about their employees.

Now, I guess the countercase would be, it is very difficult right now for employees to get letters of recommendation, and we are going to have more letters of recommendation and employees might be helped in this. But I have concerns about the wording of this bill, and I would certainly hope that the interest groups involved and the Senate and the

Governor's Office would take a very good look at this wording before it actually becomes law.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Turzai.

Mr. TURZAI. Thank you, Mr. Speaker.

I just have a few questions on the bill, given the interesting support.

The SPEAKER pro tempore. Does the gentleman seek to interrogate the chairman of the Judiciary Committee?

Mr. TURZAI. Yes.

The SPEAKER pro tempore. The gentleman has agreed, and you may proceed.

Mr. TURZAI. My understanding is that— I have had some correspondence from folks back in my district to ask about the bill. The first question is, does this bill in fact weaken the presumption of good faith, the good-faith allowance, that is already present in the common law?

Mr. O'BRIEN. No, it does not.

Mr. TURZAI. Does it strengthen it?

Mr. O'BRIEN. Yes, it does.

Mr. TURZAI. They also wanted to know, there is a concern whether it is a limited definition of what constitutes a quote, unquote, "reference"; that it only applies to a very small category of employer recommendations and/or bad information with respect to a past employee. Is that a narrow definition?

Mr. O'BRIEN. This specifically applies to the ability of the employee to do their job, not anything outside of that.

Mr. TURZAI. And finally, does the bill remove current common law protections for employers?

Mr. O'BRIEN. No. There is a specific section that says, "THIS SECTION SHALL NOT BE CONSTRUED TO AFFECT IMMUNITIES FROM CIVIL LIABILITY OR DEFENSES, ESTABLISHED BY LAW OR AVAILABLE AT COMMON LAW...."

Mr. TURZAI. Thank you very much, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Is there anyone else that wishes to speak on this Senate bill?

On the question recurring,

Shall the bill pass finally?
