Give them humility that they may always remember the simplicity of true greatness, the open mind of true wisdom, and the meekness of true strength. Then I will dare to whisper, "my prayers have not been in vain."

REMARKS SUBMITTED FOR THE RECORD

Mrs. HARHART submitted the following remarks for the Legislative Journal:

I decided to draft this bill after hearing several heartbreaking stories of women who were unaware of ways to prevent this disease, or who did not realize the importance of having a yearly Pap exam. For many of these women, their cancer was treatable and they now use their experience as a way to educate others of the importance of annual examinations.

For a few, however, treatment was unsuccessful and they lost the battle to cervical cancer. We do not want to see another woman become a victim of this disease.

This task force, which would be developed as a division of the Department of Health, would be made up of individuals with expertise in women's health issues, including but not limited to gynecological oncology, epidemiology, social services, and outreach to women and minorities who are at risk to contract this condition.

The task force will also include representatives from the department's Healthy Women Project and the Department of Public Welfare's Breast and Cervical Cancer Treatment Project.

This group, which will meet at least quarterly, will work with the Department of Health to raise public awareness on the causes and nature of cervical cancer, personal risk factors, value of prevention, early detection, options for testing and treatment costs, as well as new technology, medical-care reimbursement, and health providers. They also will research and compile information in order to provide recommended strategies that will reduce the costs associated with cervical cancer and number of diagnoses.

Statistics show that cervical cancer disproportionately affects women in minority groups and those with lower incomes, citing they are less likely to have access to routine screenings. However, like all cancers, this disease does not discriminate by age, ethnicity, or social class. It is equally important to educate all women on the various signs of detection and preventative measures that can be taken.

The primary cause of this cancer is the human papillomavirus, or HPV. HPV can be detected through regular Pap smears and many times clears up without the person even knowing they are infected.

More than 5 million people acquire HPV each year. This disease is classified into "low-risk" and "high-risk" categories. Usually the high-risk classification, if it does not clear up on its own, can cause precancerous cells to form.

Approximately half of all of the cervical cancer cases occur in women who have never been screened. An additional 10 percent of cases are in women who have not been checked within 5 years.

I urge all women to have a yearly gynecological exam, and I urge all of the men present to encourage the women in their lives to make a yearly appointment for a screening.

 - (iii) Up to 15% of the additional money raised may be used by the county for the administrative costs associated with affordable housing and economic redevelopment efforts and for costs of administration and collection of fees.

The Chair recognizes the gentleman, Mr. Levdansky.
 Mr. LEVDANSKY. Thank you, Mr. Speaker.
 Mr. Speaker, would the maker of the bill stand for brief interrogation?

The SPEAKER. The gentlelady indicates she will stand for interrogation. The gentleman, Mr. Levdansky, is in order and may proceed.

Mr. LEVDANSKY. Mr. Speaker, there is language in this bill that alludes to, that talks about, a joint agreement. Just for legislative intent, could you let me know, what are the parties to the joint agreement in your legislation?

Mrs. GINGRICH. If you will give me a moment, Mr. Speaker, I am not sure I heard the entire question.

Mr. LEVDANSKY. Okay.

Mrs. GINGRICH. Thank you for that moment to clarify.

Mr. Speaker, I assume the question was with regard to those in line to receive and to agree to the receipt, if I am correct, and we have the discharge to the tax claims, which I am sure you know are to city, county, borough, incorporated town, township, home rule or optional plan municipalities, school district, and redevelopment authority. They must be willing to accept the property from the donation portion of this bill. Am I answering your question correctly?

Mr. LEVDANSKY. I think so. I just want to make sure I understand, and specifically I am referring to subsection (c), lines 19 through 26, on page 2 of the legislation, okay? That specific language, I want to make sure I understand, so that the parties to the joint agreement are the person donating the property and the tax body receiving the property.

Mrs. GINGRICH. You are absolutely correct on that.

Mr. LEVDANSKY. Okay. A further question. What if, for example, the individual property owner, say an individual was donating the property, and a city, borough, or township agreed to receive the property. So that would be the parties to the joint agreement; it would not be the city, county, and the school district and the property owner.

Mrs. GINGRICH. The intent of the bill would be just that. You are correct. There would be agreement in advance.

Mr. LEVDANSKY. Okay. Now I am really confused. Before the transfer could— Assuming that one of the taxing bodies agreed to receive the property, would the joint agreement require the other two taxing bodies to agree to the transfer?

Mrs. GINGRICH. Yes, that would be the intent of the bill. They would be aware, and there would be agreement before the transaction took place.

Mr. LEVDANSKY. Okay.

Mrs. GINGRICH. Am I saying something, Mr. Speaker, that is not clear?

Mr. LEVDANSKY. So all the affected parties, say, for example, the municipi— I mean, typically when taxes are owed, they are owed to the municipality, the school district, and the county. Would all three tax bodies have to agree to the transfer before it could occur?

Mrs. GINGRICH. It is the intent of the bill that all three would be in agreement before it could occur.

Mr. LEVDANSKY. Okay. And the reason why I raise this is normally when back taxes are owed on a property, it is normally the school district taxes that are more likely, more substantial, than both the municipal and county taxes, in my judgment. Most of the time the enormous amount of back taxes are owed to the school district rather than to the municipality or the county, and my concern is that the school district ought to be, that all three taxing bodies ought to be required to approve any joint agreement to transfer properties.

Mrs. GINGRICH. I appreciate that commentary.

Mr. LEVDANSKY. Okay.

Mrs. GINGRICH. I appreciate that commentary, and that is the intent of the bill—

Mr. LEVDANSKY. Okay; yes.

Mrs. GINGRICH. —but thank you for clarifying.

Mr. LEVDANSKY. Yes; I just want to make it clear what the intent is. Frankly, I think the language needs to be modified a bit to make that clearer, but that is why, I guess, we have a State Senate, to take care of that. And I know over the last couple of months the School Boards Association has been rather engaged on other legislative matters, but this is one in particular that I think they needed to be a little more focused on and giving us a little more input.

But you know, Mr. Speaker, I appreciate your answers, and just hopefully, you know, we can get a little more clarification on this maybe through amendments in the Senate. But thank you.

Mrs. GINGRICH. Thank you, Mr. Speaker, and we can talk to the Senate about that as it moves along the process.
