"THERE OUGHT TO BE A LAW" CONTEST WINNERS INTRODUCED

The SPEAKER. The Chair at this time recognizes the gentleman from Allegheny, Mr. Stevenson, for the purposes of an introduction.

Mr. **LEACH** offered the following amendment No. **A01571**:

Amend Title, page 1, line 3, by removing the period after "organizations" and inserting

; and providing for an offense relating to drug-free park zones.

Amend Bill, page 3, by inserting between lines 18 and 19 Section 2. Title 18 is amended by adding a section to read:

§ 7508.2. Drug-free park zones.

(a) General rule.—A person 18 years of age or older who is convicted in any court of this Commonwealth of a violation of section 13(a)(14) or (30) of the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, shall, if the delivery or possession with intent to deliver of the controlled substance occurred within 1,000 feet of the real property on which is located a State, county, city, borough, incorporated town or township park, be sentenced to a minimum sentence of at least two years of total confinement, notwithstanding any other provisions of this title, The Controlled Substance, Drug, Device and Cosmetic Act or other statute to the contrary. The maximum term of imprisonment shall be four years for any offense:

(1) subject to this section; and

(2) for which The Controlled Substance, Drug, Device and Cosmetic Act provides for a maximum term of imprisonment of less than four years.

If the sentencing court finds that a violation of any other statute would impose a larger minimum sentence, such sentencing provision shall apply.

(b) Proof at sentencing.—The provisions of this section shall not be an element of the crime. Notice of the applicability of this section to the defendant shall not be required prior to conviction, but reasonable notice of the Commonwealth's intention to proceed under this section shall be provided after conviction and before sentencing. The applicability of this section shall be determined at sentencing. The court shall consider evidence presented at trial, shall afford the Commonwealth and the defendant an opportunity to present necessary additional evidence and shall determine by a preponderance of the evidence if this section is applicable.

(c) Authority of court in sentencing.—There shall be no authority for a court to impose on a defendant to which this section is applicable a lesser sentence than provided for in subsection (a), to place the defendant on probation or to suspend sentence. Nothing in this section shall prevent the sentencing court from imposing a sentence greater than that provided in this section. Sentencing guidelines promulgated by the Pennsylvania Commission on Sentencing shall not supersede the mandatory sentences provided in this section. Disposition under section 17 or 18 of The Controlled Substance, Drug, Device and Cosmetic Act shall not be available to a defendant to which this section applies.

(d) Appeal by Commonwealth.—If a sentencing court refuses to apply this section where applicable, the Commonwealth shall have the right to appellate review of the action of the sentencing court. The appellate court shall vacate the sentence and remand the case to the sentencing court for imposition of a sentence in accordance with this section if it finds that the sentence was imposed in violation of this section.

Mr. VITALI. Thank you, Mr. Speaker.

I first want to salute Representative Leach for his excellent efforts in dealing with a very serious problem, the sale of drugs

anywhere, especially in parks. I do have a couple of concerns with the bill, so I just want to put on the record why I will be voting against this.

It is my understanding that if someone is convicted of selling any quantity of drugs, be it \$5 worth of marijuana in a park area, even if the person has no criminal record, any set of circumstances, no matter how benign, that person would need to go to jail for 2 years, and I think that that is just too much, overreaching.

Another one of my concerns, which is also related, is if you have a person, let us say, in that scenario who perhaps sells that \$5 bag of marijuana in a park, that identical person or someone similarly situated, if they did it outside this prescribed area, outside the thousand feet, they would probably get probation for that same set of actions, and I am concerned about that disparity in the treatment of those two defendants, one getting at least 2 years and the other getting probation, only because one chose to sell it in an area which is a park area. I think selling drugs anywhere is a serious offense, and I am not sure the mere fact we are dealing with a park as opposed to a street corner or a movie theater or some other place justifies that differential in punishment.

So in closing, again, I fully salute Daylin Leach's efforts. It is a very serious problem, and he is doing a great job dealing with it. I just wanted to— I understand this is going to pass overwhelmingly, but I just wanted to get my thoughts on the record.
